The above figures indicate no unusual or excessive mortality from any particular cause.

#### ESTIMATED POPULATION OF WATFORD.

The Registrar General's estimate of the total civil population of Watford at Mid Year 1941 is 72,950, and this figure has been adopted for compiling our local statistics. This figure is exclusive of military population.

BIRTH RATE.—The number of births in the Borough of Watford during the last year after correction for inward and outward transfers was 1,006 compared with 1,014 in 1941. This gives a Birth Rate of 13.8.

This Birth Rate is less than that of the whole country for 1941 which was 14.2.

STILL BIRTHS.—Thirty-six still births were notified during the year compared with 42 in 1940. This gives a rate of .49 per 1,000 population as compared with .51 per 1,000 for England and Wales.

DEATHS.—The number of deaths for the Borough after allowing for outward and inward transfers is, according to the Registrar-General's Return, 801 as compared with 807 in the previous year.

This gives a *Death Rate* of 10.9 per 1,000 from all causes as compared with 11.7 in 1940. It compares favourably with London's Death Rate of 12.9 and that of the whole country, which was 16.3 per 1,000.

INFANT DEATHS.—Under the age of 12 months. These number 56, giving an *Infant Death Rate* of 55.06 per 1,000 births. The Infant Death Rate of Watford is lower than that of London which is 68 and the whole country which is 59.

### II. PROVISION OF HEALTH SERVICES IN THE AREA.

#### (a) HOME NURSING AND MIDWIVES.

THE WATFORD AND DISTRICT NURSING ASSICIATION has its headquarters in Alexandra Road.

An annual grant to the Society is made by the Watford Corporation.

MIDWIVES. — The Herts. County Council is the supervising authority for Midwives, whose services may be engaged from the Home in King Street. In addition there are four midwives in private practice in the Borough.

#### (b) LABORATORY FACILITIES.

Diphtheria swabs from the Borough are sent to the Peace Memorial Hospital for examination; also certain other pathological specimens. Swabs from the Joint Isolation Hospital for K.L.B. and haemolytic streptococcus are also examined there. The pathological work at this hospital has recently been greatly extended under Sector IV of the new Emergency Medical Service.

# (c) LIST OF ADOPTIVE ACTS, BYE-LAWS AND LOCAL REGULATIONS RELATING TO THE PUBLIC HEALTH IN FORCE IN THE DISTRICT WITH DATE OF ADOPTION.

For these lists see previous Annual Reports. No further Acts have recently been added to the list.

#### (d) MATERNITY AND NURSING HOMES.

The Stanboroughs Maternity Home has ceased to exist since the war time changes at this Institution. The accommodation in Watford is now as follows: King Street Hospital, 25 beds, and Watford P.A.I., 31 beds.

#### (e) MATERNAL MÓRTALITY.

There were no deaths from puerperal pyrexia during the year 1941 and one from "other puerperal causes". This gives a maternal mortality of 0.9 per thousand births for Watford.

#### (f) AMBULANCE FACILITIES.

In addition to Motor Ambulances in use at the Isolation Hospital for removal of infectious cases, there are also the Corporation Ambulances provided in co-operation with the St. John Ambulance Brigade. These Corporation ambulances now form part of the fleet of ambulances used for A.R.P. and are under the direct control of the Medical Officer of Health.

#### (g) CLINICS AND TREATMENT CENTRES.

These are the same as in pre-war years with the following additional units:—

- (1) Maternity and Child Welfare Centre, Stanboroughs.
- (2) Ante-Natal Centre, Stanboroughs.
- (3) Additional Clinics for Diphtheria Immunisation.
- (4) Child Guidance Clinic.

#### III. SANITARY CIRCUMSTANCES.

#### Water Supply.

The Water Supply of the Borough is obtained from three sources, as described in last year's report.

### WORK CARRIED OUT BY THE SANITARY INSPECTORS DURING THE YEAR 1941

The usual routine work has been carried out by the Sanitary Inspectors during the year and the necessary action has been taken as far as possible to remedy nuisances, sanitary defects or contraventions of the various Acts coming within the jurisdiction of the Public Health Department.

Regular inspections have been made and action taken where any infringements were noted, with satisfactory results.

#### (a) MILK.

During the year 54 samples of milk were taken and all proved satisfactory.

#### MILK (SPECIAL DESIGNATIONS) ORDER, 1936

There are three licensed Vendors of Tuberculin Tested milk in the Borough and one licensed apparatus for the pasteurisation of milk. DIPHTHERIA.—Forty-seven cases occurred with 5 deaths.

DIPHTHERIA IMMUNISATION.—Fortunately the Borough of Watford is in a district where diphtheria cases are less numerous, and outbreaks of this disease are less frequent than in certain other districts where this disease appears to be more or less endemic. It must not be argued from these facts that immunisation against diphtheria is unnecessary in Watford, as there is always the danger of importation of the disease from other districts. A vigorous campaign has therefore been carried on to obtain as much protection as possible amongst the younger section of the population. Dr. Margaret Ward has continued her clinic for pre-school cases and in addition much work has been done in the schools and also at the Harebreaks First Aid Post and in the Hut on Fridays (morning and afternoon). The number of cases dealt with has been as follows:—

The total result is that 5,014 cases have been completed during the year. Much assistance has been given in the campaign by the Ministry of Health Laboratory, A.R.P. workers, Health Visitors and School Nurses. Some of the head teachers have also helped very considerably. The above figures do not include the work carried out by medical practitioners in their private practice, but no doubt these would amount to several hundred cases more. Dr. Osler was responsible for the work in the schools.

With regard to dosage, a first dose of 0.3 c.c. is given, followed after an interval of four weeks by a dose of 0.5 c.c. The prophylactic used is Alum Precipitated Toxoid supplied by the Ministry of Health.

WHOOPING COUGH Injections (preventive and curative): 65. This work was carried out by Dr. Margaret Ward.

ERYSIPELAS.—Twenty cases were notified as compared with 17 in the previous year.

PUERPERAL PYREXIA.—Nine cases were notified. No death occurred from this disease but there was one death from "other Puerperal Causes."

PNEUMONIA (which includes primary pneumonia and influenzal pneumonia).—Sixteen cases were notified. This notification is of some value at times when influenza is prevalent, in order to show the extent of the epidemic, and also the number of serious cases. MEASLES AND WHOOPING COUGH.—The usual seasonal incidence of these diseases occurred, resulting in one death from measles and eleven from whooping cough. A hundred and ninety-three cases of whooping cough were notified and 1,300 cases of measles.

CEREBRO-SPINAL FEVER.—Twenty-five cases of this disease were notified, with 2 deaths. All cases were removed to the Joint Isolation Hospital, the low death rate being due to improved methods of treatment by chemo-therapy.

INFLUENZA.—A comparatively mild type of this disease was prevalent in 1941 which caused 13 deaths.

VENEREAL DISEASES are dealt with by the County Council. A clinic for Watford has now been opened at Shrodells Hospital. The times of attendance are as follows:—

Men.—Tuesdays, 5 - 7 p.m.; Fridays, 2 - 4 p.m.

Women and Children.—Mondays, 5-7 p.m.; Fridays, 10-12 noon.

Of the 38 cases who died from tuberculosis, all were notified.

PUBLIC HEALTH ACT (PREVENTION OF TUBERCULOSIS) REGULATIONS, 1925, AND PUBLIC HEALTH ACT, 1925, SECTION 62. It was not found necessary to take action under the powers given by either of these. There is only one cowshed in the Borough at which none of the workers suffers from pulmonary tuberculosis. With regard to compulsory removal to hospital of persons in an infectious state suffering from pulmonary tuberculosis, up to the present time no cases have arisen where removal was so urgently necessary as to justify the exercise of compulsion.

VISITS TO TUBERCULOUS PATIENTS.—These are paid by the Health Visitors of the Borough. The object of the visit is chiefly to ensure that precautions against infections are taken, to advise about general care of the health, and to ascertain whether home and sanitary conditions are satisfactory. During the year 435 visits of this nature were paid. There are several shelters in use by patients in the Borough.

#### (d) MATERNITY AND CHILD WELFARE DENTAL CLINIC.

DENTAL CLINIC.—A dental clinic is held for nursing and expectant mothers and for children under five years of age. The

work is steadily increasing and 380 cases received treatment during the past year. Twenty-eight sessions were held. Eighteen mothers were provided with new dentures, either whole or partial sets, and in four cases assistance was given by the Council in paying part of the cost.

#### (e) INFANT LIFE PROTECTION.

The Borough of Watford is now responsible for carrying out this work which was formerly done in connection with the old Poor Law Administration. The following figures have been compiled by Miss Brown:—

The number of cases admitted during the year 1941 was 487, compared with 404 in 1940, and 283 in 1939. The following table gives the number of cases admitted from each district, and also the total number of cases of each disease.

Other diseases admitted were as follows: Poliomyelitis 2 (Rickmansworth), Encephalitis Lethargica 1 (Watford Rural), Dysentery 6 (2 Watford Borough, 4 Bushey), 1 Ophthalmia.

Fifteen deaths occurred in the Hospital in 1941: Diphtheria 3, Whooping Cough 4, Cerebro-sp. Fever 4, Measles 3, Enteric 1.

In addition, the following 4 cases were admitted from districts outside the area of the Joint Hospital Board:—

Hemel Hempstead.—Diphtheria 1. St. Albans.—Measles 1, Mumps 1. Bishop Stortford.—Whooping Cough 1.

This brings the total number of cases treated during the year to 494.

A comparatively large number of cases was admitted to the hospital as in the previous year. Scarlet fever was responsible for nearly half the admissions, the cases being mostly of a very mild type and resulting in no death. Diphtheria cases numbered 59, most of the cases being of the mild type. The number of cases admitted with the diagnosis of cerebro-spinal fever was much larger than usual, but fortunately out of a total number of 48 cases only 4 deaths occurred. This low mortality is partly due to the new treatment by chemo-therapy, and also to the fact that 10 of the cases admitted were not true cases of cerebro-spinal fever, but meningismus due to the onset of another acute infection. All these cases yielded a cerebro-spinal fluid containing no meningococci and ran a favourable course with early recovery.
