TO THE MAYOR, ALDERMEN AND COUNCILLORS OF THE BOROUGH OF WEDNESBURY.

Mr. Mayor, Ladies and Gentlemen,

I have the honour to present an Interim Annual Report on your Public Health Services for the year 1939.

Circular 2067 of the Ministry of Health, dated July 19th, 1940, states that in view of the increasing pressure of work in the Public Health Department of Local Authorities, and the need for strict economy in the use of paper, the Minister considers that interim reports only should be made for 1939—but that arrangements should be made for careful preservation of all records, including statistics supplied by the Registrar-General, in order that after the termination of the war a full report could be made for the period from the beginning of 1939 to the end of the last complete year, giving separate statistics for each year in order that annual records may be continuous and complete. The usual Tables which have been filed for reference are this year omitted and the report generally is much abridged.

During 1939 further recommendations of the Minister's report of March, 18th, 1938, were implemented; the services of the Obstetrical Emergency Unit of the County Borough of West Bromwich were made available for us from February 1st. We are grateful to our neighbour for placing these facilities at our disposal, and on March 1st an additional Health Visitor and School Nurse was appointed. In February an Enquiry was held regarding the remaining houses in the Portway Road Area, approval of their demolition being received in July.

The long present threat of war and its declaration on the 3rd September brought into active use a new service—that branch of Civil Defence designated Air Raid Precautions—Casualty Services, which has occasioned much additional work since the submission of my first memorandum in October, 1937. The Scheme-making Authority for the Borough is the Staffordshire County Council.

I would desire to record my appreciation of the help and encouragement which I have received from my Chairmen and Committee members, to express to Dr. Allen, the Health Visitors, Clerical and Sanitary Department Staff, my thanks for their loyal support during a year full of calls for special service, and to acknowledge the ready co-operation of my colleagues in private practice and of the officers of other departments.

SOCIAL CONDITIONS.

I am indebted to Mr. A. S. Morgan, Manager of the Employment Exchange, for the following statistics.

Unemployed at end of 1939: Men (age 21 and over) 392; Young men (18—20 inclusive) 19; Boys (14—17 inclusive) 3; Women (age 21 and over) 168; Young women (18—20 inclusive) 9; Girls (14—17 inclusive) 7. Total: 598, made up of 375 wholly unemployed and 223 temporary stoppages or short time workers.

The figures for 1939 are the lowest since January, 1921.

Contributors to Unemployment Insurance (age 14-64): 11,625 males and 2,855 females. Total: 14,480.

Mr. J. Parkes, Clerk to the Wednesbury Guardians' Committee, informs me that the number of persons in receipt of Public Assistance at 31st December, was : Medical relief only, 13; Outdoor relief, 418; Total, 431.

Ophthalmia Neonatorum.

Two cases notified, in no instance did impairment of vision result.

Free Milk.

Liquid or modified dried milks were supplied as in previous years. Approximate cost being $\pounds 158$ 19s. 9d.

Child Life Protection.

The Superintendent Health Visitor (Miss C. L. Evans) is the Child Life Protection Visitor. One child was under supervision at the end of the year.

Maternal Mortality.

The Rate is set out under Vital Statistics; all cases were subject to investigation and report.

Ailing Babies' Hostel.

The patients of the Hostel were discharged to their homes on the 1st of September—no provision for protection against air raids being available. Since the Hostel was opened there has been a great increase in facilities for treatment of the type of cases dealt with in neighbouring hospitals, and it is anticipated that there will be no lack of accommodation for patients who would have been accommodated in the Hostel. Up to the 31st of August admissions numbered 35.

Sources of supply are as detailed in the report for 1938. Bacteriological and chemical tests have proved satisfactory.

The medias of three choked percolating filters have been washed and re-graded.

Of the houses built for Slum Clearance under the Housing Act, 1930, 18 were erected in 1933, 216 in 1934, 340 in 1935, 327 in 1936, 93 in 1937, 587 in 1938, and 71 in 1939.

Overcrowding.

At the beginning of the year 566 houses were scheduled as overcrowded in accordance with the standards of the Housing Act, 1936.

42 families, comprising 278 persons, were re-housed from 42 houses, apart from overcrowding abated as the result of slum clearance.

Small Dwellings Acquisition Act.

The Borough Treasurer, Mr. J. S. Hodges, F.I.M.T.A., A.S.A.A. reports that $\pounds 4,940$ was advanced in respect of 12 houses, and that since the Act was brought into operation $\pounds 29,900^{\circ}$ has been advanced in respect of 64 houses.

SECTION E.

INSPECTION AND SUPERVISION OF FOOD.

Statistics have been filed for presentation in next full report. Sampling under the Food and Drugs Act and under the Milk and Dairies Order has as heretofore been carried out by the Staffordshire County Council.

SECTION F.

PREVALENCE OF, AND CONTROL OVER, INFECTIOUS AND OTHER DISEASES.

Cases notified : Scarlet Fever, 119; Diphtheria, 35; Enteric Fever, 1; Pneumonia, 67; Erysipelas, 20; Puerperal Pyrexia, 2; Cerebro-Spinal Fever, 2.

No disease assumed epidemic character, but measles and mumps were prevalent during the first five months. Whooping Cough and measles only became compulsorily notifiable from November 1st.

231 Throat swabs were sent to the County Laboratory for examination, 33 being positive for Diphtheria, 198 negative.

Immunisation against Diphtheria.

This has been carried out as detailed in the report for 1938.

From September, 1936, to December 31st, 1939, 939 children have completed a course through the School Medical Service and 338 through Infant Welfare Centres. Particulars are as follows :—

During the year 161 Sputum Tests were carried out at the County Laboratory, 37 being positive, 124 negative.

Close co-operation is maintained with the Tuberculosis Officer (Dr. D. J. Loughran).

Vaccination.

Dr. G. E. V. Morris, the Public Vaccinator, has rendered the following return for the year 1939 :—

Births, 526; Vaccinations, 42; Declarations, 370; Insusceptibility, 1; Deaths, 20; Postponements, 15; Removals, 21. Cases to be dealt with by the Vaccination Officer, 57.

TO THE MAYOR, ALDERMEN AND COUNCILLORS OF THE BOROUGH OF WEDNESBURY.

Mr. Mayor, Ladies and Gentlemen,

Circular 2067 of the Ministry of Health, dated 19th July, 1940, lays down that the Annual Report in respect of the year 1939 shall be regarded as an interim one and that the usual records and statistics shall be carefully preserved in order that after the termination of the war, a report may be made dealing more fully with the period from the beginning of 1939 to the end of the last complete year, when the whole of the statistics for each year may be given, in order that the records may be continuous and complete. The usual Tables will not therefore be circularised this year.

1939 was a year of marked activity by the Sanitary Department and the services of a second Additional Sanitary Inspector were made full use of.

Particulars as to the provision of New Houses and of Slum Clearance and Demolition Orders, Overcrowding, Disinfestation, etc., will be found in the Report of the Medical Officer of Health.

The Inspectors of the Sanitary Department were fully employed in visits in connection with the Public Health Acts, Housing Acts, Factory Acts, Infectious Disease, Food Inspection, etc. Over 13,562 carcases were inspected, and the weight of food condemned totalled 9 tons 5 cwts. Over 100 houses were represented for re-condition and repair.

Offensive Trades.

Two applications were received for the establishment of a fish frying business; neither were granted.

Removal of Refuse.

The number of men employed was 26. Vehicles : one 3-ton and two 2-ton refuse collecting vehicles, five horses and carts, and one 1-ton Morris van (part-time). Total weight of refuse collected : 10,611 tons. Disposal, as in the past, was by means of controlled tipping.

This is the last Annual Report I shall have the honour of rendering to you, and I cannot conclude without expressing my thanks for the courtesy which you have always extended to me over a period of 33 years service to the Borough. From the general townspeople I have always received a kindly reception in what are oftentimes distasteful tasks, and I shall look back with pleasure in my retirement to the great progress which has been made in regard to the Sanitary and Health Services in the Borough during my years of office.
