

The figures show that 3 unsatisfactory samples were obtained during the year. The great majority of the supply is chlorinated before it is distributed to consumers. It will be noted that only one chlorinated sample was unsatisfactory.

The samples described as unsatisfactory were only slightly so. They showed slight bacterial impurity since coliform organisms were present in small numbers. In the absence of bacteria of excremental type the bacteriologist considered there was no evidence of dangerous contamination.

(ii) Milk.

During the year 122 samples were obtained and submitted to the Ministry of Health Laboratory Service for examination.

The number of unsatisfactory samples shows an increase on previous years. All unsatisfactory samples were followed up.

On June 3rd, 11 samples were obtained from the six purveyors selling milk in the torn, and all were found to be unsatisfactory. On July 22nd, 12 samples were obtained of which 10 were found to be unsatisfactory. These failures which may resonably be attributed to abnormal hot weather, make the general quality of the towns milk supply appear lower than it was. Whilst samples of milk should pass the prescribed tests, even in summer, the record breaking high temperatures during the year were sufficient to cause initially clean milk to fail to pass the tests.

(iii) <u>General</u>

During the year 976 inspections were made. Two informal notices outstanding from 1946, were complied with. 55 informal notices and 1 statutory notice were served and complied with during the year. One retail rurveyor of milk was prosecuted and fined £2 with £3.3.0 costs for selling milk in a dirty bottle.

(iv) Factories Act. 1937.

89 factories with mechanical power, and 3 without mechanical power are registered. During the year 71 inspections were made. 4 cases of default were found, these comprised, dirty sanitary conveniences, absence of intervening ventilated space to sanitary conveniences, and insufficient sanitary conveniences. One case of insufficient conveniences was outstanding at the end of the year.

All factories in the town are of modern construction. A wide range of articles are made or assembled providing opportunity for a considerable variety of employment. The prescribed particulars required by the factories act are as follows :-
