BIRTHS.

The number of births recorded during the year was 727, which is an increase of 9 on the number for 1942. Of the total births 364 were males and 363 were females. There were 28 illegitimate births—19 males and 9 females.

DEATHS.

The total deaths registered for the Rural District during 1943 numbered 449. The figure for 1942 was 414.

Maternal Mortality.—The maternal mortality rate per 1000 live births was 1.37 against 2.78 in 1942. The figures for England and Wales were :—

Infantile Mortality Rate.—There were 30 deaths of infants under one year, which gives an infantile mortality rate of 41 per 1000 births. This figure is 2 less than the figure for 1942 and 11 less than the five years average. The rate for England and Wales was 49 per 1000 births.

Section B.

GENERAL PROVISION OF HEALTH SERVICES FOR THE AREA.

PATHOLOGICAL REPORTS.

Specimens are sent for examination to the Bacteriological Department of the University of Liverpool, to Messrs. Evans, Lescher and Webb's Biological Institute at Runcorn, to the Pathological Dept., of the Southport Infirmary, and to the Bootle Infectious Diseases Hospital. Emergency examinations are carried out by the staff of a local Military Hospital, through the courtesy of the Officer commanding.

Two hundred and eleven nose and throat swabs were taken and examined for *Bacillus Diphtheriæ*, which was found to be present in twelve swabs. Two ear swabs examined for *Bacillus Diphtheriæ* and *Hæmolytic Streptococci* were negative.

Of eleven swabs examined for *Hæmolytic Streptococci* ten proved negative and of five swabs examined for Vincent's Angina, only one was positive.

Three specimens of blood were tested for the presence of the typhoid group of organisms, all were found to be negative.

One specimen of sputum examined for tuberculosis was negative.

In addition to the above twenty-four swabs were taken from Skelmersdale patients in the Infectious Diseases Hospital; all proved to be negative.

AMBULANCE.

The Local Authority provides ambulance facilities for infectious cases only. The Ormskirk General Hospital and also the County Hospital at Ormskirk each provide ambulances for accidents and general hospital cases. Ambulances belonging to the Merseyside Hospitals Council also operate in the area.

The arrangement with the Bootle General Hospital whose ambulances, driven by Fire Brigade drivers, provided services in the southern part of the Rural District, has been terminated in view of the drivers being absorbed by the National Fire Service.

The parishes formerly served by Bootle now derive their ambulance facilities from the Urban District of Litherland and the Non-County Borough of Crosby.

During the year 1943 the ambulance services throughout the district may be said to have been satisfactory, but towards the end of the year, owing to the shortage of drivers, difficulties arose in parts of the area in the night-time and Sunday services.

SCHOOL HYGIENE.

The milk-in-schools scheme is in operation in the majority of the schools. Complaints of souring of the milk have been received from time to time, and these are dealt with by the Department. Some of the schools are now supplied with Pasteurised milk, and this is proving popular, its advantages being realised by parents. Two schools (Haskayne C.E. and Melling R.C.) have been unable to obtain supplies, and in one or two cases irregularity of supply has been complained of, but this has been adjusted as far as possible.

School dinners are now served at Scarisbrick R.C., C.E. and Council Schools, Netherton Council and R.C. Schools, Maghull C.E., Lydiate R.C., Ince Blundell R.C., Halsall Central, Melling R.C., Banks St. Stephens and Aintree Council Schools. Bispham Free Grammar School adopted the scheme in December. Aintree Council School is now accommodated in Maycrete huts, a great improvement in comparison with their former temporary school.

Many teachers complain of the worn-out condition of playgrounds: these and the other defects mentioned in previous war-time reports have not received attention owing to the present emergency. Several schools have no covered playground accommodation for use in inclement weather; cloakroom and lavatory facilities in the older schools will need to be overhauled after the present emergency. Ince Blundell R.C. School has been fitted with electric light and improved heating has been provided.

Milk Sampling.—Thirty-nine samples of milk were taken by the Inspectors during the year.

Twenty-four of these samples were for Tuberculosis, 22 of which proved to be negative and 2 positive,

Six examinations were for cleanliness, 2 of which were satisfactory and 4 unsatisfactory.

Six examinations were for Tuberculosis and cleanliness, all proved negative for Tuberculosis; 4 were satisfactory for cleanliness and 2 unsatisfactory.

Three examinations were taken for Hæmalytic Strept. and all proved negative.

All the examinations were carried out by the Pathological Department of the Liverpool University.

Twenty-one samples were taken in the district under the Sale of Food and Drugs Act, 1928.

Tuberculosis.—As a result of notification from Medical Officers of Health that tubercle bacilli had been discovered in milk produced in West Lancashire, an inspection of one herd in Aughton and two in Bickerstaffe was made by a County Veterinary Inspector during the year. Eight animals were dealt with under the Tuberculosis Order, 1938.

SALE OF FOOD AND DRUGS ACT.

As from July, 1940, this Act has been administered by the County Sanitary Inspectors. The work was previously carried out by the County Police.

DIPHTHERIA.

Central Clinics are held at certain of the schools in the Rural District where children from the neighbouring schools attend for immunisation treatment, together with pre-school children from the surrounding districts. In addition, a weekly clinic is held at the Council Offices and a monthly Clinic at the Maghull Parish Institute. Treatment is also offered to all convalescents at the Infectious Diseases Hospital who are recovering from complaints other than Diphtheria.

The incidence was much lower than in 1942, there being only 12 cases as against 25 in the previous year. Only 1 carrier was discovered.

The following tables illustrate the incidence and fatality of the disease during the year and also the work done with respect to immunisation.

SCARLET FEVER.

Scarlet Fever incidence was normal during 1943, 66 cases being notified which is the average number for the past five years. This figure, however, is considerably more than the number of cases occurring during the previous year.

All cases were of mild type and it was only necessary to remove 28 of the them to hospital. The general policy is to remove to hospital only such cases of Scarlet Fever as are living under overcrowded conditions or in such circumstances that they may become conveyors of infection through inefficient isolation.

In thirty-seven houses inspected during the year by reason of tuberculous inmates, eighteen cases were found not to be sleeping in separate bedrooms, and seventeen of these not even in separate beds.

PNEUMONIA.

Forty-nine cases of pneumonia were notified during 1943, an increase of eight on the figure for 1942. Deaths from pneumonia numbered 19. There are no facilities locally for the typing of pneumococci and for the provision of appropriate type sera, such work being of necessity performed in one of the large towns adjacent to the District.

ENCEPHALITIS LETHARGICA

(Epidemic Encephalitis).

No new notifications were received during 1943, and no deaths occurred due to the disease.
