

DISTRICT MIDWIFERY, INFANT WELFARE, HEALTH VISITING AND HOME NURSING.

During 1945 a grant of £7,683 was made to the District Nursing Associations from the County Council in respect of the following duties undertaken on behalf of the Council:—

Health Visiting is carried out by 35 District Nurses, who are supplied with cars. The whole County area is thus covered.

Immunisation of Pre-School Children against Diphtheria.

This is now the responsibility of the County Council and clinics are arranged throughout the County so that every mother has a chance to get her child treated at the age of one year. As a result, very few children reach school age without having been protected against diphtheria.

Infant Welfare Clinics.

Nine clinics at different centres are held once a month with the assistance of the Nurses.

The clinics have been well attended and they serve as very useful centres for immunisation as well as for the distribution of fruit juices, cod liver oil, and, at some centres, dried milk.

Regular voluntary workers render valuable assistance at these centres.

Care of Illegitimate Children.

A scheme for the extension of this Service has been formed and is being put into action with the help of the Social Worker. A register of Foster Mothers is being compiled in addition to the provision of Institutional care.

A residential Nursery was opened in Kendal in December in temporary premises to take 20 children under 5. This is jointly run by the Health Department and the Social Welfare Department and is intended to take most of the long term cases of children under 5 out of the Institutions.

Care of Premature Infants.

Notification of prematurity is now being carried out and these infants are referred to the Health Visitor of the district at the earliest possible moment.

School Nursing, Tuberculosis Visiting and Infant Life Protection Visiting.

This is still being carried out satisfactorily by the Nurses.

Supervision of the Work of Midwives.

This work is now largely undertaken by Miss Gill in her capacity of Non-Medical Supervisor. She reports a satisfactory year of nursing in spite of many changes of nursing personnel.

- Relief Work carried out by Miss Gill—Rural areas 18 weeks and 5 weekends.
- District Inspection—2.2 visits per year to each nurse in rural areas.
- County Council Midwives in Kendal—3 visits per year to each nurse. Since October, 1945, Miss Gill has undertaken one third of the Midwifery in Kendal.

REGISTRATION OF NURSING HOMES (Sections 187 to 194 of the Public Health Act, 1936).

There were 5 Registered Homes at the end of the year, providing beds for 49 maternity patients and 36 other patients. They have been inspected and found to be satisfactorily run.

SCHEME FOR ANTENATAL AND POSTNATAL MEDICAL SUPERVISION OF MIDWIVES' CASES.

The Scheme includes the Borough of Kendal and makes provision for every midwife's case to be examined by a doctor before the confinement.

DENTAL TREATMENT FOR EXPECTANT AND NURSING MOTHERS.

Report of Senior Dental Officer for Year ending 31-12-45.

During this year there has been a marked increase in the number of cases attending under the scheme. Patients continue to be referred from various parts of the county—some from outlying districts where transport has had to be provided by W.V.S. car. The largest number of cases, however, continue to be referred by the Medical Officers.

The number of extractions is practically the same as last year, but fillings and dentures have increased considerably. Total attendances by patients to the clinics number 23 more than last year and 61 sessions were devoted by the Dental Officers to M. and C.W. work this year.

THE PUERPERAL PYREXIA REGULATIONS, 1939.

During 1945, 8 cases of Puerperal Pyrexia were notified (see Tables, Notifiable Diseases, page 19), 1 patient was admitted to the Lancaster Isolation Hospital for treatment and 1 was admitted to Carlisle Infectious Diseases Hospital.

MATERNITY HOSPITAL ACCOMMODATION.

Westmorland County Hospital.

The Maternity block has 8 beds which serve for abnormal cases requiring special treatment and as an overflow from Helme Chase Maternity Home when required.

The Council's Institutions at Kendal and Kirkby Stephen each have 1 maternity ward. Eight maternity cases were undertaken by these institutions.

Helme Chase Maternity Home.

This Home is administered by a joint committee of representatives of the Westmorland County Hospital and the County Council. It was opened on 4th December, 1939. There are 13 beds, one labour ward and one isolation bed. This provision is in addition to the beds provided at the Westmorland County Hospital. During 1945, 332 patients were admitted to Helme Chase Maternity Home and 54 cases received a grant towards the cost of their maintenance under the County Council's Scheme. The rising number of applications for admission to this Home and the shortage of nursing and domestic staff has thrown a great strain on the existing staff.

St. Monica's Maternity Home for Unmarried Mothers (Carlisle Diocesan Maternity Home).

The Home possesses 23 maternity beds. 55 maternity cases were admitted in 1945; 8 of these were Westmorland cases.

Gas-Air Analgesia.

During the year the Kendal Midwives have administered analgesia to 77 cases (Maternity cases 29, Midwifery cases 48).

Twelve District Nurses, acting as Midwives, are now qualified to administer Gas-Air Analgesia, and had been supplied with the necessary apparatus at the end of the year.

The policy of the County Nursing Association is to train as many midwives as possible to administer analgesia; those who have the largest number of cases and are anxious to qualify are selected first for the training courses.

The percentage of adulteration for the year is 10.11; for the 12 months ended the 31st December, 1944, it was 9.52. In each case all samples below standard, adulterated or disclosing some irregularity are included except those shown to be of genuine quality but below standard, although these are included in the total number for the purpose of calculation.

(3) During the past year 71 samples of milk were received for analysis, of which 68 were taken in the ordinary course of inspection, and 3 samples were taken as appeal to cow samples.

Of the ordinary samples 6 were found to fall below the limits laid down in the Sale of Milk Regulations, 1939, and 1 sample was of genuine quality but below standard; the 3 appeal samples have been dealt with at some length in the report for the quarter ended the 31st December last, as has also the sample out of which arose the appeal samples.

The composition of the 62 samples of genuine milk taken throughout the year shows the following average figures which are of some interest by comparison with former years.

These figures speak for themselves and are, perhaps, the more remarkable when it is remembered that considerable replacements must have taken place in the herds to which these results app'y during the last ten years.

The percentage of adulteration for milk during 1945 was 8.82; for the 12 months ended 31st December, 1944, it was 2.40.

(4) Other Samples.

The samples of articles other than milk received for analysis during the year comprised 19 different commodities, both food and drugs, represented by 21 samples; the descriptions and the number of samples in question were :-

Only 2 of these samples were found not to be satisfactory, one being a sample of orange squash which was deficient in Citric Acid which is given in the Soft Drinks Order, 1943, as being not less than 1.735 per cent. whereas the sample contained only .65 per cent., but the Sugar content was 9.04 per cent. as against 6.89 per cent. specified in the Order, so that it seemed probable that a genuine mistake had been made in preparing the drink.

In the other case a sample of Sponge Mixture had been infested by mites so as to make it unfit for human consumption.

Apart from these all the samples complied with their descriptions and were of perfectly satisfactory quality.

THE FOOD AND DRUGS ACT, 1938. ANNUAL REPORT.

To the Chairman and Members of the Public Health Committee.

I beg to present my annual report on the administration of the Food and Drugs Act, for the year ending 31st December, 1945.

During the period under review a total of 84 samples have been obtained; of these, 67 were of milk and 17 other than milk.

Five (5) samples of milk were found to be slightly below the standard for fat and six (6) samples of milk were found to be below the standard for non-fatty solids. Of the latter number, 4 were pre-

sumed to contain added water to the extent of 3.2 per cent., 1.4 per cent., 20 per cent. and 4.4 per cent.

Unsatisfactory features reported upon by the Public Analyst in connection with samples other than milk were as follows:—

Orange Squash.—Deficient in citric acid and excess of sugar.

Egg Substitute Powder.—Desirable that it should conform to the description covered by the term Golden Raising Powder.

Sponge Mixture.—Infested with food mites.

Satisfactory replies have been received to letters of caution in respect of unsatisfactory samples. The sample containing 4.4 per cent. of added water was taken in connection with that indicating 20 per cent. of added water and as a result of legal proceedings authorised by the Clerk to the County Council the defendant was fined £10 and ordered to pay costs amounting to £7 18s. 6d.

Owing to difficulties experienced in obtaining equipment used for the purpose of food sampling, the total number of samples obtained is rather less than is desirable when based upon a comparison with the population of the administrative area. These difficulties have now been largely overcome and it is expected that the total number of samples per year will, in the future, be not less than 144.

COUNTY OF WESTMORLAND TUBERCULOSIS SCHEME.

The County Authority have the services of the Sanatorium Superintendent as the Clinical Tuberculosis Officer and herewith follow notes of work done.

There are Dispensaries at Meathop, Kendal and Appleby, and the attendances there during the year have numbered 721 (688 in 1944). As the Dispensaries cannot cover the distant portions of the County, domiciliary visits are proportionally high at 262.

A total of 317 patients were seen for the first time and amongst these were 70 (including "transfers in") suffering from tuberculosis.

Practitioners in the County sent 117 sputum specimens for examination in the laboratory.

The V.C.P. car service has been replaced by the car Hospital Service, and this has been regularly used for the convenience of outpatients attending for A.P. refills. 396 refills were given and 419 X-Ray examinations have been made for Westmorland County patients.

The District Nurses continue to carry out successfully the Tuberculosis visiting in their respective districts, and I would specially mention Nurses Williams and Brigg, who help me at the Kendal and Appleby Dispensaries.

I would like to acknowledge the help and co-operation received from the medical officers and general practitioners in the County.

In conclusion, I have pleasure in recording my grateful thanks to the medical, clerical, nursing and domestic staffs, who, often under heavy handicaps, have all continued to give me every possible help in coping with what has been a very busy year for Westmorland Sanatorium.

BOVINE TUBERCULOSIS.

The Tuberculosis Order, 1938, is carried out by the Divisional Inspector of the Ministry of Agriculture and Fisheries, in co-operation with the County Police.

During the period 1st January,—31st December, 1945, 26 animals were slaughtered under the above Order as follows:—

Cows in Milk:-

4 with T.B. Milk.

3 suffered from tuberculous udders.

7 suffered from chronic cough.

Other Cows or Heifers:—

12 suffered from chronic cough.

Compensation to owners is paid by the Ministry of Agriculture and Fisheries.

We desire to thank the Divisional Inspector for his ever-ready and valued help in investigating bovine tuberculosis.

BACTERIOLOGICAL AND BIOLOGICAL EXAMINATION OF MILK.

The systematic examination of milk samples for the bacterial count and for the presence of Bacillus Tuberculosis was commenced in November, 1932.

9 samples of pasteurised milk were tested by the Phosphatase Test and were all satisfactory.

The regular supervision of Tuberculin Tested and Accredited Milk is carried out by the County Agricultural Organiser.

The foregoing figures show that in the biological examination of milk for Bacillus Tuberculosis, of the 183 samples representing the milk from 3,983 cows, 4 samples were positive.

Immediately on receipt of a positive Laboratory Report on a sample, the Divisional Inspector is informed and makes arrangements for the examination of the herds involved, for the exclusion from the milk herd of any suspected cows, for the taking of individual samples from such cows for biological examination, and for a bulk sample being taken from the rest of the herd. Cows proved to be yielding the germ in their milk are destroyed.

A duplicate copy of the Laboratory Report on each sample is sent to the Medical Officer of Health of the Westmorland Combined Districts, who, through the various Sanitary Inspectors, informs the milk producer. Copies of unsatisfactory reports are also sent to the County Agricultural Organiser.

When an unsatisfactory report is received, steps are taken to encourage the producer in question to overhaul his methods of production and to secure cleaner milk. The active co-operation of the County Agricultural Organiser is invaluable here.

WATER SUPPLIES.

Appleby Borough Council.

One sample has been analysed and the report states:-

"After 24 hours, this sample afforded no evidence of any

- "action on lead. The results of both the chemical analysis and of
- "the bacteriological examination show that the sample is free
- "from contamination by sewage and other foul drainage, the only
- "defect being the presence of a large number of micro-organisms,
- "probably due to some slight defect which, if remedied, would
- "leave no ground for criticism; otherwise the supply is satis-
- "factory."

The supply is sufficient for the area. All houses in the area are connected to the main supply with the following exceptions:—

- Colby Laithes Farm, drinking water from pump. Stock from River Eden.
- 2. Hungriggs Farm, piped supply from spring.
- Dwelling house at Bainbridge Close, spring with rainwater store in addition.

26 premises outside the Borough, situated in the North Westmorland Area, are supplied with water from Appleby Main.

Kendal Borough Council.

The total rainfall at Fisher Tarn was 49.03 inches.

At the commencement of the year there were 178 days' supply; $50\frac{3}{4}$ million gallons were supplied from Mints Feet; at the close of the year there were 105 days' supply in hand.

By-washing from Fisher Tarn took place in February to the extent of 16½ millions.

Bolefoot Tank was cleaned and lime washed and Mints Feet Well weeded twice. The Chlorination Plants worked satisfactorily.

Monthly bacteriological examinations of the public supplies have been made and these have been satisfactory, and chemical examinations show that the waters are quite fit for human consumption and for all domestic purposes.

There are 45 houses in the Borough which do not obtain their water from the Corporation Mains. Of these 13 obtain their supply from the Thirlmere Pipe-line and the remainder from pumps and other private sources.

Lakes Urban District Council.

All Public Supplies under the control of the Council were maintained in a satisfactory and efficient condition and were abundant; 58 per cent. of the houses in the area are supplied.

A complaint was received regarding the impurity of water in a small private supply scheme involving 6 houses, and upon analysis this was found to be unsatisfactory; a neighbouring owner who has installed a pump and chlorinating plant is prepared to provide a supply to the houses.

A partial renewal at Ambleside of the 3in. main from Lake Road to Stonecroft and the Gas Works has been carried out and in place of the old cast iron pipe a 4in. Everite one has been substituted. Further renewals are contemplated shortly. The supplies to Patterdale and Little Langdale are under consideration.

Windermere Urban District Council.

The supply is adequate in quantity and the quality is good.

North Westmorland Rural District Council.

No extensive alterations have been made to any of the public water supplies in the Eastern Area during the year.

As samples of water from all public supplies were submitted for analysis during the year 1944, and with the exception of minor defects which have since been remedied were found to be satisfactory, no samples have been analysed during the year except a sample from Kirkby Stephen Supply which was found to be satisfactory.

A sample was also submitted for analysis from a spring near Howgill Castle, Milburn, with the object of using the water to augment the Kirkby Thore Supply; the Analyst's report shows the water to be unsatisfactory and its possible use has been abandoned.

In accordance with the directions of the Council, the following Water Supply Schemes have been prepared by the Council's Consulting Engineers:—Ravenstonedale, Kirkby Stephen, Wharton, Mallerstang, Brough and Longmarton. These schemes have been submitted to the County Council for consideration in accordance with the Ministry of Health Circular 119/44.

Continuous Chlorination of the Regional and Kirkby Stephen Water Supplies has been maintained during the year.

In the Western Division the Regional Scheme serves 16 parishes and here connections continue to be made and the consumption is upwards of 2,000,000 gallons weekly, or 280,000 average daily flow. Whilst this works out for the population served at considerably over 50 gallons per head per day, the greater part is used in connection with cowsheds and milk production which has been steadily increasing beyond what might be anticipated a few years before the war.

17. Estimated number of houses without piped supplies

For increased storage, an application has been made to the Ministry for sanction to a loan to construct reservoirs at Hackthorpe and Newby and a smaller one for Maulds Meaburn.

No extensions have been made other than a length of loop main of about 200 yards to connect a dead end branch in Maulds Meaburn with the main which goes forward to Kings Meaburn.

Military requirements for water have lessened, but two camps in Brougham Parish can make a considerable draw off, being situated at the lowest part of the area.

Supplies have continued to be normal and no shortage has been experienced from dry weather.

The Orton Scheme has given some trouble in the sufficiency for Orton Village and higher points beyond. This appears to be due to the proportionately heavy draw-off between the headworks and the reservoir; the extension of the intake to a point higher up the course of the stream which yields the supply is under consideration.

The quality of the Regional Scheme supply has been good, and the addition of lime and chalk bi-weekly to raise the pH value has been maintained.

Quality of Supplies.

Samples submitted for examination from the Council's main supplies at Lupton, Kirkby Lonsdale and Staveley, were found to be satisfactory, but smaller supplies occasionally varied.

Private Supplies.

A considerable number of the private supplies in the area are of very doubtful quality; of 9 samples from these sources taken during the year only 3 were reported as being satisfactory. Six of the unsatisfactory samples were from the same supply, taken at different points, and 4 other samples were obtained in an effort to find a satisfactory supply to premises at present without such a supply.

Extension of Public Supplies.

The extension of the supply to the Parish of Stainton was completed during the year and an extension also of the Arnside Main to Grange View.

Regulation 33B.

For the year ending 31st December, 1945, 9 single references and 1 double reference were received. This is considerably more than in 1944. All these cases have been investigated.

All applicants, before admission to St. Monica's Maternity Home, Kendal, for unmarried mothers, have the Wassermann Test applied. Should any prove positive they are admitted to the Hope Hospital, Leeds, for appropriate treatment. No patients were admitted to this Hospital during 1945.

In 1945, 192 blood specimens were sent to the Public Health Laboratory, Manchester, of which 13 were positive, 174 negative and 5 doubtful. Drugs were supplied to private practitioners where required.

MENTAL AND NERVOUS DISORDERS CLINIC.

This clinic was commenced at the Fellside Dispensary, Kendal, on Thursday, the 30th November, 1944, and thereafter fortnightly from 11 a.m. to 1 p.m. and from 2 p.m. to 4 p.m. The clinic is being conducted by Dr. Joseph Braithwaite, M.B., D.P.H., Superintendent of the Cumberland and Westmorland Mental Hospital, Garlands, Carlisle. Dr. Braithwaite advises:—

- 1. As to whether the patients would benefit by institutional treatment, either on certificate or voluntarily.
- 2. As to whether he can help by seeing patients regularly at the clinic over a period.

Bed-state returns are not now required by the Ministry of Health. Morland Hall Convalescent Home was closed on the 30th November, 1945.
