- 1. The Port Health Inspector carries out a detailed inspection for rodents on all ships arriving from foreign ports.
- 2. Arrangements have been made for the bacteriological and pathological examinations of rodents to be carried out at the County Laboratory, Dorchester. No such examinations were carried out during 1957.
- 3. The Port Health Inspector has been trained in modern methods of rodent control, including "1080 Sodium Fluoroacetate. Small infestations are dealt with by trapping and baiting. Large scale infestations would be dealt with by specialist funigation firms from Southampton or London.
