

Mr. Chairman and Gentlemen,

My Report for the year 1958 has been compiled in accordance with the requirements of Form Port 20 of the Ministry of Health, 1952.

The health of the seamen arriving at the Port has been generally good. There was no case of infectious disease during the year and only three cases required hospital treatment for surgical or medical conditions. During the year there was an increase of venereal disease.

The importation of petroleum products has increased by some 10,000 tons, but mineral cargoes still constitute the bulk of trade. The only foodstuffs imported during the year were 450 tons of potatoes from Ireland.

There has been a decrease in the number of vessels entering the Port due to a recession in the steel trade, consequently the volume of imports and exports has declined. The tendency is for larger modern vessels to carry iron ore, and the amenities provided for the crews are very good.

STAFF.

There were no changes of staff during the year. A list of the personnel and of the members of the Port Health Authority appear on page 2.

WATER SAMPLES.

The Port is supplied with chlorinated water via the mains of Workington Borough: ship water-tanks are filled from hydrants situated on the dockside. Routine samples, both bacteriological and chemical, taken during the year, proved to be satisfactory.

Routine enquiries were made on all vessels as to the source of the water on board and as to the frequency and method of cleaning out water tanks.

In four cases samples of water taken from foreign-going vessels were found to be satisfactory.

PUBLIC HEALTH (SHIPS) REGULATIONS, 1952.

The Regulations have continued to work smoothly in all sections itemised in the report for 1955.

SMALLPOX.

The reception hospital for cases of Smallpox is now Langley Park Hospital, Co. Durham. The ambulance and laboratory services remain the same as in recent years.

VENEREAL DISEASE.

Particular enquiries are made on all vessels in respect of these diseases and printed directions as to procedure for obtaining treatment locally are given.

During the year eighteen seamen (15 British and 3 foreign) received treatment.

No case of infectious disease was reported and no cases of illness seen by the Port Medical Officer was of this nature.

MEASURES AGAINST RODENTS IN SHIPS FROM FOREIGN PORTS.

All vessels are searched for rats. Test baits and traps are periodically laid. Rat guards belonging to the Authority are available.

Slight evidence of rats was discovered on two vessels but trapping and baiting proved unsuccessful.

The carrying of mineral cargoes minimises the risk of rat infestation, and the legal necessity for vessels to carry Deratting and Rodent Control Certificates is gradually eliminating rats from all vessels.

During the year 21 Deratting Exemption Certificates and 10 Rodent Control Certificates were issued.

Dockside buildings are periodically test-baited. One minor infestation was cleared.
