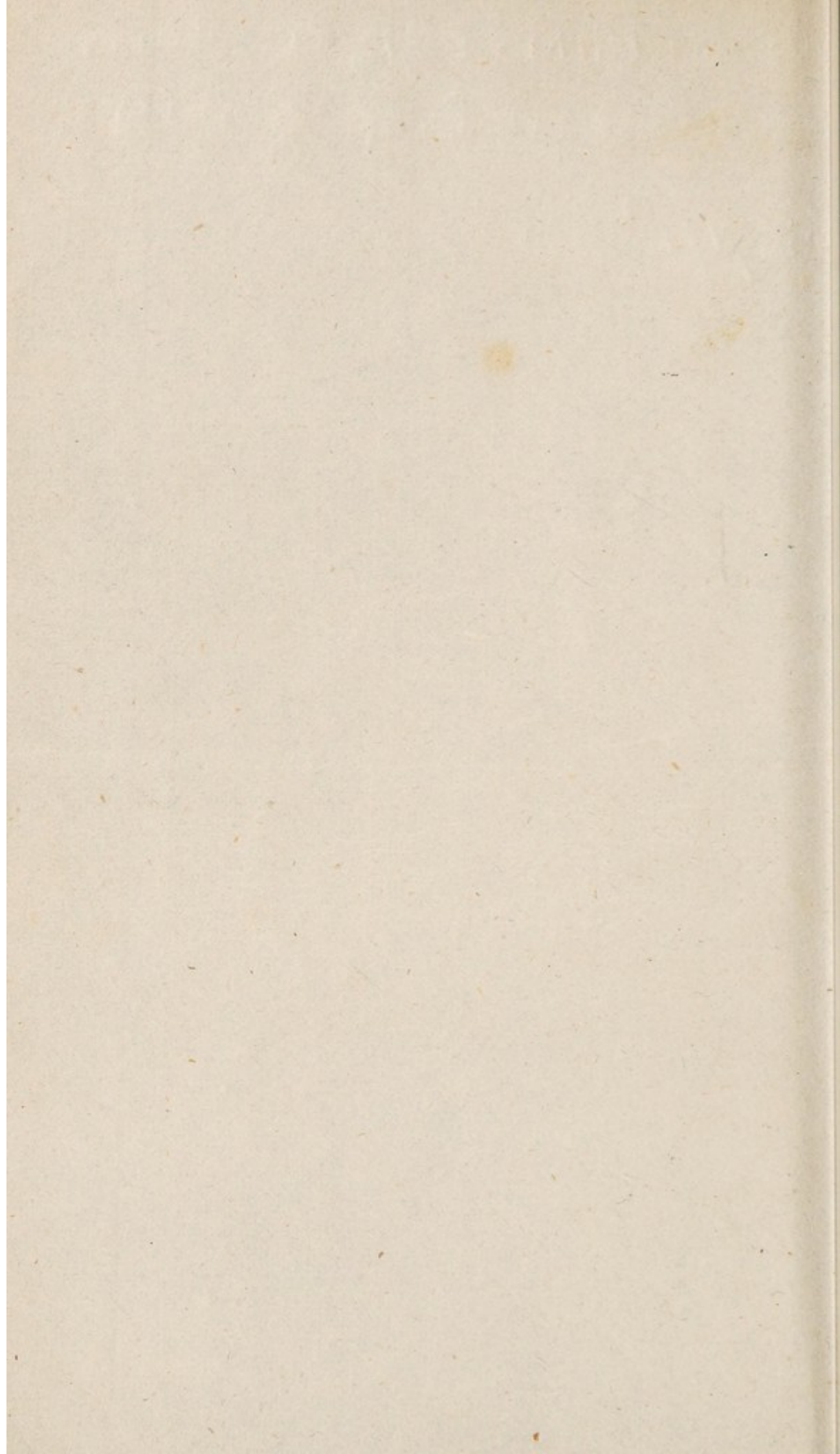

INTRODUCTION.

THOUGH the benevolence of the present age may readily forego the arguments which may be brought in favor of Charity, yet in a Preface to the Plan of an Institution of this kind, it becomes the concern of the writer not alone to state the success which has accompanied, or the motives which gave birth to the undertaking, but to submit to the feelings of the Public its claim to their well-wishes, and its plea to their support.

In a part of the metropolis which is over-run with indigence, and where, in a comparative view, affluence is but thinly scattered, one plea, as arising from the

situation of the Dispensary, may venture to approach even the ears of the great, and will surely not be unattended to by those, who in affluent, yet in inferior stations, possess feelings to pity, and inclinations to relieve, the urgent necessities of sickness, and of sickness labouring under the accumulated weight of want, sorrow, and despair!

There are not wanting other circumstances which tend to recommend this Institution to the patronage of the Public in general, and of the neighbourhood in particular; and it ought to be remembered, that from its situation it interferes with no other Institution of the kind (if there can be any interference in one common field, which seems to possess scope enough for all, wherein to exercise the ardors of benevolence), and therefore disavowing all spirit of opposition or jealousy towards others, it is modestly induced to look up for public support from its utility alone, or

at least its unremitting endeavours in the service of the afflicted.

The noble Founders of the Institution already feel themselves flattered, not only by the generous support which has been given to their undertaking, but by the stated accounts of the benefits which the sick have received; and, warmed by this double proof of the advantages of the WESTERN DISPENSARY, they are emboldened to look forward to the Public for an increase to its funds, in order that Charity, who presides over them, may multiply her benefits, and give to her zeal a more active diffusion.

SOLDIERY.

From the first origin of the Dispensary, it was a wish of the Founders to lay open its benefits to the indigent without distinction; and as this part of Westminster abounds with the Soldiery, they felt happy with a view to the relief of the sickness which frequently oppresses the wives and

children of that order of men, from whom, when reflection takes in the smallness of their allowance, the consequent indigence of their families, and the bold claim which they have to our love and encouragement, as the instruments of national defence, the feelings of the humane and the patriotic can never be withheld.

INOCULATION.

The Founders were in like manner averse to the exclusion of any particular disease, and reflecting what numbers of the infant poor, and those of maturer age, are carried off at times by the epidemical small-pox, they wished to give a patronage to inoculation, when the season of the year and the state of individuals admitted it, as a salutary mode of preservation from the malignity of that disorder; and which has now established its character perfectly in this island, and in some measure over the greater part of Europe, in spite of the fears of prejudice and the jealousy of innovation.

As in many instances of sickness, what ^{Sago,} from the depressing nature of the disease ^{&c.} and the inevitable sinking state of the indi- ^{given.} gent individual, wine, sago, and invigorating nourishment are indispensably necessary, it became a wish of the Promoters of this Dispensary to see its funds in that state of firmness which would allow those articles when required, and they keep the same still in view, as a part of their Plan, whenever the generosity of the Public shall promote its enlargement.

To awaken this generosity, no further account of the Institution need be added. The Subscription, from its smallness, can neither excite the frowns of the great, or startle those of inferior fortune: it is a sum which every one must cheerfully pay, who duly considers that he is giving it for the mitigation of pain, and for the succour of enfeebled bodies and sinking minds—for the preservation perhaps of some parent of a helpless family, or for that of an only child agonizing under the eye of its be-

wildered parents!—whatever may be the particulars to which the bounty may tend, let it be remembered in general, that it goes to the relief of helpless indigence, which might otherwise sink hastily into the grave, under the increasing weight of sickness and despair.

REGULATIONS.

I.

THIS Charity to be conducted by a President, Vice-Presidents, a Treasurer, and Governors; with such officers as may be found necessary.

II.

A Subscriber of one, two, three, or more guineas per annum, constitutes a Governor, who is entitled to have one patient constantly on the books for each guinea subscribed, and a vote at an election, or on any matter that concerns the Charity.

III.

Ten guineas at one payment, or such as make up their last Subscription within the year to that

sum, shall be Governors for life, with the privilege of having one patient constantly on the books.

IV.

Twenty guineas at one payment, or such as make up that sum within the year, shall be Governors for life, and have two patients constantly on the books.

V.

Upon the payment of a legacy of fifty pounds, or upwards to this Charity, the person appointed to pay the same shall be deemed a Governor for life; and for a less sum, for one year from the time of such payments.

VI.

Every Governor, on paying his or her Subscription, is requested to take a receipt for the same; and will be furnished with proper letters of recommendation, which they are desired to sign, to prevent improper advantages being taken of the Charity.

VII.

Such Governors who may be absent from town,

may appoint any other person to sign his letter of recommendation; first giving notice thereof, in writing, at the Dispensary.

VIII.

A General Meeting will be held on the first Thursday in the months of January, April, July, and October; at which Meeting seven Governors shall be deemed a competent number to proceed upon business.

COMMITTEE.

IX.

Twenty-one Governors shall be chosen at the first General Meeting, who shall form a Committee, to meet at the Dispensary on the third Thursday in every month, for conducting the affairs of the Charity; seven of whom will go out by rotation annually. This Committee to be open to the President, Vice-Presidents, Treasurer, and Governors for life, who shall be entitled to vote: three of them shall form a quorum.

No person interested in any matter under debate, shall be entitled to vote at any Meeting or Committee of the Governors of this Charity.

The last Committee in December shall nominate proper persons to succeed the seven who go out by rotation : this nomination to be subject to the approbation or alteration of the next General Meeting.

X.

At every General Meeting, the Committee shall deliver a report of their proceedings during the three last months, signed by the Chairman, which shall be publicly read by the Secretary, for the consideration of the Governors then present.

XI.

No bye-law, rule, order or resolution, made by the Committee or General Meeting, shall be binding, or have any force or effect, until the same shall be agreed to and confirmed by a succeeding General Meeting. The same method to be observed in altering or repealing any bye-law, rule, or order.

XII.

The President, Vice-Presidents, and Treasurer, or either of them, the Committee, or any five of them, or any ten of the Governors, have power at

any time to call a General Meeting, by sending notice in writing, signed by their name or names, to the Secretary, and expressing the business of such meeting : and the Secretary shall give at least four days notice thereof, in any three of the daily papers.

XIII.

The President, Vice-Presidents, and Treasurer, or either of them, the Committee, or any three of them, may call a Meeting of the Committee at any time, by sending notice in writing to the Secretary, signed with their name or names, and expressing the purpose of such Meeting: who thereupon shall give at least three days notice thereof, by a circular letter to the Members of the Committee.

XIV.

In case of the sickness, death, or resignation of any officer, or any other circumstances or accidents which may prevent his attendance, the President, Vice-Presidents, or Treasurer, or either of them, shall be empowered to appoint any other person to officiate in his stead, till the next Meeting of the Monthly Committee; who shall either approve of such appointment, or nominate any other person to act until (if it be a vacancy) the time of election.

XV.

In case of a vacancy of any Officer of this Charity, the Treasurer shall, within seven days afterwards, cause a Meeting of the Monthly Committee to be called; which Committee shall appoint a day for a General Meeting to fill up such vacancy.

XVI.

Not more than one month, nor less than a fortnight, shall be allowed from the declaration of any vacancy to the day of election.

XVII.

The election of Officers of this Charity shall be by ballot, determined between the hours of ten in the morning and three in the afternoon of the same day; and no person shall be allowed to vote at such elections unless such person has paid in a second annual subscription.

XVIII.

Nobility, Ladies, and Members of Parliament, shall have the privilege of voting by proxy.

XIX.

Five Auditors shall be annually elected from

among the Committee, at the General Quarterly Meeting of January, to examine all the bills and accounts of the preceding year; and no interested person shall be on the audit. The report of which Auditors shall be delivered in to the Meeting next following their appointment.

XX.

A Medical Committee, consisting of three persons, shall be chosen by the General Meeting held annually in January, out of such Governors as practise physic, surgery, or pharmacy, or are conversant in the knowledge of drugs and medicines, who shall have full power to inspect the drugs and medicines, examine the bills for the same, and to make their report to the Committee, as they find occasion, who shall afterwards report the same to the next General Meeting for their consideration.

XXI.

If any Officer of this Charity shall accept of any tradesman, patient, or others, any reward or gratuity, directly or indirectly, he shall be immediately discharged.

XXII.

The Officers of this Charity are to attend the

General Meetings and Committees, to give such information, and do such business, as may be required.

XXIII.

All accidents will be attended to by the Surgeon (at all times) and consultations will be held on all dangerous cases.

XXIV.

At a proper season of the year, when the Physician and Surgeon shall think it right, persons of all ages may be inoculated for the Small Pox, at the Dispensary, from whence they shall be supplied with proper medical assistance.

XXV.

No patient, on any pretence whatever, shall presume to come to the Dispensary when the Small Pox appears, as he or they will be attended at their own habitations, by the Physician or Surgeon.

XXVI.

There shall be an Anniversary Dinner, between the 2d of April and the 2d of July, on a day to be appointed by the Stewards for such dinner, when a state of the Charity shall be laid before the Governors.

FORM.

OF A

BEQUEST IN A WILL RECOMMENDED.

ITEM, *I give and bequeath unto A. B. and C. D. the sum of _____ to be raised and paid by and out of my personal estate and effects, which by law I may or can charge with the payment thereof, upon trust, and to the intent that they or either of them, shall and do pay the same to the Treasurer (for the time being) of a Charity, called or known by the name of the WESTERN DISPENSARY, for the relief of the Poor, there, or at their own habitations: which Charity was instituted in the year 1789, and is now kept in Charles-street, Westminster; and which sum I desire may be applied towards carrying on the benevolent designs of the said Charity.*

N. B. Giving land, or money, or stock, by will, with directions to be laid out in the purchase of any estate for the benefit of this Charity, will be void by the statute of Mortmain; but money or stock may be given by will, without being directed to be laid out.

PHYSICIAN.

The Physician is to attend at the Dispensary, every Wednesday and Saturday, precisely at twelve o'clock, to give advice to such Out-patients as come properly recommended ; and afterwards to visit the Home-patients at the places of their abode, as the case may require.

If the Physician, from indisposition or any other cause, be incapable of attending, he must provide some other Physician to attend in his stead ; of which he must always give notice to the Apothecary, who must inform the President, a Vice-President, or the Treasurer thereof, so that they, or either of them, may approve of the person so appointed, or nominate another to officiate as his substitute, till the next Monthly Committee.

SURGEON.

The Surgeon is to attend at the Dispensary, every Monday and Thursday, precisely at twelve o'clock, for the purpose of examining and relieving Out-Patients, and afterwards to visit the Home-Patients at their own habitations.

The same regulations are to be observed in case

of the indisposition or absence of the Surgeon, as are before mentioned with respect to the Physician.

APOTHECARY.

He is constantly to reside at the Dispensary, to compound and dispense the medicines prescribed by the Physician and Surgeon. He is to enter the tradesmens' bills in a ledger, and keep the accounts respecting the same.

He is to examine the letters of recommendation, and keep regular books, with a register of the Patients under cure, their time of admission, by whom recommended, and when discharged; the Governors may at any time inspect these books, and they are always to be laid before the Committee, at their Meetings. He is to take care of the medicines, utensils, and other effects of the Dispensary, and see that none be wasted, spoiled, or embezzled; and to see that all the apartments are always in order fit for the reception of the Officers of the Charity.

He is not to absent himself from the Dispensary on any account whatever, without leaving a note where he may be found, or taking care that a proper assistant be there until he returns; nor is he to absent himself one whole day or night, with-

out leave from the President, a Vice-President, the Treasurer, or Monthly Committee; and in such case, he is to procure another Apothecary to officiate in his stead, who must be approved of by the person giving him such leave.

He is not to practise as an Apothecary, except in the business of the Charity.

SECRETARY.

He is to be present at all Meetings and Committees, at the appointed hours, unless necessarily prevented; in which case he is to send a deputy.

He is to keep the proceedings of the Charity in a methodical manner, and in proper books, and do all such business as is requisite.

COLLECTOR.

He is to find security (to be approved of by the Monthly Committee) to be bound with him in a bond of 500*l*. for the faithful discharge of the duties of his office.

He must keep a perfect list of the Governors, and regularly collect the subscriptions to the Charity, as they become due, and pay the same to

the Treasurer, on the last Friday of every month, or oftner, if required. And in case of the absence of the Treasurer, he is to pay the money to such person whom the Treasurer shall authorise to receive the same.

He is never to retain in his possession to the amount of fifty pounds more than seven days, on pain of being discharged.

He shall be in waiting in an adjoining room to attend upon all General Meetings and Committees, to do all such business as may be wanted, and is not to leave the Dispensary till such Meetings break up.

He shall call at the Dispensary every Monday and Friday, to receive instructions, carry out commendatory letters, and other papers on account of the Charity, and shall regularly once in every week give into the Apothecary the names and residence of all new Subscribers.

PATIENTS.

No persons are to be deemed objects of this Charity, but such as are really necessitous.

The Dispensary to be open from nine in the morning till twelve at noon, and from two till four in the afternoon.

All Patients, from whatsoever place they may come, if properly recommended, shall be prescribed for, and furnished with medicines, provided they attend at the proper hours.

Patients may be visited at their own habitations, if they reside within the limits of the Dispensary, which are from *Westminster-bridge* to *Pimlico*, *Chelsea-bridge*, through *Sloan-street*, *Knights-bridge*, *Piccadilly*, through *Covent-garden*, down *Drury-lane*, to the *Strand*.

The proper hours for Patients to come for advice are from nine till eleven in the morning, every day (Sundays excepted). And if any person neglects to attend the Physician or Surgeon, for ten days successively, such Patients shall be discharged.

Those that require only a repetition of medicines, must apply for them at the Dispensary, between the hours of two and four in the afternoon.

Such Patients (living within the districts) as are unable to attend personally, must send their letters

of recommendation by some adult person to the Dispensary, who will be furnished with proper medicines, and the Physician or Surgeon will attend them at their places of abode, when necessary.

They must furnish themselves with phials, and other things necessary to contain their medicines; they are to behave themselves decently and soberly, and to conform to such rules as are given them, or be immediately dismissed.

Venereal Patients are not to be admitted to this Charity, unless particularly recommended as such by a Governor. And no person to be admitted a second time with that complaint upon any account whatever.

The Patients, when cured, are to deliver their Letters of Recommendation at the Dispensary, and receive a Letter of Thanks, which they are immediately to present to the Governor who recommended them; and they are personally to attend at the place of Divine Worship they usually go to, on the Sunday next following their discharge from this Charity, and there return thanks to Almighty God for the benefit of such cure; and if any neglect to comply with the whole of this rule, they shall not be admitted to receive any future benefit from this Charity.
