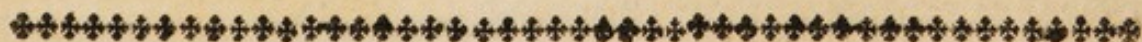

I N T R O D U C T I O N.

AMIDST the Variety of Charities, which are the Distinction and Glory of this Age and Nation, perhaps not one has been proposed to the Public more truly beneficial, or more extensive in its Benefits, than an Hospital for Lying-in Women. It would be invidious to compare this with the many noble Institutions, which in different Parts of the Town are growing Evidences of the Public Spirit and Humanity of the Times : But thus much it is natural and just to observe, that all the Arguments for establishing any Hospital, are at least as strong, when applied to this. Poverty is an Object of Pity ; Sickneſs and Poverty united, ſeem to comprehend all the natural Evils of Life : But, as it is not the Caſe of every ſick Perſon to be diſtreſſed in Circumſtances, ſo there are not many Perſons thus diſtreſſed, whoſe Calamity it is to be frequently or periodically afflicted with Sickneſs ; whereas moſt Women that marry bear Children, and thoſe who work for their Subſiſtence, are, for a conſiderable Part of their Lives, annually diſqualified for Labour ; at other Times their Labour is but a bare Support. During the Time of their

Lying-in, the needy Family is wholly taken up in Attendance upon them; and the Joys, natural at such a Season, are suppressed by the Wants which surround them. Or, if they be destitute of this Attendance, how great is the Hazard that the helpless Mother, or the Child, or perhaps both, may by their Deaths become melancholy Instances of the Evils of real Poverty? If, besides, it be considered, that the Public is interested in the Life of both, as the Poor are the necessary Instruments of Ease and Happiness to the Community, this Charity will be so far from needing a Recommendation, that it is rather Matter of Surprise, a Design, so full of the mutual Love enjoined by Religion, and of the Sympathy excited by Nature, has not been sooner executed. However, it takes Place at last, and must by Degrees flourish, whilst a Spirit of Charity and Benevolence prevails.—But there are some Persons whom it more particularly addresses for Encouragement: Ladies who have experienced the Pains of Child-Birth, this Hospital calls upon them to remember their own Fears and Sufferings, their Expence in providing against all the possible Accidents of their Situation, how much they felt for themselves, how much for their Infants! what Care and Attendance they thought absolutely necessary for their own Preservation, and what Grief they underwent at the Loss, or even the Indisposition of the Child. When they recollect all this, they cannot but sympathize with the Poor in the same Situation, who undergo

all

all their Fears and Sufferings, without their Comforts and Convenience. Other Ladies, who have not experienced, may yet imagine the Distresses of this Condition, and will be naturally prompted, by the Tendernefs and Compaffion of the Sex, to contribute to its Relief. Gentlemen too, whether Fathers of Families or not, are by Motions of Humanity in general, and Affection for the Sex in particular, powerfully excited to commiserate the Cafe of Women so circumftanced.

By the Plan of this Hofpital, every Convenience thefe diftressed Objects can require, is amply provided : Commodious Apartments and Beds, good Nurfing, plain fuitable Diet, proper Medicines, the charitable Affiftance of Gentlemen of Skill and Experience in Midwifry, and, on due Occafions, the fpiritual Comfort of a fober and pious Divine. Thefe feveral Benefits they will enjoy without the leaft Expence to themfelves, and at a Time when their Condition renders them ufelefs, or rather a Burthen to their Families at Home, to which, from the Care taken of them in this Hofpital, they will, probably, in a few Weeks, be able to return ftrong and healthy.

THIS Charity was Instituted in November 1749, by the Name of **THE LYING-IN HOSPITAL FOR MARRIED WOMEN**, and the first general Meeting of the Subscribers (under the Patronage of the late Duke of **PORTLAND**) was held on the 17th of that Month.

In April 1756, by a Resolution of a general Court, it obtained the Name of **THE BRITISH LYING-IN HOSPITAL FOR MARRIED WOMEN**.

The Annual Subscriptions and Benefactions to the Charity being insufficient to support a general Admission of all Patients recommended, that the Governors may not be disobliged by postponing their Recommendations, or suspect any undue Preference, and that every Governor may have an equal Chance for the Admission of his or her Patient, the respective Time of each Patient's Reckoning is taken by some of the Gentlemen of the Faculty, or in their Absence by the Matron, and subscribed at the Bottom of their respective Letters of Recommendation. The Patients are admitted by Ballot, agreeable to the respective Times of their Reckoning. Those drawing the white Balls receive immediate Orders for Admission; those drawing the black Balls are referred to the next succeeding Board-Day, to ballot again.

To promote Subscriptions, and extend the Influence of the Charity, any Person having a Patient to recommend,

commend, whose Reckoning is out, on sending a Subscription of Three Guineas, or upwards, such Patient will receive an immediate Order to be admitted into the House. And the same Regard is paid to any Subscriber's first recommended Patient. And by Order of a Quarterly General Court held the 22d of January 1766, each Subscriber of Three Guineas per Annum, or Benefactor of Thirty Guineas (and so in Proportion) is intitled to have One Patient in the Course of each Year received into the Hospital, without balloting, on writing the Word PREFERENCE on the upper Corner of the Letter recommending such Patient, and the Recommender subscribing his or her Name immediately under the Word Preference, over and besides subscribing the said Letter in the usual Manner ; but all other Patients are to take their Chance by balloting for Admission.

That this Charity might be rendered more extensively useful to the Public, and that not only this great Metropolis, but the remotest Parts of the Kingdom, might be supplied with well instructed and experienced Midwives, on the 25th of June, 1752, it was proposed, That Female Pupils should be permitted to attend Labours under the immediate Inspection of the Matron, and the occasional Directions of the Gentlemen of the Faculty ; who have undertaken to instruct them in all Matters relating to Midwifry. Which Proposal being maturely considered, and the Committee having formed a Plan for regulating such Pupils, the same was presented

to the General Quarterly Court, held the 20th of October, 1752, and was then approved : And at a General Quarterly Court, held the 26th of April, 1769, Provision was made for the more effectually furnishing the Lecture Room with Necessaries to instruct the Female Pupils.

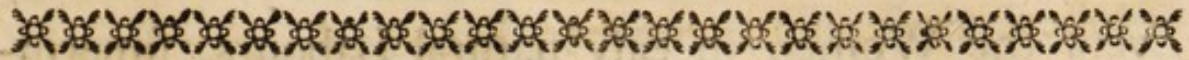
N. B. No Pupils of the Male Sex are permitted to attend this Hospital.

☞ It will be esteemed a great Benefit to the Charity, if Ladies should be pleased occasionally to visit the Hospital to inspect the Management of the Women and Children ; and in Case they shall please to signify their Observations by Letter, or otherwise, they will be duly regarded.

And as the Intention of this Charity is to relieve the Wives or Widows of Sailors and Soldiers, whose Husbands are abroad ; of Persons who have been reduced from affluent or easy, to indigent Circumstances ; of distressed Housekeepers ; and of the labouring and industrious Poor ; the Governors are desired, in their Recommendations, principally to have regard to such kind of Objects. It is also thought expedient, both for the Reputation of the Charity, and the Ease and Comfort of the more decent Sort of Patients, that no Women, who do not come clean in their Cloaths, and free from Vermin, or any contagious Distemper, be admitted into this Hospital.

And the Weekly Committee have a Power of rejecting such Patients as appear to them to be improper Objects.

A PRESIDENT, perpetual.

FOUR VICE-PRESIDENTS, chosen annually.

A TREASURER, chosen annually.

TWO CONSULTING PHYSICIANS who attend and give their Assistance in extraordinary Cases.

TWO PHYSICIANS and two SURGEONS, practising Midwifry, who visit occasionally, and by Rotation deliver the Women in difficult Cases.

A CHAPLAIN, who performs divine Service in the Hospital, baptizes the Children, churches the Women, and does the necessary Duties belonging to his Function.

AN APOTHECARY, who prepares such Medicines as are prescribed for the Women or Children.

A SECRETARY, who keeps the Accounts of the Hospital, attends at General Meetings and Weekly Boards, and does all such other Business as is commonly done by Secretaries, Clerks, or Registers, at other Hospitals.

A MATRON well skilled in Midwifry, who delivers the Women in easy natural Labours, superintends the Nurfses, and fees that every Thing necessary for the Women and Children, be provided, according to the Direction of the Physicians and Surgeons. She also takes care of the Provisions, Linen, and Furniture; and has under her an ASSISTANT MATRON.

A GENERAL MEETING of the Governors of this Charity is held every Quarter on the fourth *Wednesday* after Quarter-Day; and the sole Power of making Laws and Rules for the Government of the Hospital, is lodged in the said General Court.

A COMMITTEE of fifteen Governors are chosen at each Quarterly General Court, the Treasurer for the Time being always to be one; any Number of which may transact Business. They meet at the Hospital every *Friday* in the Forenoon to receive the Women recommended, and to direct the ordinary Affairs of the House. Temporary Orders for the Service of the Hospital may be made by this Committee. But these, and all their other Proceedings, are to be reported to the Quarterly General Court. Any Governor of the Charity may be present at this Weekly Committee; but none have a Right of voting there, except those who are Members

bers of the Committee, and the PRESIDENT, or VICE-PRESIDENTS, if present. The same Rule to extend to all other Committees.

A SPECIAL GENERAL COURT may, on a Fortnight's Notice, be called at any Time between the Quarterly Courts, either by Order of a General Court, or of a Weekly Committee, or at the Demand of the Treasurer, or of any Five of the Governors, the said Demand being delivered in Writing at the Weekly Board, and signed with their respective Names. The Business of such special General Court to be expressed in the said Writing and in the Summons to the Governors.

ALL OFFICERS and SERVANTS of the Hospital, above the Rank of Assistant-Matron, Messenger or Nurses, to be elected by Ballot, at a General Court of the Governors: And, on any Vacancy, the Day of Election for filling it up to be appointed, at least One Month, and not more than Three Months, from the Day such Vacancy happens, unless directed otherwise by express Order of a General Court: But the inferior Servants to be appointed by the Weekly Committee.

The QUALIFICATION of an ANNUAL GOVERNOR of this Charity is a Subscription of THREE GUINEAS or upwards *per Annum*, and a PERPETUAL GOVER-

NOR, a Payment at once of THIRTY GUINEAS or upwards, which intitles the Subscriber to recommend, and have in the House, one Woman at a Time. A Subscription of SIX GUINEAS *per Annum*, or a Payment at once of SIXTY, intitles the Subscriber to have in the House two Women at a Time, and so in Proportion for larger Sums.—LADIES subscribing the like Sums have the Privilege of recommending Women in the same Manner as Governors; and they have a Right of Voting in all Elections at General Courts, for Officers and Servants, by Proxy, provided that such Proxy be a Governor of this Charity; or they may send a Letter to the Board without a Proxy, naming the Person they vote for, which will be regarded as their Vote. No Governor to be Proxy for more than one Lady at a Time.—Benefactions and Subscriptions of smaller Sums, than those above-mentioned, will be thankfully received, and properly applied to the Use of the Charity.

WOMEN are received into this Hospital, on producing a Letter of Recommendation from a Governor, and making an Affidavit of their Marriage and their Husband's Settlement. During their Continuance in the Hospital, all Necessaries are provided for them and their Children, at the sole Charge of the Hospital. No Money or other Gratuity is to be taken of them by the Nurses, or by any of the Officers or
 Servants

Servants of the House, on any Pretence whatsoever.

FRIDAY being the Day appointed for the Admission of Women, they are required to be at the Hospital by Eleven of the Clock in the Forenoon: No Letters of Recommendation being received after that Hour, it being necessary for the Dispatch of the Business of the Hospital, that such Letters should be examined and entered by the Secretary, before the Weekly Board sits, who enter upon Business at Twelve.

N. B. Printed Forms of the Recommendatory Letter are to be had at the Hospital, and Affidavits of the Marriage and Place of Settlement of the Patients are there prepared by the Secretary, *gratis*.

Two Governors who are not Officers of the House, are weekly appointed VISITORS by the Committee; to visit the Hospital at convenient Times during the Week, and to make their Report of the State of the Hospital to the ensuing Board.



SUCH Persons, who are inclined to favour this charitable Institution, are desired to send their Subscriptions or Benefactions to JOSEPH CHAPLIN HANKEY, Esq; and Co. Bankers, in Fenchurch-Street; to Mess. COURTS, and Co. Bankers, in the Strand; to Mess. BACKWELL, and Co. Bankers, in Pall-Mall; or to the Weekly Committee, who meet at the Hospital every *Friday* in the Forenoon.

By an Order of the General Court held on the 21st of January, 1767, a Subscription Book is opened to receive Benefactions, Donations, and Legacies, towards erecting a new Hospital, or enlarging the present, and towards fitting up a Chapel; the Interest of which Money is to be applied to the current Expences of the Hospital, until such Buildings or Alterations shall take place.

And

And to those, who chuse to be Benefactors by their last Will, the following Form is recommended :

Item, *I Give and bequeath unto A B, and C D, the Sum of*
upon Trust, and to the Intent that they, or one of them, do pay the same, out of my personal Estate, to the Treasurer or Treasurers for the Time being, of a Society, who now call themselves the GOVERNORS of the British Lying-in Hospital for Married Women, situated in Brownlow-Street, Long-Acre, London ; which said Sum of
I desire may be applied towards carrying on the charitable Designs of the said Society.

N. B. Bequests of Land, or Money or Stocks with Directions to be laid out in Land, will be void by the *Mortmain Act*.

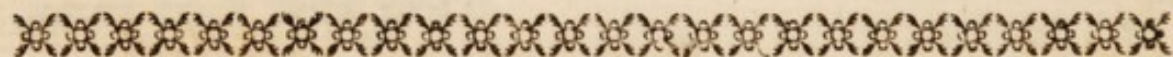

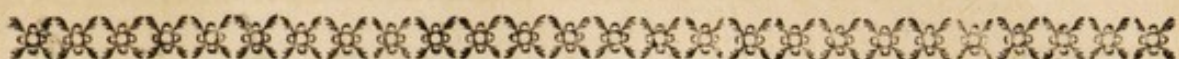

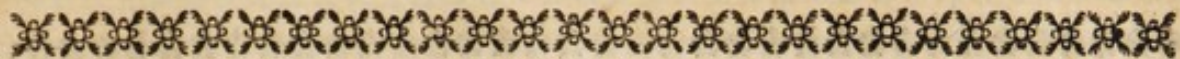
