Modes of Use, and Formula Recommended. While various combinations of the Juice, with Spirits of Tar, and other ingredients, will suggest themselves to the practical Farmer, the following is recommended as a safe and efficient cure FOR SCAB AND VERMIN ON SHEEP, viz.:—

The Hellebore and Soap to be boiled together in water for fifteen minutes; the Tobacco Juice and additional water to be added thereafter, to make the Wash in all Six Gallons. This quantity

by the process of "pouring" should cover Thirty Sheep; or, when the stock is comparatively clean, Forty Sheep may be covered—a little more water being added.

The Hellebore and Soap to be boiled as above, the Tobacco Juice being added thereafter, with sufficient water to make a Bath in which Thirty Sheep may be "dipped."
