I. REPORT

PRESENTED TO THE WORSHIPFUL THE MAYOR
OF HASTINGS FROM THE EAST-SUSSEX
MEDICO-CHIRURGICAL SOCIETY.

Hastings, March 10, 1859,

Sir,

In reference to the Water question, which was referred by the Hastings Local Board of Health to the EAST-SUSSEX MEDICO-CHIRURGICAL Society, we are directed to inform you that the Members have carefully considered all the evidence bearing upon the subject which they have been able to procure, and that they have come to the following conclusions : viz.—

1. That the degree in which the waters supplied by the different Waterworks act upon lead, under the most favourable circumstances, is exceedingly small, being less than that manifested by many soft waters used for the supply of towns.

2. That no authenticated case of contaminated water, fairly drawn from a leaden cistern, has been brought before them ;—that four samples drawn from such cisterns, having been subjected to analysis, were found to contain no trace of lead ;—and that, therefore, in all ordinary cases the water drawn from leaden cisterns in the Borough may be used with safety.

And 3. That no authenticated instances of lead-poisoning from water have been brought before them;—that not one such case has been observed by any of them within the Borough during the past two years;—and that, therefore, any such cases, that may from time to time have occurred, must have been so slight and so rare as to be practically unimportant.

For further details on these points we would refer you to the two accompanying Reports.

We would beg you to bear in mind, that the Members have avoided entering on the abstract question as to the use of leaden pipes and cisterns in general, and have confined themselves strictly to the matter referred to them.

In conclusion, we have only to express to you the gratification felt by the Members at having had it in their power to be of any service to the Local Board of Health, and to assure you of their readiness to give their assistance hereafter, in any matter connected with the sanitary condition of the Borough.

II. REPORT

PRESENTED TO THE MEMBERS OF THE EAST-SUSSEX MEDICO-CHIRURGICAL SOCIETY
BY THE COMMITTEE.

In order to assist the Members of the East-Sussex Medico-Chirurgical Society in forming an opinion on the question submitted to them by the Local Board of Health, we have arranged and (with the consent of the Town Clerk,) caused to be printed for private circulation all the letters and other documents relating to the subject. Several of these are totally unworthy of publication, some because they are in themselves quite unimportant, and others because they are in a great measure occupied with subjects entirely unconnected with the matter in hand. Nevertheless it was thought better to print at full length every document at all bearing upon the question, in order to avoid any appearance of concealment by suppressing even those which are in themselves wholly unimportant. Accordingly, we now forward a copy to each Member of the Society for his examination.

At the same time we think it will not be out of place to state at length the course which we have pursued in our enquiry, and the conclusions at which we have arrived; and if the Members of the Society are at first inclined to think that our proceedings have been dilatory (seeing that it is now more than two months since the matter was first brought before us,) we would beg them to look at the dates of the accompanying letters, which will sufficiently show that *we* are not answerable for the delay that has occurred.

But before proceeding further we may perhaps be allowed to remind the Members both of what *has been* brought before us, and also of what has *not*; for unless this is very distinctly kept in mind, we are likely to be placed

in a false position, and to appear to be advocating or defending what we either condemn, or pass over without expressing any opinion on the subject.

In the first place, we were not called upon to consider the purely scientific and abstract question, whether water ever becomes dangerous to health from contamination by lead. On this point there could be no difference of opinion.

Neither, secondly, were we consulted as to whether it would be advisable to discontinue altogether the use of leaden pipes, cisterns, &c., within the Borough. On this point (if we may judge from what has taken place in London and other towns where the question has been discussed by practical and scientific men of great eminence,) it is hardly likely that we should be all agreed; and even if we were, it would have been impertinent to offer an opinion on a matter about which we were not consulted.

Neither, thirdly, were we called upon to pronounce an opinion on the general quality of the water supplied to the inhabitants and visitors, though this is a most important subject for the consideration of the Local Board of Health, especially when one medical practitioner has been "assailed with the remarks, 'how bad your water is here,' 'the water of Hastings always affects me,' &c., and on inspecting various specimens has found some muddy, some green from filthy tanks, and others positively stinking;" though he admits that this state of things might "possibly be dependent on the care of the householder."*

But, fourthly, we apprehend that the matter about which we *were* consulted is this, viz. to what amount of danger the inhabitants and visitors of this Borough are at the present time exposed from the use of water passing through leaden pipes and kept in leaden cisterns.

It is to this question that we have strictly confined our attention; and in order to arrive at a satisfactory conclusion we have endeavoured to conduct our enquiries in an impartial and judicial temper, not wishing to support or controvert any particular "assertion" or "discovery,"

but simply to arrive at the truth, the whole truth, and nothing but the truth, as nearly as the evidence brought before us would permit.

The whole enquiry seemed to resolve itself into the three following questions, which we found to admit of being answered with different degrees of logical and scientific certainty, though for all practical purposes the result is much the same in each: viz.

1. Whether the water supplied to the inhabitants by the different Waterworks * has, in its natural state, such "a peculiar affinity for lead"† as to render it probable that it will become contaminated by passing through leaden pipes or being kept in leaden cisterns ;

2. Whether the water used by the inhabitants of those houses in which there are leaden cisterns, is contaminated with such "a considerable quantity of lead" as to be likely "to produce dangerous disease ;"‡

And 3. Whether, in point of fact, cases of lead-poisoning from water do frequently occur among the inhabitants and visitors of the Borough.

1. With respect to the first point (viz., the quality of the water in its natural state,) one gentleman says § that "it is a notorious fact that the water supplied in these Towns has a peculiar affinity for lead." He also "asserts that the leaden tanks are eaten away rapidly ;" and that "plumbers say that an inch [or *thick*] leaden tank will be eaten in holes in three years," which statement he apparently believes.

In order to ascertain the correctness of these assertions we sent to Dr. Alfred Taylor a sample of water taken

Upon the receipt of this Report, so different from what some of us expected, and apparently so contradictory to the results obtained by Dr. R. D. Thomson, we thought it right again to communicate, through the Town Clerk,* with the gentleman in question, in order to give him an opportunity of substantiating his statement, and explaining the discrepancy between the two analyses. As he again declined to avail himself of this opportunity, (although it was proposed that he should take the samples himself in the presence of a competent witness,)+ and as we have consequently no accurate information as to how or where his specimens were procured, we shall not attempt to discuss this part of the question any further, but shall simply state that no authenticated case of contaminated water, fairly drawn from a leaden cistern, has been brought before us; and that, until such specimens are produced, we are justified (on Dr. Taylor's authority,) in believing the amount of lead ordinarily present to be "too small to produce dangerous (lead) disease." (p. xix.) †

3. The remaining point of enquiry is the most important of all, viz. Whether cases of lead-poisoning from

water are, or are not, of frequent occurrence among the inhabitants and visitors of this place. This is entirely a question of fact, which can be answered only by the aggregate experience of the medical practitioners. One gentleman last autumn "made the discovery that some of his patients were suffering from the poisonous effects of lead ;"* within a short space of time he met with "many cases of colic and other disturbed states of the digestive organs ; he was led to classify such cases, and upon enquiry he found that in all instances where such indisposition occurred leaden tanks were in use ;" he "nearly lost several cases from repeated colic and its consequent innutrition, each one exhibiting manifest symptoms of lead-poisoning ; such persons immediately recovered on his desiring them to send for their water from the street pumps, and keeping them on a diet made from that water under their own eyes ;"† he had cases that "were accompanied with tenderness of the abdomen, pain, heat, coldness of the extremities, constipation and fever, which convinced him that a metallic poison was at work."

"On Oct. 4, he was called up at 4 a.m. to visit a gentleman, who had colic in a most violent degree about the navel, and all the symptoms of lead-poisoning," who "had in fact all the symptoms of painter's colic. On the 7th, at 5 a.m., the patient had a second most violent return in an aggravated degree. On the 15th, he was again seized in the same manner with increased ferocity ; again on the 17th, and on the 21st. His health was now fairly broken down, and his medical attendant, as well as his family, began to feel great anxiety, and to despair of his life from extreme exhaustion.... Where to seek for the cause of such renewed attacks the medical attendant knew not, till he tested the water he drank," when "his conviction was sealed in a minute. This was the water he analyzed." The patient "sent for pure water to drink and to have his food cooked in, and had no further attack. He returned

to Town, and consulted a physician who has the largest practice amongst the aristocracy of any man in Town, and was met in consultation by another most eminent man. Both expressed their conviction that lead was the cause of the patient's ill health."

The same medical gentleman had "a lady sent by a noble Earl in Sussex to be under his care; she had similar symptoms, and lost them on having her water from the George-Street pump." He also states that "children have languished in houses where he has found leaden tanks;" that (about the same time,) "cases were crowding on him....of constipation, and other effects traceable to lead;"* and that "cases occurred to him here, in which all the symptoms of lead-poisoning became so palpably manifest to him and other physicians elsewhere, that he sought for lead in the water, and he found it."

Though the language of these extracts is somewhat deficient in preciseness, still it is sufficiently alarming, and the general impression meant to be conveyed is abundantly clear, viz. that this gentleman, within a short space of time, met with a considerable number of cases of sickness, occasioned by drinking water kept in leaden cisterns. We wished to learn the exact number of these cases, and if this information had been obtained,† we should have been ready to have received any further particulars respecting them that might have been offered in order to authenticate them. In this instance, however, as in the case of the contaminated water, no information has been given, and therefore the statements must rest entirely on the writer's own responsibility.

In order to discover whether the same symptoms, arising from the same causes, had been observed by the other medical practitioners of the place, we circulated among the Town Members of the Society the following question, viz. "What number of cases of sickness caused by the drinking of water contaminated by lead have you

met with in your own practice during the past two years?"*

Some of us thought it not unlikely that cases of lead-poisoning from water must from time to time have occurred in a place where leaden pipes and cisterns are in use; and if so, it was hardly probable that *all* these cases should have been treated by one and the same practitioner. However, from the answers received it appeared that not one such case had been observed by any other gentleman within the Borough.† We have used the word "*observed*" designedly, because it is important to remember the exact logical value of this testimony; and certainly, if it could be proved that within the last few months there had occurred as many cases of lead-poisoning from water as the gentleman in question believes he has met with, the fact would more than counterbalance any amount of mere negative evidence that could be brought forward. But we would remind the Members of the Society that the existence of these cases has *not* been proved, and that the Informant has declined to produce any evidence of their reality, or to give any information on the subject; and therefore we think, that, until any well-authenticated instances are brought forward, we may safely come to the same conclusion on this point as on the former, viz. that any cases of lead-poisoning from water that may from time to time have occurred within this Borough, must have been so slight and so rare as to be practically unimportant.

We therefore take the liberty of recommending that a short Report be sent in the name of the Society to the Local Board of Health, merely stating the result of our enquiries, without entering into unnecessary arguments or details.

Perhaps we ought to apologize for the length to which these remarks have extended; but they have been written

with the hope of sparing the Members the necessity of wading through a long, rambling, tedious, and unprofitable correspondence. Our own task has been neither an easy nor an agreeable one ; but, if we have not succeeded in pleasing every body, we have had the consciousness of having endeavoured honestly to do our duty to all the parties concerned in the enquiry.*

III. REPORT

OF EXAMINATION AND ANALYSIS OF CERTAIN SAMPLES OF WATER FROM HASTINGS, BY DR. A. S. TAYLOR.

THE samples of water, well secured and sealed in Winchester Quart bottles, were received at the Chemical Laboratory, Guy's Hospital, on Feby. 1, 1859. The samples were seven in number, arranged in two groups, Nos, 1, 3, 5, and Nos. 2, 4, 6, 7. Samples.

They were submitted to a qualitative examination for the detection of the usual constituents of spring and river water. They were colourless, and without smell or taste, —for the most part clear and bright, depositing on standing but a small amount of sediment, chiefly of a silicious or sandy nature. In all the samples, the same mineral constituents were found, namely sulphuric acid and lime, as sulphate of lime,—chlorine, representing common salt or chloride of sodium, carbonic acid and air. General properties.

FIRST GROUP.

Samples 1, 3, 5.

Of this group, No. 5 was remarkable for its comparative purity or freedom from saline matter. It contained a mere trace of sulphuric acid and lime, as sulphate of lime : the principal mineral ingredient in it, was chloride of sodium, or common salt. No. 1 gave rather stronger indications of the presence of sulphate of lime than No. 5 ; and after 48 hours, there was a visible deposit of the constituents of this substance. The quantity of chlorine or chloride, appeared to be the same as in No. 5. Sample No. 3 contained the largest amount of saline matter of this group. There was a well-marked quantity of sulphate of lime, and a comparatively large proportion of common salt. This water No. 3 also differed from Nos. 1 and 5 in its Samples 1, 3, 5.

No. 3 deposited the largest quantity.

Saline constituents.

Saline constituents. strong alkalinity as a result of the presence of a large proportion of bicarbonate of lime. No. 5 gave no indications of the presence of this salt, and No. 1 gave but a faint trace. No. 3, however, gave those reactions which generally characterise a water derived from chalk, or a chalky soil. Nos. 1 and 5, on the other hand, resembled pure soft waters derived from beds of sand.

Question proposed. The question proposed for solution respecting these three waters, which are said to have been taken from reservoirs, is whether they "HAVE A PECULIAR AFFINITY FOR LEAD," i. e. any chemical action on that metal by which effects noxious to health may be produced.

Answer as to action on lead. The three samples were first tested for lead, in the state in which they were received. They contained no trace of that metal. Eight ounces of each water were then exposed in an open jar, in contact with eight square inches of plumber's lead as it is used for cisterns, the surface of the metal having been previously cleaned but not polished. After 48 hours' contact and free exposure to air (circumstances most favourable to the development of any chemical action of water on lead,) they were examined, with the result that a slight chemical action had been set up in each case. This was not rendered visible by any change in the appearance of the water, although the pieces of lead used had acquired a whitish incrustation (of hydro-carbonate of lead,) at the line where the air and water met. The waters on being tested for lead, gave the following results. The maximum effect had been produced in sample No. 5. The lead here dissolved amounted to about one-fifth of a grain of the metal in the imperial gallon, or in the proportion of one grain of lead in five gallons of water. In Nos. 1 and 3, the action was found to be nearly equal: it amounted to a proportion of one-eightieth of a grain of lead in the imperial gallon, or one grain of the metal to eighty gallons of water. After the lapse of four days, the waters, left in contact with lead, were again examined. There was no perceptible difference in the results.

Conclusion.

The affinity of these waters for lead, or the degree in which they act on that metal, under the most favourable

circumstances, is exceedingly small, being less than that manifested by many soft (lake, river, or spring,) waters used for the supply of towns. The chemical action, so far as it went, appeared to have reached its full intensity in 48 hours, and to have then ceased.

SECOND GROUP.

Samples 2, 4, 6, 7.

These waters contained the same mineral constituents as the preceding samples. No. 2 contained a trace of sulphate of lime, much bicarbonate of lime, and a small quantity of chloride of sodium or common salt. No. 6 contained scarcely any sulphate of lime,—but little lime, and only a small proportion of common salt. No. 7 contained the largest amount of saline ingredients,—the sulphate of lime, bicarbonate of lime and salt being greater than in any other sample. No. 4 came next to No. 7, having more saline matter than Nos. 2 and 6. Hence, of these waters, qualitatively speaking, No. 6 was the purest and No. 7 was the least pure.

Mineral ingredients.

The question proposed with respect to this group of samples (said to have been taken from leaden cisterns) is whether they “ARE CONTAMINATED WITH A VERY CONSIDERABLE QUANTITY OF LEAD, SUFFICIENT TO PRODUCE DANGEROUS DISEASE.”

Each of the samples was carefully tested at two separate intervals of time for the presence of lead. There was not a trace of that metal in any one sample. A water artificially impregnated with lead in the proportion of one-eightieth of a grain of the metal in a gallon, was tested with them side by side, and the lead in this small proportion was distinctly revealed. Hence it follows that they contain no lead, or the quantity present is too small to be appreciated by the most delicate tests, or to produce dangerous (lead) disease.

Conclusion.

REMARKS.

When a water in the entire state gives no evidence of the presence of lead by a test which will reveal the presence of the one-hundredth part of a grain in a gallon,

it may be practically regarded as free from that metal and innocuous. By the concentration of a gallon, it is possible that some traces of lead derived from a leaden pipe or cistern may be found in it ; but in a sanitary point of view, this proceeding is seldom resorted to, and is not usually considered necessary. The river water of London is occasionally impregnated with traces of lead ; but this is chiefly when it is first used with new leaden pipes or cisterns, or when it contains alkaline nitrates derived from the decomposition of nitrogenous organic matter. It may contain no lead when first drawn from a long used leaden pipe or cistern, but it will act upon and dissolve the metal in small quantity if exposed to a clean surface of lead. I have thus found that the Thames river water supplied to Guy's Hospital, which was entirely free from lead, acquired in less than hour, when exposed to a clean surface of lead, an impregnation of the metal in the proportion of one-eightieth of a grain in the gallon.

Viewing the whole of these samples, the waters from which *â priori* I should apprehend risk of lead-contamination are Nos. 1, 5, 6. A quantitative analysis of these, or of one of these (No. 5) might be desirable ; and if circumstances appeared to justify a still more minute investigation, then I would advise that the samples 1, 3, 5, should be exposed for a longer period of time (a week) in lengths of ordinary leaden pipe as it is used for domestic service. These experiments can be performed if the Local Board of Health desire it. There is enough remaining of each sample for these additional experiments on lead : but should a quantitative analysis of any one sample be required, then it will be necessary that I should receive at least a gallon (two Winchester quarts) of such sample. The proportion of saline matter is obviously so small in the waters designated, that less than one gallon of the water evaporated, would not give satisfactory results.

Hastings.*

Hastings, Nov. 20, 1858.

Dear Sir,

Dr. Garrett wishes the Water Committee to see this specimen of water from a lead cistern.* It contains about six grains of carbonate of lead, and is poisonous. He has had some rather bad cases of "lead-poisoning" through water of this kind, and wishes the Committee to encourage, if they cannot compel, the use of slate cisterns.

He was going to send the letter of which I enclose a copy, to the Home Secretary;† but I told him he had better not send it, except as based on the *general* use of lead cisterns, which are by no means peculiar to Hastings.

Please bring this before the Water Committee to-day, which I am unable to attend.

*Letter from Dr. Garrett to the Secretary of State for the Home Department.***(enclosed in the preceding.)*

Hastings, Nov. 16, 1858.

Sir,

Permit me to call your attention to the following circumstances, and to solicit your advice on the subject.

The towns of Hastings and St. Leonards are supplied with water by the Corporation†, which is carried in *iron mains*‡ through the streets, but conveyed from them into the dwelling-houses by *leaden pipes*.

From the shortness of the supply the Corporation compelled every house-holder to *provide tanks* for the reception of water for their daily supply. I think I am right in saying that forty-nine out of fifty of these tanks are *leaden*,§ the slate tanks existing only|| in private houses.

From the many cases of colic and other disturbed states of the digestive organs I met with, I was led to classify such cases, and upon inquiry I found that in all instances where such indisposition occurred *leaden tanks were in use*.

I have nearly lost several cases from *repeated colic* and its consequent innutrition (in other words, starvation from arrested digestion), each one exhibiting manifest symptoms of LEAD POISONING.

Such persons have immediately recovered on my desiring them to send for their water from the street pumps, and keeping them on a diet made from that water under their own eyes.

I have examined many specimens of water from different lodging-houses, and have found lead in each of them; indeed in one specimen, which I have lodged with the Mayor,* the water looks positively milky from the presence of Carbonate of Lead.† This water is filtered for the use of the house, whereby only the thick portion is removed, the soluble part holding salt of Lead in solution being left for consumption by the inhabitants of the house—visitors as well as the occupiers themselves.

It is a notorious fact that the water supplied in these Towns has a peculiar affinity for lead,‡ which is much increased at this time of year, when a large quantity of vegetable matter in a state of decay impregnates the water derived from the springs, and furnishes in abundance the necessary *Carbon* to unite with the lead in furnishing that deadliest of its salts—the *Carbonate of Lead*.

Plumbers say that an *inch leaden tank*§ will be eaten in holes in three years.||

As weak persons, (especially those who flock to these towns for health and recovery,) are most amenable to the influences of lead, this is a subject full of *deep importance*.

The Corporation's powers are limited to compelling householders to *provide tanks*; they cannot enforce any particular *kind of tank*. May I ask you, Sir, where powers are to be sought to remedy these evils affecting human life, to which I have humbly called your attention?

Letter from the Town Clerk of Hastings to Dr. Garrett

Hastings Local Board of Health,

Sir,

At a meeting of the Water Committee held this day, the copy of a letter addressed by you to the Secretary of State on the subject of lead cisterns was read. The Members of the Committee present were of opinion that you could not be aware of the few houses where cisterns are used, certainly not more than half,† within the Local Board District; and in many instances slate is used instead of lead. Where the latter ones are used, the same are cemented inside, which prevents the chemical action of the water upon the lead.

The Committee attribute the thickness of the water to the boring which is now going on at the Waterworks. Doubtless there are some cases where the cisterns require fresh cementing, which perhaps is the case in some of the houses alluded to in your letter.

Letter from Dr. Garrett to the Mayor of Hastings.

Hastings, Dec. 7, 1858.

Dear Sir,

I cannot help feeling excessively grieved, and I may say astonished, that an act of mine, which was done with the best and purest intentions, should have been so misinterpreted as to have given rise to the condemnation which I hear has been expressed by members of the Hastings Corporation ; and I must say that I think it is exceedingly indiscreet that any member of that body should be so far forgetful of the interests of the place, as to have made *that* a matter of *public discussion*, which was intended to be strictly private and confidential.

During the enquiry instituted by the Metropolitan Board of Health a few years ago, I collected and communicated to that Board, through Dr. Southwood Smith, a mass of information relating to the action of water on lead, and its pernicious effects on the human system. I saw diseases upon diseases generated by lead—many victims led to a premature grave by its occult, mysterious, and poisoned shafts ; yet the symptoms, causes, and effects had, in many instances, been overlooked, and their identity escaped recognition, and failed to be established.

No sooner did my practice here lead me among a varied class of individuals than I was assailed with the remarks, “ how bad your water is here,” “ the water of Hastings always affects me,” &c. ; and on inspecting various

specimens I found some muddy, some green from filthy tanks, and others positively stinking. All these facts I passed by, as being of a character [possibly*] dependent on the care of the householder. But I began to find that in cases of irritative indigestion, or weakness of those organs, that symptoms grew up and became manifest, which no previous constitutional condition could account for or explain. Most of them were accompanied with tenderness of the abdomen, pain, heat, coldness of the extremities, constipation and fever, which convinced me that a metallic poison was at work. One specimen of water (corresponding with that I sent to the Water Committee,) I tested, and after evaporating it down, I passed a stream of sulphuretted hydrogen gas through it, and its characteristic dark color was the result—indicating lead.

On the 4th of October I was called up at 4 a.m. to visit a gentleman who had colic in a most violent degree about the navel, and all the symptoms of lead-poisoning. He had been a dyspeptic for years, and was therefore especially obnoxious to the poisonous action of lead. He had in fact all the symptoms of painter's colic. On the 7th, at 5 a.m., he had a second most violent return in an aggravated degree. On the 15th he was again seized in the same manner with increased ferocity; again on the 17th, and on the 21st. The patient's health was now fairly broken down, and I, as well as his family, began to feel great anxiety, and to despair of his life from extreme exhaustion. Where to seek for the cause of such renewed attacks I knew not, till I tested the water he drank. My conviction was sealed in a minute. This was the water I analyzed. This gentleman sent for pure water to drink and to have his food cooked in, and had no further attack. My patient returned to Town, and consulted a physician who has the largest practice amongst the aristocracy of any man in Town, and was met in consultation by another most eminent man. Both expressed their conviction that lead was the cause of the patient's ill health. A noble

Earl in Sussex sent a lady to be under my care ; she had similar symptoms, and lost them on having her water from the George-Street pump. Children have languished (one lately from Tunbridge Wells in particular—a medical man came over and fetched the child away,) in houses where I have found leaden tanks.

I much regret that I was led into unintentional error in two or three particulars in my letter to the Secretary of State, but which I corrected *immediately* ; and I must say that my informant, from his knowledge of the place, *ought* to have known better.

I mentioned the above circumstances to one of the most talented and esteemed of your Corporation, and asked if the possessors of leaden cisterns could not be *compelled* to change them ? He said, “ We can only oblige persons to have tanks, but cannot control the composition of them.” Cases were crowding on me (as is usual when autumnal rains wash into the earth the carbon of decomposing vegetable matter, and which readily unites with lead,) of constipation, and other effects traceable to lead ; and indeed no varnish can offer protection if the water can reach the lead even through a pin hole. I spoke of these matters to a M.P., (son of one of Her Majesty’s Ministers,) and a patient of mine, and he said, “ You will be doing the town a great service by writing to the Secretary of State, and ask who has power to alter this state of things. I believe *he* can compel the change of inoffensive tanks for leaden ones.” I wrote accordingly, and sent a copy immediately to your late Mayor.

Now I will ask, can the most malevolent and ingenious mind conceive or invent any intention *I could have had*, or any feelings but those of a philanthropic and humane character ? Privacy was my object—the publicity the subject has obtained, others have to answer for. I being in practice in the place, and being most intimately and (for many years) professionally connected with the family of the largest proprietor in these towns, my whole *interest* is to exalt the character of these localities, and to make them as attractive as possible ; and my *duty* is, if

there be a black spot, to seize upon it and eradicate it. Let the family of some analytical chemist come down here and suffer from the causes I have alluded to ; he will sound the clarion of alarm, and sweep the very town out. A good and honest citizen will, by forewarning you, forearm you.

Finally, my dear Sir, let me assure you (and I trust this letter may be laid before your municipal brethren,) that, if there is ought to blame in my proceedings, it must be ascribed, as is the truth, to an error of judgment coupled with the best intentions.

A gentleman in the North is about to publish a work on the water supplies of the Towns of England, and their analyses. He applied to me for specimens, and I have forwarded him jars of water from (1) the George-Street pump ; (2) Mr. Rock's factory ; and (3) Spring-Terrace well ; and I believe that these represent the water supplies of Hastings.* I will send the analyses to the Corporation on my receipt of them.

The President of the Privy Council has written to the Local Board upon the subject, and has requested a report thereon, which the Board intend making; but before they do so, they would much like to have the subject discussed by those medical gentlemen who belong to the Medical Society, and that they will take such steps as they think necessary to test the water, and ascertain whether or not the leaden tanks produce such an effect upon the water as to be injurious to health.

Letter from the Secretaries of the East-Sussex Medico-Chirurgical Society to the Mayor of Hastings.

(Answer to the preceding.)

Hastings, Jan. 6, 1859

Sir,

We are instructed by the Committee of the East-Sussex Medico-Chirurgical Society to inform you that the Town Clerk's letter on the subject of the quality of the water supplied to the inhabitants of the Borough, was laid before the Members of the Society at their Annual General Meeting, held on the 4th instant; and that it shall immediately receive from the Society all the attention which the importance of the subject demands. The matter was discussed at some length last Tuesday; but, as the Mem-

bers had not then had any opportunity of fully informing themselves of the facts of the case, a meeting of the Committee was held yesterday for the purpose of considering what steps should be taken.

The Committee are of opinion that further investigation will be necessary before the Society will be able to report on the subject in a manner satisfactory both to themselves and to the Members of the Local Board of Health; and they require additional information on the four following points before they are prepared to bring the matter again before the Members of the Society for their consideration: viz.

1. The quality of the water supplied to the inhabitants of the Borough generally, both before it enters their houses, and also after it has stood some time in one of the leaden cisterns;

2. The quality of the water used by the inhabitants of the different houses in which the cases of sickness have occurred, with a distinct specification of each locality;

3. The experience of each individual Member of the Society as to the amount of sickness caused by lead-poisoning from water during the past two years; and

4. The number of houses throughout the Borough in which water is kept in leaden cisterns, compared with the total number of houses supplied with water by the different waterworks, with a specification of the localities where most of these houses are situated.

We will take the liberty of saying a few words on each of these points.

1. With respect to the quality of the water used by the inhabitants of the Borough generally, although there may be among the Members of the Society more than one gentleman fully competent to make a chemical analysis (both quantitative and qualitative,) with sufficient accuracy for all ordinary purposes, the Committee are of opinion that on the present occasion it will be advisable (for several reasons which do not require to be specified,) to employ a first-rate analyst entirely unconnected with the place. If this suggestion be adopted, it must be carried out at the

expense of the Local Board of Health, and may be done under their superintendence; if, however, you would prefer that the Medico-Chirurgical Society should undertake the task, the Committee are willing to do so, and to select (subject to your approval,) the chemist to be employed. The Committee will be glad to know your decision on this point as soon as possible, in order that no time may be lost in forwarding specimens of the water for examination.

2. The Committee are of opinion that it will not be sufficient to examine the water supplied to the inhabitants of the Borough generally, without at the same time testing that which is used in each house where any case of lead-poisoning has occurred. It will therefore be necessary for you first to obtain from your Informant a precise specification of each contaminated cistern, and then to procure from each a specimen of the water *in such a state as it is actually used by the owners*. The Committee will also be obliged if you will procure for them the exact number of the individuals seized with symptoms of lead-poisoning during the past two years,* in order that they may be able to compare the experience of your Informant with that of the Members of the Medico-Chirurgical Society.

3. This (viz., the experience of the Members of the Society,)+ constitutes the third point of inquiry, and this information the Committee will undertake to procure for themselves. We may be allowed to inform you that the Society comprehends twenty gentlemen practising within

* [It was thought that the space of two years was quite long enough for our purpose, as the gentleman who had met with all these cases of lead-poisoning had not been longer resident in Hastings. If, however, we had heard of any cases at all of lead-poisoning from water during that time, we should then have extended our enquiries.]

the Borough;* and the Committee think that the aggregate experience of all these Members will afford sufficient data for ascertaining the prevalence of any specific disease during the last two years.

4. Lastly, the Committee wish to know what proportion the leaden cisterns throughout the Borough bear to those composed of other materials, in order to enable them to estimate the real amount of danger to the inhabitants from water contaminated by the poison of lead. They also think it will desirable to ascertain the precise parts of the Borough where the leaden cisterns are most in use, in order that they may be able to judge whether all classes of the community are equally exposed to the danger, and have equally suffered from the poisonous effects.† This information the Committee believe that the Local Board of Health will be able to give them, or at any rate to procure for them without much difficulty.‡

We have only in conclusion to apologize for the length of this communication, and to assure you that you shall receive a further report on the subject from the Society as soon as possible.

*Letter from Dr. Garrett to the Town Clerk of Hastings.**(Answer to the preceding.)*

Hastings, Jan. 13, 1859.

Sir,

I beg to acknowledge receipt of your letter of the 11th inst., in which you request me to furnish the Hastings Board of Health with information relating to the

use of leaden tanks at Hastings. Having seen in my professional occupations frequent instances of the injurious and fatal effects of lead-poisoning in years past, my mind has always remained sensibly alive to that insidious enemy.

Cases occurred to me *here*, in which all the symptoms of lead-poisoning became *so palpably* manifest to me and other physicians elsewhere, that I sought for lead in the water, *and I found it!* I therefore became, as you state, "the mover in the matter." To my utter amazement and disappointment I learned that my acts and motives had been violently assailed by some members of the Town Council, and epithets applied to me with a taste I shall not attempt to characterize. In my own defence, I sent two specimens of water taken from leaden cisterns to Dr. R. D. Thomson, of St. Thomas's Hospital, for analysis; —he "*found them to be contaminated with a very considerable quantity of lead, sufficient to produce dangerous disease, &c.*" *

Take my word for it, that that man is not an honest supporter of the interests of the town who slanders the beauty with flattery and idolatry only, and conceals her imperfections. Let them rather be sought out in a kindly and delicate manner, and be properly remedied. Considering the extremely false and painful position in which I have been placed by some Members of the Municipal body, I beg to decline having my name associated in any manner, for the future, with anything connected with the water supply of Hastings.

I shall, at all times, make it my duty and pleasure to support the best interests of Hastings and St. Leonards, but I shall certainly never again place myself in a similar position to that which I have done in this instance.

Medico-Chirurgical Society to Dr. A. S. Taylor.*
(Private.)

Hastings, Jan. 13, 1859.

My dear Sir,

The matter of lead-poisoning by water has been brought before the Hastings Local Board of Health,

who have requested the advice and assistance of our Medico-Chirurgical Society, of which I am one of the Secretaries. We have (among other recommendations,) advised that the water should be examined by some eminent chemist *quite unconnected with the place*, (for, as you may imagine, considerable local feelings and interests are likely to be concerned in the enquiry,) and it is probable that in a few days I may be officially instructed to apply to you for assistance. In the mean time I have engaged to write to you in my private capacity, just to obtain a little preliminary information for the guidance of our Society. Would you therefore be so kind as to tell me,

1. Whether (if the matter should be put into your hands,) you would be able to attend to it at once, as there are several reasons which render it desirable to have the subject examined into as soon as possible :—

2. Whether both a quantitative and a qualitative analysis will be necessary :—

3. What will be the probable cost of making the necessary analysis :—(In connection with this query I ought to say that the Society has proposed to examine not only a certain number of specimens of the water supplied to the inhabitants *generally*, but also the water used in each individual house in which a case of sickness from lead-poisoning is supposed to have occurred.) *

4. How long it will take to examine the waters :—

5. Whether you would prefer coming to Hastings yourself in order to procure the specimens in a fair and satisfactory manner, (which perhaps would in our opinion be the better mode of proceeding,) or whether you would consider this to be beyond your province, and that *your* duty only requires you to examine the water presented to you, no matter how it is procured. —

Will you also add any other hints or information that may be useful to the Committee of our Society at

their next meeting, which is to be held as soon as I receive your answer?

I need hardly assure you that it is the wish of our Society (and, I quite believe, of the Local Board of Health also,) that the matter should be examined with the greatest candour and impartiality, and I should be sorry if you found a single word in this letter that might lead you to discover my own private opinion on the subject ;—at the same time you will allow me to remind you that the question referred to our Society is not one of mere abstract science, viz., whether the water conveyed through leaden pipes is *ever* injurious to health, (about which there can be no doubt,) but one of practical importance to this Borough, viz. to what amount of danger from this source the inhabitants are at this present time exposed.

Letter from Dr. A. S. Taylor to one of the Secretaries of the East-Sussex Medico-Chirurgical Society.

(Answer to the preceding.)

My dear Sir,

In answer to the inquiries in your letter of the 13th inst., I have to say—

1. That, should the matter be referred to me, I could at once undertake the investigation, and complete it with all reasonable speed.

2. A qualitative analysis would certainly be required ; but the quantitative analysis might be limited to the actual amount of the solid contents in the imperial gallon, and the weight of the *principal constituents* of the water.

3. The customary fee for a quantitative analysis of water is ———; but in this case, the analysis of *each water*, including the search for lead, (the determination of the proportion present, if any,) and the action of the water on lead, would not exceed ———. If more than six waters were examined, the fee for each water above six, would be ———, provided several could be examined at once.

Should, however, the number of waters requiring examination for the Board of Health be so great as to render the expense very heavy, I shall be most happy to reconsider the amount to be charged.

The largest analysis of the kind that I ever had, was in conjunction with my late colleague, Mr. Aikin. We examined for the Corporation of Leicester 42 waters. The customary fees were reduced accordingly.

4. The analysis of one water would occupy two days, as at least half-a-gallon ought to be evaporated: but I can make arrangements by which from four to six waters can be set in operation at once.

5. In cases of great importance to private and public interests, I have generally taken the samples of water myself, or they have been taken in my presence. I have gone as far as Sunderland on a mission of this kind. This, however, is purely a matter for the consideration of those who desire to have the water analyzed. It of course adds to the expense. My customary fee for that is ——— for each day occupied, exclusive of expenses out of pocket.*

In important cases, too, another chemist has been generally associated with me. This is always desirable, where there are funds to meet the additional expense.

In conjunction with my friend Professor Brande I have just completed an analysis of two waters sent to us from Melbourne, in Australia. The enquiry has been a most elaborate one in reference to the action of water on lead. Numerous cases of lead-poisoning have occurred in Mel-

bourne, and are reported to have created great alarm. Our experiments have been carried on from the 8th December, and we have only signed the report to-day, to leave London to-morrow by the mail to Australia. It is a remarkable circumstance to have water sent 10,000 miles for the determination of this question. Our experiments have been on a large scale in leaden pipes—as well as in leaden pipes tinned inside—and in leaden pipes consisting of an alloy of five per cent. of tin and 95 per cent. of lead. We have discovered the cause of the water becoming poisoned. Its composition is almost identical with the Surrey sands water, which led to the poisoning of the Royal Family of France at Claremont.

We have also made the unexpected discovery that lead pipe *tinned inside* is acted upon by the water more powerfully than lead alone. This is owing to the necessary imperfection of the tin lining, and the setting up of a galvanic current by reason of the contact of the water with the two metals. It seems they have been using this imperfect pipe rather extensively.

If the water should be sent to me from Hastings, the bottles should be sealed and labelled by letters or figures. Glass Winchester quarts are the best for this purpose, as we can see the condition of the water. Each Winchester quart holds about from 80 to 90 ounces. The water was thus sent from Australia, and out of twelve bottles only one was broken in transit.

Dear Sir,

I have to thank you for your note of yesterday's date.

When I first made the discovery that some of my patients were suffering from the poisonous effects of lead, I told a Member of your Corporation the fact; he informed me that that body had no power to act. As a matter of *pure philanthropy* I enquired in higher quarters how such an evil could be remedied, and I *privately* acquainted the Corporation with what I had done.

Would any man believe, that, in a place characterized for its piety, I should have been assailed with such ill-feeling as I have met with? Indeed one Member of the Water Committee, and who adds to his signature "a Member of the Town Council," wrote me such a note as for rudeness, disgusting language, and falsehood, I never recollect to have seen equalled. All balance was then lost. I must either remain the gentleman, and be silent; or, in order to meet such conduct with proper weapons, become a confirmed blackguard. I much prefer the former position.

You say that "he," the analyst, "has been unable to discover any *amount* of lead."* He therefore clearly discovered *some* lead, and confirms Dr. Thomson's and my own analysis.

I, for one, regardless of the odium which may be showered upon me, will defend the public from lead-poisoning, and fearlessly stand in the foreranks of those who study the public health and the general welfare of our visitors and the inhabitants.

Had the Corporation conferred with me, instead of appealing to the Medical Society for information which *I* alone could give, I would have joined heart and soul in the investigation and eradication of the evil. If the Water Committee is desirous that the invalids who resort to this place *for health*, should drink out of leaden tanks, be it so. I have entirely washed my hands of the whole subject.

As you are going to print my correspondence, I shall be glad to see a proof sheet.

Letter from Dr. Garrett to the Mayor of Hastings.

March 1st, 1859.

Dear Sir,

I wish now to conclude this correspondence, so that you may complete its publication. After writing you my letter of Dec. 7th, 1858, I received a visit from the Turncock,* as the only person the Water Committee could depute to confer with me respecting this most important affair. As the salubrity of particular dwellings was concerned in the subject, I at once declined placing such information in his hands, and in which he concurred ; but I sent word by him to the Water Committee, that, if any one of their body would call upon me, I would shew him the specimens of water I had analyzed, tell him where I had obtained them, and give every information in my power. This offer, as you know, was never accepted.† Is it decent or right that in asserting a great principle I should be driven to stigmatize certain houses only? Had my offer been accepted, the truth must have come out. Here was their dodge. I assert that the leaden tanks are eaten away rapidly. Who eats them? The water, clearly. Will any honest man, then, condemn me for *privately* calling the attention of the Water Committee to such a terrible circumstance? Do not all these proceedings bear a construction of an advocacy of leaden tanks and filthy water, as well as of a medical cabal against a successful brother? Mark me, as sure as the God of truth and justice is evidenced in a righteous cause, this cabal will fall back upon those who seek to persecute me. No, Sir ; there is too much of the medical influence at work. A surgeon in this town declared that “ now we have got our Don of a Doctor, and we will drive him out of Hastings.”

If you of the Water Committee are content to let your visitors drink out of leaden tanks, I say it is the duty of a medical man, who studies the interest of his patients, to stand forward and *protect them*. I say that the keepers of lodging-houses are *great sufferers*. They are *obliged* to give their lodgers the water they receive; and if the Municipal powers do not make an effort to get the leaden tanks removed, then the holders of lodging-houses are *deep sufferers* from causes over which *they have no control*. A more respectable body of inhabitants does not exist than the lodging-house keepers of these towns, kind, honest, cleanly,* and attentive, to a degree that has gained them a wide spread renown; it is a cruelty to them to be made the victims of any such circumstance. This contest, Sir, will much interest the public; for a contest it is, far more than a research after truth.
