



# RULES and ORDERS,

Of the HOSPITALS for the

## SMALL-POX and INOCULATION.

HAT the Affairs of this Society be I. conducted and managed by a Prefident, four Vice-Prefidents, a Treafurer, and all the Governors; together with fuch Officers and Servants as may from time to time be thought neceffary.

II. That all Perfons who pay Five Guineas yearly to the Support of this Charity, be Governors fo long as they continue fuch Contribution; and all who beftow Benefactions of Thirty Guineas or upwards, at one time, be Governors for Life;

Life; with fuch others as shall be elected from time to time at a General Court.

III. That a General Court (to which every Governor shall be fummoned, and have a Vote) be held Half-yearly, (to wit) one between Lady-Day and Midfummer, and the other between Michaelmas and Christmas, at Eleven of the Clock in the Forenoon; to take the Reports of the Committees, and transfact such other Business as may be laid before the Court; and that every General Court confist of Thirteen Governors at least.

IV. That a Houfe-Committee be appointed at every Half-yearly General-Court, confifting of Thirteen Governors; who at their first Meeting shall choose from among themselves, a Chairman for the enfuing Half-year; and that every other Governor who attends that Committee, tho' not of the Number chosen, shall be esteemed a Member of the fame; and in cafe of an Equality of Voices, the Chairman shall have a casting Vote. If the Chairman, chosen for the Half-year, is not prefent, the Governors who make the Committee may appoint another Governor, of those who are prefent to take the Chair during his Abfence, who shall act in his stead; and it shall be deemed a just Committee, if held at the Place and Time appointed, provided three Governors are prefent; and shall proceed to do Business accordingly. The Houfe-Committee shall have Power to contract for, order, and examine the Diet

Diet and Provisions, and all Goods fent in by the feveral Tradefmen for the Ufe of the Charity, and fee that they are bought at a fair Price, and good of their Kind; to order any Conveniences that may from time to time be wanting; to examine into the Conduct of the Officers, Servants, and Patients; to have Power to fuspend or difcharge any of the faid Officers or Servants for Misbehaviour or Neglect of Duty; and to appoint others to officiate in his, her, or their Room, until the Senfe of a General-Court be farther known; to infpect the Hofpital Accounts; to order Payment of the Bills, after they have been examined, and allowed to be fair and just, by a Committee of Accounts; and to make fuch Rules as regard their own Meetings and Conduct, provided they be not contradictory to any Rule or Order of a General-Court: That this Committee meet the first Thursday in the Month, in the General Hospital, in Cold-Bath-Fields, at Eleven o'Clock in the Forenoon, and on the other Thursdays at Child's Coffee-House, in St. Paul's Church-Yard, at Five in the Afternoon; or at any other Hour or Place, which the faid Committe fhall find convenient for the Business of the Charity, or shall adjourn to; And that the Committee at their laft Meeting, before the half-yearly General Court, do confider of proper Perfons to be proposed to the Court for its Approbation as a Houfe-Committee, for the next Half-year, which, with fuch other Matters, B 2

Matters, as have been transacted during the faid Half-year, shall be reported in Writing, and laid before the faid General-Court; and likewife proper Perfons shall be proposed at the same Time for the Committee of Accounts, having been first named in the House-Committee. And that this Committee of Accounts, (which shall meet Quarterly at a fit Time and Place) confist of Seven Governors; two of which being present, shall proceed to Business of examining the Tradesmens Bills for the preceding Quarter, and comparing them with the Books ordered to be kept at the Hospitals; and if found true, they shall order them to be laid before the House-Committee, who shall direct them to be paid.

V. That the Prefident, and in his Abfence any of the Vice-Prefidents, or the Treafurer, fhall have Power to call a General-Court, at any other Time than the ordinary General-Courts are preferibed; one Week's Notice being given to each Governor, and an Advertifement publifhed in fome of the Daily-Papers; and if the Houfe-Committee or Thirteen Governors by a Writing under their Hands defire a General-Court, the Prefident, or Vice-Prefidents, or in their Abfence, the Treafurer, fhall call one in like Manner : And that the particular Bufinefs, for which any extraordinary Court is called, be expreffed in the Summons, and firft entered upon and determined before any thing elfe is propofed.

VI. That

VI. That at a General-Court, in the Absence of the Prefident, and Vice-Prefidents, the Treafurer shall take the Chair; and in his Absence, the Chairman of the House Committee; and if he be absent, some other Person shall be appointed Chairman, by the Governors prefent : That the Chairman of this Court, or any Committee shall not refuse to propose any Question, or have Power to adjourn or diffolve the Court or Committee, without the Confent of a Majority of the Governors prefent, until the Bufinefs be wholly finished; and in case of his Refusal to propose the Question, or attempt to adjourn or diffolve the Court or Committee, the Majority of the Governors prefent may appoint fome other Governor to act as Chairman, as if fuch Chairman was absent.

VII. That every Perfon fpeaking at a General-Court or Committee, fhall addrefs himfelf to the Chair; and no Perfon to be allowed to fpeak more than Twice on any one Subject without Leave; and if two offer to fpeak at the fame Time, the Chairman fhall direct which of them fhall proceed; and if a Difpute arife on any Queftion, fuch Queftion fhall be fairly flated by the Chairman, and determined by the holding up of Hands, or dividing, as the Chairman fhall direct; but if a Ballot fhall be demanded, before they fhall divide, by five Members, the fame fhall be entered on immediately, and determined by one general Ballot; and in cafe of an Equality

of

of Votes, the Chairman shall have a casting Vote.

VIII. That at the General-Court, held between Lady-Day and Midfummer, the Prefident, Vice-Prefidents, and Treasurer, be chosen out of all the Governors; as also the several Officers of this Charity; who shall hold their respective Offices for one Year; except the Chairman of the House-Committee, who is chosen Half-yearly.

IX. That the Minutes of the Proceedings of every General-Court and Committee be read over before fuch Court or Committee be diffolved or adjourned, and figned by the Chairman; which fhall be first read at the next Meeting, and if approved of, confirmed, before any other Business is entered upon.

X. That there be a Phyfician and two Apothecaries, one of which Apothecaries fhall dwell in the General-Hofpital, and the other in the Houfe of Preparation; and in cafe of a Vacancy by the Death, Refignation, or Difmiffion of the prefent or any future Phyfician, or either of the Apothecaries, fuch Vacancy be filled up by a General-Court; and in cafe of the Refignation of any of thefe Perfons, he fhall give one Month's Notice thereof to the Houfe Committee.

XI. That there be an Annual Meeting of the Governors and Subfcribers between Lady-Day and Midfummer, on a Day to be appointed by the Prefident, or in his Abfence, by the Vice-Prefidents, or in their Abfence, by the Treafurer, for an Anniverfary Feaft; when a printed a printed Report of the State of the Hofpitals, of the Number of Patients received and difcharged in the preceding year, and an Abstract of the Accounts of the Hospitals to the 24th of March in every Year, shall be laid before them, at which time no other Business shall be transacted.

XII. That no Governor shall be prefent while any Demand or Claim of his, is under Consideration.

XIII. That all Ladies who are or fhall be Governors of these Hospitals, may fend their Proxy in Writing, to any Governor to vote for them at any General Election.

XIV. That all Annual Contributions paid in any part of a Quarter be reckoned to commence the enfuing Quarter-Day.

XV. That proper Tables of the Rules and Orders, which relate to the Conduct of the Officers, Servants, and Patients, be hung up in fit Places in each Houfe, as the Houfe-Committee from time to time fhall think proper.

## Admission of PATIENTS.

I. THAT no Perfon under the Age of Seven Years be admitted a Patient of these Hospitals.

II. That all Perfons who apply to be relieved by this Charity, shall bring a Letter of Recommenda-

mendation, figned by a Governor or Subscriber; except at any time any Perfon shall be found to be a proper Object of Diftrefs by the Houfe-Committee.

III. That no Patient give Money to any Perfon whatfoever, upon pain of Expulsion.

IV. That every Patient in the Natural Way do deposite One Pound Two Shillings for the Charges of Burial, in cafe fuch Patient shall die in the Hospital; but if they shall live, or be buried by their Friends, then the faid Sum shall be returned without any Deduction whatfoever.

V. Any Perfon intending to fend a Patient, who has the Diftemper, into the Hofpital, muft fend previous Notice thereof; to prevent the Inconveniencies that may arife, in cafe there should be no Room to receive fuch Patient when brought.

VI. That all Governors be at liberty to recommend Patients in the Natural Way, but not to have more in the House than one at a Time, and one likewife entered upon the Books for Inoculation; who will be admitted on the Day of Reception, when it comes to his or her Turn.

Particular RULES to be observed relating to the HOSPITALS, and the Conduct of them.

I. THAT the Keys of the Poor's-Box be kept by the Chairman of the House-Committee and the Phyfician, and the Money found

found therein, taken out once every Quarter or oftener, in the Presence of the Committee.

II. That no Perfon (Governors excepted, or in the Prefence of a Governor) be permitted to vifit the Patients in the Houfe in the Natural Way, unlefs it be by the Appointment of the Governor Recommending, with the Approbation of the Phyfician.

III. That the House-Committee shall appoint the Number of Persons to be received at a Time for Inoculation, according to the Order they stand entered on the Books, by giving Seven Days Notice in the *Public Advertiser* of the Day fixed for their Admission.

IV. That a proper Drefs be provided for the Patients, and worn by them while their own Cloaths are carefully fumigated and a r'd; after which they are to be delivered to them in a Room detached from the Hofpital; and then they are to be immediately difmiffed, and not fuffered to go back into the Wards.

V. That no Officer or Servant of the Hofpital, or other Perfon any way belonging to it, prefume to take of any Governor, Tradefman, Patient, Stranger, or others, any Fee, Reward, or Gratification of any Kind, directly or indirectly, for any Service done, or to be done, on account of the Hofpital, on pain of being immediately difcharged.

VI. That the Apothecary and Matron of each House shall never on any Occasion be both absent at one and the fame Time, from the House under their Care.

VII. That any Acquaintance or Friend of any Patient, who fhall prefume to give Money or any other Gratuity to any Nurfe or Servant, fhall not be admitted to vifit the Hofpitals.

### PHYSICIAN.

I. THAT he attend daily the General-Hofpital; and the House of Preparation as often as is neceffary, to inoculate the Patients, examine them, give fuch Orders, direct their Diet, and prefcribe fuch Medicines, as he shall think fit.

### SECRETARY and RECEIVER.

I. THAT there be a Secretary, who fhall be Receiver, and find two good Sureties to the Satisfaction of the Houfe-Committee, to be bound with himfelf in the Penalty of Two Hundred Pounds, for the faithful Difcharge of his Duty and Truft as Secretary and Receiver.

II. That he be prefent at all General-Courts and Committees, at the Hours appointed.

III. That he keep the Books and Accounts in a methodical Manner; and do all fuch Bufinefs as

is requifite and commonly done by Secretaries and Receivers at other Hofpitals.

#### APOTHECARIES in General.

I. THAT each find two good Sureties to the Satisfaction of the Houfe-Committee, to be bound with himfelf in the Penalty of One Hundred Pounds for the faithful Difcharge of his Duty as Apothecary, and alfo as Steward of the Houfe to which he belongs.

II. That they give their own Bonds refpectively in the Penalty of Ten Pounds, with a Condition thereunder written, for giving one Kalendar Month's Notice in Writing to the Houfe-Committee, of their Intentions of quitting the Service of the Hofpital, and in default of fuch Notice to forfeit Ten Pounds, for the Ufe of the Charity; and that fuch Bonds be deposited in the Hands of the Treasurer for the Time being.

III. That they do not practife as Apothecaries out of the Hofpitals; or attend any other Bufinefs, than that of this Charity.

IV. That they never be absent from their Houses on any Account, without leaving a Note in the Dispensary where they are to be found.

V. That they examine all Provisions brought into their own particular House; Coals, Candles, Bread, Beer, and other Necessfaries, as to Quantity and Quality; and deliver them to the Care

of

of the Matrons, or according to the Order of the House-Committee.

VI. That they visit the Patients in their feveral Wards every Morning before Eight o'Clock, that they may be able to inform the Physician of the Condition of each Patient, and as often as occasion requires.

VII. That they take care of the Utenfils, Drugs, and Medicines, of the Difpenfary, and fee that none be wafted, fpoiled, or embezzeled; and make up, label, and deliver out, the Medicines, according to the Prefcription of the Phyfician; punctually, carefully, and faithfully obferving his Orders.

VIII That they always attend the Phyfician at his Hours; and be at Home before Eleven o'Clock at Night at farthest.

IX. That they never lie out of the Hofpital without fpecial Leave of the Houfe-Committee; and in fuch Cafe, they refpectively appoint another Apothecary, who shall be approved of by the Physician, to officiate in his or their Places.

X. That they lay before the Houfe-Committee at every Meeting an Account of what Things are wanting in each Houfe refpectively, for their Approbation; and that they do not give Directions for any Goods or other Things without their Order; and that they inform the faid Committee from time to time of any Mifbehaviour in the Servants, and of all Irregularities in their refpective Houfes.

XI, That

XI. That they keep Accounts of all Goods and Provisions fent into their Houses; and that each Person have a proper and separate Account, in Books provided for that Purpose; and that they daily enter the several Goods that are delivered, with their Prices; so that, at the End of the Quarter, the Account kept by them may be compared with the Bills delivered by the Tradefmen.

# APOTHECARY of the GENERAL HOSPITAL in particular.

I. THAT he fix a Ticket on every Patient's Bed in the Natural Way, specifying their Names, Age, by whom recommended, and Times of Admission, when they were first feized with the Disease, and the Time of the Eruption of the Pustules.

II. That he keep Registers of the Natural and Inoculated Patients, containing their Names, Times of Admission, Places from whence they came, Age, Business, Issue of the Disease, and by whom recommended.

III. That he give Receipts for the Depofit-Money of the Natural Patients; and pay the fame on their Difcharge, or Burial at the Expence of their Friends, to the Perfon who produces the Receipt for fuch Depofit-Money; but if buried at the Charge of the Charity, then he is to pay the fame fame to the Undertaker, at the Time of Burial; and take Receipts for all fach Payments.

IV. That whenever a Patient shall happen to die, he do forthwith give Notice thereof to the proper Friends of such Patients.

V. That a Letter of Thanks be filled up by him for every Patient when difcharged, to be given to the Governor who had recommended them; and alfo a Note for every Patient to return Thanks in their refpective Places of Public Worfhip.

### APOTHECARY of the House of PREPARA-TION in particular.

I. THAT he keep a diftinct Book for each Sex, containing the Names of the Patients and Places of Abode, Names of the Governors, who recommend, Dates of the Recommendations, the Days they came to his Hands, and where they are to have Notice fent them of the Days of their Admission.

II. That he give a Receipt or Acknowledgement in Writing to every Governor for their Letter of Recommendation of every Perfon to be inoculated, as the fame shall from time to time come to his Hands.

III. That upon receiving a Recommendation from a Governor, he enter the fame in the proper Book immediately; provided that the Perfon recomcommending has not at that Time a Patient already fet down; in which Cafe he must write a Letter to the Governor, letting him know that the former Perfon recommended has not been yet admitted, and therefore the prefent Recommendation cannot take place.

IV. That he give to a fufficient Number of thole who are in Turn, Seven Days Notice, or more when neceffary, of the Day appointed by the Houle-Committee for their Admiffion; and when he finds that he has not a fit Number who acknowledge by Letters, Poft-paid, and promife to attend, that he forthwith write to as many more, who are fufficiently near to attend, to fupply the Deficiency, according to the Order they ftand on the Books.

V. That he acquaint each Governor, as well as the Patients, when fuch Patients recommended by them will be admitted.

VI. That in cafe any Perfon fo recommended, having had Notice fent them as above-mentioned, fhall neglect to attend in order to be admitted, that he do forthwith by Letter acquaint the Governor recommending, of fuch Neglect, and of being then at liberty to recommend the fame, or any other Perfon, as fhall be thought fit by fuch Governor.

VII. That he take, in Truft, the Patients Money, upon their Admission at his House; and send fend it with the Accounts of the fame to the Apothecary of the *General-Hofpital*, upon the Patients being removed thither; where it fhall be kept by the faid Apothecary till the Patients are difcharged.

## MATRONS.

I. THAT they fee all the Patients observe the Rules of the Hospitals; the Nurses, and other Servants do their Duty; and in case of Misbehaviour or Neglect, they acquaint the House-Committee therewith.

II. That they go round their refpective Houfes every Night, and fee that the Patients go to Bed in due Time, viz. from Michaelmas to Lady-Day, at Nine o'Clock, and from Lady-Day to Michaelmas at Ten o'Clock.

III. That they acquaint the Apothecaries what Provisions are necessary for their respective Houses; and that they weigh, measure, and examine all Provisions when they come into their respective Houses; see that they be good, such as charged in the Bills sent therewith, and according to Order; and keep a daily Account of the Quantities used by Weight and Measure, and suffer none to be wasted or carried out.

IV. That they take care of all the Houfhold Goods and Furniture belonging to the refpective Houfes Houses under their Care, and be ready to give an Account thereof when required.

V. That they take care of, and keep the Keys of the Doors; and that they be always locked from *Michaelmas* to *Lady-Day*, at Six in the Evening, and not opened before Eight in the Morning; and locked from *Lady Day* to *Michaelmas*, at Nine in the Evening, and not opened before Seven in the Morning, unlefs upon extraordinary Occafions; and that they admit an Officer or Servant refiding in the Hofpital, before Eleven o'Clock at Night, but not afterwards.

VI. That they be not absent from their respective Houses, without Leave of the Chairman of the House-Committee, or Physician.

VII. That they do not receive any Patient into the Hofpital without an Order of the Committee, or of a Governor or Subscriber.

VIII. That if they know of any of the Rules of the Hofpital being tranfgreffed, they give Notice thereof to the Houfe-Committee, at their next Meeting.

### MATRON of the House of PREPARATION in particular.

I. THAT the take care of what Cloaths and Apparel or other Effects are brought into her Houfe by the Patients; that they may be returned to them or to their Friends, when difcharged.

#### OVERSEER at the GENERAL HOSPITAL.

I. T HAT whenever Patients are admitted in the Natural Way, fhe fhall fee them properly put to Bed; having firft of all (in the Prefence of thofe who bring them) taken away by a thorough Search, all their Money, in order to prevent the Patients obtaining Spirituous Liquors, or any thing elfe that may be injurious to their Health; fuch Money is either to be given back at that Time to their Friends, or elfe, being fet down with their Cloaths in a Book provided for that Purpofe, to be kept in her Cuftody, while the Patients remain in the Hofpital, in order to be returned to them at the Time they are difcharged, or to their Friends in cafe of Death.

II. That fhe likewife at the fame Time make one of thofe, who come with the Patients, write down in a fit Book, what is brought in with them; and that fhe fign her Name thereto; or if none of them can do this properly, fhe fhall write the Things therein herfelf, and they fhall fign it; and whatever fhall be fent afterwards to each Patient, must be entered there accordingly; fo that whether the Patients do well or otherwife, they or their Friends may be fure to receive, without any Miftake, all that belongs to them, agreeable to fuch an exact Account.

III. That she inform the Patients Friends what Apparel may be wanted for them, that they

may

may be properly furnished; besides it is her conftant Business to enquire of the Patients themselves what their Wants are, and to make Application to the proper Persons, that their Wants may be duly supplied.

IV. That she see all the Patients take their Medicines agreeable to the Direction of the Phyfician.

V. That she be not absent from the House without Leave of the House-Committee or Phyfician.

#### NURSES.

1. THAT they diligently attend the Patients; and keep their Beds in a neat and defcent Manner; obferve the Orders of the Matron, Overfeer, and their other Superiors; fee that the Rules made for the Patients be exactly complied with; and that they behave themfelves with Tendernefs to the Patients, and with Civility and Refpect to Strangers.

II. That they shall not receive any Present, Acknowledgement, or Gratuity, either in Money, Treats, or any Thing whatsoever from any of the Patients or their Friends, either during their being under the Care of this Charity or after their Discharge; nor from any Tradesman, or any other Person.

III. That they shall not on any Pretence be abfent from their respective Wards, but that all Er-

rands

rands shall be done by some proper Persons, by Directions of the Matron.

IV. That they clean their Wards every Day; by Seven in the Morning, from the First of March to the First of Ostober; and before Nine, from the First of Ostober to the First of March; and that special Care be taken at all Times that the Utenfils be kept neat and clean.

V. That they do not convey or carry out of the House any Provisions or other Things belonging to it, on pain of being immediately discharged and profecuted.

VI. That they do not bring, or fuffer to be brought in, any Liquors, or Provisions of any Sort, to the Patients, from or by their Friends, or any other way whatfoever.

### PATIENTS.

I. THAT the Natural Patients, immediately upon their Admiffion, deliver up to the Overfeer, or elfe to their Friends, their Money; and that those who are to be inoculated do the fame to the Governors who attend their Admiffion; which Money is to be kept for them by the Apothecary of the House of Preparation, and transmitted by him to the Apothecary of the General Hospital, and returned to the Patients, or their Friends, when they are discharged.

II. That

II. That if any Money be found after their Admission, the Persons upon whom it is found be expelled, and the Money forfeited to the Use of the Charity.

III. That the Perfons who are entered upon the Books for Inoculation, and are in Turn to be admitted, if they do not acknowledge their Notice, which they fhall have received, and promife to attend accordingly, by Letter, Poft-paid, or otherwife fignify a Certainty of their Attendance, they fhall lofe their Right of Admiffion, and be ftruck off the Books, and not afterwards be taken in, unlefs by a frefh Recommendation, which fhall be entered at the End of the Lift.

IV. That they do not play at Dice, or any other unlawful Games.

V. That they do not Swear, Curfe, or give any abufive Language, or behave themfelves indecently, on pain of Expulsion.

VI. That they do not lie out of the House on any Account whatsoever, nor even go out of Doors without Leave.

VII. That they do not fit up after Nine in Winter, and Ten in Summer at fartheft.

VIII. That they do not fend for, or receive in any Manner whatfoever, Provifions of any Sort; Spirituous, or any other Liquors; nor give away any of the Houfe-Provifions, on pain of immediate Expulsion.

IX. That fuch Patients as are able, do affift the

the Nurses in taking care of the others; and do other Services in the House, as far as is convenient and proper.

X. That the Men do not go into the Womens Wards, nor the Women into the Mens.

XI. That every Patient take fuch Medicines as are prefcribed by the Phyfician, in the Prefence of the Overfeer; and fubmit to the Operations judged neceffary.

XII. That when the Patients are cured, they fhall return Thanks to the Governor or Subferiber, who recommended them; as also in their respective Places of Public Worship.
