# CHAIRMAN OF THE MEDICAL STAFF COMMITTEE OF THE GOVERNORS

OF

## ST. MARY'S HOSPITAL.

SIR,

I BEG to offer myself as a candidate for the appointment of Physician to St. Mary's Hospital.

In 1837, after an extended course of literary, scientific, and professional education, I took my degree as a Doctor of Medicine at Edinburgh; and in 1841, was elected a Fellow of the Royal College of Physicians of that city. Upon the occasion of my graduation, the Medical Faculty of the University adjudged to me, for my Essay on "Air in the Organs of Circulation", one of the four Gold Medals annually bestowed on those who present the best Theses; and during the previous year, I received the Harveian Prize for the best Treatise on Creasote. Both of these works have had an extensive circulation, and are quoted as authorities in the text books. I have likewise published a work on Fever, and memoirs on various subjects connected with Clinical Medicine, most of which have been reprinted in America, and translated into several European languages.

Some of the testimonials as to my education and professional qualifications, which I submitted in 1841 to the Managers of the Royal Infirmary of Edinburgh, are here subjoined for your information; and prefixed to them are submitted a few additional certificates procured for the present occasion.

I am familiar with the duties of an Hospital physician, having filled successively the offices of Clinical Assistant in the Royal Infirmary, of Physician to the Royal Dispensary, of Physician to the Fever Hospital, and afterwards of Physician to the Royal Infirmary, of Edinburgh.

I have had considerable experience as a medical Lecturer, having delivered several courses upon Forensic Medicine, and having likewise, for some weeks, lectured upon Physiology for the late Professor John Reid, when he was confined by illness.

## EXTRACTS FROM STANDARD WORKS.

THE following passages are taken from standard works in which Dr. Cormack is cited as an authority. One extract only is given from each author.

Fergusson's Practical Surgery, 1842, p. 393.

"It was supposed by Dupuytren, and the opinion has since been extensively entertained, that in operations at the root of the neck, implicating one or more of the minor veins, the ingress of air into their canals has occasionally been the cause of sudden death. Dr. Rose Cormack, who has ably inquired into this interesting subject, has, however, expressed his opinion, that the alarm on this score is greater than the occasion justifies. No surgeon would willingly keep the orifice in a wounded vein open: and, as Dr. Cormack has shewn, a few globules which may accidentally be admitted, cannot do that harm which some have imagined."

Skey's Operative Surgery. London, 1850, p. 621.

"The subject" (Air in the Veins) "has been especially investigated by Nysten, Amussat, Sir C. Bell, Cormack, Dr. J. Reid, and more recently by Mr. Erichsen."

Reid's Physiological, Pathological, and Anatomical Researches, pp. 558.

"The supposition that when air enters the venous system in large quantities, it produces emphysema of the lungs, has been rendered completely untenable by the observations of Cormack and Amussat."

Christison on Poisons. Edition, 1845; p. 780.

"It is probable that Bleeding from the jugular vein deserves more attention as a remedy" (in cases of poisoning by prussic acid) "than it has yet received. The right side of the heart is almost invariably found much gorged with blood in animals examined at the moment of death; and the contractions of the heart, in such circumstances imperfect or arrested altogether, have often been observed by experimentalists to be instantly restored on promptly removing the state of turgescence. Accordingly, Dr. Cormack (Prize Thesis) found that a dog, at the point of death, after receiving a fatal dose of the acid, was speedily roused and eventually saved by bleeding from the jugular vein."

Christison's Dispensatory. Edinburgh, 1842; p. 375.

"The actions of Creasote require further investigation before a satisfactory account can be given of them; but the knowledge already possessed on the subject, shews that it is a substance of extreme interest; and in the course of a few years it has become an established article of the Materia Medica. The researches of Miguet, Corneliani, and especially of Dr. Cormack, upon its physiological effects, prove that it is an irritant, styptic, narcotic, sedative, anodyne, antiseptic, and possibly also a diuretic."

Neligan on Medicines. Dublin, 1844; p. 235.

"Creasote, in poisonous doses, appears from the observations of Dr. Cormack, of Edinburgh, to resemble prussic acid in its sudden depressing action on the heart, as well as in the temporary nature of its toxicological operation."

Beck's Medical Jurisprudence. London, 1842; p. 1069.

"According to Dr. Cormack, Creasote appears to act on the heart itself, which it seems almost instantaneously to paralyse. There appear also to be many points of resemblance between its effects and those of prussic acid. One is that the odour is diffused through all the tissues, and indeed continues the longest with Creasote. The remedies advised by Dr. Cormack are the same as for prussic acid,—chlorine, ammonia, and other stimuli."

Pereira's Elements of Materia Medica. London, 1839; pp. 226.

"According to Dr. J. R. Cormack (Treatise on Creasote, 1836), the only essential part of the mummifying process practised by the ancient Egyptians, was the application of such heat as would first dry up the body and then decompose the tarry matters which had been previously introduced, and thus generate Creasote."

Churchill on the Diseases of Children. Dublin, 1850; pp. 589.

"There are only two instances of which I am aware, in which abscess was the result of Scarlatinous Nephritis: both are contained in a paper by Dr. Rose Cormack."

Annales de Thérapeutique, par M. le Docteur Rognetta. Paris, 1843 : pp. 111.

"Docimasie Hydrostatique.—M. Cormack, professeur distingué de toxicologie et de médecine légale à Edimbourg, s'est attaché dernièrement à éclaircir expérimentalement un des points délicats de la question si controversée de la docimasie pulmonaire. L'auteur établit, comme un fait constant, que toutes les fois que, sur un enfant mort-né on insuffle le poumon dans le but de le faire respirer ou dans l'intention criminelle de faire planer une accusation, l'homme de l'art peut reconnaître aisément à la dissection une pareille manœuvre; ces cellules bronchiques étant constamment rompues, plusieurs espaces interlobulaires étant distendus par des bulles d'air extravasées, et de l'air étant aussi rencontré à l'état extravasé dans la plévre pulmonaire. La surnatation du poumon par conséquent est sans valeur dans ces occurrences, si on ne s'est pas d'abord assuré de la condition organique signalée par M. Cormack."
