That at such meeting the matter was discussed, but having regard to an intimation by the Secretary of the Weavers' Association that there would shortly be a meeting of Cotton Manufacturers and their Employees upon the Holidays, which rendered it inadvisable in his opinion to discuss the matter fully now.

It was **MOVED** by Mr. Walter Helm, of Messrs. Francis Helm, Limited, and seconded by Mr. Hargreaves, coal dealer, that a recommendation be sent to the Employers and

Operatives Association that the Annual Holidays for the Padiham Distrit, held in the month of August, should commence on the Friday evening following the Wednesday evening on which they commence according to present arrangements.

AN AMENDMENT was moved by Mr. Whittaker (representing the Padiham Soap and Chemical Co.), and seconded by Mr. Russell, of the Padiham Weavers' Association (he expressly stating that he seconded it in his personal capacity and not as representing the Association) that the Annual Holidays, usually held in the month of August, should begin on the evening of the last Friday in July.

On being put to the meeting the amendment was carried, 8 voting for and 6 against, and such amendment on being put to the meeting as a substantive resolution, was carried, 9 voting for and none against.

RESOLVED—That the same be entered on the minutes of the Council.

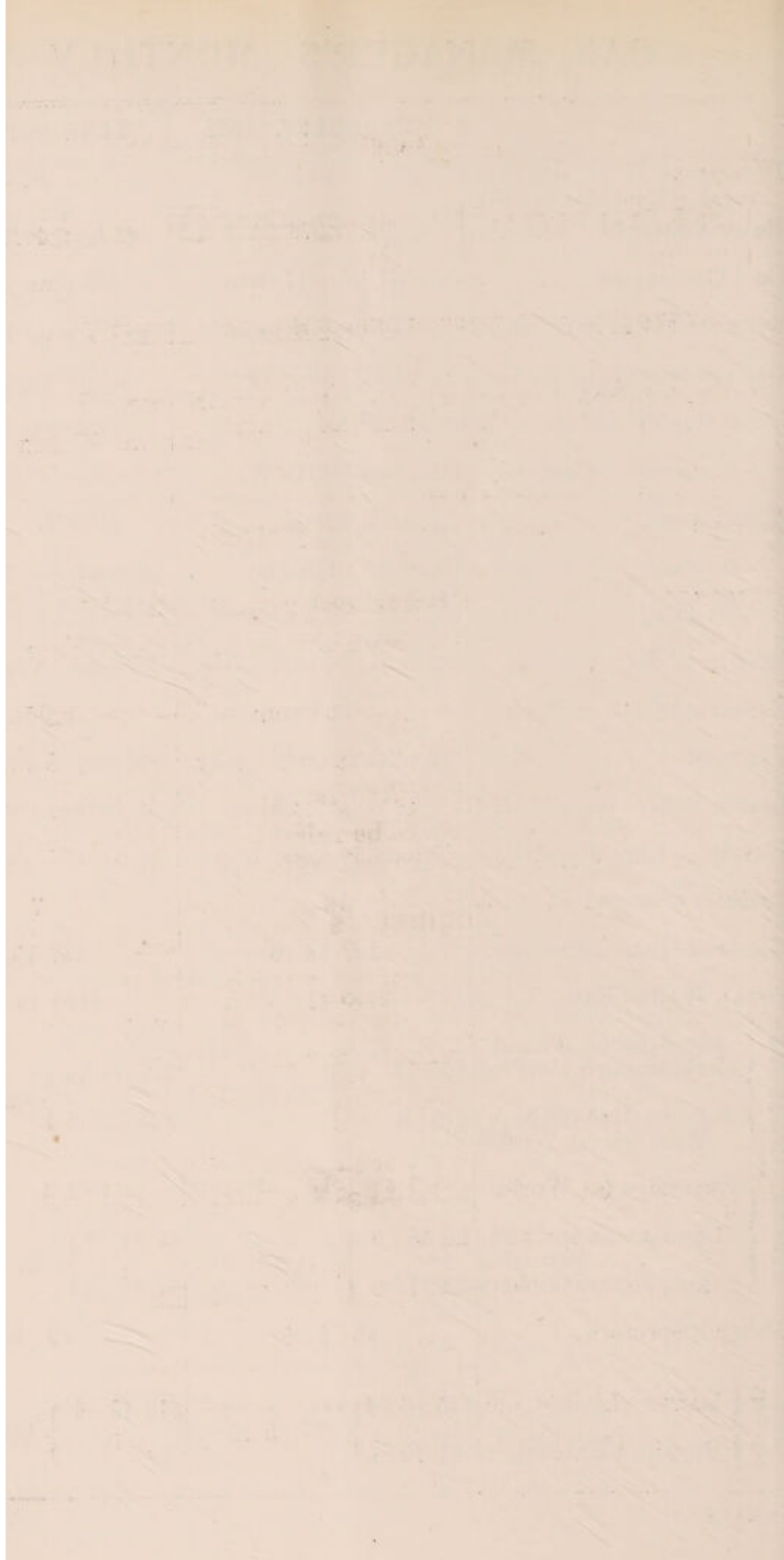

Councillor Jackson reported that he along with Councillor Foster and the Clerk, attended a meeting of the Committee of Management of the Padiham Co-operative Society on the 1st instant and arranged to purchase the land required by the Council for street improvements, for the sum of £80, the Council to make good the parapet in Burnley Road abutting on the Society's property.

RESOLVED---That the arrangement be confirmed, subject to the conditions to be contained in an agreement of purchase to be prepared by the Clerk to the Council.

Plans.

RESOLVED---That the Plan submitted by Mr Emanuel Howarth for alterations to his Laundry, situate in Brook Street, Padiham, be referred back for further consideration, the same not complying with the Bye-Laws of the Council and the Public Health Acts.

Private Street Improvements.

Letters read from Mr. Emanuel Howarth, dated the 19th and 27th February, 1906, relative to the improving of the condition of the Streets on the North and East Sides of his Laundry situate in Brook Street, Padiham.

Medical Officers' Annual Report.

The Report of the Medical Officer of Health for the year 1905, was read and the Surveyor submitted a statement as to the estimated population of the District of Padiham, on March 1st, 1906, taken on the basis of the Census of 1901.

Annual Medical Report.

Area 976 Acres. Population 13,000.

Estimated to middle of 1905.

To the Chairman and Members
of the Council. February 14th, 1906.

Gentlemen,

I beg to present to you my Report for the year 1905, and in doing so, am pleased to be able to state that it is the most favourable one I have as yet made, the death rate being comparatively low, and the infantile mortality being very much reduced, in fact it is reduced over ninety per thousand

births registered; this may perhaps be only a coincidence. It is very gratifying, however, even if it be only temporarily, to have discarded the unenviable notoriety of a high infantile mortality such as we had last year, also in the years 1899 and 1901, each of these being well over two hundred per thousand births registered.

Death Rate.

This is 13·84, as against 16·67 last year, and as against an average of 17·07 for the years 1901 to 1904 inclusive. There has been one death of a resident from this district in a public institution, which brings our exact nett death rate to 14·00.

Deaths.

These number 181; Males 78, Females 103. The chief causes:—Pneumonia 19, Bronchitis 13, Plurisy and other respiratory diseases 5, Phthisis and other tubercular diseases 17, Heart Disease 13, Cancer 9, Enteritis 6, Diarrhœa 1, Measles 1, Scarlet Fever 1, Diphtheria 2, Typhoid Fever 1, Premature Birth 5, Accidents 5.

From the seven principal infectious diseases there have been six deaths as compared with twenty-one during last year; this gives a zymotic death rate of ·45, which is very favourable.

There are nine less deaths from chest troubles this year than last, the decrease being chiefly in children under one year.

The deaths from Phthisis and other tubercular diseases are rather more numerous (17) this year than last (11); this gives a Phthisis death rate of 1·30. This is only what might be called an allowable rate from this complaint.

Forty six of the total deaths were in persons over sixty-five years of age.

Infantile Mortality.

31-11 The death rate of children under one year per thousand births registered is ~~118-11~~ 118-11, as against 222-22 last year, and against an average of 200-50 for the years 1901 to 1904 inclusive; for the years 1897 to 1904 inclusive, the average is 192-79. Much has been said lately about this subject, and one and all who take any interest in the matter, would welcome a solution of the problem, but as I have frequently said in my reports, a solution will be difficult to find so long as factory life for women is as it is—(1) the long working hours, (2) working for too long a period during pregnancy, (3) resuming work too soon after confinement, (4) a very indifferent knowledge of the feeding of infants, (5) the nursing-out system, and very often all these conditions are rendered very much worse by (6) too early and improvident marriages. Each one of these may cause respectively either in mother or child an indifferent state of health, and adds to the number of infantile deaths under the headings of (1) Premature Birth, Congenital Debility, &c., and (2) Diarrhœal Diseases, Chest Troubles, &c.

Deaths of children under one year total 40, as against 70 last year, and against an average of 65 for 1897 to 1904 inclusive. Chief causes:—Measles 1, Scarlet Fever 1, Diarrhœa, Enteritis, Gastritis 6, Debility 4, Tubercular Diseases 2, Meningitis 1, Convulsions 6, Bronchitis 5, Pneumonia 5, Suffocation 2, Premature Birth 5.

From this table it will be seen that there is a decided improvement in our district this year, diseases which might be reasonably attributed to the ill-health of the mother having

caused 11 deaths; those which might be attributed to the nursing-out system 10; and those which might be attributed to indifferent feeding 6.

Infectious Diseases.

104 cases:—Small Pox 4, Diphtheria 6, Erysipelas 20, Scarlet Fever 69, Enteric Fever 4, Continued Fever 1.

Last year there were only 45. The difference is due to Scarlet Fever, there having been 58 more cases than last year. This is probably due to the fact that I could not effect the removal of the first two or three cases, and as a general rule in this district, it is practically impossible to get the isolation one would wish when the cases are kept at home, as in the first place, the people will not be persuaded of the necessity for it, and in the second they could not afford to do it.

Scarlet Fever has been spread over the whole year, the greatest number of cases being in May, June, August, and October.

Thirty-two cases of Scarlet Fever were removed to Sanatorium.

Deaths in Hospital: Scarlet Fever 1, Diphtheria 1.

I am confident that the Sanatorium is now being considered a great boon.

The Small Pox cases were all in January; one at Stone Moor Bottom, three in one house in Green Lane; all were traced to the previous cases we had in December, 1904; all were removed to Crown Point, and all did well. One occurred in an unvaccinated child of six years of age, the other three in adults who had been vaccinated in infancy.

Births.

Number 305; Males 140. Females 165. (Illegitimate 15) Last year the total was 315. The birth rate is 23.46 as against 25.25 for 1904, and against an average of 26.99 for the years 1901 to 1904 inclusive.

Making allowances for our over-estimated population at the time I took up the appointment in 1897 up to 1900 inclusive, the birth rate would average over 28. The average for the next four years as stated above is 26.99, now it is 23.46, so as in other places, the rate is gradually falling, and as with the Infantile Mortality, it is a problem which is difficult of solution.

Water Supply.

Excellent and abundant.

Scavenging.

Satisfactorily carried out by the local authority

Destructor.

Though at present costly, is the only really sanitary method of dealing with refuse.

Drainage and Sewage Disposal.

Efficient; a satisfactory effluent is obtained.

Bakehouses

are in a good sanitary condition.

Slaughterhouses

are kept clean and healthy.

Lodginghouses

are regularly inspected, and comply with the regulation.

Sixty-five nuisances have been remedied. Eight notices of nuisances have been sent, and all have received the necessary attention. As I have already had occasion to remark this year in one of the quarterly reports, and as I have indeed remarked many times, our necessity of possessing our own disinfectant is no less than it ever was, and until we get it, proper and systematic disinfection of clothes and bedding will not be carried out as it ought to be.

At the census in 1901, the number of inhabited houses was 2,760, now it is 3,108.
