COLLETT'S SPECIFICATION.

TO ALL TO WHOM THESE PRESENTS SHALL COME, I, JOSEPH COLLETT, of the Parish of Saint Martin in the Fields, in the County of Middlesex, Gentleman, send greeting.

WHEREAS His most Sacred Majesty King George the Second did
5 give and grant unto me, my executors, administrators, and assigns, His
Royall Letters Patent, bearing date at Westminster, the Sixteenth day of
August, in the thirty-second year of His reign, empowering me, during the
term of years therein expressed, to make, use, exercise, and vend my new
Invention of "ANTI-ARTHRITICK WINE AND POWDER FOR THE CURE OF THE GOUT"
10 within England and Wales and Town of Barwick-upon-Tweed; in which
Letters Patent there is contained a proviso obliging me, the said Joseph
Collett, by some instrument in writing under my hand and seal, to cause a
particular description of the nature of the said Invention, and in what
manner the same is to be performed, to be inrolled in His Majesty's High
15 Court of Chancery within four calender months after the date of the said
recited Letters Patent, as in and by the same Letters Patent (relation being
thereunto had) may more at large appear.

NOW KNOW YE, that in compliance with the said proviso, I, the said
Joseph Collett, do hereby declare that the said anti-arthritis wine and
20 powder is to be made and prepared in the following manner (that is to
say);—

First, put seven gallons of the best Madeira wine and five gallons of
genuine French brandy together into a vessell; the put into it of the roots
of gentian, snake root, and galangal, of each two pounds; of the tops of

centory, burdock seed, and Russia rhubarb, of each two pounds and an half; of the best saffron, four pounds; of the volatile salt of millepedes, twelve ounces; digest together twenty-one days without heat, and then strain it off for use. To make the powder, take of salt of tartar and saltpetre, of each five ounces; of regulus of antimony, one ounce; of spirit of vitriol, two ounces; 5 rub it all together in a mortar, and then put it into an iron crucible, and calcine it till the red fumes disappear; the take it of the fire and reduce it to a fine powder, and so keep it for use. The powder is to be taken fifty grains for a dose, mixed with a glass of warm white wine at night going to bed, and repeated every eight days as long as there shall be occasion. The wine is 10 to be taken a gill at a time, at night, going to bed, and in the morning fasting, and may be repeated with discretion till the cure is performed.

In witness whereof, I, the said Joseph Collett, have hereunto set my hand and seal, this Sixth day of December, in the thirty-second year of the reign of His said Majesty, and in the year of our Lord One 15 thousand seven hundred and fifty-eight.
