

# PENNSYLVANIA HOSPITAL.

BOUT the End of the Year 1750, fome Perfons, who had frequent Opportunities of observing the Diffress of fuch diffemper'd Poor as from Time to Time came to Philadelphia, for the Advice and Affiftance of the Phyficians and Surgeons of that City; how difficult it was for them to procure fuitable Lodgings, and other Conveniences proper for their refpective Cafes, and how expensive the Providing good and careful Nurses, and other Attendants, for want whereof, many must fuffer greatly, and fome probably perish, that might otherwife have been reftored to Health and Comfort, and become ufeful to themfelves, their Families, and the Publick, for many Years after; and confidering moreover, that even the poor Inhabitants of this City, tho' they had Homes, yet were therein but badly accommodated in Sicknefs, and could not be fo well and fo eafily taken Care of in their feparate Habitations, as they might be in one convenient Houfe, under one Infpection, and in the Hands of fkilful Practitioners; and feveral of the Inhabitants of the Province, who unhappily became diforder'd in their Senfes, wander'd about, to the Terror of their Neighbours, there being no Place (except the House of Correction) in which they might be confined, and fubjected to proper Management for their Recovery, and that Houfe was by no Means fitted for fuch Purpofes; did charitably confult together, and confer with their Friends and Acquaintances, on the best Means of relieving the Distressed, under those Circumftances; and an Infirmary, or Hofpital, in the Manner of feveral lately eftablished. in Great-Britain, being propoled, was fo generally approved, that there was Reafon to expect a confiderable Subscription from the Inhabitants of this City, towards the Support of fuch an Hofpital; but the Expence of erecting a Building fufficiently large and commodious for the Purpofe, it was thought would be too heavy, unlefs the Subscription could be made general through the Province, and some Affistance could

could be obtained from the Assembly; the following Petition was therefore drawn, and prefented to the House on the 23d of January, 1750-51.

To the Honsurable House of REPRESENTATIVES of the Province of Pennfylvania,

The PETITION of fundry Inhabitants of the faid Province.

#### Humbly Sheweth,

THAT with the Numbers of People the Number of Lunaticks, or Perfons diffemper'd in Mind, and deprived of their rational Faculties, hath greatly encreafed in this Province.

THAT fome of them going at large, are a Terror to their Neighbours, who are
daily apprehenfive of the Violences they may commit; and others are continually
wafting their Subftance, to the great Injury of themfelves and Families, ill difpofed
Perfons wickedly taking Advantage of their unhappy Condition, and drawing them
into unreafonable Bargains, &c.

<sup>6</sup> THAT few or none of them are fo fenfible of their Condition as to fubmit volun-<sup>6</sup> tarily to the Treatment their refpective Cafes require, and therefore continue in the <sup>6</sup> fame deplorable State during their Lives; whereas it has been found, by the Ex-<sup>6</sup> perience of many Years, that above two Thirds of the mad People received into <sup>6</sup> Betblebem Hofpital, and there treated properly, have been perfectly cured.

<sup>6</sup> Y O U R Petitioners beg Leave farther to reprefent, that tho' the good Laws of this Province have made many compafilonate and charitable Provifions for the Relief of the Poor, yet fomething farther feems wanting in Favour of fuch whofe Poverty is made more miferable by the additional Weight of a grievous Difeafe, from which they might eafily be relieved, if they were not fituated at too great a Diftance from regular Advice and Affiftance, whereby many languifh out their Lives, tortur'd perhaps with the Stone, devour'd by the Cancer, depriv'd of Sight by Cataracts, or gradually decaying by loathfome Diftempers; who, if the Expence in the prefent Manner of nurfing and attending them feparately when they come to Town, were not fo difcouraging, might again, by the judicious Affiftance of Phyfick and Surgery, be enabled to tafte the Bleffings of Health, and be made in a few Weeks ufeful Members of the Community, able to provide for themfelves and Families.

<sup>6</sup> THE kind Care our Affemblies have heretofore taken for the Relief of fick and <sup>6</sup> diftemper'd Strangers, by providing a Place for their Reception and Accommoda-<sup>6</sup> tion, leaves us no Room to doubt their fhewing an equal tender Concern for the <sup>6</sup> Inhabitants. And we hope they will be of Opinion with us, that a finall Provincial <sup>6</sup> Hofpital, erected and put under proper Regulations, in the Care of Perfons to be <sup>6</sup> appointed by this Houfe, or otherwife, as they fhall think meet, with Power to re-<sup>6</sup> ceive and apply the charitable Benefactions of good People towards enlarging and <sup>6</sup> fupporting the fame, and fome other Provifions in a Law for the Purpofes above-<sup>6</sup> mentioned, will be a good Work, acceptable to GOD, and to all the good People <sup>6</sup> they reprefent.

"W E therefore humbly recommend the Premises to their serious Confideration."

ON

O s the fecond Reading of the Petition, January 29, the Houfe gave Leave to the Petitioners to bring in a Bill, which was read the firft Time on the firft of February. For fome Time it was doubtful whether the Bill would not mifcarry, many of the Members not readily conceiving the Neceffity or Ufefulnefs of the Defign; and apprehending moreover, that the Expence of paying Phyficians and Surgeons, would eat up the whole of any Fund that could be reafonably expected to be raifed; but three of the Profession, viz. Doctors Lloyd Zachary, Thomas Bond, and Phineas Bond, generously offering to attend the Hospital gratis for three Years, and the other Objections being by Degrees got over, the Bill, on the feventh of the fame Month, passed the House, Nemine Contradicente, and in May following it received the Governor's Affent, and was enacted into a Law, as follows.

#### An ACT to encourage the Establishing of an HOSPITAL for the Relief of the Sick Poor of this Province, and for the Reception and Cure of Lunaticks.

**N** H E R E A S the faving and reftoring ufeful and laborious Members to a Community, is a Work of publick Service, and the Relief of the Sick ' Poor is not only an Act of Humanity, but a religious Duty; and whereas there " are frequently, in many Parts of this Province, poor diftemper'd Perfons, who lan-' guifh long in Pain and Mifery under various Diforders of Body and Mind, and ' being fcattered abroad in different and very diftant Habitations, cannot have the Benefit of regular Advice, Attendance, Lodging, Diet and Medicines, but at a great Expence, and therefore often fuffer for want thereof; which Inconveniency " might be happily removed, by collecting the Patients into one common Provincial . Hofpital, properly difpofed and appointed, where they may be comfortably fub-' fifted, and their Health taken Care of at a fmall Charge, and by the Bleffing of GOD on the Endeavours of fkilful Phyficians and Surgeons, their Difeafes may be cured and removed. And whereas it is reprefented to this Affembly, that there <sup>4</sup> is a charitable Difpolition in divers Inhabitants of this Province to contribute largely towards fo good a Work, if fuch Contributors might be incorporated with proper · Powers and Privileges for carrying on and compleating the fame, and fome Part of ' the Publick Money given and appropriated to the Providing a fuitable Building for ' the Purpofes aforefaid.

<sup>6</sup> THEREFORE, for the Encouragement of fo ufeful, pious and charitable a Defign, we pray that it may be enacted, And be it enacted by the Honourable JAMES <sup>6</sup> HAMILTON, Efquire, Lieutenant-Governor under the Honourable THOMAS <sup>6</sup> PENN, and RICHARD PENN, Efquires, true and abfolute Proprietaries <sup>6</sup> of the Province of Pennfylvania, and Counties of New-Caftle, Kent and Suffex, up-<sup>6</sup> on Delaware, by and with the Advice and Confent of the Reprefentatives of the <sup>6</sup> Freemen of the faid Province in General Affembly met, and by the Authority of the <sup>6</sup> fame, That it shall and may be lawful to and for all Perfons, each of whom shall <sup>6</sup> have contributed or subscribed the Sum of Ten Pounds or more, towards founding an <sup>6</sup> Hospital, for the Reception and Relief of Lunaticks, and other diftemper'd and <sup>6</sup> fick Poor within this Province, or as many of them as shall think fit to affemble and <sup>6</sup> meet on the first Day of the Month called July next; and for all Perfons who shall <sup>6</sup> thereafter

· thereafter contribute the like Sum of Ten Pounds or more (together with the faid firft · Subferibers) or fo many of them as shall think fit to affemble and meet on the fecond · Day of the first Week, in the Month called May, yearly for ever, at fome conve-" nient Place in the City of Philadelphia, then and there to elect by Ballot, twelve fit and fuitable Perfons of their own Number to be Managers of the faid Contribution and Hofpital, and one other Perfon to be Treasurer of the fame, until the next · Election; and farther, to make fuch Laws, Rules and Orders, as shall appear to ' them the faid Contributors met, or the major Part of them, to be good, ufeful and neceffary, for the well governing, ordering and regulating the faid Hofpital, 6 and for the Regulation of the future Elections of Managers, Treafurer, and other ۲ neceffary Officers and Ministers thereof, and for limiting and appointing their Num-6 · ber, Truft, and Authority, and generally for the well ordering all other Things concerning the Government, Eftate, Goods, Lands, Revenues, as alfo all the Bufinefs and Affairs of the faid Hofpital : All which Laws, Rules and Orders, fo to be made as aforefaid, shall be from Time to Time inviolably observed by all concern'd, · according to the Tenor and Effect of them, provided they be not repugnant to the Laws of England or this Government, and are approved by the Chief · Juffice, the Speaker of the Affembly, and the Attorney-General of this Province " for the Time being, under their Hands and Seals. And the faid Contributors shall be, and are hereby made a Body Corporate in Law, to all Intents and Pur-· pofes, and shall have perpetual Succession, and may fue, or be fued, plead, or be · impleaded, by the Name of The Contributors to the Pennfylvania Hofpital, in all " Courts of Judicature within this Province, and by that Name, shall and may re-· ceive and take any Lands, Tenements, or Hereditaments, not exceeding the year-' ly Value of One Thousand Pounds, of the Gift, Alienation, Bequeft, or Devise of any Perfon or Perfons whomfoever; and of any Goods or Chattels whatfoever; and \* the faid Contributors are hereby impower'd to have and ufe one common Seal in ' their Affairs, and the fame at their Pleafure to change and alter.

PROVIDED neverthelefs, That no General Meeting of the faid Contributors, nor
any Perfons acting under them, fhall employ any Money or other Eftate, expressly
given or added to the Capital Stock of the faid Hospital, in any other Way than
by applying its annual Interest or Rent towards the Entertainment and Care of the
fick and diftemper'd Poor, that shall be from Time to Time brought and placed
therein, for the Cure of their Difeases, from any Part of this Province, without
Partiality or Preference.

<sup>6</sup> A N D for the further Encouragement of this beneficent Undertaking, Be it enact-<sup>6</sup> ed by the Authority aforefaid, That when the faid Contributors fhall have met and <sup>4</sup> chofen their Managers and Treafurer as aforefaid, and fhall have raifed by their Con-<sup>6</sup> tributions, a Capital Stock of *Two Thoufand Pounds* Value (the yearly Intereft or <sup>6</sup> Rent of which is to be applied to the Accommodating of the Sick Poor in the faid <sup>4</sup> Hofpital, free of Charge for Diet, Attendance, Advice and Medicines) and fhall <sup>6</sup> make the fame appear to the Satisfaction of the Speaker of the Affembly for the <sup>6</sup> Time being; that then it fhall and may be lawful for the faid Speaker of the Af-<sup>6</sup> fembly, and he is hereby required to fign an Order or Orders on the Provincial <sup>6</sup> Treafurer, or Truftees of the Loan-Office, for the Payment of *Two Thoufand* <sup>6</sup> *Pounds*, • Pounds, in two yearly Payments, to the Treasurer of the faid Hospital, to be ap-• plied to the Founding, Building, and Furnishing of the same.

<sup>6</sup> AND be it further enacted by the Authority aforefaid, That the Accounts of the <sup>6</sup> Difburfements of the faid *Two Thoufand Pounds*, fo ordered by the Speaker of the <sup>6</sup> Affembly aforefaid, or any Part thereof that fhall be hereafter expended, as the <sup>6</sup> Cafe may be, and of the Rents, Products, and Interefts of any real or perfonal <sup>6</sup> Eftates or Sums of Money charitably given to the Ufe of the faid Hofpital, toge-<sup>6</sup> ther with a Lift of fuch Donations, fhall be fairly drawn out and publifhed annu-<sup>6</sup> ally in the *Gazette*, or other News-papers : And the Managers of the faid Hofpital <sup>6</sup> fhall at all Times, when required, fubmit the Books, Accounts, Affairs, and Œco-<sup>6</sup> nomy thereof, to the Infpection and free Examination of fuch Vifitors as may from <sup>6</sup> Time to Time be appointed by the Affembly of this Province, to vifit and infpect <sup>6</sup> the fame.

<sup>6</sup> PROVIDED always, and it is hereby further enacted by the Authority afore-<sup>6</sup> faid, That if at any Time hereafter, there fhould not be a conftant Succeffion of <sup>6</sup> Contributors to meet yearly and chufe Managers as aforefaid, then the faid Hofpi-<sup>6</sup> tal, and the Eftate and Affairs thereof, fhall be in the Management, and under <sup>6</sup> the Direction of fuch Perfons as fhall be from Time to Time appointed by Act of <sup>6</sup> General Affembly of this Province for that Purpofe.'

As foon as the Law was published, the Promoters of the Defign set on Foot a Subscription, which in a short Time amounted to confiderable more than the Sum required by the Act. And on the First of the Month called *July*, 1751, a Majority of the Contributors met at the State-House in *Philadelphia*, and pursuant to the Act chose by Ballot twelve Managers, and a Treasurer, viz.

THE Managers met foon after the Choice, and viewed feveral Spots of Ground in and near the City, which were thought fuitable to erect Buildings on for this Purpole; and agreeing in Judgment, that one particular Lot, belonging to the Proprietaries, would fuit as well or better than any other, they drew up the following refpectful Addrefs, and fent it (with the following Letter) to *Thomas Hyam*, and *Sylvanus Bevan*, to be prefented by them to the Proprietaries. And that it may be feen at one View, what has been hitherto done in that Affair, it is thought proper to add the Anfwers the Managers received from their Agents, and other Papers relative thereto. To the Honourable THOMAS PENN, and RICHARD PENN, Esquires, Proprietaries of the Province of Pennsylvania, &c.

The A D D R E S S of the Managers of the Pennfylvania Hofpital.

May it pleafe the Proprietaries,

I T bath been long observed, that this your Province, remarkable for the Goodness of its Constitution, Laws and Government, and many other Advantages, is yet deficient of a common Hospital or Infirmary, for the Relief of such Poor as are afflicted with curable Diseases.

YOUR good People here, to supply this Defect, and out of a tender charitable Regard for their Fellow-creatures, have voluntarily subscribed, and are still subscribing, large Sums towards a Stock for the Support of such an Hospital: And the General Assembly being petitioned by a Number of the Inhabitants of all Ranks and Denominations, have passed an Act to encourage the same, and granted Two Thousand Pounds for the Founding, Building, and Furnishing thereof.

IN Purfuance of that AEI, we the Subscribers were, on the first of this Instant; chosen by the Contributors to be Managers of the said Hospital, and think it our Duty to take this first Opportunity of laying the Affair before our Proprietaries, in humble Confidence that so good and pious an Undertaking will not fail of their Approbation; boping withal, from the accustomed Bounty of the Proprietary Family, in encouraging former Designs of publick Utility to the People of their Province, the present will also receive their kind Affistance; and as private Persons raise a Stock to support the Hospital, and the Affembly build the House, so (that all concerned in the Province may share in the Honour, Merit and Pleasure of promoting so good a Work) the Proprietaries will be pleased to favour us with the Grant of a Piece of Ground for the Buildings, and their necessary Accommodations.

IF any Thing should occur to the Proprietaries, that they may think of Service with respect to the Management or Rules of the Hospital, we should be obliged to them for their Sentiments, being desirous that what falls within our Duty, may be done to the greatest Advantage for the Publick.

T H E Opinion we have of your beneficent Principles, induces us to make this Application to you, and we hope the Opportunity of exerting your Tendernefs to the Afflicted and Diftreffed, will be fo acceptable, as to render any Apology unneceffary for our Freedom in requefting your Friendship in delivering and folliciting the Addrefs we herewith fend to our Proprietaries, Тномаs and Richard PENN.

<sup>6</sup> THE Circumstances of this Province have, in a few Years past, been much al-· ter'd, by the Addition of a great Number of Perfons who arrive here from feveral · Parts of Europe, many of whom are poor, and fettle in remote Parts of the Coun-• try, where fuitable Provision cannot be made for their Relief from the various Dif-• orders of Body and Mind fome of them labour under; the Confideration of which hath lately rais'd in many of the Inhabitants of this City a benevolent Concern, and engaged them to apply for the Affiftance of the Legislature, by whom a Law is paffed, and fome Provision made out of the Provincial Treasury for the Erecting a e publick Hofpital or Infirmary, under the Direction of a Corporation, by whom we " have lately been elected the Managers; but as the publick Funds are not fufficient to <sup>6</sup> anfwer the Expence of endowing it, a charitable Subfcription for that Purpofe hath · been propos'd and begun with good Succefs. The Neceffity and Advantages of this . Inftitution are fo apparent, that Perfons of all Ranks unite very heartily in promoting ' it; and as feveral of our most eminent Physicians and Surgeons have freely offered " their Service for fome Years, we have good Grounds to expect that this Under-' taking may be of general Service much fooner than was at first expected, and that our Legislature will foon make a further Provision for the Building, which we ap-" prehend it will be prudent to contrive and erect in fuch Manner, as to admit of fuch Additions as the future State of the Province may require. The principal Dif-· ficulty we now labour under, is the Want of a commodious Lot of Ground in ' a healthy Situation; for (tho' we have fo great Encouragement as we have men-' tion'd) we cannot flatter ourfelves with speedily raising a Sum sufficient to enable ' us to provide for all other neceffary Charges, and to purchase a fuitable Piece of "Ground fo near the built Part of the City, as the conftant Attendance of the Phyficians, and other Confiderations, will neceffarily require : We are therefore under the ' Neceffity of laying the State of our Cafe before our Proprietaries, and we hope the ' fame Motives which have induced others, will have due Weight with them to pro-" mote this good Work, and that they will generoufly direct a Piece of Ground to be allotted for this Service.

<sup>6</sup> THERE are feveral Lots in different Parts of this City very fuitable, but from <sup>6</sup> their Situation, &c. are of great Value for other Purpofes; we have therefore <sup>6</sup> thought of one, which is in a Part of the Town quite unimproved, and where, in <sup>6</sup> all Probability, there will be the Conveniency of an open Air for many Years; it is <sup>6</sup> the vacant Part of the Square between the Ninth and Tenth-ftreets from Delaware, <sup>6</sup> on the South Side of Mulberry-ftreet, and is 396 Feet Eaft and West, and 360 Feet <sup>6</sup> North and South. The Lots in this Part of the City have not advanced in Value <sup>8</sup> B ' for feveral Years past, and are not likely to be foon fettled; fo that we are in Hopes, f if you will favour us with your Application for this Piece of Ground, you will meet " with no Difficulty in obtaining it.

THOMAS PENN, and RICHARD PENN, true and absolute Proprietaries of the Province of Pennfylvania, and of the Counties of New-Caftle, Kent, and Suffex, on Delaware, in America :

To JAMES HAMILTON, Elq; our Lieutenant-Governor of our faid Province, and Counties, and to all other Perfons whom these Presents may concern, greeting.

WHEREAS it hath been represented unto us, that there is a Want in our faid Province of a common Hospital or Infirmary, for the Relief of " fuch Poor as are afflicted with curable Difeafes; and that many of the good In-<sup>6</sup> habitants thereof, to fupply that Defect, and out of a tender and charitable Regard \* to their Fellow-creatures, had voluntarily fubscribed, and were ftill fubscribing, large " Sums of Money, towards a Stock for the Support of fuch an Hofpital; and that \* the Affembly there, being petitioned by a Number of the Inhabitants of all Ranks " and Denominations, had already granted Two Thousand Pounds, for the Founding, " Building and Furnishing thereof; and that the Perfons who had contributed towards " the Stock thereof, or many of them, had, in the Month of July last past, chosen <sup>c</sup> certain Perfons to be Managers of the faid intended Hofpital.

· AND whereas the faid Managers have addreffed us, laying the faid Affair before " us, in Confidence that fo good and pious an Undertaking would not fail of our · Approbation, and hoping, from the accuftom'd Bounty of our Family in encourag-' ing former Defigns of publick Utility to the People of our faid Province, the pre-" fent would also receive our kind Affistance; and that as private Persons raised the \* Stock to support the Hospital, and the Assembly were to build the House, fo that " we would be pleafed to favour the faid Managers with the Grant of a Piece of " Ground for the Buildings and neceffary Accommodations for the faid Hofpital; and " also requefting our Sentiments, if any Thing should occur to us that we might think ' of Service with refpect to the Management or Rules of the faid Hofpital :

KNOW ye therefore, that we, having taken the Premifes into our Confideration, \* and approving and greatly favouring the faid general Scheme and Intention, and <sup>4</sup> being defirous to aid and affift the fame, as conceiving that the due Execution there-" of may tend to the Relief of many poor and neceffitous Perfons in our faid Pro-" vince, and to the general Benefit and Advantage of the fame, have refolved to in-" corporate the prefent and future Subfcribers by our Grant of Incorporation; and at ' the fame time to grant unto fuch Corporation fo incorporated, a valuable Tract of Land in a proper Place within our good City of Philadelphia.

" In order whereto, we do by these Presents give, grant, and commit unto you, ' our faid Lieutenant-Governor, full Power, Commission, and Authority, by one ' Inftrument or Grant of Incorporation, to be iffued in our Names, and to be fealed \* with the Great Seal of our faid Province, to incorporate and erect into a Body Politick

litick or Corporate, by fuch Name or Title as to you shall feem most apt and convenient, all and every fuch Perfons, who already have fubfcribed and paid, or at any Time hereafter shall subscribe and pay the Sum of Ten Pounds or more, of current Money of our faid Province, towards the Founding and Eftablishing an Hofpital for the Reception and Relief of Lunaticks, and other diftemper'd and fick Poor within our faid Province, fuch Corporation to have Continuance to fuch Contributors and their Succeffors for ever; and to grant all usual, common, proper and reafonable Powers of a Corporation unto fuch Corporation, and their Succeffors ; and particularly for the Making of fuch reafonable and lawful By-Laws, Rules and Orders, as to the faid Corporation, or the major Part of them, when duly affembled in fuch Manner as fhall be therein appointed, fhall feem u feful and neceffary for the well-ordering, regulating and governing the faid Hofpital; for the Regulation of the future Elections of Managers, Treasurer or Treasurers, and other neceffary Officers and Ministers thereof; for limiting their Numbers, Trusts and Authorities, and the Times and Durations of their respective Continuance in their Offices, and the Caufes and Manner of removing any of them (if Occafion fhould require) and generally, for the well-ordering all other Matters and Things, any way relating to or concerning the good Government, Eftate, Lands, Rents, Revenues, Intereft, Monies and Goods, and all other the Bufinefs and Affairs of the faid, Hofpital, and of the Poor therein, and of the Officers and Ministers thereof. And alfo to grant, that all fuch By-Laws, Rules and Orders, fo to be made as aforelaid, shall be from Time to Time inviolably observ'd by all concerned, according to the Tenor and Effect of them, provided they be reafonable in themfelves, not repugnant to the Laws of Great-Britain, or of our faid Province, and be first approved by us, or fuch of us, our Heirs or Assigns, Proprietaries of our faid Province, as shall for the Time being be in America, and by the Chief Justice, and Speaker of the Affembly for the Time being, under our and their Hands and Seals, in cafe we, or either of us, or the Heirs or Affigns of us, or of either of us, or any of them, shall for the Time being happen to be in America; but in cafe we, or either of us, nor any of the Heirs or Affigns of either of us, Proprietaries of our faid Province, shall happen from Time to Time to be in America, then being first approved by and under the Hands and Seals of the Governor or Lieutenant-Go-· vernor, the Chief Juffice, the Speaker of the Affembly, and the Attorney-Genes ral of our faid Province for the Time being, or by any three of them. And alfo to grant and appoint fuch Perfons to be prefent and immediate Officers of fuch . Corporation (until a future Election of new Ones) as have already been chofen or appointed by the Subfcribers thereto; and to grant Power to the faid Corporation, and to their Succeffors, to take and receive, and to hold and enjoy, for the Ufe of the faid Corporation, any Lands, Tenements or Hereditaments within our faid · Province, not exceeding in the whole the yearly Value of One Thousand Pounds at the Time of fuch taking of the Gift, Grant, Alienation, Bequeft or Devife of any · Perfon or Perfons whatfoever; and alfo to take, receive, hold and enjoy, any " Goods or Chattels, to any Value whatfoever : And to grant unto the faid Corpo-\* ration Power to use a common Seal for the Business of the faid Corporation, and the fame at Pleafure to alter and change ; but you are in fuch our Grant of Incor-· poration

' poration to infert one or more express Provisoes and Conditions, that no General "Meeting of the Members of fuch Corporation, or any Perfons acting under them, " shall fell or convert into Money, any real Estate, given or to be given to the faid . · Corporation (unlefs directed fo to do by the Donor or Donors of the fame) nor : " shall employ or dispose of any Principal Money or other Effects, which are or ' shall be given or added for the Purpose of encreasing of the Capital Stock of the faid Corporation, in any other Manner than by applying the annual Rent, Reve-" nue, Income, or Intereft of the fame, towards the Entertainment and Cure of the · fick and diftemper'd Poor, that fhall from Time to Time be brought and placed ' in or under the Care of the faid Hofpital, and the Officers and Minifters thereof, for the Cure of their Difeafes, from any Part of our faid Province, without Par-' tiality or Preference. And alfo that fair, full and plain Accounts in Writing, of all Subscriptions, Benefactions, Donations, and Gifts of every Kind to the faid Cor-' poration, and of the Difpofal, Employment and Difburfements of the fame, and of the Rents, Revenues, Incomes, Intereft and Produce ariling therefrom, and of the Difpofal thereof, and of all Salaries paid to any Officers or Servants, fhall · conftantly lay open in fome publick Part of the Hofpital, for the free View and ' Infpection, at all Times in the Day, of any Subfcriber or Contributor; and that an Account of the fame, figned by three or more of the Managers, be, from . ' Time to Time, once in the Month of October, in every Year, published in the · Gazette, or other News-paper, printed in our faid Province, for the Information of \* all Perfons. And that the Books, Accounts, Affairs, Œconomy, Difpofition, and Management of the faid Hofpital, and of all the Eftate, Rents, Revenues, and Intereft thereof, and of all the Managers, Treasurers, Officers, Ministers " and Servants thereof, and every Matter and Thing relating to the fame, or to any of them, and all Abufes concerning the fame (if any fuch fhould ever happen) ' fhall at all Times be fubject to the Infpection, free Examination and Reformation . of fuch Visitors, not exceeding four in Number, as we, our Heirs or Affigns, · Proprietaries of the faid Province, or the Lieutenant-Governor of the faid Province for the Time being, shall from Time to Time appoint, fo as the Chief Justice, ' and the Speaker of the Affembly of our faid Province for the Time being, be always two of fuch Vifitors.

<sup>6</sup> AND we do hereby give, grant and commit to you, our faid Lieutenant-Governor, further Power, Commiffion and Authority, in and by the fame Inftrument or <sup>6</sup> Grant of Incorporation to be fo iffued as aforefaid, to give and grant unto, and for <sup>6</sup> the Ufe of the faid Corporation, and their Succeffors for ever, all that Part of the <sup>6</sup> Square or Parcel of vacant Land, in our faid City of *Philadelphia*, herein after de-<sup>6</sup> fcribed; *That is to fay*, All that Piece or Parcel of Land fituated, lying and being <sup>6</sup> on the *North* Side of *Saffafras-freet*, between *Sixth* and *Seventh-freets* from *Dela-*<sup>6</sup> *ware*, containing from *Eaft* to *Weft* on *Saffafras-freet* Three Hundred and Ninety-<sup>6</sup> fix Feet, or thereabouts, little more or lefs, and from *South* to *North*, on *Sixth* and <sup>6</sup> *Seventh-freets*, Three Hundred Feet, and bounding Northwards on other vacant <sup>6</sup> Land, Part of the fame Square, referved to us, to hold unto, and to the Ufe of the <sup>6</sup> faid Corporation and their Succeffors, to and for the Ufe of the faid Hofpital for <sup>6</sup> ever, rendering to the Hands of our Receiver-General, and of the Receiver-General ral of us, our Heirs, or Affigns, Proprietaries of the faid Province for the Time being, in our faid Province, for our Ufe, the yearly Rent of *Five Shillings* of lawful
Money of *Great-Britain*, on the first Day of *March* in each and every Year henceforth
for ever, under a declared and express Provisoe and Condition to be contained in fuch
Grant of Incorporation, that if, at any Time hereafter, there shall not be a constant
Succession of Contributors to meet yearly and choose Managers and Officers, then
the faid Tract of Land thereby to be granted, shall revert and return to us, our Heirs
and Affigns, Proprietaries of our faid Province, as in our first and former Essate.
And you are to infert in such Grant, all such other proper Clauses and Matters not
contrary to, or inconsistent with, the Directions hereby given, as to you shall seem
proper and reasonable; and particularly for the Enrolment of the faid Grant in the
Mafter of the Rolls-Office in *Philadelphia*.

• FOR all which this shall be to you our sufficient Warrant, Commission and Aue thority.

#### REMARKS.

THE Defign of the Hospital being (in itself) so beneficent, and our honourable Proprietaries having fully express'd their Approbation of it in strong Terms, as well as declared their kind Intentions of aiding and assisting it, by granting a valuable Tract of Land, in a proper Place, for an Hospital; all therefore that seems necessary for us to do, is to convince our bonourable Proprietaries, that the Methods by which they have proposed to aid and assist the Hospital, will by no Means answer these good Intentions, but are really inconsistent therewith.

W E must then beg Leave to remark in the first Place, with regard to the Charter, That as the Ast of Assembly is undoubtedly the best Grant of Incorporation that we can possibly have, and as the Representatives of the Freemen of this Province have generously contributed towards the Design, we should fail of the Respect that is justly due to them, were we to accept of any other, without obtaining some very great and manifest Advantage by it; but that there are no such Advantages in the Charter proposed, is evident at first View: On the contrary, we should by it be confined to stricter Limits than we now are, particularly with respect to the Power of making By-Laws, and being subjected to Visitors of the Proprietaries Appointment. But that Clause which makes the Lot (and of Consequence the Buildings on it) revert to the Proprietaries, on Failure of a Succession of Contributers, is so weighty an Objection, that were there no other, we could not entertain tertain the least Thoughts of accepting the Charter; for as the Sum allowed for Support of the Hospital is limited, we may reasonably conclude, that in Time there will cease to be a Succession of Contributors, and no Person can imagine that when that happens to be the Case, the Lot and Buildings ought to become the private Property of any Man: And the Act of Assembly bath made Provision in a Manner which may be liable to some Inconveniences, yet it can scarce fail of answering the Purposes first intended. The Proprietaries, to be sure, have not attended to these Consequences, or they never would have proposed any Thing so inconsistent with the Design they intended to promote.

AS to the Lot that the Proprietaries defigned for the Hospital, it is so situated, and so circumstanced, that it will by no Means be suitable for the Purpose; it is a moist Piece of Ground, adjoining to the Brick-yards, where there are Ponds of standing Water, and therefore must be unhealthy, and more sit for a Burying-place (to which Use Part of it is already applied) than for any other Service; besides, as it is Part of a Square allotted by the late honourable Proprietary for publick Uses, as the old Maps of the City will shew, our Fellow-citizens would tax us with Injustice to them, if we should accept of this Lot by a Grant from our present Proprietaries, in such Terms as would seem to imply our assessed to their having a Right to the Remainder of the Square.

W E now, on Behalf of the Contributors to the *Pennfylvania* Hofpital, with much Gratitude and Refpect, acknowledge the benevolent Difpofition you have manifested by your Industry and Care in folliciting our Address to our Proprietaries; and as we are fully convinced nothing hath been wanting on your Parts, we should have been much pleased that the Lot which the Proprietaries proposed for the Hospital, and the Terms of their Grant, were such as we defired, or could accept.

• IMMEDIATELY after the Receipt of your Letter, with the Copy of that • you had from the Proprietaries, our Prefident waited on the Governor, who was • pleafed to communicate to us the Inftructions he had received; and as the An-• iwer given by the Proprietaries to you, may have induced you to think they had • granted our Requeft, we think it neceffary to fend you a Copy of their Inftructions • to the Governor, after Perufal of which, and of the few Remarks we have made • thereon, we have no Doubt you will approve of our Refolutions not to accept of • a Lot on thefe Terms.

<sup>6</sup> BEFORE we agreed on the Address to the Proprietaries, we furvey'd the Square <sup>6</sup> (of which the Lot proposed by them is a Part) and the Situation appeared to us <sup>6</sup> in every Respect inconvenient and unfuitable for our Purpose: It is contiguous to <sup>6</sup> the Brick-makers Grounds, from which the City hath been furnished with Bricks <sup>6</sup> above Forty Years pass, fo that their large Ponds being continually filled with <sup>6</sup> standing Water, renders the Neighbourhood unhealthy, and of courfe absolutely <sup>6</sup> improper for our Purpose, which is to restore the Sick to Health; and the only <sup>6</sup> proper Use of that Square will be for a Burying-ground, to which Service fome <sup>6</sup> Part of it hath been applied by a Grant from the Proprietaries; and the Diffatis-<sup>6</sup> faction which appeared, and still substitutes among our Fellow-citizens, on the Pro-<sup>6</sup> prietaries. <sup>6</sup> prietaries claiming a Right to make that Grant is fo great, that if there were no <sup>6</sup> other Objection, we would not run the Rifque of encreafing it.

· WE ftill think that the Lot we first mentioned is more fuitable for us than any ' other fo near the City, and of fo fmall Value, and we are not entirely without Hopes ' that the Proprietaries, who have fo fully declared their Approbation of our Defign, " will still grant the fame to us; we are affured, if they regard their own Interest in the "Affections of the People, or even attend to the Juffice of their concurring in the · Promoting of every Scheme calculated for the Publick Utility of their Province, ' they will chearfully grant it to us : And if you should entertain the fame Senti-" ments, we requeft you to renew your Sollicitations to them, and if you find them ftill unwilling to favour our Requeft, we fhould be pleafed to know whether they 6 " will fell it to us, or let it for ever on an annual Rent, and the Price or Rent they propofe; for as the Number of Contributors still continues gradually encreasing, we shall 6 rather endeavour to purchase a Lot in a proper Situation, than to build the House in " an inconvenient Place, or to accept of any Lot on fuch Terms as we know would ' give a general Diffatisfaction.

<sup>6</sup> ONE of the Contributors hath offered to give a Lot of Ground much larger than <sup>6</sup> that we now afk, and in a very good Air, but being about a Mile out of Town, we <sup>6</sup> are apprehenfive it will be inconvenient to the Phyficians, who, as they freely give <sup>6</sup> their Attendance, fhould be fubjected to as little Difficulty as poffible.

<sup>6</sup> W E have, for the prefent, hired a Houfe tolerably convenient, into which we <sup>6</sup> began to admit Patients about fix Months fince; the Number fince received is <sup>6</sup> Twenty-three, of which Twelve have been cured and difcharged, and Eleven are <sup>6</sup> remaining; and as the Benefits of this Inftitution become daily more attended to, <sup>6</sup> we have not the leaft Doubt that the Minds of fuch who are bleffed with the Means, <sup>6</sup> will gradually become the more freely difpofed to contribute towards this good <sup>6</sup> Work, and that it will foon become of general Service to the People of this Pro-<sup>6</sup> vince.

• THE kind Manner in which you have chearfully engaged to ferve us, gives us • Reafon to think you will approve of our writing to you with fo much Freedom, • we shall not therefore offer any Apology for it.

#### To the MANAGERS of the Pennfylvania Hofpital.

Refpected Friends,

to him your Remarks on the Grant of Land made by him and his Brother RICHARD to your Society (dated the Eighth of October, 1751) and requested instead thereof that Spot which which your Memorial mentioned, and defired might be granted for the intended Hospital; be perused the Remarks, and made Objections to them, alledging that the Ground which you defired was contiguous to that which they have offered, consequently no Difference in the Healthinefs thereof. And as to the Remark against its reverting to the Proprietaries, be very readily declared nothing more was intended by the Clause in the Grant, than that provided the Scheme for the Establishment and Continuance of the Hospital should not succeed, either for want of the Sum proposed to be raised as a Fund, or through any other Cause. that then the Ground should revert, &c. but as to the Erections thereon, they should be at the Managers Disposal. We desired his Answer in Writing, but he refused the Giving it in that Manner, and added, the Governor should have the necessary Instructions on the Affair, unto whom you might apply concerning it. On the whole, he came to this Refolution, not to make any Alteration in what was before granted, nor to lett or fell the Spot of Ground you pitch upon; and therefore we are of Opinion, you should either accept the Proprietary's Offer, with the Clause relating to the reverting to them being explained, or else to fix on some other Piece of Ground. And if there is no other Objection than the small Distance of a Mile to the Place which one of the Contributors hath offered to give you, may not that be more fit for an Hospital or Infirmary, than to have it in the City, where infectious Diseases may be much more liable to spread. We observe, with Pleasure, the Success that bath attended the Beginning of the good Work you are engaged in, and hope it will go forward, and be happily compleated, and are, with hearty Salutes,

THE following Papers were published in the Pennsylvania Gazette, of August the eighth, and fifteenth, 1751, viz.

#### Post obitum benefacta manent, æternaque Virtus Non metuit, Stygiis nec rapiatur Aquis.

I was sick, and ye visited me. MATTH. XXV.

A MONG all the innumerable Species of Animals which inhabit the Air, Earth and Water, fo exceedingly different in their Production, their Properties, and the Manner of their Existence, and fo varied in Form, that even of the \* fame Kind, it can scarce be faid there are two Individuals in all Respects alike ; it \* is remarkable there are none within our Obfervation diffinguished from the reft by <sup>6</sup> this Particular, that they are by Nature incapable of Difeafes. The old Poets, how extravagant soever in their Fictions, durst never offend so far against Nature and Probability, as even to feign fuch a Thing; and therefore, tho' they made <sup>6</sup> their Achilles invulnerable from Head to Foot, and clad him befide in impenetrable " Armour, forg'd by the Immortals, they were obliged to leave one foft unguarded · Place in his Heel, how fmall foever, for Destruction to enter at .--- But tho' every Animal that hath Life is liable to Death, Man, of all other Creatures, has the greatest Number of Difeases to his Share; whether they are the Effects of our In-6 ' temperance and Vice, or are given us, that we may have a greater Opportunity of exercifing towards each other that Virtue, which most of all recommends us to \* the Deity, I mean CHARITY.

" THE great Author of our Faith, whole Life should be the constant Object of " our Imitation, as far as it is not inimitable, always fhew'd the greatest Compassion and Regard for the Sick; he difdain'd not to vifit and administer Comfort and . Health to the meaneft of the People; and he frequently inculcated the fame Dif-· pofition in his Doctrine and Precepts to his Difciples. For this one Thing (in that · beautiful Parable of the Traveller wounded by Thieves) the Samaritan. (who was s efteemed no better than a Heretick or Infidel by the Orthodox of those Times) " is preferred to the Prieft and the Levite, becaufe he did not, like them, pais by regardlefs of the Diftrefs of his Brother Mortal, but when he came to the Place " where the half-dead Traveller lay, be had Compassion on him, and went to him, and " bound up bis Wounds, pouring in Oil and Wine, and fet bim on bis own Beast, and 5 brought him to an Inn, and took Care of him .--- Dives, alfo, the rich Man, is reprefented as being excluded from the Happiness of Heaven, because he fared sump-' tuoufly every Day, and had Plenty of all Things, and yet neglected to comfort s and affift his poor Neighbour, who was helplefs, and full of Sores, and might e perhaps have been revived and reftored with fmall Care, by the Crumbs that fell " from his Table, or, as we fay, with his loofe Corns .--- I was fick, and ye vifited me, is " one of the Terms of Admiffion into Blifs, and the Contrary, a Caufe of Exclusion : " That is, as our Saviour himself explains it, Ye have visited, or ye have not visited, " affisted and comforted those who stood in need of it, even tho' they were the least, or meanest of Mankind. This Branch of Charity seems effential to the true Spirit of 6 Christianity,

Chriftianity, and fhould be extended to all in General, whether Deferving or Undeferving, as far as our Power reaches. Of the ten Lepers who were cleanfed, nine feem to have been much more unworthy than the Tenth, yet, in refpect to the Cure of their Difeafe, they equally fhared the Goodnefs of G O D. And the great Phyfician in fending forth his Difciples, always gave them a particular Charge, that into what foever City they entered, they fhould heal all the Sick, without Diffunction.

<sup>6</sup> W HEN the good Samaritan left his Patient at the Inn, be gave Money to the Hoft, and faid, take Care of him, and what thou fpendeft more, I will repay thee. We are in this World mutual Hofts to each other; the Circumftances and Fortunes of Men and Families are continually changing; in the Courfe of a few Years we have feen the Rich become Poor, and the Poor Rich; the Children of the Wealthy languifhing in Want and Mifery, and those of their Servants lifted into Eftates, and abounding in the good Things of this Life. Since then our prefent State, how prosperous soever, hath no Stability, but what depends on the good Providence of G O D, how careful should we be not to harden our Hearts against the Distress of our Fellow Creatures, left he who owns and governs All, should punish our Inhumanity, deprive us of a Stewardship in which we have so unworthily behaved, laugh at our Calamity, and mack when our Fear cometh. Methinks when Objects of Charity, and Opportunities of relieving them, prefent themselves, we should hear the Voice of this Samaritan, as if it were the Voice of G O D founding in our Ears, Take Care of them, and whatsoever thou spendess, I will repay thee.

" BUT the Good particular Men may do feparately in relieving the Sick, is fmall, " compared with what they may do collectively, or by a joint Endeavour and Intereft. · Hence the Erecting of Hospitals or Infirmaries by Subscription, for the Reception, · Entertainment, and Cure of the Sick Poor, has been found by Experience exceedsingly beneficial, as they turn out annually great Numbers of Patients perfectly · cured, who might otherwife have been loft to their Families, and to Society. " Hence Infirmaries fpread more and more in Europe, new Ones being continually · erected in large Cities and populous Towns, where generally the most fkilful Phy-" ficians and Surgeons inhabit. And the Subfcribers have had the Satisfaction in a \* few Years of feeing the Good they proposed to do, become much more extensive \* than was at first expected; for the Multitude and Variety of Cafes continually treated in those Infirmaries, not only render the Physicians and Surgeons who at-' tend them, ftill more expert and skilful, for the Benefit of others, but afford fuch <sup>s</sup> fpeedy and effectual Inftruction to the young Students of both Professions, who \* come from different and remote Parts of the Country for Improvement, that they <sup>6</sup> return with a more ample Stock of Knowledge in their Art, and become Bleffings \* to the Neighbourhoods in which they fix their Refidence.

May the Father of Mercies grant it his Bleffing, and Thousands <sup>6</sup> of our unhappy Fellow Creatures, yet unborn, will have cause to bless him, for put-C 2 <sup>6</sup> ting ting it into the Hearts of the generous Contributors, and enabling them thus to provide for their Relief.'

<sup>6</sup> THIS Motto, taken from a Pagan Author, expresses the general Senfe of <sup>6</sup> Mankind, even in the earliest Ages, concerning that great Duty and exten-<sup>6</sup> five Charity, the administring Comfort and Relief to the Sick. If Men, without <sup>6</sup> any other Affistance than the Dictates of natural Reason, had so high an Opinion <sup>6</sup> of it, what may be expected from Christians, to whom it has been so warmly re-<sup>6</sup> commended by the best Example of human Conduct. To visit the Sick, to feed <sup>6</sup> the Hungry, to clothe the Naked, and comfort the Afflicted, are the infeparable <sup>6</sup> Duties of a Christian Life.

<sup>6</sup> ACCORDINGLY 'tis obfervable, that the Chriftian Doctrine hath had a real <sup>6</sup> Effect on the Conduct of Mankind, which the mere Knowledge of Duty, without <sup>6</sup> the Sanctions Revelation affords, never produced among the Heathens: For Hi-<sup>6</sup> ftory fhows, that from the earlieft Times of Chriftianity, in all well regulated <sup>6</sup> States where Chriftians obtained fufficient Influence, publick Funds and private <sup>6</sup> Charities have been appropriated to the Building of Hofpitals, for receiving, fup-<sup>6</sup> porting, and curing those unhappy Creatures, whose Poverty is aggravated by the <sup>6</sup> additional Load of bodily Pain. But of these Kind of Inftitutions among the <sup>6</sup> Pagans, there is no Trace in the Hiftory of their Times.

<sup>4</sup> THAT good Prince EDWARD VI. was fo affected at the Miferies of his poor <sup>6</sup> difeafed Subjects, reprefented in a Charity Sermon preach'd to him on the Occa-<sup>6</sup> fion, that he foon after laid the Foundation of four of the largeft Hofpitals now <sup>6</sup> in London, which the Citizens finished, and have ever fince maintain'd.

IN Hide-park, at Bath, in Edinburgh, Liverpool, Winchefter, and in the County
of Devon, and fundry other Places in Great-Britain, large and commodious Infirmaries have been lately erected, from trifling Beginnings of private Charities:
And fo wonderfully does Providence favour these pious Institutions, that there is
not an Instance of any One's failing for want of necessary charitable Contributions. \*

• In the Year 1740, on the Promotion of Dr. Gilbert, Dean of this Church, to the Bilhoprick of • Landaff, his Majefty was pleafed to confer the Deanery on Dr. Alured Clarke, who was inftalled in • the Month of January, in that Year; and if we may be allowed to judge from the pious Acts he • began with in that Station, a more worthy Man could not have been preferr'd thereto.

• THE House, an ancient Building, belonging to that Dignity, had, thro' the Remiffaels of its • former Posses been too long neglected; wherefore his first Work was to set about altering and • repairing that, which he did within nine Months of his Instalment, at an Expence of about Eight • Hundred Pounds.

<sup>6</sup> BEFORE this was perfected, wiz. in the Spring 1741, he drew up and published Proposals for found-<sup>6</sup> ing an Hospital in this City, for lodging, dieting, and curing the fick and lame Poor thereof, and of <sup>6</sup> the County of *Devon*, on the like Plan of that which he had before founded at *Winchesser*, for the <sup>6</sup> Benefit of that City, and County of *Hants*. A Design fo good, recommended by the pious Elo-<sup>6</sup> guence of a Divine so learned and judicious, on Views so visibly disinterested, and so clearly ab-<sup>6</sup> fracted

\* THE Increase of poor diseased Foreigners and others, settled in the distant Parts of this Province, where regular Advice and Affiftance cannot be procured, but at an Expence that neither they nor their Townships can afford, has waken'd the Attention of fundry humane and well difpofed Minds, to procure fome more certain, effectual and eafy Methods for their Relief than have hitherto been provided; and " having reprefented the Affair to the Affembly, a Law was paffed, without one " diffenting Voice, giving Two Thousand Pounds for building and furnishing a Pro-" vincial Hospital, on Condition that Two Thousand Pounds more should be raifed · by private Donations, to be put out to Intereft as Part of a perpetual Fund for " fupporting it; and the Contributors were made a Body Corporate, with all the Powers neceffary on the Occafion. Since which, People of all Ranks in this City have " united zealoufly and heartily in promoting this pious and excellent Defign, and " more than the Sum flipulated was fubfcribed in a few Days only, and a much larger <sup>4</sup> Sum will probably be raifed here, if the Country chearfully contributes to the Capi-· tal Stock, which 'tis not to be doubted they will do, when they confider how, ' much they are interefted in it.

THE Difference between nurfing and curing the Sick in an Hofpital, and feparately in private Lodgings, with Regard to the Expence, is at leaft as ten to one.
For Inftance, fuppofe a Perfon under the Neceffity of having a Limb amputated,
he muft have the conftant Attendance of a Nurfe, a Room, Fire, &c. which cannot for the firft three or four Weeks be procured at lefs Expence than *Fifteen Sbil- lings* a Week, and never after at lefs than *Ten*: If he continues two Months, his
Nurfing will be *Five Pounds*, his Surgeon's Fee, and other accidental Charges,
commonly amounts to *Three Pounds*, in the whole near *Ten Pounds*; whereas in an
Hofpital, one Nurfe, one Fire, &c. will be fufficient for ten Patients, the Extra
Expences will be inconfiderable, and the Surgeons Fees taken off, which will bring
the above Calculation within the Limits of Truth.

<sup>6</sup> BUT the Difference with regard to the unhappy Sufferer is ftill greater. In an
<sup>6</sup> Hofpital his Cafe will be treated according to the beft Rules of Art, by Men of
<sup>6</sup> Experience and known Abilities in their Profession. His Lodgings will be com<sup>6</sup> modious, clean and neat, in an healthy and open Situation, his Diet will be well
<sup>6</sup> ces

<sup>4</sup> flracted from all Party Schemes or Intentions, met with the general Applaufe and Affiltance of the <sup>5</sup> Gentry and Clergy of all Parties, Sects and Denominations; who, however different in Religion <sup>6</sup> and Politicks, unanimoufly join'd in this pious Undertaking: And a Subfeription being opened in <sup>6</sup> March, hath already (November, 1741) brought in about Two Thoufand Pounds, of which near Fif-<sup>6</sup> teen Hundred Pounds are annual Engagements, which, 'tis highly probable, will be not only conti-<sup>6</sup> nued, but much augmented, fo that 'tis hoped that Two Hundred Patients at a Time may be pro-<sup>6</sup> vided for. John Tuckfield, of Raddon, Efq; was pleafed to accommodate the Governors with a Plot <sup>6</sup> of Ground near Southernhay, without the City Walls, at a very moderate Price, and to give One <sup>6</sup> Hundred Pounds towards carrying on the Building for the intended Holpital, the Plan of which was <sup>6</sup> commodioully defigned by the Direction of the Dean, and the first Stone thereof laid by him, affilted <sup>6</sup> by the Bishop of Exon, Sir William Courtenay, Knight of the Shire, Sir Henry Northcote, and Hum-<sup>6</sup> phy Sydenham, Efquires, the Citizens in Parliament, the Honourable Henry Rolle, and John Tuck-<sup>6</sup> field, Efq; attended by a great Number of Clergy and Gentry, that are Subferibers, and Thoufands <sup>6</sup> of joyful Spectators, on the Twenty-feventh of Auguft, 1741. The Building contains upwards of <sup>6</sup> Three Hundred Feet in Length, and is already in a good Forwardnefs. <sup>6</sup> ces for his Relief, fuch as hot and cold Baths, Sweating-rooms, Chirurgic Ma<sup>6</sup> chines, Bandage, &c. which can rarely be procured in the beft private Lodgings,
<sup>6</sup> much lefs in those miserable loathsome Holes, which are the common Receptacles
<sup>6</sup> of the difeased Poor that are brought to this City.----In short, a Beggar, in a well
<sup>6</sup> regulated Hospital, stands an equal Chance with a Prince in his Palace for a com<sup>6</sup> fortable Subsistence, and an expeditious and effectual Cure of his Difeases.

<sup>6</sup> I τ is hoped therefore, that whoever will maturely confider the ineftimable <sup>5</sup> Bleffings that are connected to a proper Execution of the prefent Hofpital Scheme <sup>6</sup> in this City, can never be fo void of Humanity, and the effential Duties of Re-<sup>6</sup> ligion, as to turn a deaf Ear to the numberlefs Cries of the Poor and Needy, and <sup>6</sup> refufe, for their Affiftance, a little of that Superfluity, which a bountiful Provi-<sup>6</sup> dence has fo liberally beftowed on them.<sup>7</sup>

On the Sixteenth of August it being made appear, to the Satisfaction of the Affembly, that the Contributions amounted to upwards of Two Thousand Pounds, an Order was obtained for the Two Thousand Pounds that had been conditionally granted by the Act, One Thousand Pounds to be paid immediately, the other in Twelve Months: The Money, when received, was lett out at Interest on good Security, that it might be improving till it should be wanted for the Building, which the Managers were obliged to postpone till a Piece of Ground could be obtained that would afford fufficient Room in an airy, healthy Situation, and yet so night the built Streets of the City, as that the Managers, Physicians and Surgeons, might readily and conveniently visit the House on every Occasion. But that fome Good might be doing in the mean Time, the Managers concluded to hire a House, and take in some Patients for a Beginning; but fome Doubts arising concerning the Power and Duty of the Managers, a general Meeting of the Contributors was called to fettle the fame, and the following Law was passed for those and other Purpose, viz.

#### A LAW for regulating the Elections of the Managers and Treasurer of the Pennfylvania Hospital, and declaring their Trust, Duty and Authority.

WHEREAS by an Act of the General Affembly of the Province of Pennfylvania, intituled, An Act to encourage the Establishing of an Hospital for the Relief of the Sick Poor of this Province, and for the Reception and Cure of Lunaticks, the Contributors to the faid Hospital are made a Body Corporate, and impowered to meet, and to make such Laws, Rules and Orders, as shall appear to them the faid Contributors met, or the major Part of them, to be good, uleful and neceffary, for the well governing and regulating the faid Hospital, and for the Regulation of the Elections of Managers, a Treasurer, and other neceffary Officers and Ministers thereof, and for limiting and appointing their Number, Trust and Authority.

<sup>4</sup> AND whereas, in Purfuance of the faid Law, the Contributors have met, and <sup>4</sup> have chofen twelve Managers and a Treasurer, which Treasurer hath received con-<sup>4</sup> fiderable Sums of Money for the Use of the faid Hospital, and it is now become <sup>4</sup> necessary, for the more orderly Disposition and Application of the faid Monies, and

· of fuch Sums as may hereafter be received, and for the more fure Direction of the . Managers and Treasurer therein, to declare and appoint their Truft, Authority and Duty : Therefore it is enacted by the Contributors to the Pennfylvania Hofpital, in general Meeting duly affembled, That the Managers of the faid Hofpital \* for the Time being, shall have the Power of disposing of all Monies paid to the · Treasurer for the Building, Furnishing, Support, Use and Service of the Hospi-' tal, and for the Hiring and Furnishing a House or Houses for the Reception of · Patients, until the faid Hofpital shall be built, under the Limitations and Reftric-" tions of the before-mentioned Act of Affembly. And the faid Managers shall · likewife have the Power to direct the Manner and Terms of receiving and dif-" charging of Patients; and all Officers and Servants belonging to the Hofpital, \* other than the Treasurer, shall be in the Choice, and under the Direction of the \* Managers, who fhall allow and order their refpective Salaries, and may difplace \* them, and appoint others, as often as they shall think fit. And the faid Managers " fhall have the Power of calling general Meetings of the Contributors, as often as \* they judge it neceffary for the Service and Advantage of the Hofpital; and fhall \* caufe due and publick Notice to be given of the Time, Place, and Defign or \* Purpofe of fuch occafional Meeting, at leaft ten Days before the fame is to be held, " and fhall nominate fome difcreet Member to prefide therein, and regulate the De-" bates thereof. And the faid Managers shall have the Keeping, and Power of af-\* fixing, the Seal of the Corporation, which Seal shall be made nearly agreeable to the \* Form or Draught hereunto annexed; and they shall fettle the Accounts with the " Treasurer from Time to Time, and take Care that all Laws, Rules and Orders \* made by the Contributors, and legally approved, be duly and faithfully executed ; \* for all which, or any other Services relating to the Hofpital, they shall not claim, " receive, or retain, any Fee, Gratuity or Reward whatfoever.

<sup>6</sup> A N D for the more orderly Execution of their Duty and Truft, the Managers <sup>6</sup> are hereby required to meet at leaft once a Month at the Hofpital, or fome other <sup>6</sup> fit Place in the City of *Pbiladelpbia*, to confer and conclude concerning the Mat-<sup>6</sup> ters hereby committed to them ; and fhall caufe fair Minutes of their Proceedings <sup>6</sup> to be kept by their Clerk, in a Book to be provided for that Purpofe : In every <sup>6</sup> of which Meetings of the Managers aforefaid, eight of their Number met fhall <sup>6</sup> be a Quorum, capable to confult, confer and conclude of and upon all Matters <sup>6</sup> appertaining to their Truft, according to the aforefaid Act of Affembly, and the <sup>6</sup> Laws of this Corporation ; and whatfoever feven of the Number fo met fhall fo <sup>6</sup> conclude, fhall be deemed and taken for and as the Refolution of the Managers <sup>6</sup> for the Time, and accordingly enter'd in their Minutes. To which Minutes, and <sup>6</sup> alfo to the Treafurer's Accounts, all Perfons concerned fhall have free Recourfe at <sup>6</sup> all feafonable Times.

<sup>6</sup> A N D it is further enacted by the Contributors aforefaid, that every Treafurer <sup>6</sup> hereafter chofen fhall, before he take upon himfelf the Execution of his Office, en-<sup>6</sup> ter into an Obligation, with one fufficient Surety, in double the Value that doth, or <sup>6</sup> probably may come into his Hands, during the Continuance of his Office, as near <sup>6</sup> as can be effimated by the Managers, unto the Contributors of the *Pennfylvania* <sup>6</sup> Hofpital; conditioned, that he will, once in three Months, or oftener if required, <sup>6</sup> render <sup>6</sup> render his Accounts to the Managers of the faid Hofpital, and well and truly ac<sup>6</sup> count, adjuft and fettle with them when required, for and concerning all Monies
<sup>6</sup> that are or fhall come into his Hands belonging to the faid Contributors, and pay
<sup>6</sup> the Ballance that fhall appear on fuch Settlement to be in his Hands, unto fuch
<sup>6</sup> Perfon, or for fuch Service as a Board of Managers for the Time being fhall or<sup>6</sup> der and appoint, and not otherwife; and that he will at the Expiration of his Of<sup>6</sup> fice, well and truly deliver up and pay the Ballance of the Monies then remaining
<sup>6</sup> in his Hands, together with the Books of Accounts concerning the fame, and
<sup>6</sup> other the Papers and Writings in his Keeping belonging to the Contributors,
<sup>6</sup> unto his Succeffor in the faid Office; and that he will do and execute all other
<sup>6</sup> Things as Treafurer to the Contributors aforefaid, according to the true Senfe and
<sup>6</sup> Meaning of this Law. And he is hereby authorifed immediately upon entring into
<sup>6</sup> his Office, to demand and receive of the preceding Treafurer, his Heirs, Execu<sup>6</sup> tors or Adminiftrators, the Cafh, Books of Accounts, Writings and other Effects
<sup>6</sup> belonging to the Corporation, giving his Receipt for the fame.

A N D for the more regular and fatisfactory conducting of future Elections, and
the Preventing of Difputes and Mifunderftandings among the Contributors, concerning the fame, it is hereby farther enacted, That the Place and Hour of the
Election fhall be appointed by the Managers of the current Year, and notified by
their Clerk, at leaft twenty Days before the Election, by printed Advertifements:
And the faid Managers fhall and are hereby required and impowered to nominate
three different Members of this Corporation to infpect and judge of the faid Election,
and declare who are the Perfons elected; and the Managers fhall caufe their Clerk
to enter in their Book of Minutes the Names of the Perfons elected, according
to the Tickets.

AND if any Perfon elected Manager, fhall refufe or neglect to act, or fhall be
abfent from three fucceffive Monthly Meetings of the Managers, in any of the firft
ten Months of the Year for which he fhall be elected Manager; or if within the
fame Year or Term of his Office, he fhall be confined by Sicknefs, or otherwife
render'd incapable of executing the Office of a Manager, according to the true
Meaning of this Law, or fhall die, the reft of the Managers, as often as Occafion
fhall require, in any of the Cafes aforefaid, fhall proceed in their Duty and Office
without him; or if they think fit they fhall nominate another of the Contributors
to fupply his Place of a Manager until the then next enfuing Election.
AND if any Perfon fo elected Treafurer, fhall abfent himfelf from his faid Office
fice for the Space of thirty Days, or fhall be otherwife render'd incapable, or ne-

<sup>6</sup> fice for the Space of thirty Days, or fhall be otherwife render'd incapable, or ne<sup>6</sup> glect his Office or Duty of Treafurer, it fhall and may be lawful for the Mana<sup>6</sup> gers for the Time being, to difplace him from the faid Office; and the Managers
<sup>6</sup> caufing their Clerk to make a Minute for the Purpofe, containing their Reafons
<sup>6</sup> for difplacing him, he fhall thereupon, and from thenceforth, ceafe to be the
<sup>6</sup> Treafurer aforefaid, and fhall, upon Notice thereof, adjuft and fettle with the
<sup>6</sup> Managers, and pay and deliver the Money, Books, Writings, Accounts, and all
<sup>6</sup> other Effects whatfoever in his Hands belonging to this Corporation, to fuch
<sup>6</sup> Perfon or Perfons as the Managers fhall order and appoint; and in that Cafe, and
<sup>6</sup> fo often, and allo if the Treafurer fhall depart this Life, the Managers fhall no-

\* minate another of the Members of this Corporation, but not of their own Num-· ber, to be Treasurer until the next Meeting for the annual Election, or other ge-neral Meeting of the Contributors.

· PROVIDED always, any Thing herein contained to the contrary notwithstand-\* ing, That before the Managers for the Time being proceed to erect any Building for the faid Hospital, a Plan of such proposed Building, with an Estimation of the \* Expence, shall be prepared and laid before a general Meeting of the Contributors · for their Confideration; and their Approbation shall be obtained before the fame " is carried into Execution."

THE Managers hired the most convenient House that could be procured, with Gardens, &c. agreed with a Matron to govern the Family, and nurfe the Sick, and provided Beds and other neceffary Furniture; and prepared the following Rules refpecting the Admission and Discharge of Patients, a Number of which were printed and difperfed among the Contributors, viz.

RULES agreed to by the MANAGERS of the Pennfylvania Hospital, for the Admiffion and Discharge of Patients.

' First, HAT no Patients shall be admitted whose Cases are judg'd incurable, Lunaticks excepted; nor any whofe Cafes do not require the particular ' Conveniences of an Hofpital.

· Secondly, THAT no Perfon, having the Small-pox, Itch, or other infectious · Diftempers, shall be admitted, until there are proper Apartments prepared for the · Reception of fuch as are afflicted with those Difeases; and if any fuch Persons " should be inadvertently admitted, they shall forthwith be discharged.

' Thirdly, THAT Women having young Children shall not be received, unless e their Children are taken Care of elfewhere, that the Hofpital may not be burthen'd " with the Maintenance of fuch Children, nor the Patients diffurbed with their Noife.

\* Fourthly, THAT all Perfons defirous of being admitted into the Hospital (not " Inhabitants of Philadelphia) muft, before they leave their Abode, have their Cafes ' drawn up in a plain Manner, and fent to the Managers, together with a Certificate from a Juffice of Peace, and the Overfeer or Overfeers of the Poor of the Town-· fhip

fhip in which they refide, that they have gain'd a Refidence in fuch Townfhip,
and are unable to pay for Medicines and Attendance; to which an Anfwer fhall
fpeedily be returned, informing them whether and when they may be admitted.
All Perfons employed in drawing up their Cafes, are defired to be particular in
enumerating the Symptoms, and to mention the Patient's Age, Sex, and Place of
Abode, with the Diftance from the City of *Philadelphia*.

Fiftbly, THAT all Perfons who have thus obtained a Letter of Licence to be received into the Hospital, must be there at the Time mentioned for their Reception, and bring with them that Letter, and must likewife deposite in the Hands of the Treasurer fo much Money, or give such Security as shall be mentioned in their respective Letters of Licence, to indemnify the Hospital either from the Expence of Burial, in case they die, or to defray the Expence of carrying them back to their Place of Abode, and that they may not become a Charge to the City.

Sixtbly, IF feveral Perfons, not excluded by the preceding Exceptions, are applying when they cannot be received, without exceeding the Number allowed by
the Managers to be entertained at one Time in the Hofpital, the Preference will be
given, when the Cafes are equally urgent, first to fuch as are recommended by one
or more of the Contributors, Members of this Corporation, refiding in the Townfhip to which the poor Perfons belong; fecondly, to those who stand first in the
Lift of Applications; but if fome Cafes are urgent, and others can admit of Delay,
those with the most urgent Symptoms shall be preferred.
Seventbly, NOTWITHSTANDING such Letters of Licence, if it space of the state of t

<sup>e</sup> pear by a perfonal Examination of any of the Patients, that their Cafes are mif-<sup>e</sup> reprefented, and that they are improper Subjects of the Hofpital, the Managers <sup>e</sup> fhall have the Power of refufing them Admiffion.

• Eighthly, Тнат at leaft one Bed shall be provided for Accidents that require • immediate Relief.

Nintbly, THAT if there shall be Room in the Hospital to spare, after as many
poor Patients are accommodated as the Interest of the Capital Stock can support, the Managers shall have the Liberty of taking in other Patients, at such reasonable Rates as they can agree for; and the Profits arising from boarding and nursing such Patients, shall be appropriated to the same Uses as the Interest-money
of the publick Stock. Provided that no such Persons, under Pretence of coming to board in the Hospital, shall be admitted, unless, on the first Application made on his Behalf, a Certificate be produced from the Overseer or Overseers of the Poor of the Township in which he lives, of his having gained a Residence in the faid Township; and unless sufficient Security be given to the Managers to indeminify the City and Hospital from all Charges and Expences whatsoever, occasioned by his removing hither.

<sup>6</sup> Tenthly, THAT those who are taken into the Hospital at a private Expence, <sup>8</sup> may employ any Physicians or Surgeons they defire.

<sup>6</sup> Eleventhly, THAT all Perfons who have been admitted into the Hofpital, shall be discharged as soon as they are cured, or, after a reasonable Time of Trial, are judg'd incurable. *Twelfthly*,

Twelftbly, THAT all Patients when cured, fign Certificates of their particular · Cafes, and of the Benefit they have received in this Hofpital, to be either pub-· lifhed or otherwife difpofed of, as the Managers may think proper.

· Thirteenthly, THAT no Patient go out of the Hofpital without Leave from one of the Phyficians or Surgeons first fignified to the Matron : That they do not ' fwear, curfe, get drunk, behave rudely or indecently, on Pain of Expulsion after · the first Admonition.

· Fourteentbly, THAT no Patient prefume to play at Cards, Dice, or any other Game within the Hofpital, or to beg any where in the City of Philadelphia, on · Pain of being difcharged for Irregularity.

· Fifteentbly, THAT fuch Patients as are able fhall affift in nurfing others, wafh-' ing and ironing the Linen, washing and cleaning the Rooms, and fuch other Ser-' vices as the Matron shall require.'

RULES to be observed in the Choice of the Physicians and Surgeons of the Pennfylvania Hospital, to limit and appoint their Number, Authority and Duty, and to raise a Fund for supplying the said Hospital with Medicines.

Imprimis, THE Managers of the faid Hospital shall, within ten Days after their first Meeting in the Month called May, yearly, choose fix · Practitioners in Phyfick and Surgery, to vifit and take Care of the Patients in the ' faid Hofpital, and the other Practitioners (who are at this Time Members of this ' Corporation) shall have the Privilege of attending and observing the Practice of \* those chosen for the Service of the Year.

\* Secondly, THE Practitioners chosen shall give their Attendance at such Times, and in fuch Manner, and be claffed with each other, as shall be concluded and agreed upon by the Managers and Practitioners.

" Thirdly, UPON extraordinary Cafes, the Practitioners in Attendance shall call in ' two or more of the Practitioners chosen for the Service of the Year, to confult " with.

· Fourthly, IN all fuch Cafes, which will admit of Time for Deliberation, all the fix Practitioners chosen for the Service of the Year, shall have timely Notice thereof. Fifships

· Fifthly, Ir any Practitioner be removed by the Managers for Neglect of Duty, or any other Caufe, or shall die, in that Cafe the Managers shall choose another · Practitioner (who is a Member of this Corporation) to fupply his Place.

· Sixtbly, EACH Apprentice or other Student the Practitioners shall introduce ' to fee the Practice of the Hofpital, shall pay one English Guinea, or Thirty-four Shillings, current Money, per Year, to be laid out in Medicines, or fuch other · Manner as the Managers think most proper.

· Seventbly, No Practitioner, during the Term for which he is chosen to ferve ' the Hofpital, shall act as a Manager.

· Eighthly, THE Practitioners shall keep a fair Account (in a Book provided for that Purpose) of the several Patients under their Care, of the Diforders they labour under, and shall enter in the faid Book the Recipes or Prefcriptions they make for each of them.

· Ninthly, No Perfon shall be received hereafter as a Candidate to be employed in the faid Hofpital, as a Phyfician or Surgeon, until he be a Member of this Corporation, and of the Age of Twenty-feven Years, hath ferv'd a regular Appren-· ticeship in this City or Suburbs, hath studied Physick or Surgery feven Years or " more, and hath undergone an Examination of fix of the Practitioners of the Ho-" fpital, in the Prefence of the Managers, and is approved of by them : And with refpect to Strangers, they shall have refided three Years or more in this City, and . shall be examined and approved of in the Manner, and under the Restrictions · aforefaid.

" Tentbly, THESE Rules shall continue in Force two Years, and from thence to the Time of the next general Meeting of the Contributors, and no longer.

FROM this Bounty the Managers have fince been enabled to furnish Medicines to many poor Out-patients, who, at their Request, have been kindly visited by the Phyficians gratis, besides the Service of them to those in the Hospital.

A BOUT the Beginning of this Year twelve Tin Boxes were provided, on which were written these Words in Gold Letters, CHARITYFORTHEHO-SPITAL. One Box for each Manager, to be put up in his House, ready to receive calual Benefactions, in Imitation of a good Custom practised in some foreign Countries, where these Kind of Boxes are frequent in Shops, Stores, and other Places of Business, and into which the Buyer and Seller (when different Prices are proposed) often agree to throw the Difference, instead of splitting it: In which the Successful in Trade sometimes piously deposite a Part of their extraordinary Gains, and Magistrates throw their petty Fees; a Custom worthy Imitation! But these Boxes among us have produced but little for the Hospital as yet, not through want of Charity in our People, but from their being unacquainted with the Nature and Design of them.

IN March, 1753, Doctor Lloyd Zachary, who had diligently attended the Hofpital from the Beginning, being difabled by a paralytick Diforder, Doctor William Shippen was about this Time chosen, by the Managers, to supply his Place.

ABSTRACT of Cafes admitted into the Pennfylvania Hospital, from the Eleventh of the Second Month, 1752, to the Twenty-seventh of the Fourth Month, 1754.

N. B. THE Majority of the Lumaticks taken in had been many Years diforder'd, and their Difeafes become too habitual to admit of Relief; others whofe Cafes were recent, and might probably have been cured, being put in at private Expence, were fo haftily taken away by their Friends, that fufficient Time was not allowed for their Recovery: The Managers have therefore, as well for the Sake of the Afflicted, as the Reputation of the Hofpital, refolved to admit none hereafter, who are not allowed to remain twelve Months in the Houfe, if not cured fooner, or judged by the Phyficians to be incurable.

THE Choice of the Sick to be supported on the publick Stock, was confined to such any whose Cafes could not be healed properly in their respective Habitations, but required the extraordinary Conveniences and Advantages of an Hospital; amongst these, several, for want of this noble Charity in Time, had languished too long to receive any other Advantage from it than the Relief of their Poverty, and the Satisfaction of being convinced they had every Chance for Recovery that Care and Tenderness could afford.

FROM

FROM the foregoing Accounts it appears, That from the Tenth of February; 1752, to the Twenty-feventh of April, 1754, which is but about two Years and two Months, fixty Perfons, afflicted with various Diftempers, have been cured, befides many others that have received confiderable Relief, both In and Out-patients; and if fo much Good has been done by fo fmall a Number of Contributors, how much more then may reasonably be expected from the liberal Aid and Assistance of the Well-difpofed who hitherto have not join'd in the Undertaking? Experience has more and more convinced all concerned, of the great Ufefulnefs of this Charity .--- The careful Attendance afforded to the Sick Poor; the Neatners, Cleanners, and Regularity of Diet with which they are kept in the Hofpital, are found to contribute to their Recovery much fooner than their own Manner of Living at Home, and render the Phylick they take more effectual. Here they have the best Advice, and the best Medicines, which are Helps to Recovery, that many in better Circumstances in different Parts of the Province do not enjoy. In short, there is fcarce any one Kind of doing Good, which is not hereby in fome Manner promoted; for not only the Sick are vifited and relieved, but the Stranger is taken in, the Ignorant inftructed, and the Bad reclaimed \*; prefent Wants are fupplied, and the future prevented, and (by eafing poor Families of the Burthen of fupporting and curing their Sick) it is also the Means of feeding the Hungry, and cloathing the Naked.

IT is therefore hoped, that by additional Benefactions from pious and benevolent Perfons (an Account of which will be published yearly according to Law) this Charity may be farther extended, fo as to embrace with open Arms all the Sick Poor that need the Relief it affords, and that the Managers will not, in Time to come. be under a Necessity, from the Narrowness of the Funds, of refusing Admittance to any proper Object. ' It is hoped that a deaf Ear will not be turn'd to the Cries · of those, in whose Favour both Religion and Humanity ftrongly plead ; who are recommended by the great Pattern of human Conduct; who in Sicknefs are loft to Society; who contribute greatly to the Inftruction of those Youth to whom 4 ' the Lives of High and Low may hereafter be entrufted, whole Prayers are to be 6 fent up for their Deliverers; but that all will affift to render the Funds of this . Hofpital answerable to the Necessities of the Poor .----- Incapacity of contributing can by none be pleaded ; the Rich only indeed can beftow large Sums, but most c can fpare fomething yearly, which collected from many, might make a handfome 6 Revenue, by which great Numbers of diftrefs'd Objects can be taken Care of, and 6 relieved, many of whom may poffibly one Day make a Part of the bleffed Company above, when a Cup of cold Water given to them will not be unrewarded. Let 6 People but reflect what unneceffary Expences they have been at in any Year for ' vain Superfluities or Entertainments, for mere Amufements or Diversions, or per-' haps in vicious Debauches; and then let them put the Question to themselves, "Whether they do not with that Money had been given in the Way now propofed? " If this Reflection has Influence on their future Conduct, the Poor will be provided

The leaft Mite may be here given without a Blufh; for what People
would not chufe to give the Treafurer, or any Manager, the Trouble to receive,
may be put into their Charity-boxes, or into the Box which is fixed in the Entry of
the Hofpital: Where Money cannot fo well be fpared, Provifion or Linen, Blankets, and any Kind of Furniture, Herbs and Roots for the Kitchen, or the Apothecary, or other Neceffaries of a Family, may be delivered to the Matron or Governefs; old Linen, and even Rags, for Lint, Bandages, and other chyrurgical
Dreffings, are acceptable, being fcarce to be purchas'd fometimes for Money; and
tho' they are of little or no Value to thofe who have them, they are abfolutely
neceffary in fuch an Hofpital, and will be thankfully received.'

I r ought in Juffice to be here obferved, that the Practitioners have not only given their Advice and Attendance gratis, but have made their Vifits with even greater Affiduity and Conftancy than is fometimes ufed to their richer Patients; and that the Managers have attended their Monthly Boards, and the Committees the Vifitations of two Days in every Week, with greater Readinefs and Punctuality than has been ufually known in any other publick Bufinefs, where Intereft was not immediately concerned; owing, no Doubt, to that Satisfaction which naturally arifes in humane Minds from a Confcioufnefs of doing Good, and from the frequent pleafing: Sight of Mifery relieved, Diftrefs removed, grievous Difeafes healed, Health reftored, and thofe who were admitted languifhing, groaning, and almoft defpairing of Récovery, difcharged found and hearty, with chearful and thankful Countenances, gratefully acknowledging the Care that has been taken of them, praifing GOD, and bleffing their Benefactors, who by their bountiful Contributions founded fo exactlent an Inftitution.
