If a Ballot is demanded by Three or more Truftees at any Ballots to be Quarterly or Special General Board, the Chairman is to appoint taken, if demanded, a Special General Board for taking the fame, at any time after Fourteen Days, and not exceeding Twenty-one Days, from the Demand of fuch Ballot; which is to begin at Eleven o'Clock in the Forenoon, and be clofed at Two in the Afternoon: And Notice of fuch Ballot, and the Queftion on which the fame was demanded, is to be given to the Truftees in the Summons, and be advertifed in fome of the publick Papers.

No Standing Order of this Society is to be repealed, or al-Standing Order to be approved tered, or any new one be in Force, without the Approbation by Two Genera of Two General Boards.

For chooling the Treasurer.

The Treasurer is to be chosen annually at the First General Board after the General Audit, and be proposed to the Weekly Board Three Weeks previous to his Election.

XIII.

Accounts to be audited.

The Accounts of this Society are to be annually closed upon the 31st of December; and be audited, as foon after as conveniently may be, by a Committee of Truftees to be appointed. by the Weekly Board for that Purpose; and Abstracts of the faid Accounts are to be printed.

XIV.

Bonds and other Securities

All Bonds, or other Securities, for Money belonging to the how to be kept. Society, are to be kept in the Iron Cheft, under Three different Keys; whereof the Vice-Prefident and Treafurer, for the Time being, and a Third Perfon to be nominated by a General Board, are to have each of them One; and the Vice-Prefident, and fuch Third Perfon, are to deliver the faid Securities, when the Weekly Board thinks proper, to the Treasurer, to receive. the Interest thereof, or to fell the fame, as may be found neceffary for the Benefit of this Charity.

XV.

Phylicians, &c. how to be choien,

The Phylicians, Surgeons, Apothecary, Clerk, and Matrom. are to be appointed by the General Board ; and no Addition is to be made to the Salary of the Apothecary, Clerk, or Matron; or any Gratuity to be given them, without the Confent of a General Board; and the inferior Servants of the Houfe, and Tradefimen to be employed, are to be appointed by the Weekly Board : And any Gentleman may be Candidate for Phylician,. who has been educated, and taken his Degrees in Phyfick, in: any Univerfity, or is a Fellow or Member of a College of Phyficians, in Great Britain or Ireland. And a General Board (not a Weekly Board) is to appoint the Day for Election of a Treasurer, Physician, Surgeon, Apothecary, Clerk, or Matron; and the first Weekly Board is to appoint a Special General Board, to declare fuch Vacancy by Death or Refignation; and, in the mean time, the Weekly Board is impowered, in cafe of Necessity, to employ fuch Person or Persons to officiate as. Treasurer,

Treasurer, Physicians, Surgeons, Apothecary, Clerk, or Matron, as Occasion requires, till a proper Person is chosen by a General Board.

XVI.

When any extraordinary Operation in Surgery is to be Surgeons to atperformed, all Surgeons, who are Truftees, have Liberty to nary Operaattend.

XVII.

Purfuant to the Will of a confiderable Benefactor to this None but Pro-Charity, none but Protestants are at any time hereafter to servants. be admitted into any Service or Employ in or about this Infirmary.

XVIII.

A Weekly Board (confifting of as many Truffees as pleafe to Powers given attend) is to meet at the Infirmary every *Wednefday*; and has Power, from time to time, to make fuch Rules, and give fuch Infructions and Orders, as they find neceffary for the immediate Direction of the feveral Officers, Servants, and Others, employed in this Charity; and for admitting or difmiffing of Patients; and regulating every thing relating to the good Management of the Houfe: But no new Order of the Weekly Board is to be of Force (if objected to by any Two Truftees prefent), till it be approved of by the Majority at the next Weekly Board.

XIX.

ach rethin or Fellens

Two Truffees are to be nominated every Wednefday, by the Daily Visitors. Weekly Board, to be Visitors for the enfuing Week, who are to attend daily, and inquire into the Behaviour of the Officers,. Servants, and Patients, the Quantity and Quality of the Provisions, and every thing relating to the Oeconomy of the House; and the faid Visitors have Power to fuspend any Servant for Misbehaviour, and reject such Provisions as they shall find defieient or improper, and provide other in their room, till they have made their Report to the next Weekly Board. All Queftions at every Board and Committee, are to be decided by the Votes of the Majority of the Truftees prefent, and of the Proxies for the Ladies who are Truftees, fuch Proxy being given in Writing to fome Perfon who is a Truftee, and being entered in a Book to be kept for that Purpofe by the Secretary; and the Minutes of each Board and Committee are to be figned by the refpective Chairmen.



That fuch of the Trustees as are Surgeons or Apothecaries, or are conversant in the Knowlege of Drugs, be nominated and appointed, as aforefaid, a Committee To inspect the Drugs, Medicines, and other Ingredients, made use of in the Dispensatory, and see that the Price be reasonable; which Committee are to meet on the Third Saturday after every Quarter-Day, at Twelve o'Clock at Noon, and at any other Times, when they, or any Three of them, shall judge expedient.

ommittee for radefmens ills, That Eleven Truftees be nominated and appointed, as aforefaid, *To examine*, *audit*, *and fign*, *the Tradefinens Bills*; and that they, or any Three of them, do meet at fome convenient Time within Three Weeks after every Quarter-Day, for that Purpofe.

That the Treasurer (for the Time being) and Eleven Trustees, be nominated and appointed, as aforefaid, a Committee For inquiring what Repairs, Furniture, Linen, or Coals, are wanting; and that they, or any Three of them, do make their Report to the Weekly Board, from time to time, as to the faid Committee shall appear necessary.

All the Phyficians and Surgeons are to meet at the Hofpital Stated Tin every *Tuefday* and *Thurfday*, at Twelve at Noon, and every *Saturday* at Twelve of the Clock, to vifit their In-patients, and confult upon difficult Cafes; and on every at

to prefcribe for their Out-patients then on the Books, and minute down all fuch Patients as are proper to be difcharged the *Wednefday* following.

IV.

The Phyficians and Surgeons are to be as punctual as may be in their Attendance at the ftated Times, that they may, by the Servants and Patients, be decently and properly attended, and the Oeconomy of the Houfe no-ways interrupted.

HE is to attend and read Prayers to the In-Patients every Day, to administer the Sacrament occasionally whenever defired, and to give such spiritual Instruction and Advice as may be expedient for them, and agreeable to his Function.

tary to atall Boards THE Secretary shall attend at all General Boards, Weekly Boards, and Committees, punctually at the Time appointed.

II.

He is to take the Minutes, and register the Proceedings, To register Proof the Trustees and Committees; to keep the Accounts with Clearness and Method; and to transact all such Business as is usually done by Secretaries at other Hospitals.

Receiver.

I.

THE Receiver, when chosen, shall give Security, him- To give Securifelf in the Sum of 100 *l*. and Two good Securities in the Sum of 50 *l*. each, for the faithful Discharge of his Duty.

Π.

He shall attend the Direction of the General and Weekly To attend the Boards, and be always ready to account to the Treasurer, whenever thereto required.

III.

He is to wait on every Truftee and Subscriber, within To wait on Three Months after their Subscriptions respectively become Subscribere. payable, and make a proper Application for the same.

The Duty of the Master.

τ.

THE Mafter shall have principally the Charge and Care Master to Have of the Hospital, and the Patients therein; and the In-tients, Servants, ferior Servants and Patients are on all Occasions to pay a proper Ser-Submission and Obedience to his Orders.

II. The

Daily publick Prayers. The Mafter shall admonish and order, daily, that such Patients as are able, and those Servants whose Duty will permit them, do duly and *decently* attend the Service of Prayers; and that he constantly enforce this Order by *Example*.

III.

And private, when afk'd, The Mafter shall take special Care that Prayers be read, and the Sacrament administred, to the Sick Patients in their Beds, when defired.

IV.

An Inventory of Goods, Sc. The Mafter shall keep an exact Inventory of the Goods, Furniture, and Clothes belonging to the Hospital; and be ready to account for the same at all Times, when required.

v.

To eftablish Peace and Quiet in the House. In order that Peace and Quietness, fo effential to the Well-being of the Patient, may be duly kept, the Master is at all times to be ready, and by feasonable and tender Admonitions endeavour to quell any little Feud or Disturbance that may happen amongst the Servants or Patients; and if such Admonition shall be fruitless, he is to report all such Offenders to the Weekly Visitors, or to the next Board of Trustees, that they may be properly dealt with.

VI.

To report Merit or Mifbehaviour. Va

He shall keep a constant and equal Eye upon all the Servants, and take all the Care he can, that they do their Duty with Sobriety and Decency, and with due and equal Tenderness to every Patient; and never fail to report to the Weekly Visitors of the Board of Trustees all such of them as either misbehave, or merit Encouragement.

VH.

To regulate Difproportion of Duty of Inferior of Duty in the Inferior Servants, to regulate the fame, until Servants. the Board shall otherwife order.

VIII.

The Mafter or Matron may employ any able Patient (with To employ able the Approbation of the Phyfician or Surgeon) in any neceffary Employ in the Hofpital; fo as the fame be not inconfiftent with the eftablished Orders.

IX.

The Master shall visit all the Wards and Offices every To visit the Morning and Evening, the Matron to attend him through the Wards twice daily. Womens Wards, and see that the Patients are orderly, and the Servants do their Duty carefully; and, upon any Neglect or Non-obedience, to report the same to the Weekly Visitors, or the next Weekly Board.

X.

He shall take care that no more *Fires* be kept than ab-^{Fires and fmoking Tobacco, folutely neceffary, and that those be extinguished in due time; and that neither Nurse or Patient do *fmoke Tobacco* in the Wards.}

XI.

He shall not receive any Person into the Hospital as a No Patients to Patient, on any Account, but by Order of the Board of by Order of Trustees, except in Cases of immediate and emergent Acci-Board (Accidents excepted).

XII.

In all fuch Cafes of Accident he shall immediately attend Immediate Care the Patient brought in, to see all possible Care taken of such Patient, and to make a proper Inquiry into his Condition and Circumstances.

XIII.

He shall take care that no Repairs or Work be begun, or Repairs and Goods of any fort be sent into this Hospital, without proper Goods. Orders *fir/t* had; and that such Work done, or Gocds sent in, be in all respects, to the best of his Knowlege, conformable thereto; and when any Workmen are employed about the House, he shall superintend them and see they do their Duty.

Provisions and He shall keep, in a Ledger, an exact and methodical Account of the Provisions and Goods fent in every Day, and the Prices thereof; and produce the fame, when required.

XV.

He shall order all the Bills in at the proper stated Times, and attend the Delivery of, and carefully infpect, all Provisions and Neceffaries fent in; and fee that they are, according to the best of his Judgment, in Quantity and Quality, just and good, and agree with the Bills of Parcels, which Bills he is to file.

XVI.

He shall keep a Diet Book, by which the Number of Patients daily on each Diet may be known; and attend the Proportioning and Delivery of the Diet at every Meal, to fee that it is according to the established Table of Diet, which has been printed, and is hung up in this Hofpital; and that no Wafte or Embezzlement be made therein; and that the Diets, not confumed by the fick or absent Patient, be returned; and shall take care, that no Stranger be fuffered to remain in the Hofpital, at the Time of Meals; and that the Doors of the Hospital be then lock'd.

XVII.

Patients may deposit their Money or Effects with the Mafter, Sc.

The Master, upon the Admission of every Patient, to prevent any Lofs, if they are defirous of depositing any Money, Clothes, or other Things in his Hands, is to keep a careful Account thereof, in a Book to be kept for that Purpofe; and shall return all Things, so deposited, on the Discharge (or, in cafe of Death, to the Reprefentative) of fuch Patient, and enter into the faid Book the Names and Places of Abode of the Friends of every Patient admitted into the faid Hospital.

XVIII.

Burials.

Upon the Death of any In-Patient, the Master is to fend after the Friends of the Deceased, if known. He is to take

care that the Corpfe be in due time decently laid out, and a Coffin and Shroud provided (if the Patient is really friendlefs) and the Deceafed buried at the Expence of the Charity.

XIX.

He shall not give Information (upon any Pretence) of any Vacancy of Vacancy of Vacancy for a Patient, without a written Note from the Trustee or Subscriber defiring such Information; and then no farther than respects the *fingle Right* of such Trustee or Subscriber.

XX.

The Mafter shall receive, from the Patients themselves To receive Let-(without Partiality or Distinction) their Letters of Recommen-mendation, and dation, to examine whether such Letters be properly filled up examine them. and figned, and deliver them to the Secretary.

XXI.

He shall not receive (from any Hand) any Letter of Re-No Letters to commendation after the *appointed* Hour, without a *previous* appointed Hour, *Direction* from the Board of Trustees then fitting.

XXII.

He shall take care the Board-Room be at all Times ready for Board-Room, and Papers left the Reception of the Boards of Trustees and Committees; and there, to be unthat no Books, Papers, or other Things, left there, be mislaid der his Care. or lost.

XXIII.

He must be ready, at all Times, to attend the Boards To attend all and Committees, when required, and obey their Orders. Committees.

XXIV.

If any Truitee, Subferiber, or Benefactor, shall at any To account to time pay him any Subscription or Benefaction, he must not fail Receiver for to pay the same to the Treasurer or Receiver upon the next Benefactions or Board-Day.

I.

Apothecary to give Security,

THE Apothecary, when chosen, shall give Security, himfelf in the Sum of One hundred Pounds, with Two good Securities in the Sum of Fifty Pounds each, for the faithful Discharge of his Duty, in duly accounting for such Goods and Money as shall be committed to his Care.

II.

Not to practife The Apothecary shall not practife out of the House, or attend out of the House. any other Business than that of the Hospital.

III.

To prepare Modicines, &c.

The Apothecary shall duly and faithfully prepare the Medicines ordered by the Physicians and Surgeons, and take all possible Care that such Medicines be duly administred, or, if not taken, returned, with all Phials and Gallipots.

IV.

Written Directions to be given with all Medicines, Sc.

The Apothecary shall deliver no Medicines, either to In or Out-Patients, without *clear* and *proper* written Directions; nor dispose of any to any Person or Persons whatsoever, unless they are Patients of the Hospital, and for their own *particular* Use; nor more to the Out-Patients at a Time, than necessary to ferve them until the next stated Time of Attendance.

He fhall once every Day vifit each Ward, and respectively inquire into the Condition of each Patient, whether the Medicines ordered have been duly taken, and with what Effect; and report the fame, if requisite, to the Physician or Surgeon.

V.

VI.

To be ready to attend at flated Times of Attendance of the Phyficians or Surgeons; and at other Times he fhall not be absent from the Hospital, with-

out

out leaving Word with the Mafter, where he may certainly and foon be found; and the Apothecary and Houfe Pupils, fhall not be abfent at the fame Time. The Apothecary is to be at the Hofpital every Evening by Ten of the Clock at the fartheft; and fhall not lie out without an Order of the Treafurer or Weekly Board.

VII.

On the First Wednesday after every Quarter-Day the Apothe-Account of cary shall lay before the Weekly Board an Account of what Drugs are wanting.

VIII.
