

BY-LAWS

OFTHE

ROYAL COLLEGE

SURGEONS.

I.

THAT this Seal, whereof the Impression is in the Margin, be the Seal of this College, and that it be affixed or appended to all Letters Teftimonial, Certificates, Licenfes, and other public Acts of the College.

Seal.

II.

THAT there shall be four Meetings of the Quarterly Meetings. College in every Year, exclusive of the Meeting appointed by Charter for the Election of Officers, in order to inquire into all Matters which may be deemed of importance to the general State of the College, and the better Regulation of the Profession; and that one of those Meetings shall be held on the first Monday

Monday in February, one on the first Monday in May, one on the first Monday in August, and one on the first Monday in November in every year.

III.

Fines,

THAT if the Prefident or Vice-Prefident (provided he has had timely Notice from the Prefident to attend for him), fhall be abfent from the Court of Examiners, when due Notice has been given by Summons, that any Candidate for Letters Teftimonial or Licenfe is to be examined, he shall be fined the Sum of one Guinea; if any of the Cenfors shall be abfent, Half-a-Guinea each; if the Secretary shall be absent Half-a-Guinea : And if the Prefident or Vice-prefident (provided he has had timely Notice from the Prefident to attend for him) shall be absent from any Court of Assistants, when due Notice has been given by Summons, that any Candidate for Letters Teftimonial or Licenfe is to be examined in confequence of an Appeal from the Court of Examiners, he shall be fined the Sum of one Guinea; if any of the Court of Affiftants shall be absent, Half-a-Guinea each; and if the Secretary shall be absent, Half-a-Guinea .- And if any intended Meeting of the College, when due Notice has been given by Summons, shall be postponed on account of the Non-attendance of the Prefident or Vice-Prefident, (provided he has had timely Notice from the Prefident to attend for him) he shall be fined Half-a-Guinea; if on account of the Nonattendance of a fufficient number of Cenfors, the absent Cenfors shall be fined five Shillings British each ;

each; if on account of the Non-attendance of the Secretary, he shall be fined five Shillings British; and if on account of the Non-attendance of a fufficient Number of the Court of Affiftants or Commonalty, those absent shall be fined Half-a-Crown British each : No excuse to be admitted but Sicknefs or Abfence from Dublin. And no Perfon incurring fuch Fine or Fines to be capable of voting, or executing any Office in the College until they shall be discharged, or remitted, by the respective Courts in which they were incurred

IV.

THAT the Examination of every Candidate for Examination, Letters Teftimonial shall be held in the Prefence of the Members and Licentiates of the College, and that the Secretary shall, by regular Summons, give four Days Notice at least of fuch Examination,

V.

That every Candidate for Letters Teftimonial On two Days. shall be folemnly examined as aforefaid on two feveral Days in Anatomy, Phyfiology, the theory and Practice of Surgery and Surgical Pharmacy.

VI.

THAT every Candidate for Letters Teftimonial Deposite. shall previous to fuch Examination deposite in the Hands of the Treasurer, the Sum of twenty-Guineas; and on his being approved of, make and fubfcribe

fubscribe in the Prefence of the Courts of Examiners, or Affistants in Case of Appeal, the following Declaration, viz.

Declaration.

" I, A. B. do folemnly and fincerely promife, that I will obferve and be obedient to the Statutes, By-Laws and Ordinances of the Royal College of Surgeons in Ireland, and that I will to the utmost of my Power endeavour to promote the Reputation, Honour, and Dignity thereof."

VII.

Appeal.

THAT in all Cafes of Appeal from the Judgment of the Prefident or Vice-Prefident and Cenfors, or Examiners, to the Court of Affiftants, the appeal fhall be lodged with the Prefident, Vice-Prefident or Secretary, within eight Days after Rejection.

VIII.

Ten Guineas THAT every Perfon having attained Letters Tefon Election. timonial shall, on his being elected a Member of the College, pay a further Sum of ten Guineas.

IX.

Examination in Midwifery. THAT the Court of Examiners may alfo Examine in Midwifery any Doctor of Phyfic, or regularly educated Surgeon, who fhall apply for that Purpofe (provided fuch Perfon be not a Fellow or Licentiate of the Royal College of Phyficians in Ireland), and grant to fuch as thall appear duly qualified, fied, a Licenfe to practice Midwifery; and every fuch Perfon unlefs he be a Licentiate of this College fhall previous to fuch Examination, deposite in the Hands of the Treasurer the Sum of ten Guineas; and on his being approved of, make and fubfcribe in the prefence of the Court of Examiners the Declaration fet forth in No. VI.

Х.

THAT every Perfon who fhall be elected a Mem. Oaths. ber of the College fhall, within fix Months after his Election, provided he be within the Kingdom, take the Oath prefcribed by the Charter, or fuch Election fhall be void; and every Perfon who fhall be elected or appointed an Officer, fhall take the Oath prefcribed by the Charter, within one Month after his Election or Appointment, otherwife fuch Election or Appointment fhall be void.

XI,

THAT it shall be lawful for the College to elect Honorary from time to time as honorary Members, fuch Per- Members. fons only, as have eminently diffinguished themselves in the Science of Surgery; and that the Diploma of fuch Election be prefented to them without Expense.

XII.

Deposite,

ber,

ber, or honorary Member, the Secretary shall post up his Name and Addition in some confpicuous Part of the Room of Meeting, and shall give at least four Days notice in the Summonses for the next Meeting, when the College shall proceed to such Election; and if it shall appear that the Majority of the Members then present, have ballotted in his Favour, he shall be declared duly elected.

XIII.

Vice-Prefident. THAT the Prefident shall appoint by Deed or Instrument under his Hand and Seal, a Vice-prefident, within one Month after his election.

XIV.

Frofeffors.

THAT for the better Advancement of the Profeffion, it shall be lawful for the College to elect or appoint a Professor or Professors, who shall annually give a regular Course or Courses of Lectures on Anatomy, Physiology, the Practice and Operations of Surgery, Surgical Pharmacy, and Midwifery.

XV.

Pupils.

THAT no Member or Licentiate of the College, fhall take, as an Apprentice or Pupil, any Perfon who has not been previoufly examined and approved of by the Prefident or Vice-Prefident, and two of the Cenfors; fuch Approbation to be ex preffed preffed by Deed or Instrument under their Hands and Seals respectively.

XVI.

THAT every Perfon fo approved of fhall, on his Registry. paying the Sum of five Guineas, be registered by the Secretary as a Pupil to the College; provided the Member or Licentiate to whom he shall be indented is not then in Arrear of his annual Subfeription.

XVII.

THAT every Member or Licentiate who fhall be Fee. convicted of having taken with an Apprentice or Pupil, whom he is to maintain in his Houfe, a lefs Fee than two Hundred Guineas, or with one whom he is not to maintain in his Houfe, a lefs Fee than one Hundred Guineas; fhall be expelled if a Member, and if a Licentiate his Licenfe withdrawn; and every Member or Licentiate taking an Apprentice or Pupil fhall make and fubfcribe a Declaration upon his Honour, either that he has really and *bona fide* received fuch Fee of two Hundred or one Hundred Guineas, as the Cafe may be, or Value, or that he has not received, nor does he expect to receive, any Fee whatfoever.

XVIII.

THAT if any Member or Licentiate shall be convicted of having more than two Apprentices or Pupils Pupils at one and the fame time without the Permiflion of the College, he fhall be incapable of voting or filling any office.

XİX.

Annual fubfcription. THAT each Member and Licentiate shall pay to the Treasurer yearly one Guinea, towards establishing a Library and defraying the necessary Expenses of the College, until a sufficient fund shall accumulate for those purposes.

XX.

Lift of defaulters.

THAT the Treafurer shall lay before the College at every meeting, a list of fuch Members and Licentiates as shall be in arrear, and that the same shall be publicly read by the Secretary, immediately after the Transcript of the Proceedings of the last meeting has been compared, and signed by the President or Vice-President, and afterwards it shall be possed up in some confpicuous Part of the Public Meeting Room of the College.

XXI.

Penalties.

THAT every Member or Licentiate shall be required to pay his annual Subscription on the first Day of January in every Year, on which Day it shall be deemed to be due, and if he shall neglect so to do, before the next quarterly Meeting, then

then the Treafurer shall give him notice in Writing that he is in arrear, and if he shall, on the fecond quarterly Meeting in May, still neglect or refuse to pay his Subscription, the Name of fuch Member or Licentiate shall be struck out of the List of Members or Licentiates, and not printed in the Almanack or other Public Lift, nor shall he be funtmoned to attend any of the meetings of the College, or Courts of Examiners or Affiftants, or be permitted to vote or discharge any Office, or to register any of his Apprentices as Pupils until the faid arrear be difcharged.

XXII.

THAT for the better maintaining the Honor and Dignity of the Profession of Surgery, no perfon practifing as an Apothecary or Druggist, or keeping a shop in the City of Dublin or the Liberties thereof, shall be admitted a Member or Licentiate of this College, and if fuch Perfon be already a Member he shall upon proof thereof before the College be expelled, if a Lcentiate his Licenfe shall be withdrawn.

XXIII.

THAT every Member, Honorary Member or Li- Confultation. centiate of the College, shall confult with any other Member, Honorary Member, or Licentiate, and whofoever refufes fo to do fhall be liable to fuch Cenfure as the College may think proper to inflict.

Not to confult

THAT no Member, Honorary Member or Licentiate, fhall confult with any Surgeon or Practitioner in Surgery, ufually refident in the City of Dublin, who is not a Member, Honorary Member or Licentiate, of the College ; and any Member, Honorary Member or Licentiate who fhall be convicted of fo doing, fhall for the first offence be cited to appear, and folemnly admonished by the Chairman in full College affembled, and any Member or Honorary Member who fhall be again convicted of fo doing, fhall be expelled; and any Licentiate who fhall be again convicted of fo doing, fhall have his Letters Testimonial or License withdrawn, and be rendered incapable for ever of being elected a Member of the College.

XXV.

Reports.

THAT any Member who shall be convicted before the College of having made a false and corrupt report to a Magistrate of the State of Health of any Person, shall be expelled, and any Licentiate, Shall have his Letters Testimonial withdrawn.

XXVI.

Difputes.

THAT all Professional disputes between the individual Members, Honorary Members, or Licentiates

of the College, shall be fubmitted to the determination of the College.

XXVII.

THAT no Member, Honorary Member, or Li- Accufation. centiate of the College, shall accuse any other Member, Honorary Member or Licentiate, of Malpractice or Mistake out of the College, or give countenance to fuch accufation made by others, under fuch penalty as the College shall think proper to inflict.

XXVIII.

THAT the College shall elect on the first Mon- Secretary. day in January in every Year, or within Ten Days thereafter, or fo often as a vacancy shall happen, by a Majority of Votes, a Register or Secretary.

XXIX.

THAT the College shall also elect on the first Treasurer Monday of January in every Year or within ten Days thereafter, or fo often as a Vacancy shall happen, by a Majority of votes, a Burfar or Treafurer, who shall (provided he undertakes the Office) give Security by Bond and Warrant in the Sum of £,500 for the faithful discharge of the faid Office ; on which Bond no Judgment shall be entered until default, and shall be always in the possession of the President.

WHEREAS it is for the Honor of all Members who may be elected to the feveral Offices of the College that fuch election be by the unbiaffed fuffrages of the Members.

Votes.

THAT any Member who folicits for Votes, or uses any undue Influence to procure his Election, fhall upon Conviction thereof be rendered incapable of filling any Office in the College for the future.

XXXI.

By-Laws.

THAT no By-Law shall be made or repealed, otherwife than in the following manner, viz.

A Motion being duly made, and feconded, the Prefident or Vice Prefident fhall put a Queffion thereon, and if carried in the affirmative it fhall be entered on the Minute Book, and the Secretary fhall on the fame Day put up a Copy of it, in a confpicuous part of the place of Meeting, there to remain for the perufal of the Members until the next Meeting, when the College fhall refolve itfelf into a Committee of the whole College to deliberate on, and amend the faid Motion if they fhall think fit ; and at the next or third Meeting inclusive, it fhall be ratified and confirmed, or rejected.

XXXII.

THAT all the Members shall take their places Places. when the College proceeds to Business, and when any Member speaks, he shall stand up and address himself to the Chairman and the rest shall remain filent.

XXXIII.

THAT when two or more offer to fpeak at the fame time, the Chairman shall determine who shall ^{Spe} speak first.

XXXIV.

THAT the College shall proceed to take the Order or Orders of the Day into Confideration before Order of the Day.

XXXV.

THAT the Chairman only, fhall deliver the Sen- Chairman. timents of the College.

XXXVI.

THAT every Member, Honorary Member and Copy of Char-Licentiate of the College shall be furnished with a ter, Sc. copy of the Charter and of the Code of By-Laws.
