**Finance Committee.**

*Duties :*

The Finance Committee shall, in accordance with the Rules of Order, and with the approval of the Board :

- (a) supervise all the fiscal concerns of the Board and report periodically as to the state of the several funds of the Board,
- (b) prepare and submit to the Board during the month of December in each year a statement of the estimated recurrent income and expenditure of the Board and its Institutions in respect of the next ensuing year,
- (c) prepare and submit to the Board during the month of December in each year a statement of the estimated capital income and expenditure of the Board in respect of the next ensuing year,
- (d) receive at each monthly meeting a statement of the payments effected by the Secretary and Treasurer of the Board during the preceding calendar month, and thereafter report to the Board the total amount of the expenditure in question,
- (e) arrange all investments of moneys held by or funds entrusted to the Board.



- (f) report to the Board at the request of any of the other Standing Committees as to the provision of funds for any object connected with the administration of the Board,
- (g) supervise the collection of all revenue due to the Board and its Institutions,
- (h) be responsible for the control of the Head Office of the Board, and deal with all matters appertaining to the appointment, emoluments, resignation or leave of the Secretary and Treasurer and other officers employed therein,
- (i) invite and deal with all tenders received for annual supplies and services required by the Board,
- (j) arrange all insurance policies, whether in respect of fire, fidelity guarantee, workmen's compensation, or any other risk,
- (k) consider and report upon or conclude, as may be directed, such matters as are specifically referred to them.

## MINUTE OF THE CHAIRMAN

### OF THE BOARD FOR THE YEAR 1922-1923.

---

**A DECADE IN RETROSPECT.**—The issue of this report coincides with the close of the first decade of the administration by the Board of the State-aided hospitals and kindred institutions in the Cape Division. It is natural, therefore, that one should consider the Board's activities retrospectively, and endeavour by comparison to measure what progress has been made. As more than four years of the period under review were the years of the Great War, which altered standards in every department of life, it is difficult, if not impossible, to draw very close and scientific comparisons. This is particularly true with regard to the financial side of the Board's operations.

When first constituted in 1913 the Board was entrusted with the control of seven institutions, namely, Somerset Hospital; Woodstock Hospital; Rondebosch and Mowbray Cottage Hospital; Victoria Hospital, Wynberg; Simon's Town-Kalk Bay Hospital; the Cape Town Free Dispensary; and the Eaton Convalescent Home. Four additional institutions have been established by the Board, namely, McGregor Convalescent Home; Salt River Free Dispensary; Peninsula Maternity Hospital; and the C.H.B. District Nursing Organisation, now comprising seven branches serving areas as widely apart as Cape Town, West London, and Simon's Town. The accommodation available for the treatment of hospital in-patients has been increased in ten years by only 34.08 per cent.; the accommodation for convalescents shows an increase of 59.09 per cent. The average daily number of in-patients treated rose from 287.67 in 1913 to 407.36 in 1922; the corresponding figures in respect of convalescents cared for were 32.23 in 1913 and 51.82 in 1922. The most remarkable expansion has taken place in regard to the treatment of out-patients; attendances of and upon out-patients, which in 1913 numbered 30,788, had increased in 1922 to 78,522.

One of the most interesting comparisons which may be drawn between the years 1913 and 1922 is in respect of the



income from the fees of patients. In the former year a sum of £6,741 accrued from this source. This item of revenue has steadily risen, and the corresponding sum in 1922 was £13,912. In this connection the following comparative table showing the percentage of in-patients and convalescents treated entirely free in 1913 and in 1922 is informative:—

A great advance has been made during the period under review in the conditions under which the members of the nursing staff are housed and rewarded for their services. It has been a settled policy of the Board from the first to improve the housing conditions of their nurses, and a large sum of money has been spent in providing Nurses' Homes at the several hospitals. The pay, leave and conditions of service of nurses generally have been very considerably enhanced under the Nurses' Salaries and Pensions Ordinance of 1918 and its amendments, which have been enacted almost annually since that year.

**MEMBERSHIP OF THE BOARD.**—In February, 1922, the members who retired by effluxion of time were Messrs. A. W. Sawkins and Geo. Smart, Mrs. R. C. Zoutendyk and myself. With the exception of Mr. Smart, we were re-elected. At the first meeting of the reconstituted Board, held on 22nd March, the resignation of Mrs. A. Dale was received. The Board thereupon appointed Mrs. A. Hallack to hold office for two years in succession to Mrs. Dale. At the same meeting, Mr. E. Graham Green was appointed to hold office for three years in succession to Mr. Geo. Smart.

Messrs. A. J. S. Lewis and H. Liberman were re-appointed for three years by the City Council of Cape Town. Mr. S. N. Ponder was reappointed, for the usual term of one year, as joint representative of the Municipalities of Wynberg, Simon's Town and Durbanville, whilst Messrs. I. C. B. de Villiers and J. J. Michau were appointed (for three years) representatives of the Cape Divisional Council.



The representatives on the Board of the Honorary Visiting Medical Officers of Institutions were appointed as follows:—

*Somerset Hospital*: Professor C. F. M. Saint and Dr. J. B. Lester.

*Woodstock Hospital*: Dr. R. Sharp.

*Rondebosch and Mowbray Cottage Hospital*: Dr. M. S. Power.

*Simon's Town-Kalk Bay Hospital*: Dr. T. W. P. Hayes.

In April, Dr. A. R. McLachlan succeeded Dr. M. S. Power.

The Hon. the Administrator reappointed Dr. A. Marius Wilson and appointed Mr. M. C. Vos in the place of the Rev. J. P. van Heerden, who had retired. Subsequently, Mr. Geo. Smart was appointed a member of the Board by the Hon. the Administrator, in succession to Sir Walter Gurney.

**CHAIRMAN AND VICE-CHAIRMAN.**—Notwithstanding my continued absence through illness, the Board did me the honour of reappointing me Chairman. Mr. A. J. S. Lewis was reappointed Vice-Chairman for another year. Upon my return to active duty, at a meeting of the Board held on 26th July, I took the opportunity of thanking the Board for their continued confidence in me, and expressing my gratitude to Mr. Lewis for the excellent service he had rendered as Acting Chairman of the Board.

**HEAD OFFICE PREMISES.**—For some years past, and particularly since the administrative work of the Board was centralised in 1920, consideration has been given from time to time to the question of obtaining more suitable Head Office premises. In March last accommodation was offered to the Board in premises situate in Lower Burg Street. Notwithstanding that the rent was very reasonable and that the premises were reported by the Vice-Chairman and the Secretary and Treasurer to be quite suitable, the Board decided against leasing them. In October the Board renewed for another year the lease of the present premises; at that time attention was again directed to the necessity of securing more commodious and suitable premises. The search for more suit-



able premises continues, but up to the present has not met with success.

**HONORARY MEDICAL SUPERINTENDENTS.**—At the beginning of the year, appointments as Honorary Medical Superintendents were made as follows:—

**PATIENTS REFUSED ADMISSION.**—Reports are still submitted to the Board every month, giving particulars of patients refused admission through lack of accommodation at the several Hospitals. The following is a summary of these returns for the year which ended on 31st December, 1922:

During the year there has been a good deal of controversy as to the value of these figures. Some members of the Board take the view that they exaggerate the insufficiency of the hospital accommodation available, as the same case may be recorded as having been refused at several Institutions and thus vitiate the statistics; others point out, with some show of reason, that the figures actually understate the lack of hospital accommodation, since members of the Board, medical practitioners and others who realise the serious inadequacy of the hospital accommodation in the Peninsula, refrain from recommending many cases which they know cannot possibly be admitted.

**NEW HOSPITAL SCHEME.**—Although the Further Hospital Accommodation Committee have done a great deal of work

during the past year, it would appear that no real progress has been made with the scheme for a new general hospital on the Groote Schuur Estate. The Board have not yet been given possession of the site, a further obstacle having arisen in that connection by the discovery that a municipal water main traverses the land which is to be leased to the Board. Negotiations took place between the University of Cape Town and the City Council with regard to the diversion of this water main, and on 23rd August the Board agreed that half the cost of the diversion would be borne, on their behalf, by the University of Cape Town on condition (a) that the work is done in sections as required, and (b) that the Board will be granted facilities for drawing water from the main for the purpose of the new hospital. In the last Annual Report, presented a year ago, the hope was expressed that a beginning would soon be made with the erection of the first instalment of the maternity hospital block which is part of the main scheme. Working drawings were actually prepared and arrangements made for the invitation of tenders, but the difficulties of securing the site and the balance (£15,000) of the money required to meet the cost of the buildings, have so far proved insuperable. After considering a report from the Further Hospital Accommodation Committee of a discussion which had taken place between that Committee and representatives of the University of Cape Town, the Board affirmed, on 27th September, that in order to attain the end in view, namely, the building of the new general hospital on the approved site at Groote Schuur, they are in favour of approaching the Union Government with a view to obtaining recognition of the fact that the projected hospital will be a South African and not a Cape Town institution, and that, therefore, the project should be subsidised out of Union Government funds. Unfortunately the main interest manifested by the public in the scheme has taken the form of strong objection to the provision in the original lay-out for closing part of the main drive at the Observatory end of the Estate. Repeated representations have been made to the Board regarding this phase of the matter by the several ratepayers' associations in Woodstock, Observatory and Mowbray, as well as by the Streets and Drainage Committee of the City Council. The disagreement is one which appears to be capable of settlement if a spirit of compromise is brought to bear upon it by the Board and the objectors, but until the lease of the hospital site has been signed the Board have no real standing in the matter. In qualification of the foregoing remark that the interest of the public in the provision of a new general hospital has mainly



taken the form of obstruction, it is pleasant to record that during the past year the first contributions in furtherance of the scheme have been received. At the first meeting of the reconstituted Board, held on 23rd March, 1922, it was reported that a donation of £100 had been received from the Estate of the late F. J. Pearce, per Mr. W. H. D. Pearce, M.P.C., and that the Women's Hospital Board of Aid had remitted a sum of £500 earmarked for the furnishing of a ward in the maternity block.

**VICTORIA HOSPITAL, WYNBERG.**—In the last Annual Report it was stated that a scheme involving structural alterations to the buildings of this Institution had been prepared, and that tenders had been received for the execution of the work. The object in view was to provide additional and better accommodation for Coloured women and children. Although the Board had sufficient money in hand to meet the cost of the structural alterations and the equipment of the additional beds, the scheme had to be abandoned owing to the Hon. the Administrator declining to permit any provision to be made on the Estimates for the increased maintenance expenditure which would have resulted if the project had been carried out.

**RADIUM.**—The radium ordered by the Board in 1921, through their London Agents, reached Cape Town on 10th April, 1922. At the following meeting of the Board, the Secretary and Treasurer reported the fact, and stated that the radium had been delivered into the custody of the Resident Medical Superintendent of Somerset Hospital. The total expenditure incurred in this connection, including the purchase price of the radium (57 milligrammes), the platinum tubes to contain the same, and other accessories, was £888 13s. Enquiry was made with a view to the insurance of this radium against loss and theft, but it was found impossible to make any satisfactory arrangements in this connection. On 28th June the Board adopted and put in force the following regulations with regard to the safe-keeping of the radium:

- (a) The radium shall be issued by the Resident Medical Superintendent only to an Honorary Visiting Medical Officer of the Somerset Hospital, and then only upon a written order signed by such Honorary Visiting Medical Officer.



- (b) Except when the radium is in the custody of an Honorary Visiting Medical Officer, as provided by the foregoing rule (a), it shall remain in the custody of the Resident Medical Superintendent, who shall be held responsible for the safe-keeping of the same.

**LIABILITY OF HOSPITAL PATIENTS FOR MEDICAL FEES.—**

The following motion, of which notice had been given by Mr. A. J. S. Lewis, was brought under consideration at a meeting of the Board held on 28th June last:

That in the opinion of this Board an undertaking given by or on behalf of a patient to pay hospital charges at any given rate should not carry with it an obligation to pay in addition fees to his or her medical attendant in hospital; and that the Hon. the Administrator be requested to take the necessary steps for the amendment accordingly of Ordinance No. 5 of 1912, in so far as the institutions controlled by the Cape Hospital Board are concerned.

With the consent of the Board the subject matter of this motion (which was not put to the vote) was referred for report to a Special Committee consisting of Drs. Marius Wilson, Hayes, Sharp, McLachlan and Petersen, the Chairman of the Board and the Chairman of the Finance Committee. At the December meeting of the Board, the whole question of medical fees and accommodation for patients in the Hospitals of the Board was referred to this Special Committee, and Mr. Vos and Dr. Wright were appointed additional members of the Committee.

**HOSPITAL SATURDAY AND OTHER STREET COLLECTIONS.**

Following upon the dissolution of the Women's Hospital Board of Aid, a matter which was dealt with in the last Annual Report, further consideration was given to the question of street collections in aid of the hospitals, and early last year the Board adopted the following recommendations of a Special Committee appointed to report upon the matter:

- (a) That for the present arrangements be made for only one additional street collection; the second may be arranged later, if it is found to be necessary;
- (b) That the ordinary Hospital Saturday street collection be conducted in future on the first Saturday in November, instead of in September as heretofore, and that the additional collection be taken on the first Wednesday in May;



- (c) That the offer of Mrs. H. Stodel to organise the May collection in Cape Town area be accepted;
- (d) That the authority required for making these street collections be obtained by the Board from the Municipal Councils concerned.

Permission was given by the City Council for holding the new mid-week collection on the second instead of the first Wednesday in May, but thanks to the very able efforts of the organisers, Mrs. R. R. Brydone and Mrs. H. Stodel, a sum of over £500 was collected. With regard to the Hospital Saturday collection it was found that permission had been given to the Cape Town-Wynberg General Board of Aid to make a street collection on the first Saturday of every month throughout the year, and notwithstanding that special representations were made to the City Council and the Board of Aid the Hospital Saturday Collection had to take second place, and was accordingly held on the second Saturday in October. The Board decided to make timely application for permission for their two street collections during 1923, and after interviewing His Worship the Mayor of Capetown, a written request was sent to the Town Clerk on 30th October last for the required permission in respect of Wednesday, 2nd May, and Saturday, 3rd November, 1923. Not until 28th December was a reply received from the Town Clerk, and this was a refusal of both the Board's requests on the grounds (1) that permission had already been granted to the Cape Town-Wynberg General Board of Aid to hold collections on the first Saturday in every month during 1923, and (2) that a collection on Wednesday, 2nd May, would immediately precede a monthly collection of the Board of Aid and would prejudice that collection. This decision of the responsible Committee of the City Council was reported to the Board on 24th January, and it was then decided that a deputation consisting of all the members of the Board should wait upon the City Council with a view to having the matter reconsidered and the application of the Board acceded to. It was also resolved that the deputation, in urging the claims of the Hospitals of the Peninsula, should direct particular attention to the history of the Hospital Saturday movement in Cape Town and suburbs, as the Hospital Saturday collection has been an annual one for over twenty years and was the pioneer of street collections in Cape Town. Advice has since been received that the desired permission to interview the City Council has been refused; the deputation has been in-



vited instead to interview the Committee which has already shown itself so unsympathetic to the requests of the Board.

**MOTOR AMBULANCES.**—During the calendar year 1922, 1323 cases (including 59 arising from street accidents) were removed in the Board's ambulances, an average of 110.25 per month. Of this number, 460 were free and 863 were charged for. For some time past the ambulance service has been maintained by means of an Overland car and a Ford car. Quite recently, however, the Board decided to replace the Overland car by another Ford one-ton truck, fitted with an ambulance body, retaining the Overland car as a stand-by vehicle.

**REPAIRS TO BUILDINGS.**—Towards the end of last year when it became evident that there would be considerable savings under certain heads of approved expenditure, the Board decided to seek the consent of the Hon. the Administrator to the application of a sum of about £3000 of such savings to repairs and painting at the several Institutions, and particularly at Somerset Hospital, having regard to the dilapidated condition of the Hospital buildings, which in some places have decayed to such an extent as to become dangerous. The request was submitted by means of a deputation of the Board, but in spite of all the arguments advanced, the Hon. the Administrator refused his consent. When the Estimates for 1923 were adopted at a meeting held on 24th January last, the Board directed that, in the covering letter to be sent to the Provincial Secretary with these Estimates, a request be made for a supplemental estimate of from £10,000 to £12,000 for repairs, renewals, painting, etc., of the buildings of the several Institutions controlled by the Board. It was also decided to suggest that an officer of the Provincial Administration be detailed to inspect the buildings in question with a view to confirming the necessity of this special financial provision, and framing detailed schedules of the repairs, etc., required.

**CLERK OF WORKS.**—As an experiment it was decided to appoint a part-time Clerk of Works to make inspections incidental to all works and proposed works; furnish reports, specifications, estimates and plans, if necessary; and supervise all such works as are put into execution, provided that no individual work to be dealt with under this arrangement shall exceed an estimated cost of £400. Mr. H. Montgomery was appointed to this new office at a remuneration at the rate of £150 per annum, for the period from 1st May until



31st December, 1922, on the understanding that the question of continuing the appointment would be considered when the Estimates for 1923 were being framed. In the Estimates for 1923 recently adopted by the Board no provision has been made for the continuance of this appointment.

**LEAVE OF LADY SUPERINTENDENTS OF CONVALESCENT HOMES.**—As the result of representations made by the Committee of the Convalescent Homes, the Board decided on 26th April of last year that the respective Lady Superintendents and Assistant Lady Superintendents of the Eaton Convalescent Home and the McGregor Convalescent Home would be allowed the same leave privileges as are prescribed for nurses under the Nurses' Salaries and Pensions Ordinances.

**RESIDENT OFFICIAL AT CONVALESCENT HOMES.**—Mr. J. E. F. X. Wyld, of the Head Office staff, was appointed on 2nd May to carry out the duties at the Eaton and McGregor Convalescent Homes at Plumstead, which had previously been performed by the late Mr. W. H. Honour, the free use of the official residence at the Eaton Home being granted to Mr. Wyld in return for these services.

**ACCIDENT CASES TREATED AS OUT-PATIENTS.**—In consequence of the repudiation of certain accounts rendered by Somerset Hospital to employers of injured persons for out-patient treatment at that Institution, the whole question of the treatment as out-patients of accident cases from industrial works, and whether such treatment should be rendered free or be charged for, was reviewed during the past year. On 23rd August last the Board decided that the employer is not liable for medical treatment, and that the individual employee only can be held responsible in the matter. The Board's decision was influenced to some extent by a report from the Committee of Somerset Hospital in which it was stated that if a charge should be insisted upon for the out-patient treatment of such cases there was a possibility of driving away from the Institution very valuable clinical material.

**FREE DISPENSARIES.**—Arising out of certain recommendations submitted by the Committee of the Salt River Free Dispensary with a view to enlarging the scope and improving the work of that Institution, the General Purposes Committee, towards the close of 1921, instituted an enquiry by means of a Sub-Committee into the whole policy of the Board with



regard to Free Dispensaries and out-patient service generally. A detailed report was presented as a result of this enquiry, and was circulated to the Committees of Institutions concerned. After considering the opinions expressed by the Committees in question, the report was amended in certain particulars and was adopted by the Board on 28th June, 1922. The principal recommendations which were embodied in this report were to the effect that greater and better service could be rendered to the public if a properly equipped out-patient department were established at Woodstock Hospital, which is within ten minutes' walk of the present Dispensary premises; the saving in expenditure anticipated as the result of this rearrangement would permit of the Dispensary work now being carried on at Salt River being removed and re-established on a smaller scale in such a locality as to serve most conveniently the area between Salt River and Rosebank, and would also enable a beginning to be made on modest lines with a Dispensary in the Claremont area, the need for which has already been affirmed and reaffirmed by the Board. As a first step towards carrying their new policy into effect, the Board have obtained tenders for the construction at Woodstock Hospital of an out-patient department building, and subject to the consent of the Hon. the Administrator being obtained to the project, have accepted a tender of £1233, which was the lowest received.

**X-RAY EXAMINATION AND TREATMENT.**—Much consideration has been given during the past year to the question of the rules and tariff of charges in respect of the use of X-Ray apparatus at the Board's Hospitals. The matter was initiated by the presentation in April last of a report from the Secretary and Treasurer. In this report the Secretary and Treasurer dealt with the whole policy of the Board in respect of the use of X-Ray apparatus, and submitted the following code of rules which he suggested should be adopted:

- (a) That no special charge be made to any in-patient for the use of the X-Ray apparatus, but that when the charge to be paid to the Hospital in respect of a contributing or paying patient is being assessed, if it is known or can be reasonably inferred that the treatment of the patient will involve the use of the X-Ray apparatus, this factor should be taken into account in assessing the charge to be paid by or on behalf of the patient;



- (b) That in respect of every out-patient not dealt with under the following clause (c), a minimum charge of 10/- be imposed for any X-Ray service; if a person cannot pay 10/-, that person should be treated free;
- (c) A person making application as an out-patient for X-Ray examination or treatment, who is adjudged to be able to pay more than 10/-, must sign the statutory Form of Admission and a declaration [to the effect that the information given in the Form of Admission is true; that application has been made to a private practitioner (named), who has informed the applicant of the amount of his charge which the applicant is unable to pay; and that the applicant is able and willing to pay a fee (stated) for X-Ray treatment or examination at the Hospital, and undertakes to pay that sum for the service], and this declaration must be countersigned by the Resident Medical Superintendent or the Honorary Medical Superintendent, as the case may be. The Admitting Officer will assess the charge to be paid from the information furnished, as is done in the case of an in-patient.

After consulting the Committees of the several Institutions concerned, the Board, on 27th September, decided (a) against the proposal embodied in the report of the Secretary and Treasurer that all special charges to in-patients should be abolished, and directed instead that only in-patients contributing less than 3/6 per diem towards their maintenance in hospital be given X-Ray treatment or examination free of extra charge, and that patients contributing 3/6 or over per diem towards their maintenance in hospital be charged 5/- per X-Ray plate used, with a minimum charge of 10/-; and (b) to adopt the proposals of the Secretary and Treasurer with regard to out-patients.

**RADIOLOGIST FOR SOMERSET HOSPITAL.**—The Committee of Somerset Hospital represented in June last that on account of the great increase of work in the X-Ray Department at that Institution, it was necessary that a radiologist should be appointed to attend there daily, and that he should be paid a salary of not less than £600 per annum. The Board adopted this recommendation, which was endorsed by the General Purposes Committee, but on 27th September the matter came under review, and further consideration of it



was deferred, as a verbal intimation had been received from the Hon. the Administrator that he was not then prepared to sanction the appointment.

#### **CONSENT FORM RESPECTING OPERATION OR TREATMENT.**

After a good deal of discussion the Board, on 24th January, 1923, decided to frame a regulation requiring the following Form of Consent to be signed by or on behalf of every patient admitted to hospital:

Should the Surgeon or Physician in charge of.....  
.....be of opinion that an operation, or  
other treatment is advisable, I hereby give my consent  
for such operation or treatment as may be considered  
necessary by him in the patient's best interest.

(Date)..... (Signature).....

(Witness)..... (Relationship).....

This regulation has not yet been approved by the Hon. the Administrator.

**HOSPITAL PUBLIC LIABILITY INSURANCE.**—On 28th July, 1920, the Board considered the advisability of arranging a policy of hospital public liability insurance under which they would be relieved of their liability to the public for alleged neglect, mismanagement, wrong treatment or professional malpractice on the part of any of the hospital authorities, resident medical staff, honorary visiting staff, nurses or employees. It was decided, however, not to effect such insurance. This matter has recently been revived with the result that the Board have approved of the principle of such insurance, and have made provision of £100 on the Estimates for 1923 to meet the cost in respect of the Hospitals and Convalescent Homes under their control. Quotations and specimen policies are now under consideration.

**CONSTITUTION OF THE BOARD.**—On 26th April 1922, there was submitted to the Board a memorandum from the Acting Provincial Secretary, forwarding a copy of correspondence which had passed between the Hon. the Administrator and Sir Walter Gurney with regard to the resignation of the latter from the Board. In the letter notifying his resignation Sir Walter Gurney had expressed the opinion that the large number of members on the Board militated against effective work, and entailed much waste of time and energy, and he suggested that the Board should be reduced from thirty-six to fifteen members, according to a plan which



he submitted. After some discussion of this proposal a Special Committee was appointed to consider the question of the rearrangement of the Board with a view to reducing the number of members. This Committee comprised Sir Ernest Kilpin, Mr. A. J. S. Lewis, Mr. H. Liberman, Mrs. J. L. Plant, Mr. A. W. Sawkins, Dr. R. Sharp and Mr. M. C. Vos, and the latter was appointed Chairman. The Committee, after holding five meetings, submitted a report on 28th June. In the foreword of this report the Committee stated that at their first meeting they had interpreted the terms of reference from the Board as embracing the question of the constitution and administration of the Board and the Institutions controlled by the Board, and that their deliberations had proceeded throughout in accordance with this interpretation. They submitted the following recommendations, which they reported had been resolved upon "by a majority of three to two":—

- (a) That the Board comprise twenty members elected or appointed as follows:—

- (b) That the powers of the Board be confined to general financial control and to broad questions of policy ;
- (c) That the Committee of an Institution be responsible for the entire administration of the institution and consist of nine members, viz.:—

- (6) Peninsula Maternity Hospital, Cape Town,
- (7) Eaton Convalescent Home, Plumstead, and McGregor Convalescent Home, Plumstead,
- (8) Cape Town Free Dispensary, Cape Town,
- (9) C.H.B. District Nursing Organisation.

In opposition to the far-reaching proposals contained in the Committee's report, Mr. Lewis submitted the following recommendation (which had been defeated at a meeting of the Committee) and moved its adoption :

This Committee recommends (1) that the reduction of the number of members of the Board to fifteen be recommended to the Administrator; (2) the abolition of Institutional Committees; (3) that the supervision of each Institution be undertaken by a sub-committee of three members of the Board (except in the case of Somerset Hospital, which shall be allotted five), to work under regulations approved by the Board.



This motion was seconded by Dr. Sharp, but was not put to the meeting. Objection was also taken to the report on the ground that the original terms of reference from the Board had not been adhered to by the Committee. The Committee's report was finally adopted, (12 voting in favour and 7 against) and was forwarded to the Hon. the Administrator. Mr. Geo. Smart, who had been prevented from attending the June meeting of the Board, wrote a very strong letter of protest when he learned of the Board's decision, and this was also forwarded for the information of the Hon. the Administrator. At a meeting of the Board held on 23rd August, a letter, dated 15th August, in the following terms was submitted from the Provincial Secretary :

Your letter of the 5th instant. The Report referred to, forwarded with your letter of the 3rd ultimo, was submitted "for the information of the Administrator." The letter therefore did not call for a reply.

Since by letter of the 5th instant you ask whether the Administrator intends to take any action with regard to the report, I am directed to state that the occasion for the enquiry resulting in the report seems to have been a statement by Sir Walter Gurney that the number of members of the Board as at present constituted was too large and that it might be reduced without loss of efficiency.

The report, however, deals with matters far beyond that limited range of reference and, though it has been adopted by the Board, its terms are so opposed to the action of the Board antecedent to Ordinance 6 of 1920, on which that Ordinance was to a great extent based, that the Administrator would require the most convincing proof that the reorganisation effected in terms of that Ordinance had failed before he would be prepared to introduce legislation reverting to what would be tantamount to the position of the Board before that Ordinance was passed.

The Board resolved that this communication be recorded, and no further action has been taken in the matter.

#### **ANNUAL MEETINGS OF SUBSCRIBERS TO INSTITUTIONS.—**

The General Purposes Committee transmitted to the Board on 26th May, 1922, a report of the Secretary and Treasurer in which, after quoting specific instances of failure to secure statutory meetings of subscribers for the purposes of electing their representatives to Committees of Institutions, the opinion



was expressed that these annual meetings of subscribers to Institutions had become almost farcical. The Board thereupon directed that this question be referred for consideration and report to the Special Committee on the Constitution of the Board, which had been appointed at the previous meeting. On 28th June the Special Committee in question recommended that in the event of failure to secure the attendance of at least two subscribers at any statutory annual meeting convened in the usual manner by public advertisements, for the purpose of electing subscribers' representatives to the Committee of an Institution, the Board be authorised to proceed to appoint the required representatives as though the vacancies on the Committee were casual vacancies to be dealt with under Section 62 of Ordinance No. 5 of 1912. This recommendation was adopted by the Board but has not yet received the approval of the Hon. the Administrator.

#### **PROVINCIAL SUBSIDY ON ENDOWMENT INVESTMENTS.—**

In adjusting the subsidy payable to the Board in respect of the years 1920 and 1921, the Provincial Administration left out of account subsidy on interest derived from special investments in connection with the endowment of beds. The subsidy claimed in this connection during the years 1920 and 1921 amounted to £221 5s. and £378 15s., respectively. Attention having been called to this omission, the Acting Provincial Secretary replied, on 22nd May, stating that the Provincial Administration was not prepared to pay the subsidy in question as there was no provision therefor under the law, and requesting that the Provincial Secretary's Minute, dated 18th August, 1915, (confirming the ruling upon which the Board's claim was based) should be considered as cancelled. A further communication was addressed to the Provincial Administration on 16th June, pointing out that the ruling conveyed by the memorandum from the Provincial Secretary, dated 18th August, 1915, was the result of a conference which a deputation of the Board had with the Hon. the Administrator on 30th July, 1915, that the position prior to that conference was that the Board had been advised by their Attorneys that under Section 31 of Ordinance No. 5 of 1912, subsidy should be paid on the capital sum of gifts for the endowment of beds; that the Hon. the Administrator having pointed out the difficulty of literal compliance with the terms of the said section of the ordinance, in view of the impossibility of providing in the Provincial Estimates for payment of subsidy on what might be termed windfalls, it was argued on behalf of the Board that the payment of subsidy on such gifts might be deferred until



the succeeding year to enable provision to be made therefor on the Provincial Estimates; that the Hon. the Administrator, however, decided to adopt the expedient of paying subsidy on the interest instead of on the capital, and that the Board accepted this settlement as a fair compromise. Furthermore, it was pointed out to the Provincial Secretary that the arrangement in question was notified to the public in the Annual Report of the Board for the year 1916-1917, and in every succeeding Annual Report, and in accordance with its terms seven beds had been endowed as perpetual free beds, and that the repudiation of the arrangement would, therefore, involve the Board in a breach of trust in respect of every such endowment. Having regard to the circumstances recited, it was urged that an agreement of this nature should not be cancelled except by the Hon. the Administrator personally, and as he was then out of Cape Town, it was suggested that the matter be kept open for submission to him upon his return. A further memorandum dated 24th July, was afterwards received from the Provincial Secretary, stating that the matter has been placed before the Hon. the Administrator, who had ruled as follows:

Regret finances do not allow of any concession. Besides the Limitation of Subsidies Ordinance would prevent anything of this sort.

The Board were unable to admit that there had been any concession to them in this matter; with regard to the other point, it may be observed that the statutory limitation of subsidy referred to was only imposed in 1921, and should not affect the position. It was decided, therefore, on 23rd August, that the ruling of the Hon. the Administrator be interpreted as a temporary suspension of the arrangement confirmed by the Provincial Secretary's memorandum of 18th August, 1915, due to the exigences of the present financial position of the Province, and that the Provincial Secretary be advised to that effect for the information of the Hon. the Administrator. A copy of the report which was adopted by the Board in this connection was sent to the Provincial Secretary, and elicited the following reply, dated 23rd October, 1922:

With reference to your letter of 24th August, 1922, submitting a copy of the Report of the Finance Committee *re* subsidy on interest from endowment investments, I have to inform you that the matter has been



referred to the Administrator, who has given the following ruling:—

I have no objection when finances permit to consider this matter in reference to the future. The Ordinance may have to be amended. To-day no subsidy on this interest can be paid.

Parliamentary action in reference to Provincial finance is responsible for cutting out everything we are not compellable by law to pay.

#### **EARMARKING OF COMMEMORATION BED DONATIONS.—**

The arrangement under which a donation of not less than £100 entitles the donor or donors to have a tablet placed over a bed to commemorate the special occasion which has prompted the gift was taken over from Somerset Hospital in 1915, and applied to all the Hospitals controlled by the Board, and following the rule which had been in operation at Somerset Hospital, the money received in this manner was credited to general revenue. However, on 26th July, 1922, after considering a report on the subject from the Finance Committee, the Board approved of the alteration of this arrangement to permit of the earmarking of such a donation for an approved purpose in connection with the Institution selected by the donor, in addition to allowing the donor to have a commemoration tablet placed over a bed or cot.

**DONATIONS FROM THE ESTATE OF THE LATE J. C. HOFMEYR.**—A sum of £1,980 was remitted by the Secretary of the Colonial Orphan Chamber and Trust Company, with a covering letter, dated 15th May, 1922, stating that this sum comprised the following donations from the charitable fund of the Estate of the late J. C. Hofmeyr, and that it was desired that the money should be allocated towards some specially urgent need in each Institution:—

The receipt of these donations was reported to the Board on 26th May, and it was resolved that cordial thanks be con-



veyed to the Colonial Orphan Chamber and Trust Company, and to those who had acted in the matter by influencing the distribution in favour of the Hospitals and kindred Institutions controlled by the Board. These contributions have been of great advantage to the Institutions concerned, and have enabled the Board to provide equipment, etc., which could not have been purchased in the ordinary way, on account of the restriction of the Board's Estimates of Expenditure.

**SOUTH AFRICAN MILITARY NURSING SERVICE.**—A circular dated 30th May, in the following terms, was received from the Acting Provincial Secretary with regard to the formation of a South African Military Nursing Service:—

The Department of Defence has decided to establish a reserve of Nurses, to be styled "The South African Military Nursing Service," who will be liable to be called up in time of War or National emergency.

The trained establishment will consist of one Matron-in-Chief, 12 Matrons, 50 Nursing Sisters and 200 Staff Nurses, and the Defence Department desires to bring the establishment up to full strength as soon as possible.

In order that the scheme may be a success, it is imperative that a proportion of the service should consist of Nurses fully qualified and fresh from nursing work, and, accordingly, it is desirable that a percentage of Nurses should be drawn from the Civil Hospitals.

The Defence Nursing Council has recommended that 20 per cent of the trained Staff of each Civil Hospital should, if possible, be enrolled, on the understanding that not more than 10 per cent. would ever be called upon at the same time.

The Defence Nursing Council feels that in a National emergency the large Civil Hospitals should be able to spare 10 per cent. of their trained Nursing Staffs but it should be emphasised that the Regulations provide that in the case of members employed in a public Hospital, they shall not be called upon for service except after consultation with the governing body of such Hospital. The Matron-in-Chief proposes communicating direct with the Matrons of State-aided Hospitals to solicit aid in obtaining recruits among the Nursing Staffs.

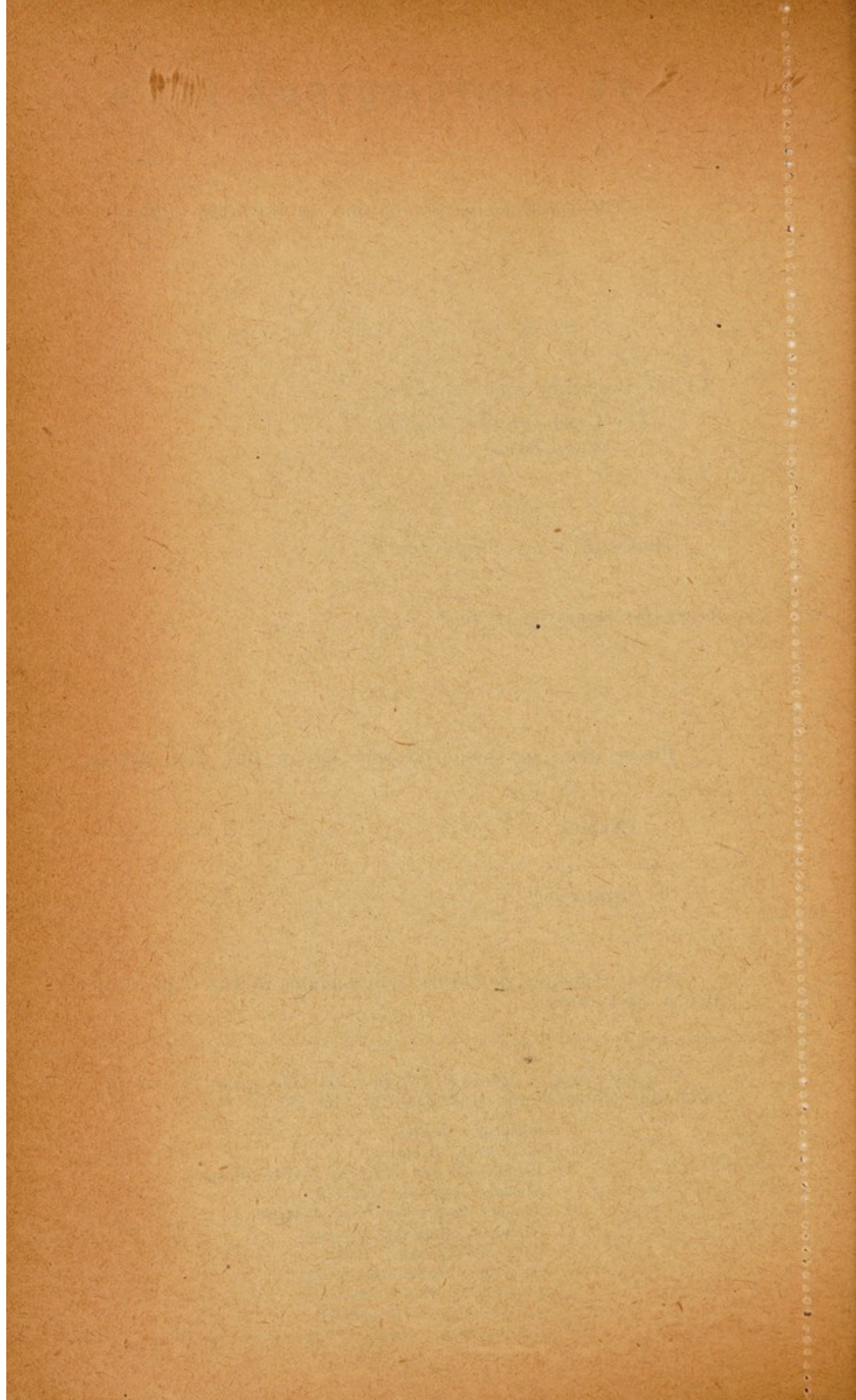

It will be seen from the foregoing that the Hospital will be fully protected: only 20 per cent. of the staff is to be allowed to enrol and only 10 per cent. is to be called upon at any one time and then only after consultation with the Board.

In these circumstances the Administrator trusts that the Board will do all in its power in the interests of this important national work to encourage the required number of its nurses to enrol in the South African Military Nursing Service.

This communication was circulated to the Committee of each general hospital controlled by the Board for their consideration, and it was ascertained that all of these committees approved of the principle of the formation of a South African Military Nursing Service. The Committee of Somerset Hospital rightly added the proviso that the regulations and conditions governing such a nursing service must be satisfactory to the nurses concerned and to the Board. On 27th December, 1922, the Board approved of the proposals contained in the Acting Provincial Secretary's letter already quoted, subject to the necessary safeguards being provided to ensure efficient nursing service in the hospitals of the Board in time of war or national emergency when those nurses enrolled in the Military Nursing Service are liable to be called upon.

#### **APPOINTMENTS TO THE CERTIFICATED NURSING STAFF.**

In July last, the whole question of the making of appointments to the certificated nursing staff of the several institutions was brought under consideration, with the result that the Board decided that the principle of the unity of the Hospital Board service should be established, and that, other things being equal, preference should be given to those nurses who had been trained in the Board's Hospitals. In order to attain these objects the following rules were adopted:

- (a) That all appointments of Staff Nurse or Sister vacant or about to become vacant be notified to the Secretary of the Board, in order that he may circulate the information to all the institutions of the Board at which certificated nurses are employed;
- (b) That an opportunity be given to every nurse who secures the Colonial Medical Council certificate after training in a Hospital of the Board, and whose services are not thereafter retained by the Board, to register her name and address in the Head Office of



the Board, in order that any appointment falling vacant which she can legally hold may be notified to her, to enable her to make application for the same in competition with any other candidates already in the service of the Board;

- (c) That if no suitable candidate is obtained by either of these methods, the appointment be then advertised in the newspapers.

**COOKING TUITION TO NURSE-PROBATIONERS.**—In May of last year arrangements were made for expert lectures and demonstrations in cookery to be given to the nurse-probationers at Somerset Hospital by a teacher from the Cape Town School of Domestic Science. On 25th October it was reported to the Board that this experimental course had yielded very satisfactory results, and it was then decided that the arrangement be continued, and that the necessary equipment for conducting the classes (which until then had been lent by the School of Domestic Science) be purchased. The arrangement has since been extended to the Victoria Hospital, Wynberg, at the request of the Committee of that institution.

**INOCULATION OF NURSE-PROBATIONERS AGAINST ENTERIC FEVER.**—Arising out of a proposal made by the Committee of Woodstock Hospital that all nurse-probationers should be inoculated against enteric fever before entering the service of a hospital, a report on this matter was obtained from the Committee of each of the general hospitals controlled by the Board. In view of the diversity of practice and the differences of opinion disclosed in these reports, the Board decided on 27th September that the question of the inoculation of nurse-probationers against enteric fever be a matter of voluntary arrangement between the nurse-probationer and the Institution to which she is admitted for her training.

**NURSES' PRIZE SCHEME.**—At the Colonial Medical Council examinations held in June last for certificates in nursing and midwifery, candidates submitted themselves as follows from the institutions controlled by the Board: Somerset Hospital, 6; Woodstock Hospital, 4; Peninsula Maternity Hospital, 10. All the candidates were successful in obtaining certificates. The following awards were made under the Board's prize scheme for nurses:—



Miss A. H. Halliday (Somerset Hospital), 1st Prize, £5.  
Miss Louise Dreyer (Woodstock Hospital), 2nd Prize, £3.  
Miss E. W. Uijs (Somerset Hospital), 3rd Prize, £2.

In order of merit in the examination list for the Province they were placed respectively first (bracketed), fifth, and twenty-third (bracketed with three others). The prize of £2 10s. awarded half-yearly to the most successful candidate amongst the pupil-midwives trained at the Peninsula Maternity Hospital was awarded to Miss F. E. D. Hazell, who was bracketed with two others for fourth place in the midwifery examination list for the Province.

At the December examination candidates entered as follows: Somerset Hospital, 10; Rondebosch and Mowbray Cottage Hospital, 2; Victoria Hospital, Wynberg, 5; Peninsula Maternity Hospital, 8. With one exception these candidates were successful. The following awards were accordingly made under the Board's prize scheme:—

In order of merit in the examination list for the Province they were placed respectively first (bracketed), seventh, and eleventh (bracketed). The prize of £2 10s. awarded to the most successful pupil-midwife trained at the Peninsula Maternity Hospital was gained on this occasion by Miss A. D. du Toit, who took fourth place in the midwifery examination list for the Province.

**HOSPITAL ADMISSION FORMS MAY BE SIGNED BY DISTRICT NURSES.**—At the December meeting the Board approved, under Section 56 (1) of Ordinance No. 5 of 1912, of District Nurses in the service of the Board being authorised to countersign the statutory Form of Admission to hospital.

**FIRE PROTECTION OF BUILDINGS.**—On 28th June last, the Buildings, Grounds and Equipment Committee reported that they had considered the question of the fire protection of the Board's buildings, and through the courtesy of His Worship the Mayor of Cape Town had obtained a comprehensive report on the matter from the Chief Officer of the Fire Brigade. Tenders had then been obtained for the fire extinc-teurs, hose and other appliances recommended in this report, and estimates



had been prepared by the Clerk of Works of the cost of the suggested structural alterations to building, including a fire-proof stair at Somerset Hospital, and the substitution of galvanised iron for thatch on certain roofs at the Victoria Hospital, Wynberg, and the Eaton Convalescent Home. The total expenditure involved amounted to a sum of £2059 0s. 8d., which included an item of £428 8s. for 84 "Minimax" extincteurs. Subsequently the Board agreed to the purchase of the fire extincteurs out of the savings effected under other heads of approved expenditure in respect of the year 1922, and these appliances have now been installed throughout the Board's Institutions. No action, however, has been taken with regard to the other recommendations submitted by the Chief Officer of the Fire Brigade.

**INCOME AND EXPENDITURE.**—The Board's difficulties during the past year in regard to ways and means were, as might have been expected, greatly aggravated by the prevailing financial stringency. Under the Payment of Subsidies Ordinance, the provisions of which were re-enacted last year, the subsidy payable by the Provincial Administration for 1922 was limited to the amount payable in respect to 1921. This meant, in effect, that the spending powers of the Board during 1922 were limited by the actual expenditure of the previous year, and, moreover, were dependent upon the amount of subsidy earned; that is to say, if the revenue from voluntary contributions and patients' fees fell below the yield of 1921, the expenditure would have to be correspondingly reduced. It should be noted that whereas, in former years, a deficit which might result from a shortfall in ordinary revenue would have been shared in equal proportions by the Local Authorities and the Provincial Administration, such a method of adjustment was no longer possible in 1922. The Board budgeted for approximately the same income and expenditure in 1922 as in 1921, and it is satisfactory to place on record that as the result of careful buying and exercising the strictest economy in all directions a nett saving of £4786 on the estimated expenditure was effected, whilst in spite of the hard times the revenue (apart from Local Government contributions and Provincial subsidy) was £1442 more than had been anticipated.

The position in regard to the payment of advances against Provincial subsidy is not so satisfactory, however. During part of the year, as the result of the non-payment of such advances, the Board's banking accounts became over-



drawn, in spite of the fact that, in order to keep the charges for overdraft interest as low as possible, a large credit balance belonging to Funds Account, which should properly have been invested, was left on current account. The interest paid on the overdraft, and the interest lost through the non-investment of the funds referred to, amounted together to approximately £700. Representations regarding this matter were made to the Hon. the Administrator on several occasions, the Board taking the view that as the overdraft had resulted from the inability of the Provincial Administration to make advances in respect of subsidy earned, the interest charges incurred should be a direct charge to the Administration, and should not be borne by the Board, but after a prolonged correspondence, and notwithstanding several deputations to the Hon. the Administrator regarding the matter, no relief has been obtained. The position taken up by the Provincial Administration is that the making of advances against subsidy is not obligatory, and that it would be illegal for the Provincial Administration to pay interest charges on an overdraft; at a meeting held on 22nd November the Board placed on record an expression of their dissatisfaction with that attitude.

**PROVINCIAL FINANCES COMMISSION.**—A Special Committee, consisting of the Chairman of the Board and the respective Chairmen of the three Standing Committees, was appointed by the Board on 22nd November last to arrange for the giving of evidence before the Provincial Finances Commission. This Committee reported at the December meeting of the Board that they had appointed the Secretary and Treasurer and myself to give evidence on behalf of the Board, with particular regard to the governance of Hospitals by the Provincial Administration. We gave evidence on 15th December, 1922, and since then a mass of information has been furnished to the Commission with regard to the transactions and the income and expenditure of the Board since it was constituted in 1913.

**OBITUARY.**—When the Board met on 26th April last year, the Vice-Chairman made reference to the deaths of Mr. Thomas Ball, Mr. Brown Lawrence and Mr. W. H. Honour.

Mr. Thomas Ball, C.M.G., died on 26th March, 1922. He was first elected to the Board of Management of the Somerset Hospital in November, 1903, and served on that Board until the Institution came under the Cape Hospital Board in 1913. Mr. Ball was one of the original members



of the Cape Hospital Board. He was also a member of the Committee of Management of Somerset Hospital until 1920, and was Chairman of that Committee during the years 1917, 1918 and 1919.

Mr. Brown Lawrence also died on 26th March, 1922. Although he was never a member of the Hospital Board, he was closely associated with the work of the Hospitals through his late wife, whose death in England was reported to the Board on 22nd June, 1921. Through their joint generosity, the Shipley Pavilion at Somerset Hospital for eye, ear and throat cases was equipped, and the Brown Lawrence Ward in that building commemorates their gift.

Mr. Walter Henry Honour was part-time Secretary of the Convalescent Homes from October, 1918, to 31st July, 1920, and was transferred to the Head Office staff on 1st August, 1920. He died suddenly in the grounds of the Eaton Convalescent Home on 24th April, 1922.

The Board directed that their sincere sympathy should be extended to the bereaved relatives in each case.

On 28th June, the Vice-Chairman reported to the Board that news had been received since the previous meeting of the death on 29th April at Bloomfield, New Jersey, U.S.A., of Mr. Polhemus Lyon, the first Chairman of the Board. Mr. Lyon was a member of the old Board of Somerset Hospital, and was Chairman of that body during the year 1912-1913. When the Cape Hospital Board was constituted in the latter year, Mr. Lyon was appointed Chairman of the Board and held office for two years. He remained a member of the Board until March, 1917, when he returned to America. The following resolution was adopted and transmitted to Mrs. Lyon:

That there be placed on record in the Minutes of the Board an expression of the Board's sorrow at the death of Mr. Lyon, and that a message of sympathy be conveyed to the bereaved widow.

Another death fell to be recorded at the same meeting. Mr. W. I. Perrott, B.A., died suddenly from pneumonia on 21st June, at his home in Newlands. The late Mr. Perrott was associated with the work of the Board for some years when he held the positions of Secretary to the Capetown Free Dispensary and the Woodstock Hospital. He was a loyal and efficient officer of these Institutions, and was held in much



esteem by all who came into contact with him. The following resolution was recorded in this connection :

That the Board express their sincere regret at the untimely death of Mr. W. I. Perrott, and direct that an expression of their sorrow be transmitted to the bereaved relatives.

On 26th July, 1922, reference was made to the loss sustained by one of the members of the Board, Mr. W. D. Hare, whose daughter, Phyllis, died on 13th July. A vote of condolence was passed by the Board and a message of sympathy was conveyed to the sorrowing parents.

At a meeting of the Board held on 27th September, 1922, the Vice-Chairman, who presided in my absence, made obituary references as follows :

I know the members of the Board will regret to learn the reason of the Chairman's absence to-day. Mrs. S. J. Eaton, Mr. East's mother-in-law, died this morning. The sympathy of the Board will go out in special measure to Mr. East and the other bereaved relatives, not only because of the personal regard in which the Chairman is held, but because of the close association of the name of Eaton, and those who bear that name, with one of the branches of the work of the Board. It is exactly 27 years ago this month since the Eaton Convalescent Home at Plumstead was established through the munificence of the late Mr. C. R. Eaton, whose widow's death is mourned to-day, and Mr. East and his brother-in-law, Mr. W. A. Eaton, have continued up to the present day to identify themselves with that useful Institution. I beg leave to move :

That the Board, having learned of the death to-day of Mrs. S. J. Eaton, of Cape Town, hereby resolve to record their profound sorrow, and to tender their respectful sympathy to Mr. H. F. East (the Chairman of the Board), Mrs. East, and the other members of the family of the deceased lady in the bereavement which has fallen upon them.

A few months ago the death of the first Chairman of the Board (Mr. Polhemus Lyon) was reported to you. Since the last meeting another of the original members of the Board has been removed by death. Major Sidney Cowper, C.M.G., J.P., joined the Board in 1913 as the



first representative of the Wynberg Municipality. Early in that year, when the standing committees of the Board were first constituted, the late Major Cowper was appointed Chairman of the Buildings, Grounds and Equipment Committee, and took a prominent part in those important and difficult tasks of organisation and correlation of the work of the several Institutions, which it fell to the Board to accomplish. After he left the Board he devoted more and more of his time to the municipal affairs of Wynberg, and was Mayor of that town for a long term of years. He died on 5th September, leaving behind him a record of long and honourable public service. I beg leave to move as follows:

That an expression of the deep regret of the Board be recorded upon the death of Major Sidney Cowper, C.M.G., J.P., which took place on 5th September, 1922, and that the sincere sympathy of the Board be conveyed to Mrs. Cowper and the bereaved family.

It is also my sad duty at this meeting to refer to the loss sustained by one of our members, Mr. A. H. Oxenham, in the death, on 30th August last, of his niece and adopted daughter, Miss Doris Oxenham. I beg leave to move:

That the sincere sympathy of the Board be extended to Mr. and Mrs. Oxenham in the bereavement they have suffered through the death of their adopted daughter.

The motions were adopted in silence, the members rising in their places.

**ACKNOWLEDGMENTS.**—I gladly take this opportunity of expressing my thanks to my colleagues on the Board for the assistance they have given me during the past year. My gratitude is due in special measure to Mr. A. J. S. Lewis, who, as Vice-Chairman of the Board and Chairman of the General Purposes Committee and of the Further Hospital Accommodation Committee, has carried a heavy load of responsibility and been unremitting in his service to the Board. Mr. H. Liberman and Mr. A. W. Sawkins, as Chairmen respectively of the Finance Committee and the Buildings, Grounds and Equipment Committee, have also earned special thanks. I also acknowledge gratefully the continued assistance I have received from the Secretary and Treasurer of the Board and the other members of the staff.



It is fitting that the thanks of the Board should be expressed to the Committees of the several Institutions, and to the organisers of the Hospital Ball, the Hospital Saturday Collection, and the additional Street Collection, as well as to those ladies who have continued the work of house-to-house collecting since the Women's Hospital Board of Aid was dissolved.

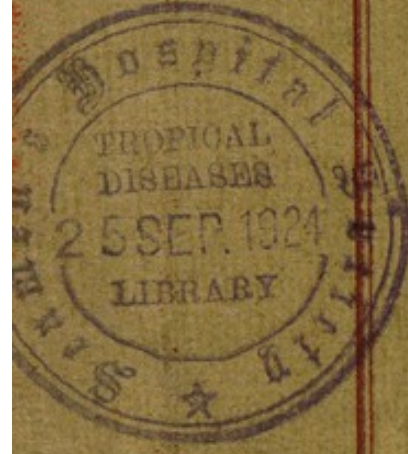


## FORMS OF ADMISSION TO HOSPITALS
