REPORT OF PROCEEDINGS AT THE FORTY-SIXTH ANNUAL GENERAL MEETING.

The Forty-sixth Annual General Meeting was held in the Recreation Hall at the Hospital on Wednesday, the 15th day of March, 1939, at 7.30 p.m., when there were present :—

Wright, J. R. Guest, A. Cooper, T. Share, J. H. Williams, R. N. Lee, G. Shaw, C. Alexander, A. Dunn, J. Hickman and B. Smith.

Sir Sidney Law referred in sympathetic terms to the great loss which the hospital had sustained by reason of the death of Dr. A. J. Collis, who he said was always willing to do anything, however large or small, for the welfare of the Hospital.

It was resolved : That an expression of sympathy be conveyed to Mrs. Collis and the members of the family. This was carried in silence.

The Minutes of the last Annual Meeting having been printed and circulated among the Subscribers and Governors were confirmed and signed.

The Report of the Board of Management for the past year was taken as read and the Report of the Finance Committee together with the Statement of Accounts and Balance Sheet were read and explained by the Chairman.

It was proposed by the Chairman, seconded by Mr. J. M. Standish and resolved : That the Report and Accounts be adopted and confirmed.

It was proposed by Major W. Harcourt Webb, seconded by Mr. J. H. Mees and resolved : That the Right Hon. Viscount Cobham be re-elected President.

It was proposed by Mr. W. H. Hill, seconded by Mr. L. Cartwright and resolved : That Mr. E. D. Trow be re-elected Hon. Treasurer for the ensuing year and that a vote of thanks be accorded him for his past services.

It was proposed by Mr. W. J. Hill, seconded by Mr. A. Hodgetts and resolved : That the following gentlemen be elected Members of the Board of Management to fill the vacancies on that body caused by retiring Members : Messrs. A. Cooper, F. L. Law, J. R. Guest, C. Roberts, F. H. Stuart and A. J. Skelding.

It was proposed by Mr. L. Cartwright, seconded by Mr. W. Wright and resolved : That Messrs. Gough and Wright be re-elected Hon. Auditors and that a vote of thanks be given them for their past services.

Mr. J. H. Mees referred to the death of Mr. G. F. James who he said had always had a great interest in the Hospital and had drawn up the Constitution when the Hospital was founded.

It was proposed by Mr. J. H. Mees, seconded by Mr. A. J. Skelding and resolved : That in future the accounts of the Hospital be closed on December 31st instead of June 30th.

It was proposed by Mr. E. D. Trow, seconded by Mr. W. Pearson and resolved : That a very hearty vote of thanks be accorded the Honorary Medical Officers for their valuable services to the Hospital.

It was proposed by Mr. C. Roberts, seconded by Mr. F. J. Moreton and resolved : That a vote of thanks be passed to the Matron and Staff for their valuable services.

It was proposed by Mr. G. Davis, seconded by Mr. L. A. Watson and resolved : That a vote of thanks be passed to the Board of Management.

It was proposed by Mr. J. M. Standish, seconded by Mr. C. Roberts and resolved : That a cordial vote of thanks be accorded the Workpeople's Committee, The Carnival and Friendly Societies of Wordsley, Cradley, Brierley Hill, Lye and Wollescote, Quarry Bank, Kingswinford and Wall Heath, the Annual Subscribers, the Fetes Committee, Major W. Harcourt Webb, Mr. Norman Webb, Mr. T. L. Tibbetts, The Stourbridge Fire Brigade, the various Churches, the Hospital Sunday Funds of Stourbridge and Brierley Hill, the Linen Fund Committee, Late Patients, the Egg Collection Committees of Stourbridge and Quarry Bank, Mr. Terah Share, The Co-operative Guild for their gift of Chairs, all those organisations and individuals who have contributed towards the Hospital through the medium of the Voluntary Association, especially the Corbett Hospital Ball Committee, Stourbridge Round Table, Stourbridge Amateur Operatic Society, the Rose Day Collection, the Mayor's Appeal, the Midland Red 'Bus Co., Stourbridge Players, and to the numerous donors of useful gifts which have been received during the year.

A vote of thanks to the Chairman which was proposed by Mr. W. Pearson, seconded by Mr. F. L. Law, and carried with acclamation, brought the meeting to a close.

Report of Board of Management

The Board of Management has pleasure in presenting their Forty-seventh Report on the activity of the Hospital during the past eighteen months. The British Hospitals Association desiring to bring all Hospitals into line regarding a uniform date for the termination of the financial year, it will be observed that the Report and Statement of Accounts cover a period of eighteen months ending 31st December, 1939.

At the April Meeting Sir Sidney Law was again unanimously re-elected Chairman of the Board and Mr. J. M. Standish was also unanimously re-elected Vice-Chairman.

The Finance Committee with the addition of Mr. J. R. Guest.

The House Committee with the addition of Major W. Harcourt Webb and Mr. F. H. Stuart.

The Building Committee with the addition of Mr. L. Cartwright.

The Co-ordination Committee, *en bloc*.

The Medical Committee, *en bloc*.

The following members were re-elected representatives of the Board of Governors on the Contributory Fund Committee :— Sir Sidney Law, Mr. J. H. Mees, Mr. J. Wright, Major W. Harcourt Webb and Dr. A. R. Sharrod.

It is with the deepest regret your Board report the deaths of the following friends who had been very closely connected with the work of the Hospital for many years :

In March, 1939, Dr. A. J. Collis who was a Trustee, a Member of the Board since 1927 and Chairman of the House Committee for a number of years. Dr. Collis had considerable Hospital administrative experience during the Great War which contributed greatly to the adoption of many suggestions which added to the efficiency of the Hospital. Dr. Collis was the son of Mr. W. B. Collis, a former Chairman of the Board of Governors.

In August, 1939, Lady Law, wife of the Chairman of the Board, who always took a great interest in the welfare of the Hospital and was an active member of the Ladies Committee for many years. She assisted Sir Sidney to carry out the additional heavy responsibilities of a greatly extending Hospital, and her many kindnesses to patients will ever be remembered.

In November 1939, Mr. Naughton Dunn the Honorary Orthopaedic Surgeon since the establishment of the Department in 1932. The interest of Mr. Dunn helped considerably to build up what is to-day one of the most efficient departments of the Hospital.

Presidency.—Owing to Lord Cobham's appointment as Under Secretary of State for War he expressed a desire to be relieved of the Presidency of the Hospital on account of the extra time he would now be called upon to give in that office. Although the Board were very sorry to learn of Lord Cobham's request they felt they ought to comply with his wishes as undoubtedly his appointment in the Ministry would involve a tremendous amount of work. In accepting Lord Cobham's resignation your Board referred to the long association of Lord Cobham's family with the Hospital and expressed their most grateful thanks for his work and interest. As the appointment of President is constitutionally the business of the Annual Meeting the vacancy will be filled at such Meeting.

New Trustees.—In acknowledgment of their great service to the Hospital the following were elected Trustees to fill the vacancies on that body:—Messrs. L. Cartwright, C. Roberts and E. D. Trow.

Special Gifts.—In September 1938 a small Committee very energetically set out to raise a fund to provide an "Iron Lung" for the use of the Hospital and the surrounding district. As will be seen from page 24, the response was particularly gratifying and not only was the Iron Lung purchased but other valuable apparatus. Your Board wish to record their thanks and sincere appreciation of the work done by Mr. E. T. Ison who was Chairman of the Committee and also to the members, everyone of whom worked so ardently. Your Board also thank every individual and organisation who subscribed or in any way assisted to make the effort such a huge success.

Honorary Medical Staff. Once again your Board wish to record their high appreciation of the services rendered to the Hospital by Members of the Honorary Medical and Surgical Staff. The work of the past eighteen months has shown a steady increase in most departments and this is again an evidence of the growing efficiency of the Hospital.

At the outbreak of hostilities the Honorary Staff lost the services of Dr. Ernest Bulmer, the Honorary Visiting Physician and Mr. R. D. Weeden Butler the Ophthalmic Surgeon, both of whom are now serving as Majors in the R.A.M.C. Fortunately the Board were able to obtain the services of Dr. W. Carey Smallwood, M.D., M.R.C.P., and Dr. Jean Strang, M.B., Ch.B., to act as their deputies respectively. As Mr. Hugh Donovan had expressed the wish to be relieved of his appointment as Honorary Visiting Surgeon owing to pressure of circumstances the Board appointed for the duration of the War, Mr. J. W. Riddoch, M.C., M.B., Ch.B., F.R.C.S., a Member of the Staff of the Midland Hospital, Birmingham.

It is with great pleasure that the Board report the appointment of Mr. A. M. Hendry, F.R.C.S. as Orthopaedic Surgeon in succession to the late Mr. Naughton Dunn. From the inception of the Orthopaedic Department in 1932 Mr. Hendry acted as Deputy for Mr. Naughton Dunn, and the Board extend their thanks to him for the tremendous amount of work he did in that capacity.

Miss Helen Gifford, M.B., Ch.B., M.R.C.S., L.R.C.P. was appointed an Honorary Anaesthetist owing to the increasing demands being made on the other Members of that Staff.

Chaplaincy. The Board having decided to appoint a Chaplain to the Hospital, the Reverend Canon M. S. Newland, M.A., R.D., was appointed. To Canon Newland and his Assistants, your Board desire to express their sincere appreciation for the kind interest they have shown to the patients.

Nursing Staff. Your Board desire to place on record their thanks and appreciation to the Matron, Members of the Nursing, Household and other sections of the Staff for their services during the past period and offer their heartiest congratulations to the following Nurses who were successful in the Final Examination of the General Nursing Council:—

As a result of the continued exertions on the part of the Contributory Fund Committee, the Divisional Committees, and the Honorary Collectors there has been a very marked increase in the number of contributors and the total income amounted to £16,014 7s. 7d. The amount contributed by the Employers also increased but your Board again earnestly appeal to more Employers to add a percentage to the contributions made by

their employees. Your Board record their high appreciation of the efforts of the Chairman, Members of the Committee, the Workpeople and the Employers and extend their sincere thanks to them for their magnificent contribution.

The Board again stress that all persons employed in the area served by the Hospital should become members of the Corbett Hospital Contributory Fund, particulars of which may be obtained from the Secretary or any authorised Collector.

Annual Subscribers. It is with pleasure that your Board report a further increase in the number of Annual Subscribers and wish to tender their thanks.

Attention is drawn to the arrangements allowed under the Finance Act whereby the Hospital is able to recover Income Tax on subscriptions and the Board appeal to Annual Subscribers to utilise the form on page 15, and so help to increase the income of the Hospital.

Laboratory. In November, 1938, the Board decided to improve the Laboratory facilities and appointed a skilled Laboratory Technician under the Directorship of Dr. Ernest Bulmer. The appointment has proved to be a great asset to the efficiency of the Hospital services and it is now possible for the greater part of the pathological work to be carried out in the Hospital.

Blood Transfusion Service. Prior to the state of emergency an appeal was made for volunteers with a view to forming a Blood Transfusion Service covering the whole area served by the Hospital. As a result of the various forms of appeal over 500 people quickly responded, some specifically for the duration of hostilities and some for all time, so that a permanent service would be available. All volunteers have been grouped and an approved system of recording is in force. The kindly assistance of Members of the Stourbridge Round Table and Rotary Club is gratefully acknowledged. Mr. Eric Fiddian of Littlewych, Pedmore, was appointed as Honorary Secretary of the Service and he would be pleased to receive lists of names of those who would be willing to volunteer.

Extensions. In the early part of last year your Building Committee went very carefully into the position of certain departments which were still being housed in the original buildings. They came to the conclusion that an immediate effort should be made with a view to the new Hospital being completed. Arising out of that decision a private appeal was launched by Members of the Building Committee on August 1st, but was unfortunately interrupted by reason of the outbreak of War on September 3rd. During that short period there were many gifts received and promised, but the Board could not possibly have proceeded with the matter in view of the adverse circumstances then prevailing. The gifts received and promised are greatly appreciated by your Board and their thanks are again tendered to the donors.

Although it may not be possible for the plans then envisaged to be proceeded with in the immediate future, your Board may find it necessary to proceed with certain improvements.

General. The Board offer sincere thanks to the General Practitioners throughout the district for their continued co-operation and to the Press who have been most helpful in bringing to the notice of the Public interesting news on the activity of the Hospital. Numerous gifts of fruit, vegetables, eggs, flowers, clothing, books, toys, etc., have been received from friends of the Hospital, and to all these donors your Board tender their best thanks.

The Board also sincerely appreciate the offers of services to the Hospital in connection with the outbreak of War.

Report of the Finance Committee.

Your Finance Committee have pleasure in presenting to the Governors and Subscribers their Report for the eighteen months ending 31st December, 1939. For this period, the accounts have been prepared on the "Revised Uniform System of Accounts" as approved by the British Hospitals Association. In view of this alteration in the accounting system comparative figures are not shown.

Your Committee have continued to exercise vigilant control of all expenditure. Although during the past six months the cost of every article and commodity has steadily increased in price, your Committee are pleased to state there was an excess of income over expenditure amounting to £2,991 13s. od. This has been appropriated to reduce the accumulated deficit of £5,037 11s. 9d., **but still leaves an adverse balance of £2,045 18s. 9d.**

The most outstanding item of income is again that from the Contributory Fund and shows another substantial increase. Although the Board have expressed their appreciation to the Contributory Fund Committee on many occasions, the Finance Committee feel that it would be remiss if they did not take this opportunity of expressing their most grateful thanks. Another item which it is very gratifying to see is the amount received from patients and other sources in respect of services rendered by the Hospital, and the sincere thanks of your Committee are tendered to all who have contributed.

The Donation of £315 from the Corbett Hospital Fetes Committee is very pleasing and your Committee highly appreciate the work done by the Chairman, Mr. J. B. Hill, the Honorary Secretary, Mr. A. Cooper, and Members of the Committee.

The Pound Day held in conjunction with the Annual Fetes was another useful source of income and resulted in £94 1s. 1d. and 364 lbs. in commodities being received. To those who were so kind to send goods or made gifts, your Committee tender their thanks and also to the members of the House Committee and the Nursing Staff who assisted in the collection.

Your Committee again wish to extend their best thanks to the Worcestershire County Council and to Dr. Wyndham Parker for his great assistance during the year. Your Committee much appreciate the co-operation between the County Council and the Board of Governors. From the Committee of the Voluntary Association, the Hospital has received £927 19s. 2d. and they wish to thank all those who have in any way contributed to ensure such a success. The very best thanks are tendered to the Chairman Mr. J. M. Standish and Members of the Committee for their continued help in the management of the Association.

The thanks of your Committee are also rendered to the various Carnival Committees, Friendly Societies, Works and other Organisations who have assisted the Hospital and whose contributions are enumerated throughout this Report.

In spite of the war the activities of the Hospital continue to increase and your Committee wish to emphasise the fact that liabilities are not likely to decrease in the future.

The Contributory Fund Committee has rightly decided to be responsible for the Hospital maintenance of the wife and dependents of all contributors serving with His Majesty's Forces with the exception of those whose service pay is being augmented by their employers.

In addition, the cost of materials, foodstuffs, and stores will rise and this increase in working expenses must be borne in mind.

Against this several sources of income are likely to be interrupted in view of the existing conditions and your Committee express the hope that friends both old and new will do their very best in various ways to help the revenue of the Hospital in order that the demands made for services may be adequately met.
