



DIRECTORS' REPORT

**For the Period (15 months) from 1st October, 1937
to 31st December, 1938**

The Directors have pleasure in presenting their Report and Statement of Accounts for the period of fifteen months to 31st December, 1938, and take this opportunity of conveying to the workers and subscribers of the Hospital their most sincere thanks for the splendid and encouraging support which they receive from time to time.

It is with very great regret that the Directors have to report the great loss sustained by the sad death of the late Secretary, Mr. E. C. Roberts, who served the Hospital so faithfully and well for exactly nine years. During his term of office the results attained have been increasingly good year after year, and it is felt by all concerned that this was largely due to his untiring efforts and great enthusiasm in the work of the Hospital. He was loved and respected by all with whom he came in contact, and the fruits of his labours for Longton Hospital will form a lasting tribute to his memory.

It is also with very deep regret that the Directors have to report the death of Mr. J. W. Skae, who only recently retired from active service, and who, only a few months ago, had been appointed Honorary Consultant Dental Surgeon of the Hospital, of Mr. M. P. Ferneyhough, Hon. Auditor for a number of years, and Preb. Codling, for many years a Chaplain of the Hospital.

The Income during the period under review amounted to £9,675 5s. 9d., as against £7,437 17s. 5d.

The decrease in the Establishment Contributions is due to the incorporation of the N.S. Voluntary Hospitals' Contributory Scheme.

The receipts from the N.S. Voluntary Hospitals' Association commenced January, 1938, and the Board feel satisfied with the progress which is being made by the Association.

It is gratifying to note that the receipts therefrom are on the upgrade, and it is sincerely hoped that Establishment and other subscribers will still continue with their full and undivided support.

The ordinary expenditure for the period amounted to £6,391 8s. 4d., as compared with £5,112 13s. 9d. for the year to 30th September, 1937. Additional expenditure of £1,101 1s. 5d. has been incurred in respect of a new Mortuary, alterations to Kitchen, Painting and Furniture.

The sum of £3,000 has been transferred to the Reserve Account in order to provide for an extension of the Female Ward, the renewal of the Heating Apparatus, and to meet liabilities which will have to be incurred in the near future. The Directors are very grateful to Mr. & Mrs. F. Wildblood, Miss Hudson, J.P., and the Rev. H. Grindley Johnson, for their kindness in subscribing towards the cost of a Short-wave Diathermy Apparatus.

The work of the Longton Hospital Linen Guild still continues, and the benefit derived therefrom is much appreciated by the Board, who wish to tender to the ladies their sincerest thanks for the work which so materially assists in keeping down the expenditure of the Hospital.

The amount received from the Longton Hospital Saturday Committee again shows an appreciable increase, and the Board are deeply grateful to the Officers and Committee of this organisation, and to the very active workers connected therewith for their generous efforts. Thanks are also tendered to the Alhambra and Alexandra Picture Palaces for their kindness in allowing the Hospital Saturday Committee the use of their premises, and to Miss Loftus and her pupils who so generously provided a Dancing Display in aid of Hospital Funds.

The amount paid over by the Longton Hospital Whist Championship Committee was a very valuable addition to the funds of the Hospital, and the Directors wish to thank the members of the Committee for their untiring efforts. Special reference must be made to the N.S. Licensed Victuallers' effort which realised £130, and to the Mossfield, Adderley Green and Parkhall Collieries' effort which resulted in £40 being received.

To the Longton Hospital Football and Cricket Committees, the Fenton and Cheadle sections of the Potteries Motor Traction Charities' Committees, the

Prudential Assurance Co., Ltd., the Blythe Bridge, etc. Carnival Committee, the Longton and Fenton sections of the Lord Mayor's Charities, the Co-operative Wholesale Society, the Stoke-on-Trent Corporation, and all other valuable subscribers both great and small, the Directors are most grateful for the valuable support given.

Various other efforts in addition to those already mentioned have taken place in support of the Hospital funds, and although it is impossible to record every activity, the Board do sincerely thank all, and appreciate everything that is being done.

The Matron received 11,350 Eggs in response to her Easter appeal, many gifts on the occasion of her "Pound Day," and numerous responses to the Christmas appeal. Many thanks.

Dr. D. F. Murphy, M.B., B.Ch., B.A.O., resigned his position as House Surgeon in July last, and was succeeded by Dr. A. Ramage, M.B., Ch.B.

During the period there were 572 major operations. The In-Patients numbered 1,156, the number of days in Hospital being 15,750, and the average stay 14 days.

The Directors are also much indebted to the Honorary Auditors, the Honorary Solicitors, the Honorary Chaplains, the Honorary Treasurer and the co-opted members of the House Committee for their valuable services, and in conclusion they thank all who have contributed gifts in money or kind, and in any way assisted them in carrying on the work of the Institution.
