



Report of the Committee

THE Committee have the honour to present to the Governors their Report for the past year.

Looking back upon the events of the past six years, it seems almost miraculous that St. Luke's has survived the great strain and grave difficulties occasioned by the War. The Hospital has been very blessed, for although bombs of every size and order fell all around and very close to the buildings, it was spared not even one window being broken.

The work during this period was constantly threatened by labour problems owing to the shortage of nursing and domestic staff. More than once the situation became desperate, but somehow or other help of a kind was always found, and the almost but never quite despairing Matron and Officials were able to breathe more freely, if only for a while. The Committee acknowledge with gratitude the valuable services of the Matron and of her late " promiscuous " staff, whose help enabled the Hospital to weather the storm during those very critical days. They are hoping conditions will soon show signs of improvement.

At the moment the question uppermost in the minds of all who are connected with and interested in the welfare of the Voluntary Hospitals is, what is to be their fate under the National Health Service Bill?

At the time of writing this Report everything is too fluid for the Committee to make any comment on the difficulties which they will have to face.

They would, therefore, just ask all friends of the Charity, who have been so splendid in the past, to give as generously as they can during the coming year, and so help the Hospital during what must be a very sad and troublesome period.

It is with regret that the Committee have to report that at the end of the year they received the resignation, by reason of serious illness, of Mr. J. Ashton Burton, who since the death of Mr. Nutter had held the post of Honorary Treasurer. Throughout his association with the Hospital Mr. Burton always took a keen and generous interest in its welfare, and his valuable services will long be gratefully remembered.

Mr. H. L. Smedley has kindly accepted the Treasurership, much to the gratification of his colleagues on the Committee, who consider themselves fortunate in having obtained his services.

The Committee are glad to announce that Mrs. Hugh Price Hughes, sister of the Founder of the Hospital, and a member of the Committee for the past fifty years, has graciously accepted office as a Vice-President of the Hospital. Also that the Rt. Rev. David Mathew, Bishop Auxiliary of Westminster, and Most. Rev. the Archbishop Germanos of Thyateira have allowed their names to be added to the list of Vice-Presidents.

They are also pleased to announce that Colonel B. Ede, O.B.E.,

and Miss Harley have joined the Committee, and that Mrs. Harrison, who for private reasons in 1942 was obliged to resign from the Committee, has now rejoined.

During the year the Committee have been fortunate in having secured the services of Mr. Reginald Ledlie, C.B.E., F.R.C.S., as Honorary Surgeon.

The Committee take this opportunity to extend a hearty welcome to these new colleagues.

Throughout the years of war the wards on the top floor of the building had perforce to be closed. These have been re-opened, and the Hospital now has its full complement of beds, *i.e.*, 48.

On January 1st there were in the Wards of the Hospital 29 patients. During the year 183 were admitted, making a total of 212 in all. Of these patients 143 died and 29 were discharged. The average number of beds open was 39, and the average number occupied 35.48.

The Committee are pleased to report that the Hospital is now co-operating with the Royal Cancer Hospital in the treatment by Chemo-Therapy of certain types of cases of cancer. This treatment does not in any sense traverse the Constitution of the Charity, in that it does not involve any extra suffering on the part of the patient. On the contrary, in many instances there has been a distinct improvement in the general condition, with relief of symptoms. Also the fact that patients are receiving selective treatment has a good psychological effect on the whole of the Ward. By this liaison with the Cancer Hospital the Committee feel that St. Luke's is contributing, if only in a small measure, to that very important and much needed branch of Medical Science— Cancer Research.

Partly in connection with this work, and partly for the reason that for some time past the want has been felt by our Visiting Physicians, a Mobile X-Ray Unit is being installed. This rather heavy item of expenditure will have to be met out of the income for 1946.

Yet once again the Subscribers and Donors are asked to examine in detail the Income and Expenditure Account and Balance Sheet.

The total income amounted to $\pounds 7,841$ and the total expenditure to $\pounds 8,002$. The deficit has had to be met by drawing on the Legacies Account, which amounted to $\pounds 6,494$.

Expenditure in comparison with the previous year shows an increase of £1,343, but it has to be remembered that besides the general increase in the cost of living, in particular salaries and wages, the full complement of beds has been in use during the latter part of the year, so that there has been an average of six more patients a week, *i.e.*, 35.48, as against 29.81 in 1944.

It only remains for the Committee to offer a tribute of sincere gratitude to all those who, by their generous help and sympathy, have enabled the Hospital to be carried on efficiently for another year. The anxiety attending the administration of a Voluntary Hospital is, in the present circumstances, considerable, and the burden of responsibility a heavy one. The Committee are deeply sensible of the debt they owe to the Subscribers, Donors, and friends of the Charity, who by their loyal support and sustained interest, have spared them financial anxiety and enabled them to present so satisfactory a Report.

bow to Increase the Income

The following expedient, whereby the normal amount of the subscription of any one subscriber can be increased in the hands of the Charity without any further expenditure on the part of the Subscriber, is rendered possible by the provisions of the Finance Acts.

The scheme, shortly stated, is as follows :---

The subscriber enters into a short deed of covenant with the Charity (e.g., this Hospital) to pay for a period of seven years or for the life of the subscriber (whichever period be the shorter) such a sum as will, after deduction therefrom of Income Tax at the rate for the time being current, leave the amount of the normal subscription. The subscriber, when the time comes for payment, deducts Income Tax at the current rate, as he is bound to do, from the gross amount which he has covenanted to pay, and will pay to the Hospital the net amount only, which will be the amount of his normal subscription as before.

The Hospital being a Charity, and as such free from liability to Income Tax, can then claim from the Inland Revenue Authorities the amount of the Income Tax deducted by the subscriber.

For example: a subscriber of a normal subscription of One Guinea will covenant to pay (with Income Tax at 9s.) f_{II} 18s. 2d. When paying his subscription to the Hospital he will deduct the amount of the Income Tax, *i.e.*, 17s. 2d., and will pay to the Hospital, as he paid before, One Guinea only. The Hospital will then recover from the Inland Revenue Authorities the amount of Income Tax deducted, *i.e.*, 17s. 2d.; and so, instead of receiving, as formerly, One Guinea only, will eventually receive f_{II} 18s. 2d.

The Secretary will be glad to supply a form of the necessary deed and any further information to any subscriber who is interested in the scheme.

Objects of the Charity

(ABRIDGED)

(r) It is a Hospital for the Dying.—Not necessarily for those suffering from any particular disease, but for all those who are in an advanced state of any mortal illness. It is not for chronic cases, for "the incurable," or for "the bed-ridden." The patient must be "dying." We consider that anyone comes within that definition who has not, as far as it can be estimated by a medical man, more than a few months to live. The average duration of the stay of our patients is a little over two months.

(2) It has a religious basis, but is altogether undenominational.—Although a living and practical Christianity is and must be the basis upon which the Charity is founded, this finds the most undenominational expression that is possible. We have our own Honorary Chaplains and Clerical Visitors—Anglican, Nonconformist, Roman Catholic and Jewish—each of whom takes charge of those patients who profess the faith he represents.

(3) It is not only a Hospital, but also a Home.—We have always kept this aspect of our work steadily in mind, and, while insisting upon the efficiency of a Hospital, have maintained, as far as possible, the appearance and atmosphere, and the elastic administration, of a Nursing Home.

(4) It is intended for (among others) particularly, to quote the words of the Founder, "the large class, among the poor, of whom the Country has reason to be proud—industrious, honourable, thrifty, respectful of others and of themselves." Also, again to quote the same authority, for "the well-born or the well-educated, the refined and gentle, who have seen better days, and who, perhaps from no fault of their own, at any rate from no moral fault, have 'come down in the world.'"

(5) It is free, but only to those whose circumstances require that it should be free. It is our custom, in accordance with the prevailing and generally approved practice of the day, to call for such a periodical or other payment towards the expenses of the Hospital as the means of the patient or of the patient's relatives or friends may fairly warrant. The amount of the requisite payment is not fixed until after careful and sympathetic enquiry into all the circumstances of the patient. NEW Members are now urgently required for the Sunday Dinner Society, which exists for the purpose of occasionally procuring for the patients more delicate fare than the Committee would otherwise feel justified in providing.

Each member arranges with the Secretary to send a certain amount of poultry or game for the patients' dinner on one (or more) particular Sunday in the year, and the Secretary sends a notice to such member about ten days before the contribution is due. If more convenient, money may be sent, which the Matron will spend on behalf of the donor.

Our warmest thanks are due to those members who have so generously helped us during many years. Want of space unfortunately compels us this year to withhold their names.

Old Linen, Etc.

Now more than ever clean old linen, cotton and flannel of every description, household or personal, is urgently needed for dressings for our bad cases, and we shall be grateful for anything sent.

We shall be glad also of gifts of flowers, plants and vegetables.

Matron's Reedlework Guild

It is earnestly hoped that National claims may not entirely overshadow the work of this invaluable little Society, and that its useful contributions, upon which the Matron hopefully relies, may still be allowed to continue.

Miscellaneous Gifts

The Committee gratefully acknowledge gifts of old linen, flowers, plants, fruit, game, poultry, eggs, books, magazines, sickroom requisites, special teas for patients, Christmas gifts, etc., received during the year from their many friends. These gifts have proved invaluable.

By=Laws

I.—Application for the admission of a patient must be made upon the printed Forms provided for the purpose, which may be obtained from the Matron or the Secretary.

II.—The decision as to the eligibility of any patient for admission rests entirely with the Medical Superintendent.

III.—Patients selected from among the London poor will have preference in admission.

IV.-Patients of all religious denominations, and of none, are equally eligible.

V.—As far as possible, eligible cases will be admitted in the order of application, but the power of granting priority to especially suitable or deserving cases is reserved to the Medical Superintendent.

VI.—Priority of admission will be granted ordinarily to adults over young persons under sixteen years of age.

VII.—Payment is not demanded from any patient; but in cases, on other grounds eligible, where the patient or friends are able to make any contribution to the funds of the Hospital, *it is expected that they will do so*. Priority of admission will not, however, necessarily be granted on account of this being done.

VIII.—Every inmate of the Hospital is under the immediate control of the Matron, who will make such nursing and domestic regulations as may from time to time be necessary.

IX.—The friends of patients are admitted on Wednesdays, Saturdays and Sundays between the hours of 3 and 4 p.m., and the nearest relatives of any patient will be summoned at all other times when such patient is in serious danger.

X.—Visitors may view the Hospital every afternoon, except Saturday and Sunday, from 3 to 5. Ministers of Religion visiting any patient are free of entrance to the Hospital at any time.

XI.—The relatives or friends of any patient admitted to the Hospital must pay a deposit of ten shillings to cover any small expenditure that may arise in connection with the discharge or the decease of such patient. In the case of discharge, this deposit (less any amount expended) will be returned; in the case of death, the whole amount will be applied towards the cost of removal.

XII.—In the case of discharge, the relatives or friends of any patient who have signed the undertaking (Form 3) must, on receipt of notice to that effect, within twenty-four hours remove such patient. In the case of death, the body will, after notice thereof to such signatories as aforesaid, be removed by the authorities of the Hospital with all care and reverence to the authorised mortuary. The signatories must make their own arrangements with the proprietor of the mortuary for the removal thence, or burial, of the body.

XIII.—The removal of patients to the Hospital must be undertaken by the relatives or friends of the patient at their own expense.

XIV.--The Management of St. Luke's Hospital for Advanced Cases undertakes no expenditure for patients, except within its own walls.
