INFORMATION TO SUBSCRIBERS.

HARROGATE ROYAL BATH HOSPITAL AND RAWSON CONVALESCENT HOME.

The following cases only are admitted to the ROYAL BATH HOSPITAL: Skin Diseases, Rheumatic and kindred Diseases (Arthritis, Myalgia, Neuritis, &c.), Disorders of the Liver, Gout, Locomotor Ataxy, and Lead Poisoning.

The following cases are NOT eligible for admission to EITHER Institution:—

- (1) Persons suffering from consumption.
- (2) Women advanced in pregnancy.
- (3) Persons suffering from infectious or contagious disease.
- (4) Persons suffering from fits or of unsound mind.
- (5) Persons suffering from neurasthenia.
- (6) Persons incapable of attending to themselves.
- (7) Persons of advanced age or in too feeble health to undergo the treatment.

Cases convalescent from an infectious disease are not admissible until the expiration of six weeks from the period of infection ceasing.

Any infringement of the rules or misconduct will render the Patient liable to instant dismissal.

The Committee of Management have many Applications each year from Patients for admission, which they are reluctantly compelled to refuse. Subscribers, who may have no Patients to recommend, are earnestly requested to send their Recommendations to the Secretary, that they may be used by the Committee for such deserving cases.

Visiting Days :—Wednesdays and Saturdays, 2-0—4-30 p.m.

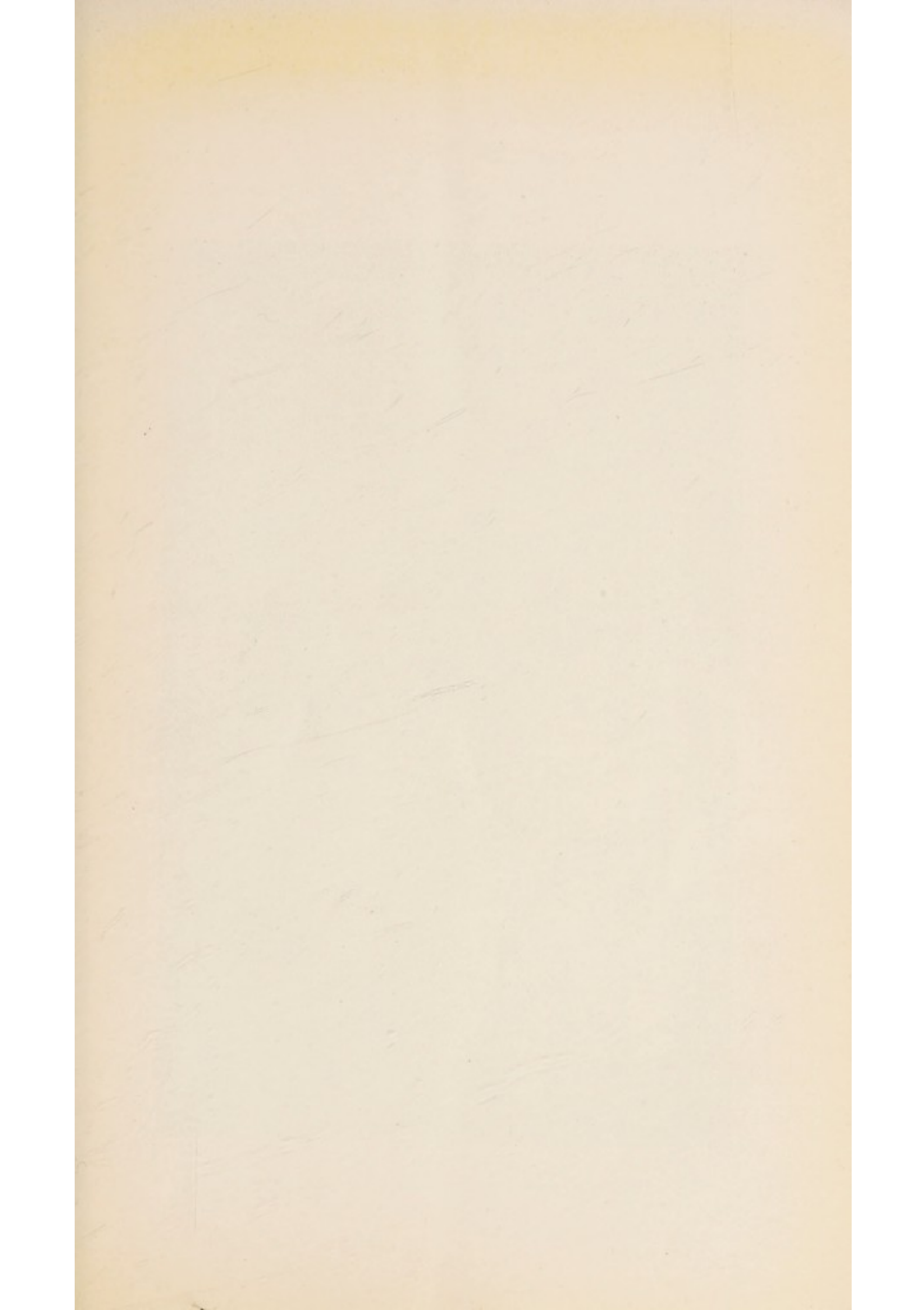
All Subscriptions are due annually on January 1st in each year and all Recommendations must be paid for in advance.

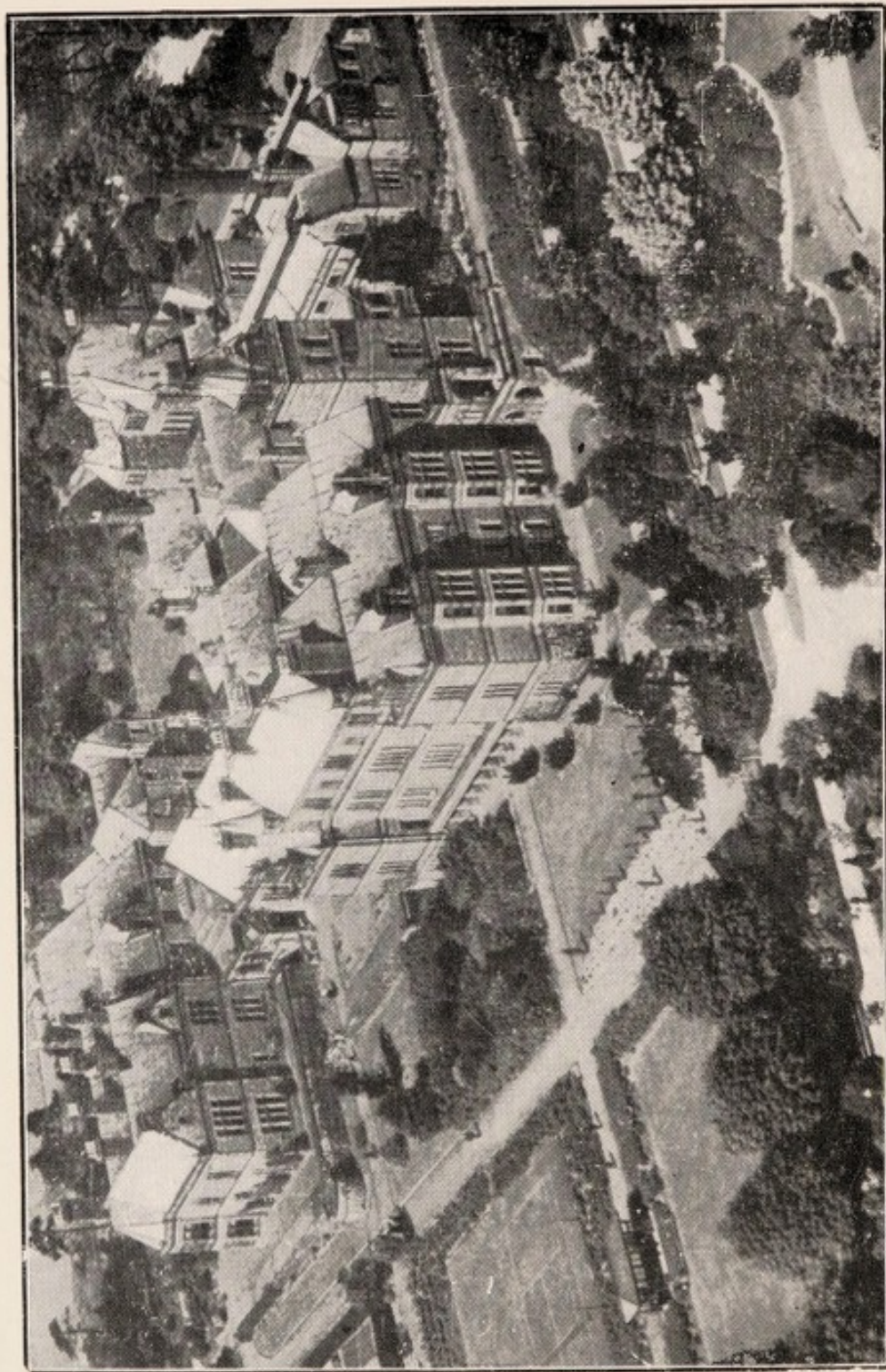

ANNUAL MEETING,

TUESDAY, 11TH FEBRUARY, 1930.

The 104th Annual General Meeting of the Royal Bath Hospital and Rawson Convalescent Home was held on Tuesday, 11th February, in the Board Room.

The Rt. Hon. the Earl of Harewood, K.G., D.S.O., presided. Among those present were Walter Freeman, Esq., J.P., Matthew Stephenson, Esq., J.P., Vice-Presidents; Sir John Eaglesome, K.C.M.G., Sir L. LORD HAREWOOD, in moving the adoption of the Reports and Accounts, said he would like to express his thanks for the very kind reference in the Report to the death of his father, who had always taken a very deep interest in the Hospital and always looked upon it, from the family point of view, with considerable pride. It was a hospital in which his family had always taken a very deep interest.

He was glad to see that the finances of the management of the Hospital continued to be in a much better state than those of most of the hospitals with which he was acquainted. It was always a matter of some anxiety to keep the expenditure of any hospital within the limits set by its income, but, thanks to an efficient Committee of Management, he thought their hospital came nearer than most to attain that desirable end.

The work done in the Laboratory seemed to be most satisfactory, although the Endowment Fund appeared to be standing still. He hoped, however, it would expand proportionately to the work which the Laboratory was bound to perform.

MR. WALTER FREEMAN, in seconding the resolution, thanked Lord Harewood for his remarks about the Laboratory. It was a subject to which he had drawn attention ever since its inception. Last year it showed a deficit of £374. The work was increasing and the costs were rising. He greatly desired to see it on a more secure financial foundation. Turning to the Revenue Account, he said they had had considerable expense of a more or less extraordinary character. They were putting in an electric lift at a cost of approximately £800, and were shortly going to build a new operating theatre at a cost of £500. This expenditure they would be able to meet by accumulations in hand from the income account. They would, therefore, not have to draw upon their capital. He would like to draw special attention to the gift of Colonel Wharton of £250 in connection with the Thanksgiving Fund for the King's recovery. This sum they proposed to put to Capital Account.

The Reports and Accounts were then adopted.

LORD HAREWOOD then moved a vote of thanks to the Chairman and Members of the Committee of Management, and proposed their re-election, with the addition of Mr. J. H. Barker in place of Mr. C. W. Lotimer, and the appointment of the nominees of the Hon. Medical Staff, Dr. G. L. Kerr Pringle, Dr. Geoffrey Holmes, Dr. L. C. E. Calthrop, and Dr. W. Yeoman.

MR. MATTHEW STEPHENSON, J.P., seconded, and the resolution was carried.

MR. C. A. RHODES, J.P., Chairman of the Committee, replying, said the Committee were grateful for the manner in which the resolution had been received. He did not think a Committee could be found which was more assiduous in the discharge of its duties. They kept a close scrutiny on all details of management and expenditure. He referred to the late Lord Harewood, and said they were always glad to see him at their meetings. He often had some shrewd advice to give them, and they were always glad to accept it. His last visit was in October, 1927, when he presented the portrait of their Treasurer.

They were all gratified to know that the family was going to continue its interest in the Hospital because the present Lord Harewood had accepted the office of Patron.

Most of the things they set out to accomplish ten years ago would be completed when the additions now in progress had been

finished, but he hoped that during the next few years they would be able to build up a fund for further use. Paying a tribute to the Matron, Miss Cort, and the Staff generally, he said that when a deputation from Sheffield went round the Hospital some time ago, one lady remarked that there was nothing of the "institution" about the Hospital. They tried to make their patients comfortable, and regarded them as individuals and not as mere numbers.

In conclusion, Mr. Rhodes expressed appreciation of the help given by the contributions from the Approved Societies, without which the financial position would be far less satisfactory.

LT.-COL. A. KIRK, J.P., proposed a vote of thanks to Mr. Freeman for his services as Hon. Treasurer, and his re-election for the ensuing year, and referred in eulogistic terms to the devoted service Mr. Freeman had given over a period of 45 years. For 12 years he had been Chairman of the Committee, and for the past 26 or 27 years he had been Hon. Treasurer. From his own experience and association with the Hospital, he could testify to the value of Mr. Freeman's services. It was a record of which anyone might be proud, and he hoped Mr. Freeman would continue to act for many years to come.

This was seconded by DR. L. J. HOBSON, and carried.

MR. FREEMAN, in reply, said the Hospital had been almost his life's work, and as long as he was able, he hoped to continue it.

SIR JOHN EAGLESOME, K.C.M.G., proposed a vote of thanks to the Members of the Hon. Medical Staff and their re-election. He said the work of the Hospital had proceeded smoothly as usual, the Medical Staff working at the alleviation of pain, the cure of the disease, and the correction of the subsequent effects. All these results had been achieved and would only continue to be arrived at by means of scientific research.

In their Report for 1929 the Ministry of Health had referred definitely to the advantage of spa treatment or balneology. The eminent physician, Sir Farquhar Buzzard, said in this connection "Spa treatment supplies unrivalled opportunities for that research which will one day enable us to teach the public how Rheumatism can be prevented." He had recently seen a summarised report on 2,000 consecutive cases of Rheumatism. This clearly indicated prominent features, which, in fewer cases, might not be specially noted, or important factors, which might have been omitted in earlier cases.

The whole question of research done in this and similar special hospitals for Arthritis deserved wide publicity. While the average medical practitioner might deal with 100 cases, the Medical Staff at the Royal Bath Hospital would have had experience of thousands of cases, and would have obtained that knowledge upon which research work must be based.

Sir John, referring to the approaching difficulty of obtaining research workers in every branch of science, said those of the former generation belonged to the days when large families were not uncommon. One or two of the boys might have to go to seek their fortunes abroad, while another would be prepared to enter a laboratory. But when a family consisted of only one or two, the boy himself and his parents not unreasonably claimed that he should aim at a position with an assured income rather than enter a field where the prizes were so few and the gains so uncertain. With taxation imposed on an Oriental scale, the remedy was to employ some of the vast sums spent on sickness and other benefits for research.

The Committee had not aimed at anything ambitious, but there had been steady and continued progress, and he had no doubt it would continue.

SIR L. G. DUNBAR seconded the resolution, which was carried.

DR. KERR PRINGLE, replying on behalf of the Hon. Medical Staff, said his colleagues were enthusiastic and very jealous of the reputation of the Hospital. Its efficiency as a Spa Hospital was a big advertisement for Harrogate. It became known amongst medical men, and he suggested that the Corporation might with advantage take more interest in the welfare of the Hospital. It was very much better than the advertisements on the railway stations and in the London omnibuses, on which considerable sums of money were spent.

Referring to the forthcoming opening in London of a clinic for rheumatic patients, which it was intended to supplement by others in the large towns, Dr. Pringle remarked that spa hospitals had nothing to fear from such clinics. On the contrary he believed that they would get more patients as a result of them, for people would see the advantage of physical and hydrological methods. There was a vast difference between treatment in a clinic and at a hospital. A man who went to a clinic was only there for an hour or two. He would have to travel from his home in all weathers,

and might be at work part of the day, whereas if he went to a hospital, he would get the benefit of a change of environment, change of air, and change of diet, and he could be looked after the whole time and have his treatment arranged and varied accordingly.

MR. C. E. LEAROYD (Shipley) proposed the re-election of the Auditors, Messrs. Lowrey, Weston & Whalley.

This was seconded by MR. T. B. NEWTON (Newcastle), who said that if the Hospital were not so far from Newcastle many more patients would come from there. The results which had been obtained had been remarkable.

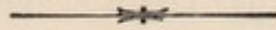
The resolution was carried.

MR. RHODES proposed a vote of thanks to Lord Harewood for presiding over the meeting. This was seconded by MR. FREEMAN and carried.

LORD HAREWOOD, responding, said it was a great pleasure to come in the place occupied by his father for so many years. He expressed gratification at the kind remarks by Mr. Newton respecting the work of the Hospital.



Report of the Committee of Management.



*To The Right Honourable The Earl of Harewood, K.G. D.S.O., and
Subscribers of the Royal Bath Hospital and Rawson
Convalescent Home, Harrogate.*

In presenting the 104th Annual Report, your Committee begs to state that during the past year the total number of patients admitted to the Hospital was 1,176, of whom 915 stayed for a second term; 401 cases were admitted to the Rawson Convalescent Home, 281 staying for a second term. The total number of cases admitted to both Institutions, 1,577, shows a slight increase over the figure (1,528) for the previous year, and, but for an outbreak of an infectious character, which, however, was happily confined to one case, the increase would have been considerably more marked.

That the work of the Hospital continues to grow and to be more widely known and appreciated is evident from the fact that the Waiting List assumed larger proportions than ever before. Possibly the fine summer to some extent contributed to this, but whether this be so or no, the fact remains that at one time nearly 300 cases were awaiting admission. This emphasises the frequently repeated request of your Committee that cases in need of treatment should apply for admission as early in the year as possible. During the first three or four months, so far from there being serious congestion, beds are available with little or no delay. If, however, patients will defer their applications until the early summer, they must inevitably face a delay (sometimes as long as two months) before they can secure admission.

PERSONAL.

It is with deep regret that your Committee has to record the death of the Earl of Harewood, G.C.V.O., the Patron of both Institutions. The Harewood family has been closely associated with the fortunes of the Hospital ever since the time when in 1822 they gave the magnificent site on which the present Hospital stands. This tradition was fully maintained by the

late Earl, who, despite the numerous claims upon his activities, has always taken a sympathetic interest in its work and the developments of recent years. By his death your Committee feels that the Hospital has lost a genuine friend.

Your Committee is, however, gratified to state that the present Earl (formerly Viscount Lascelles) has very kindly consented to fill the position vacated by his father, and it is their sincere hope that he will, for very many years to come, be able to give them the help and influence which has ever been readily forthcoming from his predecessors in the highest position which the Hospital has to offer.

The departure of Dr. David Brown, who has gone to live in Oxford, necessitated his resignation from the Hon. Medical Staff, and his place has been filled by the appointment of Dr. Dorothy Potter.

Dr. Brown's zeal and devotion to the best interests and progress of the Hospital, coupled with his unfailing courtesy and personal charm, had endeared him to his Medical colleagues, and indeed to all associated with the work of the Hospital. Your Committee, as some slight recognition of the value of his services, has elected him a member of the Hon. Consulting Staff. It is hoped that thus his association with the Hospital, though of necessity in a much modified form, may long continue.

For the vacancy created on the Board of Management through the removal of Mr. C. W. Lotimer from Harrogate to the South of England, your Committee proposes to nominate Mr. J. H. Barker, who has consented to allow his name to be put forward. Mr. Barker has been connected with the management of Addenbrooke's Hospital at Cambridge, and it is believed that his experience will be most valuable to his new colleagues.

Your Committee is gratified to report that it now feels justified in proceeding with the installation of an Electric Lift and the provision of a Theatre for minor surgical Operations. Work on the former is now proceeding and it is hoped that both will be ready for use by midsummer. It is confidently expected that with the addition of these long needed facilities the work of the Hospital will greatly gain in efficiency.

The buildings have been maintained in a state of complete repair. The outside has been painted throughout, the heating arrangements have been extended and improved and a considerable sum of money has been expended in remodelling the fall pipes for dealing with the surface water. The lightning conductors have been tested and put in thorough working order.

FINANCE.

Receipts for the year show a satisfactory, if, in several cases, only slight increase on those of the previous year. The most noticeable are the annual subscriptions and grants from Approved Societies, both of which are greater by about £200. Expenditure has in its turn increased by nearly £600. Outside painting accounts for about £200 of this and has been wholly defrayed out of this year's income, though it is not of course an annual charge. The Housekeeping items show little variation from those of 1928, but there are substantial increases for Fuel, Wages and X-Ray charges, though it must be remembered that our radiologists receive no fees for their work and only charge for their out-of-pocket expenses. Another item showing a marked increase is that of "Rates." This is likely to be both permanent and inevitable, since it is due to the new assessment, which is considerably higher than that hitherto in force.

The expenditure on the Laboratory has increased by £90 and as the income can show no increase so long as the Endowment Fund remains stationary—(which it has now done for the past three years)—and entirely inadequate for the purpose for which it was inaugurated, this additional burden has to be defrayed from the income of the Hospital. So long as this unsatisfactory state of affairs continues, it is idle to expect any substantial surplus on the year's working.

Although there is a gratifying increase of about £200 in the amount received by way of grants from the Approved Societies, the importance of maintaining and extending the list of annual subscribers cannot be too strongly stressed. That voluntary hospitals have of recent years, in increasing numbers, been able to show a credit balance on the year's working is in most cases due to the help they have received from the locally organised contributory schemes. Our local Infirmary is a striking example. From such substantial assistance this Hospital is precluded since its patients come from all parts of the Kingdom. This fact seems further to affect adversely its oppor-

tunities for bequests and donations, since the claims of local institutions are naturally apt to take the first place in the intentions of the charitably disposed.

The amount received by way of Hospital Sunday and other Collections shows a small but welcome increase and the thanks of your Committee are accorded to all those who have contributed to this result. As, however, the Hospital participates to the extent of only one-ninth of all monies, which have not been definitely allocated to a particular institution, its share in the increased total collected is, comparatively speaking, small. Hitherto also it has received nothing whatever from Queen Alexandra's Rose Day, nor has it inflicted upon the public an annual Flag Day.

Details showing the cost per patient per week are shown, under the different items of expenditure, on page 18.

From these it will be seen that the total cost of a stay of two weeks amounted to £4 7s. 6d. In view of the fact that the full payment for this period amounts to only three guineas, it will be seen that the Hospital has to find from its other sources of revenue no less a sum than £1 4s. 6d. in respect of each fortnight, while in cases where the patient is exempted from payment of the weekly board fee of 10/6, the difference is automatically increased to £2 5s. 6d.

LEGACIES, &c.

During the year the following sums were received: Dr. Robert Hamilton, £100; Mrs. E. A. Richardson, £135 (on account). These two amounts have, in accordance with the invariable practice, been placed to the credit of the Hospital Endowment Account. No bequests have been received on behalf of the Rawson Convalescent Home during 1929.

Your Committee desires to express its gratitude to Colonel W. H. A. Wharton, of Skelton Castle, for a special donation of £250. This was earmarked for the Hospital under the Thanksgiving for the King's Recovery Fund and is the only gift of its kind which has been received. Your Committee has decided that this most handsome and welcome gift shall be devoted to the equipment of the new Operating Theatre.

Few, if any, absent themselves and it is encouraging always to find so many men present who join heartily in the Service. Much is due to the Matron, Sisters and Nurses.

Report of the Hon. Medical Staff.

A decade has passed since the Hospital was re-opened for civilian patients, and during that period over 12,500 patients have been treated in the Hospital, and, in addition, there have been almost 10,000 re-admissions.

During the ten years which have passed the class of case admitted has become gradually more that belonging to the rheumatic group. The number of semi-convalescent, chronic and debilitated patients admitted in 1929 being only a quarter of the number of those admitted in 1919. These facts show that the Hospital is being used for the purpose for which it was originally intended, and each year the number of cases admitted steadily increases. This last year we had a very large waiting list which we were unable to get through before the end of the year. This was partly due to an outbreak of Scarlet Fever among the domestic staff, which arrested the admission of patients.

With the exception of the months of January, February and March, the Hospital is full, and cannot cope with more, and we would again ask our professional colleagues to send in suitable cases which they know require treatment, in the early months of the year and not wait until the summer months. The Hospital is well warmed, and there is little risk of patients getting cold.

It is quite impossible for the Hospital to deal with all the cases who desire to be admitted in the summer months, and if the demand for beds continues, it will necessitate some definite alteration in the conduct of the Hospital.

The treatment of arthritic and rheumatic disease is a complicated, expensive and lengthy business, and the view is being gradually thrust upon us by the trend of present day happenings, that we shall have more particularly to define the exact type of case which shall be treated in the Hospital, and that a more careful selection of the cases must be made. Again, we recognise that in certain cases a duration of four to six weeks is far too short a period for treatment, that is if we are really to accomplish what we desire for the patient. The question therefore arises: Is it wiser to attempt to treat a large number of patients in a

limited time, or, to treat thoroughly a limited number to a successful conclusion, which would entail a considerably longer period of residence in the hospital. The governing body may have to consider the advisability of

- (1) Either altering its rules regarding admission, or
- (2) Adding a considerable number of beds to the Hospital.

Nine years ago we brought forward a development programme before the governing body—a new Bath-house, Cooling Room, Clinical Laboratory, Electric, Orthopædic, Dental, and Gynæcological Departments; Lift, Operating Theatre, and X-ray Department.

This programme of development is now nearing completion by the installation of Electric Lift and Operating Theatre; and of our original programme there only remains the X-ray Department, and we are under a debt of gratitude to our radiological colleagues who so kindly do all this work at their own private houses.

This class of hospital, although one of the best equipped in the country, is not yet on a level with many of the Rheumatic Hospitals in America.

We must not forget the psychological side in treating these cases. We must educate our patients to the fact that they can do a great deal for themselves in the way of treatment, that it is no good "lying down" to their condition and believing that they are chronic invalids and must not be expected to do this or that. We have before referred to what the Americans call "Educational Therapy," by which patients are taught employments which will assist them to move their stiffened joints and which may enable them to earn their living, besides giving them a fresh outlook on life and a sense of independence. This method of therapy is closely linked up with the medical aspect of Orthopædics. Faulty postures which lead to a vicious cycle must be corrected. The foot gear, of the women more particularly, requires constant attention, and they require much education on this point. It is becoming more and more necessary that the Hospital should have at its command the services of a skilled surgical boot and brace maker, who, on the premises, could alter the alignment of soles and heels to counteract deformities which are often increased or entirely due to faulty foot gear, and who would be able to fit accurately to the patient, braces, etc., to counteract faulty posture.

With the provision of the Operating Theatre our surgical colleague should be able to carry out the minor surgery of these arthritic joints, which is so often necessary, and which it is so difficult to get carried out in a general hospital. Such proceedings will, however, entail an increase in the Nursing Staff.

The work of the department concerned with the internal diseases of women progresses and would justify itself even more, but that many of the cases are of long standing. These require much longer time for treatment than that of the customary two or three weeks. That this special treatment is often essential in many female rheumatic cases is continuously being demonstrated, and the results are most gratifying.

The Honorary Medical Staff much regret that their colleague Dr. David Brown has had to relinquish his appointment on the Staff owing to his leaving Harrogate. His scientific services will be a distinct loss to the Hospital, and men of his type and thought are difficult to replace. Further reference is made to Dr. Brown's services in the Committee's report.

CLINICAL LABORATORY.

The routine work referred to the Clinical Laboratory during 1929 has increased considerably in volume, though the type is similar to that of previous years. 485 patients have been referred for technical observations, 2,042 specimens being examined and 116 vaccines prepared. Details of the type of specimens examined are appended.

This increase in work indicates the value of the Laboratory in the treatment of patients in the Hospital.

During August, 1929, Dr. Geoffrey Holmes, along with Dr. Whitridge Davies, of the Leeds University, and two of his assistants, used the Laboratory extensively in research work on the circulatory rate and the effect of baths thereon. An extensive research on the effect of the sulphur water on the excretion of purine bases was carried out by Dr. David Brown and Mr. Woodmansey, B.Sc., the Analytical Chemist to the Harrogate Royal Baths. Further investigation into the variation in gastric analysis in cases of arthritis has been carried out, and the results will be reported in due course.

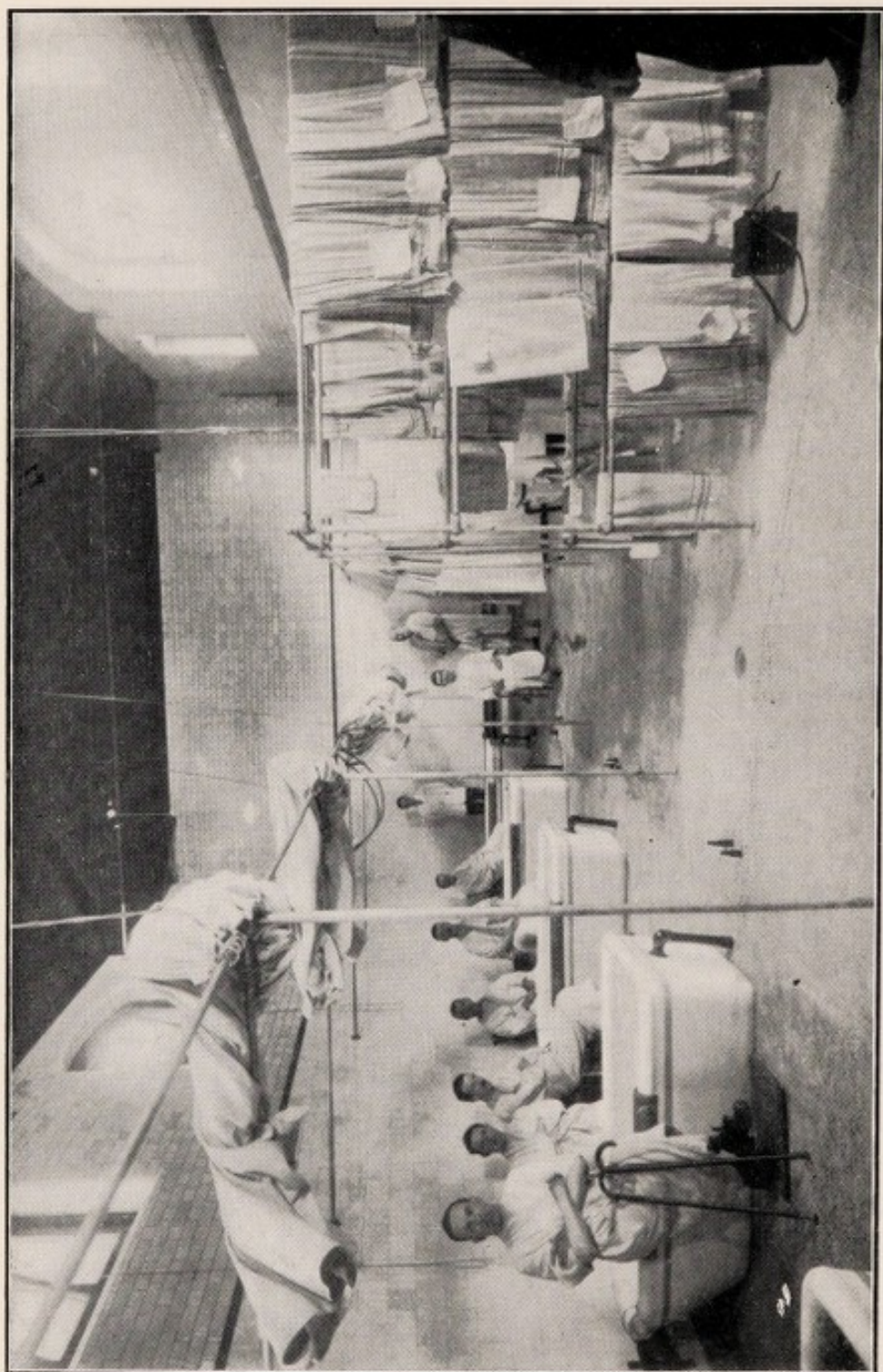

RULES AND REGULATIONS OF THE ROYAL BATH HOSPITAL.

Revised January 30th, 1919.

Title and Purposes of the Hospital.

1. The Hospital having been built with a view to affording to deserving persons, free of expense, the benefits of the Harrogate waters and treatment, shall be denominated "THE ROYAL BATH HOSPITAL." No patients shall be admitted except such as in the opinion of the Honorary Physicians and the Committee of Management are suitable cases for such treatment.

Constitution.

2. The Officers shall consist of a Patron, President, Vice-Presidents, Twelve Trustees, Honorary Consulting Physicians, Honorary Physicians (not exceeding four), and the Honorary Treasurer.

3. All the real estate belonging to the Hospital shall be vested in the names of six Trustees and their personal representatives and the personal estate in the names of six Trustees and their personal representatives, but subject to the control of the Subscribers as to any appropriation for the benefit of the Hospital, which may be agreed upon by them at any annual general meeting, or special meeting called for the purpose.

4. Whenever the number of Trustees, either of the real or personal trust estate, shall be reduced to three by all or any of the following means, viz., death, resignation, refusal, incapacity to act, or permanent residence out of England, the Committee of Management (as specified in Rule 31) shall by any writing under their hand fill up the vacancies by appointing three new Trustees, and upon every such appointment the surviving or continuing Trustees shall transfer such real or personal trust estate respectively vested in them so as to vest it respectively jointly in the surviving or continuing Trustees and such new Trustees.

Admission of Patients to the Royal Bath Hospital.

5. Recommendations for the admission of Patients are issued on the following terms:—

(a) Annual subscribers of two guineas and upwards shall be entitled to recommend one patient annually for each two guineas so subscribed. These recommendations shall only be available in the year in which they are issued:

PROVIDED ALWAYS that Annual Subscribers of One Guinea and upwards whose names appear in the Subscription List for 1924 shall, so long as they continue to subscribe annually, retain the privilege of recommending one patient for each guinea so subscribed, the number of recommendations to be issued at this rate to such old subscribers to be limited and determined by the amount of the first subscription sent in any one year, but in no case shall exceed Five. Old Subscribers entitled to this privilege who require to recommend additional patients beyond the number to which they may be entitled by their first subscription in any year may do so on payment of Two Guineas for each additional recommendation.

(b) Every donor of £40 to the Endowment Fund shall be a Life Subscriber, and shall be entitled to recommend one patient annually for every full sum of £40 so subscribed. These recommendations shall only be available in the year in which they are issued.

(c) Executors of persons bequeathing sums of money to the Endowment Fund of the Hospital shall be entitled to ONE recommendation for every £25 paid to the Treasurer, but to not more than FOUR, whatever the amount of the legacy bequeathed. These recommendations shall only be available in the year in which the Legacy is paid, or in the following year.

(d) Every Clergyman, or minister of any Denomination, who shall transmit a congregational collection to the Treasurer, shall be allowed to recommend one patient for every £3 3s. so contributed during the year.

(e) Every Hotel, Boarding-house, or Lodging-house Keeper or other person, shall be allowed to recommend one patient for every £3 3s. collected and paid to the Treasurer during the year.

These recommendations (d) and (e) shall be available within 12 calendar months from the date of issue.

6. In no case shall any part of the cost of a recommendation be paid by the patient or any member of his or her family. Any such payment shall disqualify for admission.

7. Recommendations for the Hospital will be available for the Rawson Convalescent Home should the case comply with the Rules and Regulations of that Institution, and be, in the opinion of the Medical Staff, more suited for treatment therein.

8. The following cases only are admitted to the Royal Bath Hospital : Skin Diseases, Rheumatism and kindred diseases (Arthritis, Myalgia and Neuritis), Disorders of the Liver, Gout, Locomotor Ataxy, and Lead Poisoning.

The following cases are **not** eligible for admission :

- (1) Women advanced in pregnancy.
- (2) Persons suffering from consumption.
- (3) Persons suffering from Neurasthenia.
- (4) Persons suffering from infectious or contagious disease.
- (5) Persons suffering from fits or of unsound mind.
- (6) Persons incapable of attending to themselves.

9. Cases convalescent from an infectious disease shall be inadmissible until a term of six weeks has elapsed from the period of infection ceasing.

10. The Committee of Management reserves the right to refuse admission to or to discharge any patient whose case may be found unsuitable for the treatment afforded by the Hospital, or who may be likely to be objectionable or injurious to the other inmates, or for any other reason.

Bye-laws and Regulations for Patients in the Hospital.

11. Every applicant for admission must procure a recommendation from a Subscriber, accompanied by the Hospital Certificate, properly filled up by a qualified Medical Practitioner, as to the suitability of the case. Each patient, when so admitted, shall pay a sum not exceeding 10/6 for each week of his or her stay towards the cost of his or her board, unless it be proved to the satisfaction of the Committee that such patient is entirely unable to meet such charge, in which case the Committee may, in their absolute discretion, remit such charge, either wholly or in part.

Each patient may be admitted for a period not exceeding two weeks on production of a Subscriber's recommendation, and shall be entitled to board, lodging, baths, medical attendance, &c. When further treatment is deemed desirable by the Hon. Physicians an extension of time to four weeks may be granted, with the sanction of the Committee of Management, on production of a second recommendation. In cases specially certified by the Medical Staff sanction may be similarly given by the Committee to retain the patient in the Hospital for a further period not exceeding two weeks on production of one further recommendation for such two weeks.

12. In no case can a patient be retained in the Hospital for a longer period than six weeks at one time. No patient can be re-admitted until the expiration of three calendar months from the date when he or she was last discharged from the Hospital.

13. It shall be in the power of the Committee instantly to dismiss any patient who in their judgment conducts himself or herself in an improper manner, or who does not conform to the Rules, Regulations, and Bye-laws of the Institution.

14. Each patient is required to bring a proper change of clean body-linen, and to pay for the washing of it outside the Hospital.



RULES AND REGULATIONS OF THE RAWSON CONVALESCENT HOME,

Revised January 30th, 1919.

Title and Purposes of the Home.

15. The Rawson Convalescent Home, having been erected in connection with the Royal Bath Hospital on land the property of the said Hospital, shall be conducted under the Officers and Committee of Management of the Royal Bath Hospital, with the addition of the three Trustees hereinafter referred to.

16. The Institution shall be used solely as a Convalescent Home. Only such patients shall be admitted as obtain a recommendation from a Subscriber of the Home or Hospital, and are, in the opinion of the Honorary Physicians and Committee of Management, suitable. It is contrary to the design of the Home to relieve persons whose circumstances enable them to pay the full cost of a visit to Harrogate.

Constitution.

17. The Property belonging to this Institution shall be vested in three Trustees. Any vacancy in their number to be filled up by the remaining Trustee or Trustees.

18. The Convalescent Home shall be charged for all expenses of the Hospital and Home in proportion to the number of patients admitted. Donations from Hotels, Lodging-houses, Hospital Sunday, and other sources of revenue (excepting legacies or donations to the endowment funds, which shall be kept separate) shall be apportioned on the same principle. This apportionment of receipts and expenses shall commence January 1st, 1898, and shall not be altered without the approval of a Committee consisting of the Patron, the Chairman of the Committee of Management, the Honorary Treasurer, and the Home Trustees for the time being.

Admission of Patients to the Convalescent Home.

19. Recommendations for admission of Patients are issued on the following terms :—

(a) Annual subscribers of Two guineas and upwards shall be entitled to recommend one patient annually for each Two guineas so subscribed. These recommendations shall only be available in the year in which they are issued :

PROVIDED ALWAYS that Annual Subscribers of One Guinea and upwards whose names appear in the Subscription List for 1924 shall, so long as they continue to subscribe annually, retain the privilege of recommending one patient for each guinea so subscribed, the number of recommendations to be issued at this rate to such old subscribers to be limited and determined by the amount of the first subscription sent in any one year, but in no case shall exceed Five. Old Subscribers entitled to this privilege who require to recommend additional patients beyond the number to which they may be entitled by their first subscription in any year may do so on payment of Two Guineas for each additional recommendation.

(b) Every donor of £40 or upwards to the Endowment Fund shall be a Life Subscriber, and be entitled to recommend one patient annually for every full sum of £40 so subscribed. These Recommendations are only available in the year in which they are issued.

(c) Executors of persons bequeathing sums of money to the Endowment Fund of the Home shall be entitled to ONE recommendation for every £25 paid to the Treasurer, but to not more than FOUR, whatever the amount of the legacy bequeathed. These recommendations shall only be available in the year in which the Legacy is paid, or in the following year.

(d) Every Clergyman or Minister of any Denomination who shall transmit a congregational collection to the Treasurer shall be allowed to recommend one patient for every £3 3s. contributed during that year.

(e) Every Hotel Proprietor, Boarding-house, Lodging-house keeper or other person, shall be allowed to recommend one patient for every £3 3s. collected and paid to the Treasurer during the year.

These recommendations (d) and (e) shall be available within 12 calendar months of the date of issue.

Admission by Payment.

20. In certain cases approved by the Committee patients may be admitted to the Home without recommendation on their own payment in advance at the rate of one and a half guineas for each week. In no case shall this privilege be granted for a longer period than four weeks.

21. Recommendations for the Home will be available for the Royal Bath Hospital should the case comply with the Rules and Regulations of that Institution, and be, in the opinion of the Medical Staff, more suited for treatment therein.

22. Convalescent cases, or cases of debility, are eligible for admission to the Home. No Sulphur Water baths are given to patients in the Home.

The following cases are **not** eligible :—

- (1) Women advanced in pregnancy.
- (2) Persons in advanced stages of consumption.
- (3) Persons suffering from any skin disease.
- (4) Persons suffering from Neurasthenia.
- (5) Persons suffering from infectious or contagious disease.
- (6) Persons subject to fits or of unsound mind.
- (7) Persons incapable of attending to themselves

23. Cases convalescent from an infectious disease are not admissible until the expiration of six weeks from the period of the infection ceasing.

24. The Committee of Management reserve the right to refuse admission or to discharge any patient whose case may be found unsuitable for the treatment afforded by the Convalescent Home, or who may be likely to be objectionable or injurious to the other inmates, or for any other reason.

Bye-Laws and Regulations for Patients in the Home.

25. Every applicant for admission must procure a recommendation from a subscriber (except in the case of those persons admitted on their own payment under Rule 20), accompanied by the Home Certificate, properly filled in by a qualified Medical practitioner as to the suitability of the case. Each patient, when so admitted, shall pay a sum not exceeding 10/6 for each week of his or her stay towards the cost of his or her board, unless it be proved to the satisfaction of the Committee that such patient is entirely unable to meet such charge, in which case the Committee may, in their absolute discretion, remit such charge, either wholly or in part.

Each patient shall be admitted for a period of two weeks on production of a Subscriber's recommendation, and shall be entitled to board, lodging, medical attendance, &c., but no Sulphur Water baths shall be given to Home patients. When further treatment is deemed desirable by the Hon. Physicians an extension of time to four weeks may be granted with the sanction of the Committee of Management on production of a second recommendation.

26. In no case can a patient be retained in the Home for a longer period than four weeks at one time. No patient can be re-admitted until the expiration of three calendar months from the date when he or she was last discharged from the Home.

27. It shall be in the power of the Committee instantly to dismiss any patient who, in their judgment, conducts himself or herself in an improper manner, or who does not conform to the Rules, Regulations and Bye-laws of the Institution.

28. Each patient is required to bring a proper change of clean body-linen, and to pay for the washing of the same outside the Home.



RULES RELATING TO BOTH THE ROYAL BATH HOSPITAL and THE RAWSON CONVALESCENT HOME.

29. The Hospital shall be open throughout the year. The Home shall be opened in March each year and closed for the admission of patients on the second Thursday in November, or at such other times and such other periods in each year as the Committee of Management may decide to be necessary.

30. No Subscriber shall have power to recommend a patient or do any other special act until his or her subscription has been paid.

Annual Subscriptions shall be deemed due on the 1st January in each year.

When any subscription shall be in arrear for 2 years the subscriber's name shall be omitted from the published list.

31. The Government of the Royal Bath Hospital and of the Rawson Convalescent Home shall be vested in a Committee of Management consisting of the Patron, the President, the Vice-Presidents, the Trustees of both Institutions (all of whom shall be ex-officio members of the Committee), the Honorary Treasurer, the Honorary Consulting Physicians, four Honorary Physicians, and sixteen other members, who shall be elected from the Life and Annual Subscribers. Three members of the Committee shall form a quorum.

The Honorary Treasurer, the Honorary Consulting Physicians, the Honorary Physicians, and the 16 members elected from the list of Subscribers shall be elected at the Annual General Meeting, and shall hold office for one year, and shall be eligible for re-election at the next Annual General Meeting.

They shall have power to engage and dismiss all paid officials, to fix the amount of salaries, and make such orders, according to the spirit of these Rules, as they shall think expedient for the management of the Hospital and the Home.

Three or more of the Committee shall attend at the Hospital every Thursday afternoon during the time the Hospital is open, to admit patients and transact general business. In the event of a special meeting of the Committee being requisite, the same shall be called by the Secretary, when directed to do so by the chairman of the Committee or three of its members.

32. A House Committee shall be appointed by the Committee of Management, and shall meet at the Hospital as often as may be necessary, at such an hour as they may appoint. They shall examine the books of admission and discharge, and all other books kept by the officers, including the register of the attendance of the Honorary Physicians and Chaplain, and the "Visitors' Book." They shall investigate any complaint of neglect or misconduct of anyone connected with the Institution. They shall examine and sign all such accounts as may require to be laid before the next monthly meeting of the Committee of Management for payment. They shall procure and submit once a year to the Committee of Management for approval, all contracts for drugs, provisions, coals, &c., required for the use of the Hospital and Home. They shall examine, from time to time, the inventories of household goods, furniture, linen, &c., belonging to the Institutions. They shall replace and renew, from time to time, as circumstances may require, all such internal fittings and furniture of the Hospital and Home as may urgently require renewal, and shall superintend all alterations and improvements sanctioned by the Committee of Management, and shall be generally responsible for keeping the grounds and buildings in order.

33. Whenever a vacancy or vacancies shall occur in the Honorary Medical Staff, the Secretary shall, when requested by the Committee of Management, give notice thereof by advertisement. Applicants, who shall be fully qualified and registered, shall forward their diplomas and testimonials, if required, to the Committee of Management, who may thereupon proceed to election, or they may in their discretion defer the appointment to the next Annual General Meeting.

34. The Honorary Physicians or a sufficient number of them, shall attend at the Hospital, every Thursday, at 2 p.m., during the time the Institution is open, to examine applicants for admission; and shall visit the Hospital three times per week, or as often as they may think necessary.

35. The Committee shall have power on the recommendation of the Hon. Medical Staff to appoint such specialists in an honorary capacity as may conduce to the better treatment of the patients. Such specialists so appointed shall not form part of the governing body of the Institution.

36. The Honorary Treasurer shall pay all monies which he shall receive to the credit of the Hospital and Home at its Bankers, and all payments due from the Hospital and Home shall be made by cheques, signed by himself and two of the Committee. He shall invest, on securities approved by the Committee, when requested by them, all monies available for investment.

37. The Auditor shall examine the accounts, and return the same properly audited, to the Secretary, within 14 days after they have been received, and shall receive such a fee as the Committee of Management may think proper.

38. The Secretary shall collect and forthwith pay over to the Treasurer all subscriptions; attend and act as Clerk at all meetings of the Subscribers and Committees; make out the annual accounts for the auditor, and perform such other duties as the Committee of Management may direct.

39. The Matron shall be appointed by the Committee of Management, subject to three months' notice on either side; she shall devote the whole of her time to her duties, and shall see that the affairs of the Hospital and Home are conducted with the greatest possible attention to regularity, cleanliness, and economy, and shall conform to such Bye-Laws and instructions as the Committee of Management may from time to time decide upon.

40. The Annual General Meeting of the Subscribers shall be held at the Hospital on the Third Thursday in January in each year, or within 28 days thereof (of which seven days' notice shall be given by circular), for the purpose of receiving the reports of the Committee and Auditor, determining if any and what substantial alterations of or additions to buildings, shall be undertaken, and for electing a Committee of Management, the Honorary Consulting Physicians, the Honorary Physicians, the Honorary Treasurer, and an Auditor.

41. The Chairman of the Committee of Management shall, within ten days after receiving a requisition in writing, signed by five Subscribers, convene by circular a special meeting of Subscribers for considering the purpose stated in such requisition only.

42. The Committee of Management shall have power to make such Bye-Laws (not inconsistent with these rules and regulations) as they may think necessary for the internal management of the Hospital and Home, and alter and annul the same as occasion may require; such new Bye-Laws to be in force until confirmed or otherwise at the next Annual General Meeting of the Subscribers, and printed copies of such Bye-Laws shall be affixed in conspicuous parts of the Hospital and Home, for the guidance of the Officers and the observance of the patients.

43. No general rule or regulation shall be altered, except by the Subscribers at the Annual General Meeting, or at a meeting specially called for the purpose; in all cases 14 days' notice shall be given to the Secretary of the proposed new rule; and seven days' notice shall be given by the Secretary to all Subscribers (together with the names of the Subscribers proposing the same), prior to the holding of the meeting at which such alteration is proposed to be made.

44. At all meetings, whether of the Subscribers or of the Committee of Management, all questions shall be decided by the vote of the majority of those present. In the event of the voting being equal the presiding Chairman of the meeting shall be entitled to give a second or casting vote. in no case is it permissible to vote by proxy
