HISTORICAL.

THE HOSPITAL is one of the four special skin hospitals in the country, others being situated in London, Liverpool and Manchester.

1881: Founded as an Out-patient Clinic in Newhall Street.

1888: Removed to John Bright Street.

- 1892: Opening of full In-patient Department of twenty-two beds.
- 1901: Inauguration of X-ray and Electro-Therapeutic Department.
- 1921: Installation of Deep X-ray Therapy for the treatment of Cancer.
- 1926: Transfer of Nursing Staff to Hostel.
- 1935: Closing of Wards at John Bright Street and opening of Extensions at George Road, Edgbaston, comprising New In-patient Department of fifty beds, Deep X-ray Therapy Department for the treatment of Cancer, and the Nurses' Home.
- 1936: Internal reconstruction of the Out-patient Department at John Bright Street.
- 1938 : Bed complement increased to fifty-nine. Deep X-ray Therapy Department discontinued.

REPORT OF THE BOARD OF MANAGEMENT

FOR THE YEAR 1944.

THE Board of Management takes pleasure in presenting to the Governors and Subseribers the sixty-fourth Annual Report and Statement of Accounts, together with a resumé of the work of the Hospital for the year 1944. At the request of the Ministry of Supply, the Report and Statement is again abridged, your Board regretting its inability, therefore, fully to acknowledge many acts of individual effort.

The passing of Alderman Sir Frederick Smith, J.P., has deprived the Hospital of a President unique in its annals. Elected to office in 1932, Sir Frederick immediately accepted an active and personal interest in the administration of the Hospital and all that appertained thereto. He applied both his energy and influence to furthering the scheme of extensions then under consideration, devoting a great deal of his leisure to the appeals side of the work, which brought into being the Hospital at George Road and rebuilt that at John Bright Street. His interest and enthusiasm for the cause of the Hospital and its patients never abated, indeed, they increased with the passing of the years. A regular attendant at Board and Committee Meetings, Sir Frederick's wide knowledge and wise counsel were of infinite value and were appreciated to the full. By special Minute the Board has recorded its indebtedness for services devotedly rendered and its deep sympathy with Lady Smith and the family. As a tribute to his memory, a Ward in the George Road Hospital is to be named "The Frederick Smith Ward."

Consequent upon his appointment as full Honorary Surgeon to the United Hospital, Mr. Hugh Donovan, M.B., F.R.C.S., has resigned from the Honorary Medical Staff of this Hospital, his decision being received with general regret. To mark its appreciation of his services, which cover a period of almost twenty years, Mr. Donovan has been appointed an Honorary Consulting Surgeon to the Hospital. At a meeting of the Board, Mr. Donovan was presented with his portrait, which will be hung in the Board Room at John Bright Street.

Due to her departure from Birmingham, Mrs. M. Moriarty has found it necessary to resign her position on the Board of Management. The Board accepted this resignation with regret and has recorded its thanks for her valued services.

Mr. A. E. Arthur and Mr. B. T. Davis have joined the Board of Management, bringing with them experience which will prove of the utmost value in the difficult years to come.

Incorporation of the Hospital under Section 18 of the Companies Act, 1929, has now been completed, the licence being dated the 28th November, 1944. The Governors of the unincorporated Hospital retain their status and privileges, but to conform with the new constitution, it is necessary that they sign either a form of consent to become a Member (Governor) of the Incorporated Association or sign the register of Members. Anxious that this formality shall not lead to any diminution of interest on their part, the Board earnestly requests all Life Governors, and Governors by virtue of an annual subscription of one guinea and upwards, to complete the post-card enclosed in this Report, and return it to the House Governor in order that they shall continue in the position of directing the affairs of the Hospital by virtue of their vote at the Annual General Meeting of Governors.

The King Edward's Hospital Fund for London recently set up a special committee to report upon hospital dietary and catering, and, following upon that committee's recommendations, supported by the Ministry of Health, hospitals throughout the country have gone thoroughly into the question. To assist it in its deliberations, your Board decided to ask the Ministry of Health to appoint one of its dieticians to carry out an impartial and independent inspection of its catering arrangements, the Ministry appointing Miss H. G. Cairney for this purpose. This experienced officer was given carte blanche, and, having inspected the kitchen and its facilities, seen meals cooked and served, interviewed patients and members of the senior and junior resident staff, both nursing and domestic, and inspected diet sheets, issued a report which proved of great value. This report enabled the Hospital to acquire the additional kitchen equipment and personnel without which it was impossible to put into operation the final stages of a catering reorganisation which had been in progress for some time, the aim of which was to provide patients and staff with a full dietary of three main meals per day. Through the Ministry of Health, your Board has expressed to Miss Cairney its thanks and appreciation for her frank and informed report, and as a further means of keeping this important branch of the Hospital's responsibilities thoroughly in keeping with the times, has asked the Ministry to arrange periodical visits of its dieticians in order that the Hospital shall be kept advised on developments. In addition to the purchase of the equipment referred to above, and to the engagement of additional kitchen staff, some increase in expenditure on provisions will be reflected in the 1945 accounts.

Conforming to a wide-spread movement throughout the country, the Board has approved the setting up of a Nursing Staff Council, such councils having proved of value by providing the means of free and full discussion between members of the Nursing Staff on all matters affecting their duties and themselves. The value of contact in this way is appreciated, not only in bringing to light many small but otherwise irritating things, but also is of great value to the Matron in that by this means she will be made aware of things of which otherwise she might remain in ignorance. The Council can under certain circumstances request that representations be made to the Board, but so far it has been found in practice that the Matron has been able satisfactorily to deal with every point the Nursing Staff have raised.

The Government's White Paper on a National Health Service, upon which your Board has expressed its views to the Minister of Health through the British Hospitals Association, is still the subject of negotiations with the Minister on many important points concerning both its administrative and its financial proposals. Important progress has been made, and, it being true that the voluntary hospitals are just as anxious as the Minister of Health to see the future Health Services of the country placed on a firm and satisfactory basis, your Board is confident that the outcome of the present negotiations will prove satisfactory to all concerned, enabling this important measure of social reform to be placed on the statute book and developed as circumstances permit.

During the year, the Hospital organised its first Flag Day, a pleasing feature being the number of friends and supporters who came forward and voluntarily undertook the difficult task of organising the collection in their respective districts, as also was the great number of appreciative letters received from old patients glad to embrace this opportunity of repaying their indebtedness to the hospital. The result of the collection is referred to later in this report.

A Bazaar and Jumble Sale which was organised by Miss Baker and her Nursing and Domestic Staffs and held at the George Road Hospital, proved an outstanding success, approximately one hundred pounds accruing from this meritorious effort.

The work of the year is outlined on page 1, the 683 in-patients being a decrease of 8. In-patient bed-days numbered 18,721, as compared with 19,719, for the previous year. This decrease of 998 is due to the Mens' Ward having been closed for painting and the Childrens' Ward having been closed on various occasions. New Out-patients totalled 13,262, a decrease of 1,554 over the comparable period.

The Revenue Account discloses the most serious deficiency recorded in the history of the Hospital, the excess of expenditure over income being £3,539, as compared with £2,031 for the previous year. Ordinary income at £18,554 represents a comparative increase of £1,588, whilst ordinary expenditure at £22,094 has increased by £3,097. An analysis of the income side of this account discloses increases under various headings amounting to £2,330, offset in part by decreases amounting to £472, the result being a net ordinary income increase of £1,588. Regarding expenditure, the principal increases are "Salaries and Wages," £1,156; "Painting, Renovations, etc.," £804; "Provisions," £380; "Domestic," £417.

The Birmingham Hospitals Contributory Association provided \pounds 7,728, as against \pounds 8,035 for the previous year, a decrease of \pounds 307. Other Contributory Schemes contributed \pounds 2,464, an increase of \pounds 823, this substantial increase being partly attributable to the

reciprocal arrangements now in force, and also to the increased use which has been made of the Hospital's services by members of Contributory Schemes outside Birmingham. 41.6 per cent. of the year's ordinary income has, therefore, been provided by the Birmingham Hospitals Contributory Association, Contributory Schemes as a whole providing 54.9 per cent. The Board places on record its thanks to the officers, contributors and voluntary workers of the Birmingham Hospitals Contributory Association, together with its Industrial Section, the Birmingham Hospital Saturday Fund. It takes this opportunity to extend its thanks to the many Contributory Schemes outside Birmingham with whom it works in happy and harmonious co-operation.

Voluntary subscribers and donors have continued generously to support the work of the Hospital, not only in respect of its maintenance, but by finally eliminating the Building Fund debt, which has existed since 1936. Under the heading "Voluntary Gifts" shown on page 10, a total of $\pounds 5,032$ is recorded, an increase of $\pounds 1,097$ over the previous year. The Flag Day previously referred to resulted in $\pounds 1,490$ being made available to the funds of the Hospital, of which amount $\pounds 254$ was allocated to finally eliminating the Building Fund debt, $\pounds 1,152$ being credited to the Maintenance Account. Legacies received during the year amounted to $\pounds 5,149$ see Legacy Account on page 12—of which amount $\pounds 3,539$ will be transferred to the General Fund to cover the year's deficit.

The Board is keenly appreciative of the many additional duties which the expanding work of the Hospital, coupled with war-time conditions in general, has imposed upon the Medical, Administrative, Nursing, Dispensary, Laboratory and other staffs, and records its thanks. It especially appreciates the additional responsibilities of members of the Honorary Medical Staff due to the difficulties experienced in obtaining the services of Resident House Physicians. It records its thanks to the members of the Ladies Linen League and is grateful for their continued interest and support, which provides so many additional comforts in the Childrens' Ward which, otherwise, would be impossible to obtain.

Whilst it may be said that in the matter of post-war planning little can be done until the position regarding the proposed National Health Service becomes more clarified, your Board is of the opinion that the report of the survey carried out on the 9th April, 1943, under the orders of the Minister of Health will, when received, assist it greatly. This side of post-war planning might be described as your Hospital's external policy of the future, but it will be readily appreciated that, due to war-time restrictions in the matter of building, equipment, supplies, etc., etc., the internal development of the Hospital has been somewhat retarded and will necessitate considerable expenditure when supplies again become freely available. Much preliminary work in both directions has already been accomplished, which will enable the special committee on post-war planning, which your Board has set up, to commence its deliberations almost immediately. It is worth noting, however, that despite war-time conditions, your Board has, amongst other things, re-equipped the whole of its important X-Ray and Actino Therapy Department with modern and additional apparatus, greatly extended the work of the Pathological Laboratory, improved its catering and dietary for patients and staff, installed the necessary kitchen equipment, both mechanical and otherwise, and, in general, has, notwithstanding war-time restrictions, given its patients the benefit of modern equipment, extended research facilities and other day by day developments.

It is clear, therefore, that to-day's maintenance expenditure of $\pounds 22,094$, as compared with $\pounds 14,862$ for 1938, cannot be looked upon as temporary and due solely to existing conditions. On the contrary, much of it must be accepted as permanent and if the Hospital is to continue to extend its usefulness and to take a major position in the Health Services of the future, your Board must continue to rely for increased support upon the charitably minded. Whatever happens under the National Health Service, it is clear, and the Minister of Health has emphasised this point, that the voluntary hospitals must continue to rely upon the charitable public for a large proportion of their income for annual maintenance purposes. Legacies must always remain the principal source from which capital expenditure can be made, apart from any special appeals organised for that purpose.

In expressing its thanks to its subscribers and donors, and to its numerous friends, your Board is confident that the voluntary hospital service, with its freedom of action and traditions of service, will be maintained by its friends and supporters side by side with the Municipal Hospitals, both working in close and cordial cooperation as essential to a unified National Health Service.
