Annual Report: 1964-5

IN THIS REPORT the accounts relate to the period from 1st January, 1964 to 31st December, 1964 inclusive. The rest of the Report covers the period from 1st April, 1964 to 31st March, 1965.

During the period under review the Executive and Finance Committee met three times.

CONSULTATIVE COUNCIL

There have been no changes during the year in the Consultative Council.

THE GENERAL SECRETARY

At its meeting in October, 1964 the Council received with much regret Dr. Colin Bertram's resignation, as from 31st December, 1964, from the General Secretaryship which post he had held for over seven years.

During his period of service he did much to call attention to the *Society* by lectures, by articles and comment in *The Eugenics Review* and other journals and by introducing new members.

He will continue to act on the Board of the Marie Stopes Memorial Foundation as the *Society's* representative, and the Council hopes that it may also continue to have his assistance in other ways.

Miss Faith Schenk, then the Administrative Secretary, was appointed to succeed him.

THE SOCIETY'S PREMISES

Following its decision to house the *Society* in smaller premises the Council has had this matter constantly under review. Suitable accommodation has not yet been found but enquiries are continuing through Messrs. John D. Wood & Co., who are acting on behalf of the *Society*. In the meantime the Council is seeking short-term tenants for the three rooms on the second floor which, apart from a short period last autumn when one was lent to the Steering Committee of the Family Planning Association, have been kept vacant since September, 1963.

The *Society* has continued to make one room on its ground floor available, rent free, to the British Social Biology Council.

In October, 1964 the caretakers, Mr. and Mrs. Horner, retired, the latter having also served the *Society* as housekeeper for more than thirty years. By decision of the Council an annuity was bought for them, in

respect of their service, of £400 a year payable immediately on their retirement.

The basement has since remained vacant.

MEETINGS

The Galton Lecture. The Galton Lecture for 1964 which, it will be remembered, was postponed from February was delivered on Wednesday, 20th May by Professor Jan A. Böök on "Some Mechanisms of Chromosome Variations and their relation to Human Malformations". The Chair was taken by the President, Sir James Gray, and about 120 people were present. The Lecture took place at the Rooms of the Royal Society and was preceded by tea.

The Galton Lecture for 1965 will be given at 5 o'clock on Wednesday, 5th May by Dr. Howard B. Newcombe on "The Study of Mutation and Selection in Human Populations". Dr. Newcombe is Head of the Biology Branch of Atomic Energy of Canada Limited, and the date of his lecture, which will also take place at the Royal Society, has been timed to follow his attendance at a Conference in Stockholm at the end of April.

The Darwin Lecture in Human Biology. The fourth Darwin Lecture in Human Biology, sponsored by the Institute of Biology in association with the *Society*, was delivered on Monday, 11th May, 1964 by Professor P. B. Medawar, C.B.E., M.A., D.Sc., F.R.S. on "Natural Selection and the Concept of Fitness". Sir James Gray was in the Chair and some 150 people attended. The Lecture took place in the Lecture Hall, Natural History Museum, Cromwell Road, S.W.7.

The fifth Darwin Lecture will be given, also in this Lecture Hall, at 5.15 p.m. on Thursday, 20th May, 1965 by Professor L. S. Penrose on "Congenital Malformations in Man and Darwinian Selection".

A notice of this and of Dr. Newcombe's Galton Lecture will appear in next year's Annual Report.

Joint Meetings. The Council has agreed that the *Society* shall collaborate with the Society for the Study of Human Biology and the Royal Anthropological Institute in organizing, in December next, a half-day meeting on *The Biology of Co-operation*, primarily for young scientists from overseas working in this country, during this International Co-operation year. Four papers are planned, followed by discussion. The meeting will be open to the *Society's* Fellows and Members who will be notified of the arrangements beforehand.

It is expected that this will be the first of a series of joint meetings with Societies with related interests.

THE EUGENICS REVIEW

The Eugenics Review has continued to appear quarterly under the Editorship of Mrs. K. Hodson.

The *Society's* contract with Pergamon Press Limited, for publication of the Review, has been terminated by mutual arrangement and an

agreement signed with Messrs. Oliver & Boyd Ltd., Edinburgh, who took over publication with the current volume.

It has been decided that in future the Review shall appear at the end of each quarter so that the volumes coincide with the calendar year; the first issue of the current volume therefore, was dated March instead of April and publication of the subsequent issues will be brought forward accordingly.

The price has been raised to £3.0.0. (\$10.00) a year and 17s. 6d. (\$2.50) for a single issue.

LIBRARY

During the past year forty-two books have been added to the Library by gift or purchase: 101 books and periodicals have been borrowed, twenty-one of them by the National Central Library.



The Editorial and Library Committee, which has met four times during the past year, has consisted of Mr. P. R. Cox (Chairman), Mr. D. R. Brothwell, Dr. C. O. Carter, Professor P. Sargant Florence, Dr. H. Lehmann and Lady Lewis.

DARWIN RESEARCH FELLOWSHIP

Dr. John B. Gibson has continued for a second year his tenure of the honorary Darwin Research Fellowship to which he was appointed in 1963 in respect of his work on social mobility and differential fertility.

No other appointment was made in 1964.

A sum of up to £100 to attend, as the *Society's* representative, meetings of the International Union of Family Organizations held in Munich in July, 1964. The net cost was, in fact, £83 7s. 6d.

At 31st December, 1964, the Grants Fund stood at £2,175 7s. 4d., representing one undrawn balance—by Professor Parkes (1964) £325 7s. 4d.—and grants amounting to £1,850 which had not been drawn upon at that date, i.e. to the Society for the Study of Human Biology (1963) £50, and to all those listed above (1964) with the exception of Professor Parkes, Dr. Blacker and the Sir Ronald Fisher Memorial Appeal.

SYMPOSIUM

The *Society's* first symposium, on *Biological Aspects of Social Problems*, was held on Thursday and Friday, 1st and 2nd October, 1964.

It had been planned that the Symposium should take place in the Rooms of the Royal Society but applicants for tickets so far exceeded the number which could be accommodated there that arrangements were made for it to be held instead in the Botany Lecture Theatre of University College, London.

The meeting was opened by the President who then took the Chair for the first session—Population Trends. The subsequent sessions were Social Mobility and Education, Genetic Aspects of Medicine, and Aspects of Fertility Control, for which the Chairmen were Sir Sidney Caine, Professor L. S. Penrose and Sir Julian Huxley respectively. During the two days, papers were presented equally by biologists and sociologists on subjects of mutual interest within the general topics. Each of the sessions was attended by over 250 people, many of whom contributed to the discussions held after each paper.

The Proceedings will be published, in volume form, by Messrs. Oliver & Boyd Ltd., and it is hoped that the book will appear in June, 1965.

The Council is now arranging the second symposium, on *Genetic and Environmental Factors in Human Ability*. It will be held, in the same Lecture Theatre, on Thursday and Friday, 30th September and 1st October next. The general topics of the four sessions as planned at the time of writing will be: The Nature and Meaning of Intelligence Tests; Selection for Higher Education; Aspects of Sub normality; and Differential Fertility and Intelligence, in that order.

A full programme of the Symposium will be obtainable at the end of May from the *Society's* office.

THE MARIE STOPES MEMORIAL FOUNDATION LIMITED

The Balance Sheet and Revenue Account for the year to 31st December, 1964, of the Marie Stopes Memorial Foundation Limited, will be found at the end of this Report. There was an excess of income over expenditure for the year amounting to £3,316 which, added to the Revenue Account balance at 31st December, 1963, of £4,518, increased the revenue surplus to £7,834. Of this balance £5,688 was carried forward, the sum of £2,146 having been expended during the year on training, research activities, grants and an allocation of £1,000 to the Eugenics Society for its general purposes. A further allocation of £320, charged to the Revenue Account, was made to the Society in respect of administrative and secretarial services.

The grants included £250 in support of the Young People's Advisory Centre under the direction of Dr. Faith Spicer and £200 to the Family Planning Association's Islington Branch towards the cost of its marital difficulties sessions. A further grant of £1,000 was agreed for Dr. J. B. Gibson's work on social mobility and differential fertility but was undrawn in 1964.

In the Autumn of 1964 extensive external repairs to the Whitfield Street premises were carried out and work is now in progress on the rehabilitation of the basement rooms so that they can be adapted for clinic use.

The number of doctor sessions during the year has been increased and now includes each week one for men and one for marital difficulties. Sessions have also been started for the intra-uterine contraceptive device, for which the demand steadily increases.

Oral contraceptives are now being prescribed for 240 women.

Attendances at the Clinic during the year have continued to increase, the annual total being fifty per cent higher than in 1963.

Six training courses for overseas nurses were held during the year at which a total of forty nurses attended.

The Clinic Committee has decided that all donations received from patients should be made over to the Family Planning International Campaign and more than £150 has so far been collected.

The Clinic has continued to make its facilities available to Dr. Spicer for her Advisory Centre which now holds four doctor sessions a week.

Dr. Elizabeth Horder has continued in a London area her domiciliary birth control research project. The number of families in the survey so increased during the year—at the time of writing there are over 100—as to necessitate the appointment, in November, 1964, of a nurse for follow-up visiting and, in January, 1965, of an assistant medical officer. A report was prepared and submitted in March, 1965 to the London County Council and to the two Boroughs directly concerned, with the recommendation that the scheme as at present operating merits the financial support of the local authority.

The foundation is indebted to Dr. C. P. Blacker for a gift to the Clinic of books from his library.

FINANCE

DONATIONS. During the year to 31st December, 1964, the *Society* has gratefully received the following donations: Mr. C. M. Goethe, £4 16s. 5d. (\$14.00); Major D. D. Sellon, £4 4s. 6d.; Mr. C. F. Wright, £10 os. od.; and Mr. G. R. S. Snow, £8 os. od.

The *Society* has also received with gratitude a donation of £356 11s. 9d. (\$1,000.00) from the Hopkins Donation Fund (Dr. Prynce Hopkins of California) specifically for the support of Dr. J. B. Gibson's research on social mobility and differential fertility.

LEASEHOLD AND FREEHOLD PROPERTY. Messrs. John D. Wood & Co., Estate Agents, of 23, Berkeley Square, W.1, have continued to manage the *Society's* properties.

The sale of the Factory at Redhill, Surrey to the tenants (Safety Products Ltd.) who had paid part of the purchase price by means of additional rent, was completed in July, 1964. The *Society* received a balance payment of £5,425 less charges of £73 and the resulting profit of £352 has been credited to the General Fund Account.

INVESTMENT. The *Society's* investment at 31st December, 1964 in the Charities Official Investment Fund amounted to 87,655 income shares, an increase of 20,051 on the previous year. The additional shares represent the conversion, in April, 1964, of the remaining investments taken over *in specie* by the Fund at the time of the *Society's* initial subscription, and the contribution of a further £4,000 cash.

Cash on deposit with the United Dominions Trust was repaid during the year.

SOCIAL WORKERS' PENSION FUND. By decision of the Executive and Finance Committee a capital contribution was made to the Fund for Miss Schenk and Miss Kordik in the amount of £427 and £302 respectively. These two sums represent the present value, compounded at 4 per cent per annum of 5 per cent of annual salaries received by them from the *Society* before becoming members of the Fund.

ACCOUNTS FOR 1964. The Balance Sheet and the Income and Expenditure Account for the year to 31st December, 1964, will be found at the end of this Report.

For the year under review ordinary working expenses exceeded income by £1,084. In addition, grants made during 1964 (£2,558) were debited together with costs of the Darwin Research Fellowship (£200) and the Symposium (£996); this produced a deficit of £4,838 which was reduced to £3,518 by allocations amounting to £1,320 from the Marie Stopes Memorial Foundation Limited.

The General Fund, which stood at £99,394 at 31st December, 1963 has been increased by £5,529 in respect of profit on the sale of investments including freehold property. The Fund has been debited with the costs of purchasing the Caretakers' annuity (£3,246) and the capital contribution to the Social Workers' Pension Fund (£729). After transferring the deficit of £3,518 the balance at 31st December, 1964 was £97,430.

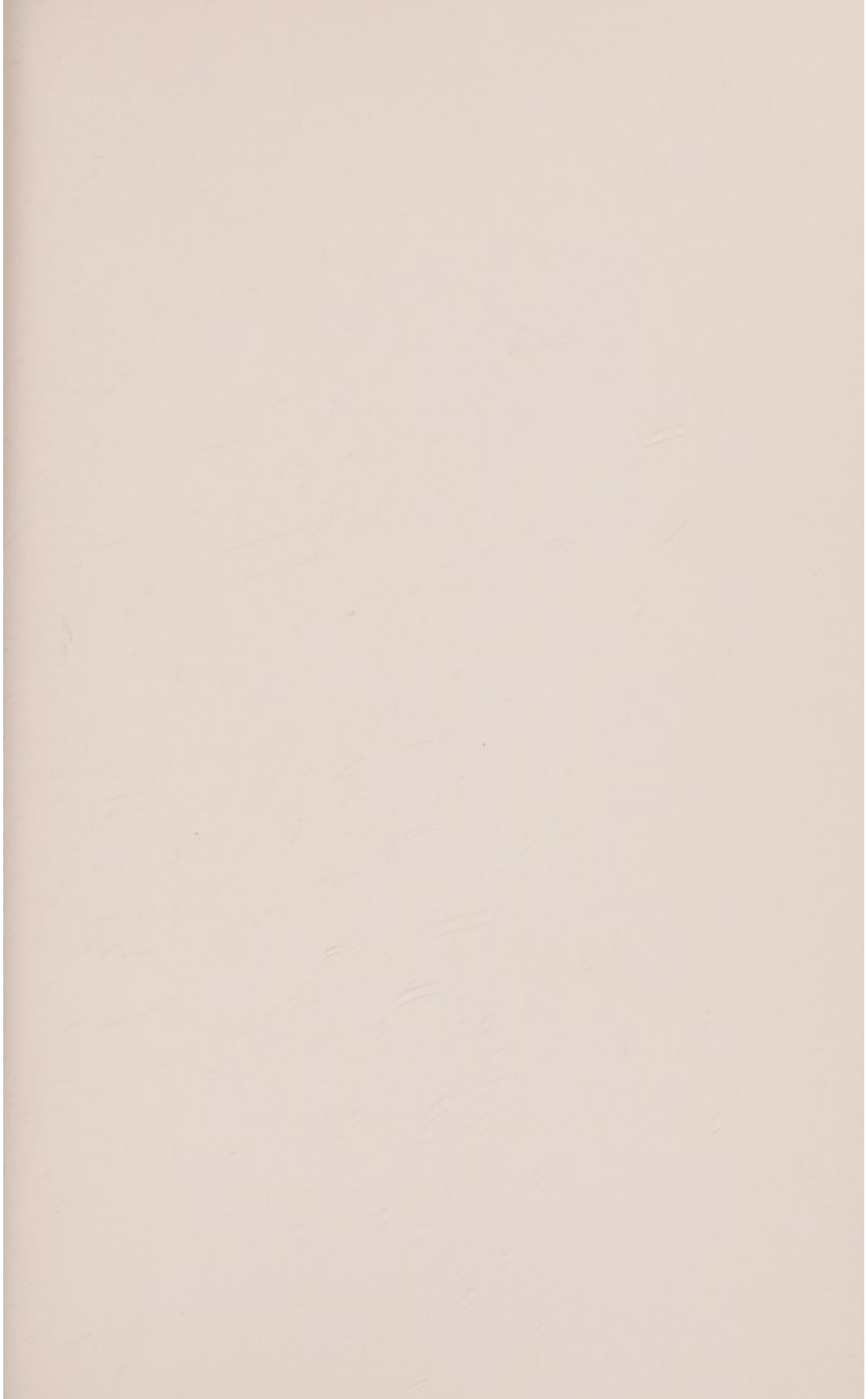
