

In this report the accounts relate to the period from 1st January, 1966 to 31st December, 1966 inclusive. The rest of the Report covers the period from 1st April, 1966 to 31st March, 1967.

During the period under review the Executive and Finance Committee has met four times.

CONSULTATIVE COUNCIL

The Consultative Council has suffered losses in the death of The Lord Brain and of Sir Arthur Ellis.

STATEMENT OF AIMS

An abbreviated statement of the Society's aims and activities has been approved by the Council. Copies are available from the Society's office.

MEETINGS

The Galton Lecture. The Galton Lecture for 1966 was delivered on Wednesday, 1st June by Dr. J. M. Tanner on "Galtonian Eugenics and the Study of Growth". The Chair was taken by the President and about fifty people were present. The Lecture took place in the Rooms of the Royal Society and was preceded by tea.

The Galton Lecture for 1967, which will also be held at the Royal Society, will be given at 6.15 p.m. on Tuesday, 25th April by Dr. A. H. Halsey on "The Changing Relations between Biological and Social Sciences". Dr. Halsey is head of the Department of Social and Administrative Studies

in the University of Oxford, and a Fellow of Nuffield College.

The Darwin Lecture in Human Biology. The sixth Darwin Lecture in Human Biology, sponsored by the Institute of Biology in association with the Society, was delivered on Wednesday, 4th May, 1966 by Dr. O. G. Edholm on "The Physiology of Human Adaptation". Dr. G. Ainsworth Harrison was in the Chair and some eighty people attended. The Lecture took place in the Lecture Hall of the Natural History Museum.

The seventh Darwin Lecture will be given, also in this Lecture Hall, at 5.15 p.m. on Tuesday, 23rd May by Professor E. C. Amoroso, F.R.s., on

"The Evolution of Viviparity".

A notice of this, and of Dr. Halsey's Galton Lecture, will appear in next year's Annual Report.

The Caradog Jones Lecture. With the consent of Mr. Caradog Jones the Council, with The Royal Statistical Society, has agreed that in future biennial lectures under his name shall be held instead of the annual

award of an essay prize for which he provided in 1963.

The first Lecture was delivered on Friday, 17th March, 1967 by Dr. Michael Nicholson, of the Department of Politics in the University of Lancaster, on "The Resolution of Conflict". The Chair was taken by Professor M. S. Bartlett, F.R.s. and the audience numbered about seventy-five. The Lecture, which was preceded by tea, was held at the London School of Hygiene and Tropical Medicine.

THE EUGENICS REVIEW

The Eugenics Review has continued to appear quarterly under the Editor-

ship of Mrs. K. Hodson.

By decision of the Council at its meeting in June 1966 the Editorial and Library Committee has been disbanded and replaced by an Editorial Board whose membership represents all the disciplines within the Society's sphere of interest. This Board, which has met four times during the year, has consisted of Mr. P. R. Cox (Chairman), Mr. D. R. Brothwell, Dr. C. O. Carter, Professor P. Sargant Florence, Professor E. Grebenik, Dr. H. Lehmann, Mr. J. Peel and Professor J. M. Tanner with the Honorary Secretary and the Honorary Treasurer as ex officio members.

Beginning with the March 1967 issue the Review has appeared in a new format; the cover has been re-designed and the contents printed in single

column.

LIBRARY

During the past year thirty-six books have been added to the Library by gift or purchase; sixty-four books have been borrowed, nineteen of them by The National Central Library.

Fifteen journals have now been bound and may be borrowed by Fellows and Members. They are housed in a ground-floor office which has been fitted with bookshelves for the purpose and which it is intended shall be used as a periodicals room. There is ample shelving space and it is hoped to add new journals from time to time.

Any business concerning the Library has been dealt with by the

Executive and Finance Committee.

THE GALTON FOUNDATION

The Council has decided to establish by Deed of Trust an organisation to be called The Galton Foundation which will have aims generally similar to those of the *Society* and designed to ensure its official acceptance as a charity.

In the first instance the Foundation will be financed by the *Society* but it is hoped that in due course it will attract from other sources funds for disbursal on grants and research activities.

GRANTS

During the period under review the Council has approved the following grants:

Professor A. S. Parkes A sum of £120 for the continuation of research on low temperature preservation of human semen.

The National Bureau A sum of £50 towards the general cost of for Co-operation in Child a review of literature in connection with Care adoption.

Dr. K. Hutton and A sum of £20 for a second inquiry into the Dr. C. O. Carter fertility of Wykehamists.

Dr. N. Nevin A sum of £200 to enable him to attend the third International Congress of Human Genetics held in Chicago in September 1966.

Dr. A. J. Boyce A sum of £500 towards research on changes in the demographic and genetic structure of some Oxfordshire villages.

The sum of £200 held in reserve since 1965 for enquiries in the field of abortion has been made over to Dr. D. M. Potts to enable him to visit Eastern European countries to investigate governmental, medical and public attitudes there to abortion.

Dr. A. Roughton has been unable to carry out the study in Japan for which in 1964 the Council made her a grant of £50. She has therefore withdrawn her claim to the money which has been returned to general funds.

In August, 1966 Mr. D. F. Richardson, who was carrying out Professor Parkes's research programme, left to work in America. Consequently the grant listed above has been drawn upon only to the extent of a small balance for equipment and Professor Parkes has withdrawn his claim to £119, which sum has also been returned to general funds, as well as to the residue of £570 of the grant made for this work in 1964.

At 31st December, 1966 the Grants Fund stood at £300 representing the grant to The Society for the Study of Human Biology (1963) £50, which had not been drawn at that date, and a balance of £250 undrawn by Dr. Boyce (1966).

SYMPOSIA

The Society's third symposium, on Social and Genetic Influences on Life and Death took place on Wednesday and Thursday, 28th and 29th September 1966. It was intended that it should be held, as in previous years, in the Botany Lecture Theatre of University College London, but owing to noise caused by building works a transfer was arranged after the first morning to the College's Chemistry Theatre.

The meeting, which again comprised four sessions, was opened by the President who then took the Chair for the first, on pregnancy, conception and birth, in place of Professor Parkes who was unable to be present. Some major causes of somatic and psychological illness were discussed in sessions two and three under the respective Chairmanship of the President and Sir Aubrey Lewis, and session four, for which Professor E. M. Backett presided, dealt with causes and effects of ageing.

The meeting was generally considered a success but the number attending the later sessions fell short of expectations owing to the change

to a Theatre where up-to-date facilities were not available.

The Proceedings will be published as volume three in the series of the Society's symposia. During 1966, 286 copies were sold of volume one, Biological Aspects of Social Problems, making up at the end of the year a total sale of about 1,583. Volume two, Genetic and Environmental Factors in Human Ability was published on 7th December, 1966; sales at the end of the year amounted to 191.

Arrangements are now being made for the fourth symposium, on Genetic and Environmental Influences on Behaviour, which will be held in the Meeting Rooms of the Zoological Society, London, on Thursday and Friday, 28th and 29th September next. As planned at the time of writing the four sessional topics will be Comparative Studies, Environmental Influences, Interrelations and Genetic Influences. A full programme will be obtainable in May from the Society's office.

THE MARIE STOPES MEMORIAL FOUNDATION LIMITED The Balance Sheet and Revenue Account for the year to 31st December, 1966 of The Marie Stopes Memorial Foundation Limited will be found at the end of this Report.

There was an excess of income over expenditure for the year amounting to £3,756 which, added to the Revenue Account balance at 31st December 1965 of £5,084 increased the revenue surplus to £8,840. Of this balance £6,495 was carried forward, the sum of £2,345 having been expended during the year on training, the domiciliary service, a grant, a special donation and an allocation of £1,500 to The Eugenics Society. A further allocation of £658 charged to the Revenue Account was made to the Society in respect of administrative and secretarial services.

The cost of the training courses for overseas personnel was £226 which was reduced by fees received of £181 to a net figure of £45; the domiciliary service was allocated the sum of £50 towards the cost of a follow-up survey; the grant, of £500, was the second of three equal payments which were guaranteed by the Board in 1965 to Brook Advisory Centres Limited; and a special donation, of £250, was to the Margaret Pyke

Memorial Appeal.

The Board has suffered losses in the death, in 1966, of the President—The Lord Brain, Mrs. Margaret Pyke and Lady Lewis all of whom will be greatly missed. Mrs. Elizabeth Mitchell has been appointed to the Chairmanship of the Clinic Committee and to membership of the Board whose other members are Dr. G. C. L. Bertram (Chairman), Mrs. H. Brook, Dr. C. O. Carter, Mr. John Peel and Mr. A. I. Wyborn. Miss Schenk has continued to serve as Secretary.

The domiciliary birth control service has continued under the direction of Dr. Elizabeth Horder with the assistance of Dr. Phyllis Fleury. It has been financed fully by the London Boroughs of Camden and Westminster, in which it is operated, and it is hoped that in due course the service in its entirety will be taken over by their Health Departments; the Foundation has now been responsible for its direction for four years. Up-to-date information has been sought on the families who have received the service and a complete re-analysis has been made of the case record cards; a final report based on the findings will be submitted to the two Boroughs. It had been planned to conduct a comprehensive follow-up survey but this has been invalidated by proportionately consistent losses of cases in each year, owing primarily to removal from the area.

Training facilities for overseas personnel have been increased during the year. In addition to the six courses for nurses, twelve special sessions have been held for doctors and arrangements have been made for doctors

on short visits to this country to observe at IUD sessions.

Further repairs and decorations to the premises have been carried out including additional roofing over the area at the back of No. 108 Whitfield Street which has enabled the stock office to be enlarged. An annual inspection of the two houses will in future be made by the architects so as to lessen the possibility of emergency repairs.

Free accommodation and facilities at No. 106 Whitfield Street have continued to be made available to Brook Advisory Centres Limited.

By decision of the Board a pension scheme, operated through the Social Workers' Pension Fund, has been established for both full- and part-time staff.

There has been a continuing rise in attendances at the Clinic and the number of new patients showed an increase of sixteen per cent over 1965. During the year 560 doctor sessions have been held; these have included 200 for the IUD and weekly sessions, recently established, on Tuesday evening and Saturday morning. The Medical Sub-Committee has felt for some time that the staff should include more male doctors and consequently Dr. Nils Regan has been appointed for a new morning session.

Pregnancy diagnosis tests, which were started last year on a trial basis, have continued as an established service which is given without appointment. The number of sessions for cervical smears has remained at one a month and the slides are now read at the Samaritan Hospital; the Foundation has made a small donation to the Hospital towards the cost.

An open day at the Clinic was held on Friday, 21st October, 1966 for social workers in the Boroughs of Camden and Westminster. Throughout the day there were about 150 visitors some of whom asked to be given further information, by means of demonstrations, film shows or talks, about the Clinic's activities. As a result, an evening meeting, in the form of a "brains trust", was held on Monday, 13th February last. Under the Chairmanship of Mrs. Windley, the panel was comprised of members of the medical and nursing staffs and about twenty-five attended. The meeting was much appreciated and consideration is being given to arranging similar events from time to time.

A report on the development of the Clinic since the Foundation took over its management in 1960 is now in preparation and will, it is hoped, be published later this year. It will contain information on all the services now available and is intended primarily for circulation to workers in the social services.

FINANCE

DONATIONS. During the year to 31st December, 1966 the Society has gratefully received the following donations: Captain A. G. Olliver, £5 os. od.; Major D. D. Sellon, £4 18s. 5d.; and Mr. G. R. S. Snow, £8 os. od.

The Society has also received with gratitude a donation from The Hopkins Donation Fund of \$5,000 (£1,799 6s. 10d.) for disbursement in grants; with the approval of the Trustees this donation was applied in full to a two-year inquiry, under the direction of Mr. James Maxwell of the Scottish Council for Research in Education, into differential fertility in relation to intelligence. A sum of £1,000 was drawn in 1966 for the first year's work and the balance carried forward to 1967.

The donation of \$2,000 (£712 10s. 6d.) for the travelling expenses of overseas speakers at the symposia, received from the Fund in 1965 and carried forward by permission of the Trustees, was drawn upon in the amount of £163 4s. od. in respect of Professor A. H. Leighton of Harvard University.

LEGACY. The grant of £500, from the balance of Mr. Richard Rumbold's legacy, made by the Council in 1965 to The Simon Population Trust but which was undrawn in that year, was paid in full in May 1966.

LEASEHOLD PROPERTY. Messrs. John D. Wood & Co., Estate Agents, of 23, Berkeley Square, W.1, have continued to manage the *Society's* property.

Second Floor. At the request of the Council this Firm, in June 1966, negotiated with the Ground Landlords for a change of user on the second floor of 69 Eccleston Square so that it might be let by the Society without restriction and for an economic rent. In August, agreement was reached by which the Landlords entered a Deed of Variation to the Society's lease whereunder they gave permission for the floor to be used for general office purposes in consideration of payment by the Society of an additional ground rent of £275 per annum to be applied on the date of letting or on 25th December, 1966 whichever was the earlier.

Accordingly, the second floor offices have been redecorated and let to

Messrs. Cecil Baker and Partners, Quantity Surveyors, on a five year lease from 12th December, 1966 at a rental of £1,000 per annum plus a yearly service charge of £105 (to include central heating; see below).

Maisonette. In accordance with the terms of the lease the rent of the maisonette has been increased to £600 per annum exclusive as from 8th February, 1967.

The Society's offices. Central heating has been installed at a cost of £1,500. This sum has been capitalised and will be written off over the remaining period of the lease.

Major decorations, and improvements to the lighting have been carried out amounting to £650.

INVESTMENT. At 31st December, 1966 the Society's investment in the Charities Official Investment Fund amounted to 87,655 income shares. There has been no change during the year.

ACCOUNTS FOR 1966. The Balance Sheet and the Income and Expenditure Account for the year to 31st December, 1966 will be found at the end of this Report.

For the year under review income exceeded ordinary working expenses by £1,178. This surplus was increased by an allocation of £1,500 from The Marie Stopes Memorial Foundation Limited and a donation of £1,779 from The Hopkins Donation Fund; the latter has been transferred to the specific purposes fund on the Balance Sheet. Net expenditure on the publication of The Eugenics Review of £1,800 and on the symposia volume 2, on which because of late publication no royalties were received in 1966, of £243 has been debited together with the cost of the Darwin Research Fellowship, £100, and the symposium, £553; these, in addition to the grants approved during 1966, £721, produced a net deficit of £739.

The General Fund which stood at £96,221 at 31st December, 1965 has been reduced by this deficit of £739 and the balance at 31st December, 1966 was £95,482.
