

In particular, he referred to the lectures held during the year in association with other organisations; the annual Symposium, in which for the first time the Galton Lecture was integrated; and the changes in the Society's publications.

THE AUDITORS' REMUNERATION

The Society's Auditors, Messrs. Allfields, who were willing to continue to serve, were reappointed.

The following RESOLUTION was proposed from the Chair and carried unanimously:

"that the Auditors' remuneration for the current year to 31st December shall be the sum of one hundred guineas with a further charge for additional accountancy as shall be agreed between the Auditors and the Treasurer."

Before the close of the meeting Dr. G. C. L. Bertram reported briefly on the current activities and progress, outlined in the Eugenics Society's Annual Report, of The Marie Stopes Memorial Foundation; and two of the Society's members present made suggestions on policy which the Chairman agreed should have Council's consideration.

Annual Report: 1969-70

IN THIS REPORT the accounts relate to the period from 1st January, 1969 to 31st December, 1969 inclusive. The rest of the Report covers the period from 1st April, 1969 to 31st March, 1970.

During the period under review the Executive and Finance Committee has met once; the business of its meetings normally held in October and January was combined with that of the subsequent Council meeting in each case.

CONSULTATIVE COUNCIL

The Consultative Council has suffered losses in the death of Professor H. A. Harris, M.D., D.SC., and R. D. Lawrence, M.D., F.R.C.P.

MEETINGS

The Galton Lecture (see Symposia below).

The Darwin Lecture in Human Biology. The ninth Darwin Lecture, sponsored by the Institute of Biology in association with the Society, was delivered on Tuesday, 6th May, 1969 by Professor Harry Harris, F.R.S., on "The Population Genetics of Enzymes and Proteins". Professor G. Pontecorvo was in the Chair and about 150 people were present. The Lecture took place in the Lecture Hall of the Natural History Museum.

The tenth Darwin Lecture will be given, again in this Lecture Hall, at 5.15 p.m. on Wednesday, 20th May, 1970 by Dr. D. M. Potts on "Against Nature—the Use and Misuse of Birth Control". Dr. Potts is Medical Secretary of the International Planned Parenthood Federation.

The Caradog Jones Lecture. The second Caradog Jones Lecture, arranged in conjunction with the Royal Statistical Society and the Master of Pembroke College, Cambridge, was delivered on Wednesday, 30th April, 1969 by Mrs. M. E. Bateman on "Improving Relationships between Management and Employees". This is one of the three topics which Mr. Caradog Jones desires should be ventilated at these lectures. Professor Sir Alan Parkes was in the Chair and Mr. P. R. Cox proposed the vote of thanks. The Lecture took place in the Lecture Theatre of the London School of Hygiene and Tropical Medicine and about 50 people were present.

JOURNAL OF BIOSOCIAL SCIENCE

The Journal of Biosocial Science has appeared quarterly and Dr. Eliot Slater, Dr. A. C. Stevenson and Dr. Barbara Thompson have joined the Editorial Board.

During 1969, 120 of the Society's members decided to pay the compound subscription which entitles them to receipt of the Journal and to its Supplements containing the Proceedings of the Society's Symposia.

The Council has agreed that in respect of the symposium Supplements the Society shall pay to the Journal in 1970 a sum of £500 for administration and publicity, and £250 for editorial work; in 1969 the former payment only was made.

THE BULLETIN

The Society's *Bulletin* has appeared each quarter under the editorship of the General Secretary with the support of an advisory committee.

The purpose of the *Bulletin*, which for reasons of cost is at present restricted normally to twenty pages, is mainly to provide for members a commentary on biosocial developments and discoveries of the day. It also announces forthcoming lectures and meetings, prints short book reviews and gives annotations of relevant periodicals.

In April 1969 a circular letter, offering a year's free subscription, was sent to selected departmental and medical school libraries, of which twenty-six accepted. The *Bulletin* is also sent to associated organisations, either free of charge or in exchange for a similar publication, in London and the United States.

THE LIBRARY

The Library now consists of some 4,000 books and of long runs of many journals of interest to biologists and sociologists. The Council has decided that there is scope for a more rapid building up of the stock, and in accordance with this policy about a hundred new books have been acquired during the year. Particulars of many of these are given in the *Bulletin*.

During the year the incomplete series in the library of the *Cold Spring Harbor Symposia on Quantitative Biology* has been completed by the purchase of a number of past issues; this is a special addition to the stock.

The gradual disposal of out-dated and duplicate books and journals has also continued.

GRANTS

During the year under review the Council has approved the following grants:

The balance, of \pounds 150, of the donations from the Hopkins Fund in 1967 and 1968 was contributed towards the cost of these two grants.

At 31st December, 1969 the Grants Fund stood at £2,000, representing the balance held in reserve for the *Journal of Biosocial Science* (1968).

RESEARCH FELLOWSHIP

As members will have read in the current issue of the *Bulletin*, the Council has decided on the principle of appointing a Research Fellow for work of direct eugenic relevance which can be initiated and pursued directly from the Society's office.

The initial appointment has been made to Mrs. Madeleine Simms, M.A., for a period of up to three years from 1st January, 1970, and it will be concerned with a scientific and impartial study of the implementation of the 1967 Abortion Act and its demographic and sociological consequences.

Mrs. Simms will be under the guidance of a research sub-committee, appointed by Council from amongst its members. She will work in the Society's library and will also travel in London and elsewhere.

In establishing a Research Fellowship, Council has decided to discontinue the provision of grants for the time being.

SYMPOSIA

The Society's sixth Symposium, on *Biosocial Aspects of Sex*, took place on Tuesday and Wednesday, 23rd and 24th September, 1969, in the Meeting Rooms of the Zoological Society of London.

The Meeting was opened by the President and, as is now customary, consisted of four sessions: the first, under the Chairmanship of Sir Dugald Baird, was on genetic and environmental aspects, and the second, for which Dr. Eliot Slater took the Chair, was concerned with sex ratios in different populations.

On the morning of the second day the President was in the Chair for the third session, which dealt with comparative occupational performances and which included the Galton Lecture delivered by Dr. Kathleen M. Kenyon on "Women in Academic Life". The President proposed a vote of thanks to Dr. Kenyon whose lecture was appreciatively received by the audience.

Dr. A. H. Halsey took the Chair for the fourth session, on sociological aspects, and closed the Meeting. Although the numbers attending during the course of the two days were not so consistently high as those in the previous year, the Symposium was well supported. A fuller report, summarising some of the papers read at the Symposium, appeared in the December 1969 issue of the *Bulletin*.

The Proceedings will be published as Supplement No. 2 to the *Journal* of Biosocial Science.

During 1969 sales of the volumes still in print of the Society's earlier Symposia were as follows: volume one, *Biological Aspects of Social Problems*, 7 copies; volume three, *Social and Genetic Influences on Life and Death*, 108 copies; and volume four, Genetic and Environmental Influences on Behaviour, 160 copies. The stock of volume one is now exhausted. By the end of the year 78 copies had been sold of Biosocial Aspects of Race published in July 1969 as Supplement No. 1 to the Journal of Biosocial Science.

The programme is now being arranged for the seventh Symposium, on *Biosocial Aspects of Human Fertility*, which will again be held in the Meeting Rooms of the Zoological Society, on Thursday and Friday, 24th and 25th September. The four sessions will be on physiological and environmental aspects, fertility in different populations, sociological aspects and problems of fertility control.

Full details will be available in May.

THE MARIE STOPES MEMORIAL FOUNDATION LIMITED The Balance Sheet and Revenue Account for the year to 31st December, 1969 of The Marie Stopes Memorial Foundation Limited will be found at the end of this Report.

There was an excess of income over expenditure for the year amounting to £5,149 which, added to the Revenue Account Balance at 31st December, 1968 of £6,867 increased the revenue surplus to £12,016. After expenditure during the year of £57 on training and the follow-up survey of the domiciliary service, an allocation of £1,000 to the Eugenics Society and a grant of £25 to the York Consumer Group, a balance was carried forward of £10,934. A further amount of £700 charged to the Revenue Account was paid to the Eugenics Society in respect of administrative and secretarial expenses.

The rent, which on 1st January, 1969 was increased from £2,000 to £2,500 per annum, paid to the Society for Constructive Birth Control Limited enabled that Company to approve grants, at the request of the Foundation, as follows: to Dr. A. Giles for further support of post-partum family planning, a sum of up to £230; and to the London Pregnancy Advisory Service for an analytical survey of its collected data, a maximum sum of £750. At 31st December, 1969 these grants had been drawn in the amounts of £180 and £150 respectively.

There have been no changes during the year in the membership of the Board who are Dr. G. C. L. Bertram (Chairman), Mrs. Helen Brook, Dr. C. O. Carter, Mrs. Elizabeth Mitchell, Mr. John Peel, Dr. Malcolm Potts and Mr. A. I. Wyborn. Miss Schenk has continued to serve as Secretary.

The training programme for overseas personnel has continued. As usual six courses for nurses were held during the year with an average attendance of seven. A weekly session has again been held for doctors referred by the European Region of the International Planned Parenthood Federation.

In August 1969, with the approval of the Board, a vasectomy clinic was initiated on a trial basis by Dr. Potts and the Medical Sub-Committee. In the course of the first three months ten vasectomies were performed, initially under the supervision of Mr. Peter Diggory, by Dr. Potts and Dr. Nils Regan. In November it was agreed that the continuing demand justified a regular service and accordingly sessions were established on a fortnightly basis to begin with and increased to one each week from 1st January, 1970. By the end of February forty-eight patients out of 102 who were interviewed had had the operation. At its meeting in March 1970 the Board further approved proposals for setting up a domiciliary scheme in which one session a week will be set aside as a vasectomy clinic which can be integrated with the Local Authorities' family planning services. The domiciliary visitor will be informed of the availability of the session and the doctor performing the operation will be available to visit patients in their own home either before or after the operation. At the time of the operation assistance will be given, if necessary, in transporting the patients to the clinic. As it is envisaged that the service will be free, or that a nominal fee only will be charged, the Board agreed to make available a provisional sum of up to £250 for the scheme; after three months it should be possible to make some assessment of the actual cost. An organising committee with power to act was appointed consisting of Dr. Potts, Dr. Regan, Mrs. Mitchell, Miss Schenk and Mrs. Windley.

New patients in 1969 numbered 3,368 as compared with 2,745 in 1968; an increase was expected when additional clinic space became available after the departure in January 1969 of Brook Advisory Centres, and the achieved improvement is encouraging. Nevertheless, the Board has given some considerable thought during the year to the reorganisation of sessions in such a way that a continuing increase can be accommodated while at the same time the standard of service is maintained. It has been agreed to consider the extension of a new form of session, carried out successfully by Dr. Gordon in 1969, at which the doctor will deal with all new patients, and the attending two nurses-instead of one as previously-will deal with check visits of patients on oral contraceptives in accordance with the procedure laid down by the doctor. This routine would be carried out on the strict understanding that the doctor will see when she thinks it advisable any patient returning for check and, conversely, that both the nurse and the patient have access to the doctor if they wish. It is hoped that up to five such sessions can be initiated during 1970.

During the year 809 doctor sessions have been held which have again included weekly sessions for marital difficulties and also for pregnancy advice and referral. Dr. Jacobs, who is in charge of the latter sessions, has completed an analysis of the 200 patients who attended in the first six months of operation; she hopes to produce a full report when the service is longer established.

In association with the Central London Branch of the Family Planning Association and Brook Advisory Centres the Clinic organised an evening meeting to launch Family Planning Week (from 3rd to 7th November, 1969). The meeting, which was held on 30th October at the St. Pancras Assembly Rooms, was very well attended and there were lively discussions after four speeches on the theme of "Birth Control in the 'Seventies'". An open day was held at the Clinic on 4th November and the staff received about fifty visitors, for whom a showing was arranged of the film *Techniques of Contraception* produced by the International Planned Parenthood Federation.

OBITUARY

We regret to record the death of the following Fellows and Members: Mr. W. Coates, Sir Victor Mallet, Mr. A. H. Smith and Mr. G. R. S. Snow.

FINANCE

DONATIONS. The Society gratefully acknowledges donations received during the year.

LEGACY. Notification has been received of a bequest of \pounds 500 to the Society by the late Mr. G. R. S. Snow who had been a Fellow for many years.

LEASEHOLD PROPERTY. Messrs. John D. Wood & Co. have continued to manage the Society's property at 69, Eccleston Square.

Repairs amounting to £848 were carried out during the year. Of this sum £300 was expended on external repairs and £95 on extending storage cupboards. The remainder was accounted for by internal decorations and maintenance.

The Council has been advised that the current market value of the property is well in excess of the book value.

FURNITURE AND EQUIPMENT. During the year to 31st December, 1969 the sum of $\pounds 627$ was expended on carpeting the ground floor offices and the library; in addition, $\pounds 76$ was expended on an adding machine and a vacuum cleaner. It is proposed to write off the cost of the carpet over the next five years.

INVESTMENT. Income shares in the Charities Official Investment Fund to the value of £20,000 were withdrawn from the Fund and £18,742 was re-invested in dated fixed-interest Stocks.

The Balance of $\pounds_{1,258}$ was applied to the general purposes of the Society.

Over the past two years there has been a capital gain of \pounds 3,800 which has been credited to the Society's General Fund Account.

ACCOUNTS FOR 1969. The Balance Sheet and Income and Expenditure Account for the year to 31st December, 1969 will be found at the end of this report.

For the year under review income exceeded ordinary working expenses by $\pounds 1,328$ and this surplus was increased by an allocation of $\pounds 1,000$ from The Marie Stopes Memorial Foundation Limited. Expenditure on the publication of the *Bulletin* of $\pounds 688$ together with the net expenditure on the Symposia, $\pounds 1,751$, has been debited together with the cost of the Symposium, $\pounds 769$; these, in addition to the grants approved during 1969, $\pounds 2,645$, produced a net deficit of $\pounds 3,525$.

The General Fund which stood at £92,796 at 31st December, 1968

has been credited with the profit on realisation of the Charities Official Investment Fund income shares, £3,800, and reduced by the deficit of £3,525, leaving a balance at 31st December, 1969 of £93,071.




