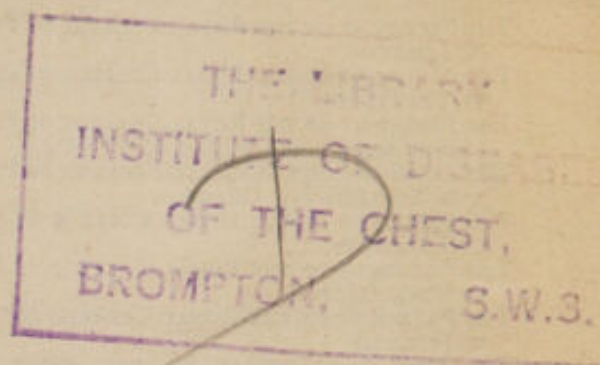

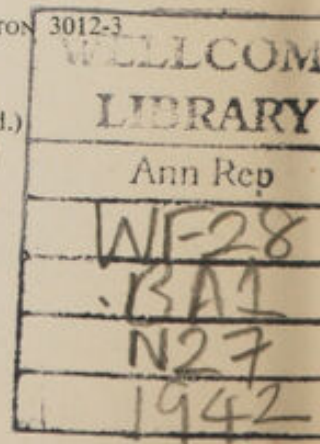

ANNUAL REPORT 1941

At the beginning of this war, the prophet and the epidemiologist agreed in predicting an increase in tuberculosis. Our understanding of its causes is far from complete, but all we know from observation and the experience of the last war suggests that the death-rate is likely to rise, and the resistance of a large number of potential patients to fall.

The first war-year seemed to suggest that such expectations were mistaken. No increase of deaths occurred. Could it be that we were justified in being more optimistic? Was this war to be the exception in respect of tuberculosis, as in so many other ways? For the present, no final answer can be given, but figures which the Minister of Health has communicated to Parliament, show that already in 1942, an increase in mortality has begun to show itself: at all ages this amounts to 11 per cent. and for the age-group 15-25, as high as 19 per cent. over the peace-time level. In one city, the war-time increase was as high as 20 per cent.

Dr. Percy Stocks, Medical Statistical Officer to the General Register Office, has given the most recent figures so far published regarding tuberculosis in the "Lancet" of February 14th, 1942:—

There are many possible explanations for this rise. To-day, many people are scattered far from their homes; institutional beds are fewer; the age and sex constitution of our people has been altered by the absence of several million of men and women in the Fighting Forces. Nevertheless, the fact remains: from all we know of vital statistics, the curve representing the deaths from tuberculosis has arrested its fall—we hope, for the time being only.

The Medical Profession, Parliament, and the public have expressed their concern, and the Minister has appointed an influential Committee, under Lord Dawson of Penn, to investigate this question. This action shows that the individual causes are far from clear.

Statistical and other enquiries will be necessary, but by next year, we should be able to establish the facts. Then remains the question :

“ Given the cause of this increase, what more can we do to arrest it ? ”

RADIOLOGY

Through original research, largely of British physicians, a type of pulmonary tuberculosis, showing few symptoms, has been discovered. It occurs chiefly in young adults : it can progress silently, without disturbing the patient very much ; or perhaps it would be truer to say that the symptoms the patient feels are mistaken for other things, and the disease in the lung progresses, until serious changes have taken place, and the germs have appeared in the sputum. He is then what is called an “ open ” case, far less curable, a potential danger to others, and a burden to the community.

Tuberculosis Dispensary work has been built up on the assumption that patients will be referred by their doctors only when there is something wrong, or where they are contacts with a person known to be suffering from pulmonary tuberculosis.

What becomes then of the tragic cases in whom the disease is stealing on, but shows no signs ?

The Association has been greatly concerned with this problem, and, with the advice of a Committee, under the chairmanship of Dr. R. A. Young, a member of Council, has decided that X-Rays are the surest method of finding these unknown symptomless cases. When Julius V. Roentgen, some 46 years ago, threw the shadow of a bone on a photographic plate by means of X-Rays, he did not foresee the value of his discovery in medicine. X-Rays have been used in the diagnosis of pulmonary tuberculosis for the last 15 years. The shadows which the air-containing lung throws on the screen with the various changes due to disease have been intensively studied, but radiology has been handicapped by its high cost, and the difficulty of examining large numbers of patients.

The Association has felt that the public requires authoritative guidance on this subject, and decided to issue a memorandum on “ The Discovery of Symptomless Pulmonary Tuberculosis.” This memorandum was circulated to Medical Officers of Health, County Medical Officers, Tuberculosis Officers, Local Authorities and their Public Health and Education Committees, Insurance Committees, Approved Societies, Trade Unions, Medical Members of Parliament, British Medical Association Divisions, as well as the medical and lay press, and nearly 9,000 copies have been sent out, mostly on request. It is evident that the memorandum has aroused considerable interest, both inside the medical profession and in the much larger circles of those who are concerned with our Public Health in war-time.

By a deputation to the Past-President of the Trades Union Congress, the Association was able to put this point of view, and to express willingness to explore further the many social developments in the Tuberculosis Scheme, which will be necessary in years to come.

THE CARE OF YOUNG WOMEN

Under the Armed Forces Act, 1941, upwards of two million young women are being medically examined, and many will find their way into the Services or industry. It may be surmised that the majority of them will find the new conditions more strenuous than their lives would be in peace-time. These are in the age groups at which the risk of serious pulmonary tuberculosis is great, and the Association is urging upon the Authorities two

lines of action which will tend : (a) to detect individual cases of tuberculosis, before admission to the Services, with a consequent saving of the expense of training and subsequent pension, and (b) the regular use of X-Rays to eliminate tuberculosis which may develop subsequently.

Never in history has such a mass of susceptible men and women been gathered together. Never has such a magnificent opportunity for observation been open to the organised medical services.

The Association will urge that these opportunities should be taken, and lessons accumulated, that can be applied later in civil life.

CARE WORK

Although Care and After-Care work for the tuberculous family has figured in tuberculosis schemes for years, the Council has often felt that little official approval was given. The Public Health Act, 1936, laid down that Local Authorities may make schemes : "The Council of a County or County Borough may make such arrangements as they think desirable for the after-care of persons who have suffered from tuberculosis." But in many areas this is not observed.

The Association warmly welcomes the Circular No. 2526 of the Ministry of Health, which includes care work as part of the normal tuberculosis service. A service not provided with some means of helping the social condition of the patient will fail to produce the best results. Money will be spent on treatment without full effect, and patients will suffer hardship which a little social care might have prevented.

The method by which this social care is given varies in different parts of the country. Some areas prefer professional almoners, in other cases the work is done through the Secretary of the Tuberculosis Dispensary. In still others a voluntary care committee is the mainstay of social work, and during the year two more such committees have applied for admission to the Association's scheme.

REHABILITATION

When we deal with the tuberculous patient, we are dealing not only with disease and toxins produced by the *tubercle bacillus*, but with a complex and often tragic social problem. In the past, perhaps too much satisfaction has been felt when the patient, after long and expensive treatment, is returned to his environment, technically cured of his physical disease, but with little prospect of maintaining his health and livelihood. Care work holds the family group together, and tries to bridge over the awkward gap between illness and normal life. But this is as much as it can be expected to do.

The complete rehabilitation of the tuberculous invalid, his training and setting out once again in normal life, perhaps with a new trade, or a fresh dwelling, and some kind of economic security, raises big problems which have been under discussion for some time. Action and change are needed. The Council is aware of these trends of opinion, and the need for action, and will see that they are fully considered in post-war planning.

STANDING ADVISORY COMMITTEE

This Committee, set up by the Rt. Hon. Walter Elliot as Minister of Health, has continued its work during the year. The Vice-Chairman and Secretary-General represent the Association on it, and the work of the Committee is carried out from the Association's headquarters. This Committee is the official channel of communication between tuberculosis work and the Minister of Health, and during the year it has investigated at his request, and the request of the Local Authorities, a number of important problems.

As a result of the Committee's deliberations, more attention has been paid to the urgent question of the shortage of staff in hospitals and sanatoria. Rationing as it affects the tuberculous has been repeatedly discussed, and Professor Himsworth, Secretary of the Food Rationing (Special Diets) Advisory Committee has assisted the Committee. The Committee recommended that recruits, particularly women, and entrants to industry, should have a radiological examination of the chest as part of their medical examination, and a meeting was later held to discuss the question of advice to be given to Local Authorities as to whether they should lay orders with British Manufacturers for mass radiology units. Viscount Dawson of Penn, Brigadier McGrigor, Dr. Cochrane Shanks and representatives of the Ministry of Supply and Ministry of Health assisted the meeting, and it was decided to recommend that apparatus for the civilian population should, for the time being, be placed under the direction of the Ministry of Health. The Committee considered that a minimum of 50 sets of apparatus would be required within the next twelve months for the examination of members of the Services and of the civilian population, and recommended that the highest priority for their manufacture should be given.

SEAL SALE

The Seal Sale has two objects—to spread an interest in the tuberculosis problem, and to collect funds, and these objects are inter-dependent. The little stamp which becomes more popular each year is designed to arouse interest, and to make people ask the question "What is all this about?" On the stamp no mention of tuberculosis is made.

Naturally the larger the number of the stamps sold, the greater the funds available to the Association and its Affiliated Branches throughout the country.

At the beginning of the war a wave of pessimism came over everyone who had the Seal Sale at heart. This has proved to be entirely unjustified. The 1941 Christmas Seal Sale has been the best on record, since the scheme was started in 1933, even surpassing the previous record of 1936. This is the case with the Affiliated Societies as well as Headquarters.

Some 58 Affiliated Care Committees participated, and the receipts were 30 per cent. higher than in 1940. The number of subscribers was substantially increased, and new avenues of pushing the propaganda embodied in the Seal Sale have been successfully opened up.

The Association is much indebted to Dame Irene Vanbrugh, whose telling broadcast on November 2nd last was almost immediately reflected in a great increase of interest.

Once again we are doubly grateful to the Canadian Tuberculosis Association, who have donated the full supply of the actual Seals, so that both the Affiliated Societies and the Headquarters of the Association have been able to carry out their arrangements free from all anxieties on this score. The Canadian Tuberculosis Association have again used a design which was sent out from Headquarters.

The Seal Sale is the result of careful planning, at least a year and a half in advance, and we must now look to the campaigns of 1942 and 1943. The proposal from the Canadian Tuberculosis Association and National Tuberculosis Association of America that the same design should be used by these countries and Great Britain has been accepted with enthusiasm by our Council, and we believe it will find general approval.

OUR COLONIAL EMPIRE

Even before the present war, serious attention was being given to health conditions in our Colonial dependencies. It is perhaps natural that the public, and even doctors and administrators, should be more interested in the dramatic diseases—yellow fever, leprosy,

malaria—in the prevention of which so much progress has been made. But tuberculosis does not fall short of these in evil consequences. If its full effects on the population, in their social and economic life, could be measured, tuberculosis might be recognised as the greatest scourge of hot countries.

Yet there is no reason to think that the disease cannot be controlled in West Africa and the West Indies any less than it is being combated in Lanarkshire, Lancashire, and West Ham. When due allowance is made for difference of climate, occupation and geography, the main facts remain the same. It is to be hoped that after the war even more attention will be paid to this problem.

A Royal Commission which went out to investigate our West Indian possessions has drawn up its report, and, as a result, a Colonial Development Fund has been started. The Medical Controller of this Fund, Sir Rupert Briercliffe, has set up an organisation in Jamaica to cover the whole of the British possessions in the Caribbean Sea. Remembering the excellent work of the late Dr. Noel Bardswell in Cyprus, the Association has offered its help to the Controller, and is prepared to carry out a similar mission of investigation. It is hoped that this may be one of a number of surveys on tuberculosis in our smaller colonies.

PROPAGANDA

The public is becoming uneasy about the fact that tuberculosis is one of the new perils of war-time. Perhaps this is the reason for an even greater interest in our education propaganda during the year. Through the Central Film Library of the Ministry of Information we have been able to borrow useful films of general interest. These serve to round off the cinema film programmes, and to prevent people feeling that they are being preached to. It will be generally agreed that propaganda is much more effective if it can be given accompanied by entertainment.

At the beginning of the year, the Association was invited by the Central Council for Health Education to collaborate in providing cinema demonstrations in the London air-raid shelters, and Dr. Harley Williams was asked to organise this work on behalf of the Central Council.

The Association's cinema unit was occupied fully for several months in the evenings, and later during the day-time, also in connection with the Civil Defence Personnel of the London Region.

Anyone who moved about in London in the darkness and peril of last winter will know that this called for energy and fortitude. Some eighty cinema demonstrations were given by this Association alone. A long list of testimonials from the shelterers, Shelter Wardens, Clergymen, and other spectators, shows that the demonstrations were much appreciated.

In addition, the Association carried on its work in rural areas. Two lengthy tours were arranged in the Counties of Leicestershire and Durham, through the Insurance Committees, Care Committees and Education Authorities. A letter from Mr. T. Crew, Clerk to the Leicestershire Insurance Committee, may be quoted as expressing the general welcome which these tours have received :—

“The sound health films have been the best series ever shown in this area, and without question everybody has praised the all-round material and excellence of the films. Such educational entertainment is bound to be of immense benefit to the school children and we feel that the tour has been well worth while and a great success.”

The wisdom of teaching young children the facts of tuberculosis may be doubtful, but no one has objected to the general health films and these we feel are a mental preparation for a later age at which the facts of tuberculosis must be faced.

Quotations of some of the children's essays are interesting :—

“Stand Up and Breathe” was rather a helpful film, and if everyone who sees this film takes its sound advice, there will be hundreds of complaints less each year. Flat chests, round shoulders, and a shambling walk can be remedied by sitting, standing and breathing properly.”

“These film programmes are an excellent idea, and more of them should be seen in Britain, they teach us much more about the subject than if a person was talking. He cannot show you movable diagrams, or germs, etc., in real life, but on the films this is possible. So I think that more of these ‘Health’ programmes should be shown at cinemas all over the country, so that everyone, including grown-ups, should see the necessity of good health.”

During the year over 40,000 persons saw the films projected by the Association's cinema unit.

BURROW HILL SANATORIUM COLONY

The Burrow Hill Colony has now been open for the cure and training of tuberculous boys for 13 years, and during this time has a record of success. The Association is indebted to the Local Authorities and their Medical Officers for their support in sending patients, and we believe the facilities of the Colony have proved a valuable opportunity for this special class of patients. The war has rather interrupted the training scheme. It is, nowadays, so easy for youths to obtain well-paid employment that they are only too ready to postpone treatment, especially in the early stages of the disease, where perhaps they do not feel very ill. The Council has, therefore, enlarged the scope of the Colony and some adult patients are now taken in. During the year extensive repairs and renovations have been undertaken, and the Colony is equipped and ready to carry on its work with undiminished efficiency.

For some years the spiritual work has been carried out by the Vicar of Frimley, the Rev. J. W. Partridge, and the Association is much indebted to him, and the keen and sympathetic interest of Mr. Isdell Carpenter, Curate of Frimley, who have conducted the services and given hours of help and encouragement to the patients. It seemed to the Council that better provision should be made for the services which had hitherto been held in the recreation room. A chapel has now been constructed in one of the Colony buildings, and the gifts for the furnishing have been made through the generosity of individual members of the Council and friends of the Colony.

This new departure will help the spiritual life of the patients, and will provide a background that is so necessary for boys at this impressionable period of life. The Chapel will be dedicated by the Bishop of Guildford in the summer of 1942.

NURSE COMMISSIONERS

The Nurse Commissioners Scheme in Scotland has now been running for some eleven years, and is believed to be one of the most satisfactory pieces of work for which the Association is responsible. One observer, who speaks with unique authority on the Highlands of Scotland, has said that the Nurse Commissioners Scheme is the best piece of work that has ever been done in these areas towards the prevention of tuberculosis.

The Advisory Committee, which, under the Chairmanship of the Hon. Mrs. Stirling of Keir, a member of our Council, controls this work, decided that the time had come for an approach to the Department of Health for Scotland, reporting the work that had been done in the previous ten years, and asking for recognition in future. This matter is now before the Department.

N.A.P.T. BULLETIN

After three years, the Bulletin has now established itself among the organs of tuberculosis opinion. It is different from the other medical journals. It is mainly a medium of digest and communication, although there are in each issue original articles.

A familiar complaint of all medical workers to-day is that they cannot cover all that is written on their own subject owing to shortage of time. The aim of the Bulletin is to give essentials in an easy and attractive form. The Council is sure that anyone who reads it six times a year would have at least a bird's eye view of what is going on in the tuberculosis world.

The Council has now decided to publish the "Bulletin" in an attractive printed form. This work will be carried out at the British Legion Village for tuberculous men, and will enable the "Bulletin" to have a much wider circulation.

ANNUAL MEETING

In days of peace, the Association was accustomed to hold every year in London, or some large provincial city, a Conference of Local Authorities, and those interested in tuberculosis. These meetings lasted $2\frac{1}{2}$ days, and it was the custom to consider several subjects both in their medical and sociological aspects, by both laymen and doctors. For the present these Conferences must be suspended, but it is hoped that before long they may be resumed.

In 1941 the Association's Annual Meeting took the form of a gathering of care workers. No wider invitation was possible, but the meeting was well attended, and the practical organisation of the Christmas Seal Sale debated from all angles. The war has proved the value of voluntary work, and this exchange of opinion made it clear that the right spirit is there.

BRITISH WAR RELIEF SOCIETY

Generous citizens of the United States of America have several times taken on themselves the burden of European relief. During the first two years of war, a large sum of money was collected in America, and administered by the British War Relief Society under the chairmanship of Mr. Bertram Cruger. A portion of this fund was set aside for the victims of tuberculosis, particularly those who had suffered exceptional hardship through the war, and through aerial bombardment. The Association was asked to help in the administration of this fund, and 31 cases were prepared and submitted to the British War Relief Society by whom relief was given.

This scheme, although limited, and not possessing any permanent form, has expressed the charitable desires of many United States citizens, and has enabled these tuberculous families who would not otherwise have been helped to be set on their road again.

GENERAL CONTACTS

It is the business of the National Association to keep in touch with tuberculosis opinion everywhere. But the areas of the world in which we can nowadays maintain effective communication are limited: and many flourishing systems of public health have been struck down in the disorganisation of war. We have unfortunately no knowledge of the UNION INTERNATIONALE CONTRE LA TUBERCULOSE, whose headquarters is in Paris, although it was known last autumn that the Assistant Secretary, Dr. Alice Churchill, is well. The Council has resolved to try and keep in touch with those countries of the former International Union, such as Portugal, the United States, U.S.S.R., and South America, with whom contact is still possible. Hardly a week passes but the Association receives communications from overseas.

FINANCE

The Association has carried out a considerable amount of work without a drain on its permanent finances. Owing to the uncertainty of the future, the capital assets which are the foundation of our work are carefully watched. But the Council believe that, in a problem of such magnitude as tuberculosis, it is the responsibility of the Association to spend money where this is justified, even although no immediate results can be expected.

MEMBERSHIP OF COUNCIL

During the year the Council has welcomed two new members. Dr. Frederick Heaf, Principal Assistant Medical Officer to the London County Council, joined the Council in May, 1941, and has since played an active part in its deliberations, as a member of the Radiology and Nutrition Committees, and of the Committee which administered the grants from the British War Relief Society of the U.S.A. His wide experience of tuberculosis makes his presence on the Council extremely valuable.

Admiral G. H. Borrett joined the Council in May, 1942. He is well known to those who have attended the Association's Conferences and Annual Meetings as Chairman of Addlestone and District Tuberculosis Care Committee and Vice-Chairman of the Standing Conference of Surrey Tuberculosis Care Committees. His enthusiasm and his active experience of Seal Sale organisation will strengthen still further the lay membership of the Council.

We have to report with regret two resignations from the Council, that of Sir Henry Gauvain, M.D., F.R.C.S., and of Dr. J. E. Chapman, both of whom found it impossible to attend meetings of Council. It is hoped that Dr. Chapman will find it possible to become again a member of Council when peace returns. Sir Henry Gauvain has been invited to become a Vice-President of the Association, together with Sir St. Clair Thomson, Sir Arthur Stanley, Sir Humphry Rolleston and the Earl of Dudley, all of whom had been unable to attend the meetings.

So far the Association has been successful in retaining the services of all its principal officials, and hopes to be able to carry on its work and be ready for the opportunities of the post-war period.

[APPENDIX V]

RULES FOR AFFILIATION

1. Any Institution, Society or Committee whose object includes the eradication of tuberculosis and whose constitution, objects and work are approved by the Council of the National Association shall be eligible for affiliation as a Tuberculosis Care Committee.

2. Tuberculosis Care Committees applying for affiliation shall satisfy the Council of the National Association that the following conditions are being or will be fulfilled :—

- (a) The Committee shall form a recognised and integral part of the Tuberculosis Service of the County, County or Metropolitan Borough or Joint Board of the area within which it operates.
- (b) The Committee shall include representatives of Authority responsible for the Tuberculosis Service of the area and of such official charitable and other organisations as may be able and willing to help.
- (c) The Committee shall make the family of the tuberculous person the unit of its operations, and shall have as its aim the rehabilitation of such families rather than mere temporary relief.
- (d) The Committee shall deal only with tuberculous persons who have expressed their willingness for their cases to be referred to the Committee. A Committee is not precluded from making such representations to Local Authorities and others as are considered necessary with reference to the welfare of tuberculous persons generally.
- (e) The Tuberculosis Officer shall act as Medical Adviser to the Committee.

3. Affiliated Care Committees shall send to the National Association each year a short report indicating the character and extent of the work done and an audited statement of account.

4. The privilege of affiliation shall be continued from year to year, and the Council of the National Association retain the right to withdraw the privilege at any time if the constitution or objects of the affiliated society are changed, or if, in the opinion of the Council, the work of the affiliated body does not reach the standard considered by the Council to be adequate.

5. The privileges of affiliation shall be as follows :—

- (a) Membership of the Annual Conference of the National Association for one representative without fee.
- (b) Use of Propaganda service of the Association without charge.
- (c) Purchase of literature, hire of films, etc., at a discount.
- (d) Use of double red cross on noteholding, etc., and free provision of block for the same.
- (e) The right to apply for participation in the Christmas Seal Sale which may be granted annually at the discretion of the Council in each case.
- (f) As circumstances permit, the National Association will be prepared to send on request, and free of charge, an experienced Social Welfare Organiser to advise with the Committee on the work generally and upon special difficulties which have been encountered.

6. During the course of the war and in time of National Emergency the Council of the Association may at its discretion waive the application of any of the above rules.
