SIR,

I am directed by the Minister of Health to refer to Circular 997 of the 10th July, 1929, in which Local Authorities were requested to furnish him with information as to the salaries and other conditions of employment of women who are whole-time officers of such Authorities carrying out duties either as Health Visitors, School Nurses, Tuberculosis Visitors or Municipal Midwives.


This information has now been received from all the Authorities concerned, and the Minister has caused a tabular statement to be prepared in which the information has been summarised under appropriate headings. A copy of the statement is enclosed herewith for the information of the Local Authority.

A perusal of the statement shows that there are still considerable variations in the salaries and other conditions of service of the women public health officers employed by Local Authorities in carrying out similar duties, and the Minister hopes that due consideration will be given to the statement by the Authorities concerned with a view to the removal of the anomalies which have been shown to exist.

In particular the Minister desires to draw attention to the wide variations in the salaries paid to Health Visitors, and to the lack of uniformity in the arrangements for the payment of salary during sick leave. It appears to him that Local Authorities who still pay inadequate salaries cannot expect to secure or retain the services of women properly qualified to discharge the important duties attached to the post of Health Visitor, and he trusts that all Local Authorities will consider the desirability of adopting the practice already in operation in most areas whereby these officers receive full pay during sick leave.

I am directed by the Minister of Health to refer to Circular 1117 of the 10th July 1951 in which local authorities were requested to forward to the Ministry of Health, as a condition of the grant of a licence to a local authority, a list of the names of the persons who are appointed officers of such local authorities carrying out duties under the Health Authorities Act, 1947, in the following manner:

The information has now been received from all the Authorities concerned, and the Minister has issued a tabular statement in which the information has been summarized under appropriate headings. A copy of the statement is enclosed herewith for the information of the local authorities.

A paragraph of the statement shows that there are still considerable variations in the salaries and other conditions of service of the persons appointed to the various offices mentioned in the statement. It is requested that the local authorities who are carrying out similar duties, and the persons appointed to such offices, will be given to the Minister by the Authorities concerned with a view to the removal of the anomalies which have been shown to exist.

In particular the Minister desires to draw attention to the wide variations in the salaries paid to Health Visitors, and to the fact that in the majority of cases the payment of salary during absence from duty is not provided for. It is requested that the local authorities who are carrying out similar duties should consider the possibility of making the matter already mentioned a point upon which they should receive full pay during any leave.
