THE NEW POSTAL CHARGES IN THE HMSO CATALOGUE SERVICE

From 29th September 1975 the Post Office has introduced new rates of postal charges based upon metric scales of weights in grams and kilograms. At the same time new methods of enabling HMSO customers to calculate the amount of postage chargeable on their orders are being introduced in HMSO lists and catalogues. Because of the frequency in changes of postal rates, the prices inclusive of postage at second class inland rates hitherto quoted in these catalogues become very rapidly outdated. In future, therefore, catalogue entries will omit prices inclusive of postage, quoting published prices only plus the weight of each item in grams or kilograms. Schedules of current postal rates will be included in each catalogue enabling customers to calculate, by reference to those weights, the amount of postage chargeable on any order using either of the commonly used methods of despatch. These schedules will of course be updated on each subsequent change in postal rates.
