1. This Order may be cited as the Disability Discrimination Act 1995 (Commencement No. 4) Order 1996.

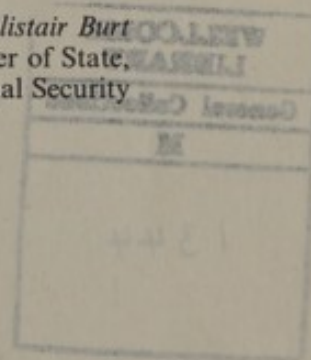
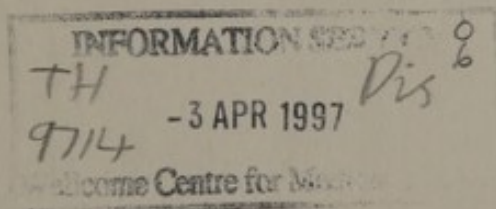

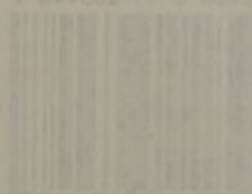
