1. This Order may be cited as the Disability Discrimination Code of Practice (Goods, Services, Facilities and Premises) Order 1996.

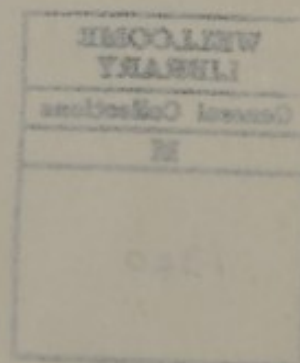
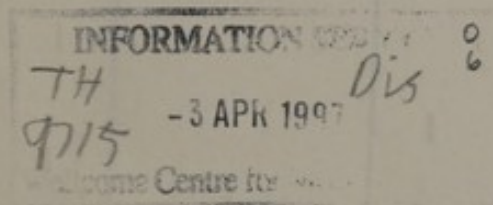
**Code of Practice**

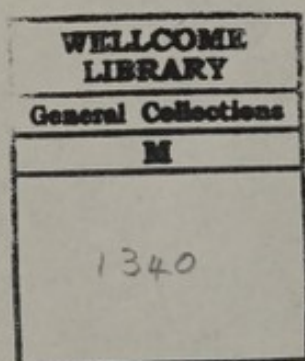
