Introduction

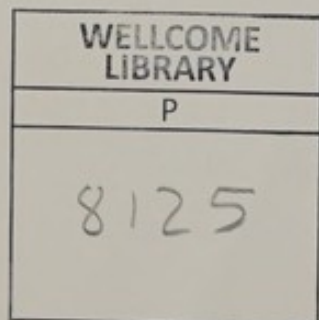

Members have been chosen primarily from the nominations put forward by Subject Associations, Professional Bodies, Learned Societies, Research Councils and similar organisations.

The main criterion for the selection of members has been pre-eminence in research. The following criteria were also used:

- a. Coverage of the subject and, where appropriate, the spectrum of basic/strategic/applied research.
- b. Coverage of both UFC and non-UFC sectors.
- c. Geographical spread.

It should be noted that members are appointed by the UFC in a personal capacity; they are not serving as representatives of their HEI nor of the body that nominated them.
