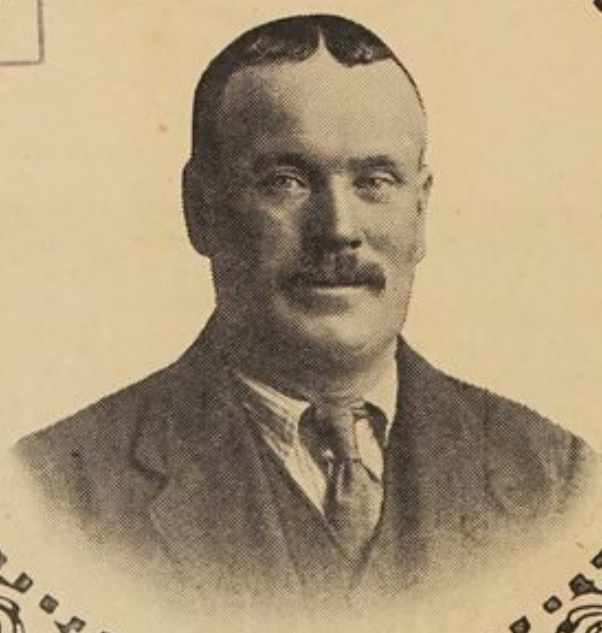

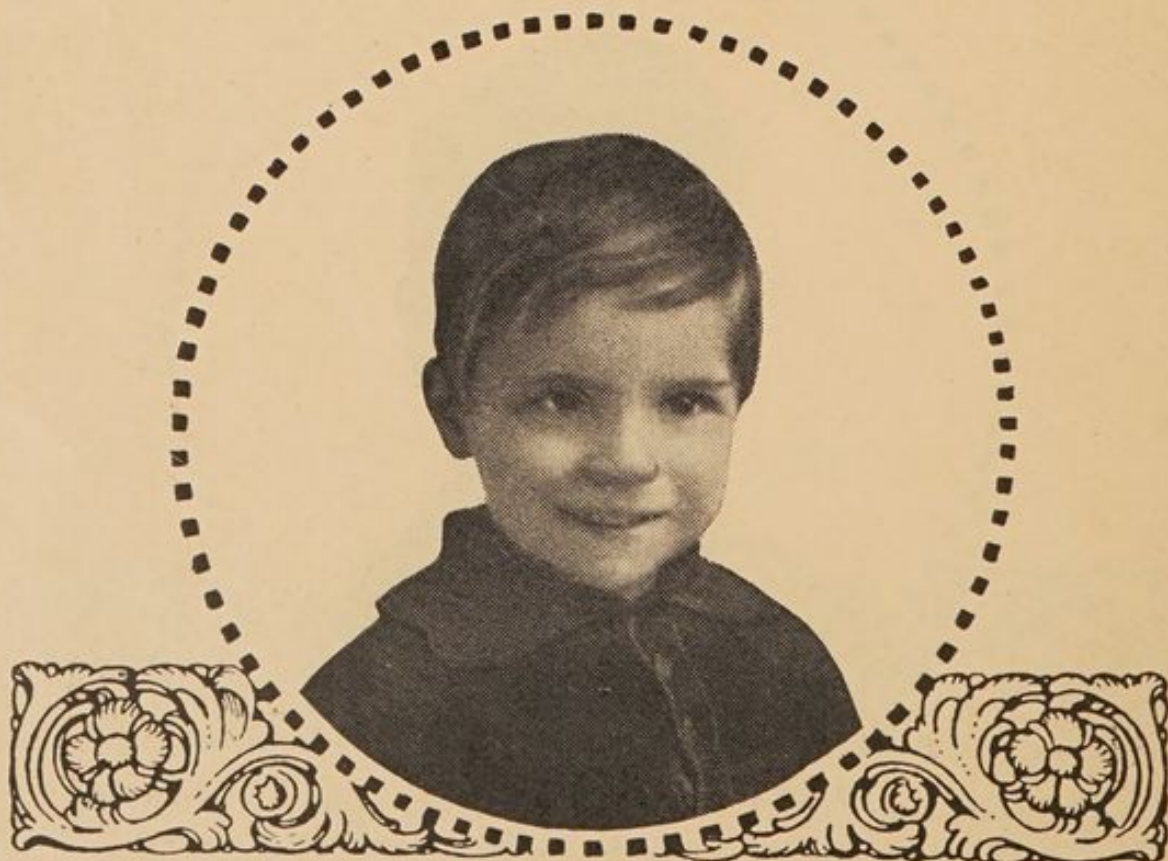
While wearing the Appliance he could run and play with the other children as if he was alright.
